

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 8 February 2023

Public Authority: Liverpool City Council

Address: Cunard Building

### **Decision (including any steps ordered)**

- 1. The complainant requested information about payments made from the Mayoral Neighbourhood Fund. By the date of this notice, Liverpool City Council ("the Council") had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the Council has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the Council to take the following step to ensure compliance with the legislation.
  - The Council must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The Council must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

#### **Request and response**

5. On 11 October 2022, the complainant wrote to the Council and requested information in the following terms:



"Firstly, thank you for your prompt response to my last request of 23 August 2022.

I would be grateful if you could now supply the following information, also relating to the Mayoral Neighbourhood Fund.

Please provide both the request forms and completed monitoring forms for any payments made to the following organisations in the financial years 2015/16 to 2021/22 (inclusive):

- Beautiful Ideas Company (Company number 09138025)
- Paper Cup Project (Charity number 1181449)
- Shrewsbury House (Charity number 1058694/Company number 03245123)
- Marybone Youth & Community Centre (Charity number: 1066366)

If a monitoring report has not been submitted, could you please let me know.

Finally, could you please supply me with a copy of the Internal Audit of the Mayoral Neighbourhood Fund carried out in 2019. I believe this has already been released in response to an FoI but has not been placed in the public domain.

I am happy to receive this information electronically and in installments if that is more convenient to you."

6. The Council acknowledged the request on 12 October 2022. To date, a substantive response has not been issued.

#### Scope of the case

- 7. The complainant contacted the Commissioner on 12 January 2023 to complain about the Council's failure to respond to their request.
- 8. The Commissioner has considered whether the Council has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.



#### Reasons for decision

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 11. On 23 January 2023, the Commissioner wrote to the Council, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 12. Despite this intervention, the Council has failed to respond to the complainant.
- 13. From the evidence provided to the Commissioner in this case, it is clear that the Council did not deal with the request for information in accordance with FOIA. The Commissioner finds that the Council has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



## Right of appeal

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
