

## Freedom of Information Act 2000 (FOIA)

### Decision notice

**Date:** 24 March 2023

**Public Authority:** NHS England  
**Address:** Quarry House  
Quarry Hill  
Leeds  
LS2 7UE

#### Decision (including any steps ordered)

---

1. The complainant requested information relating to services or contracts NHS England awarded to multiple consultancy firms over the value of £100,000. By the date of this notice NHS England had not issued a substantive response to this request.
2. The Commissioner's decision is that NHS England has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
3. The Commissioner requires NHS England to take the following step to ensure compliance with the legislation.
  - NHS England must provide a substantive response to the request in accordance with its obligations under FOIA.
4. NHS England must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

## Request and response

---

5. On 6 December 2022, the complainant wrote to NHS England and requested information in the following terms:

"For any services or contracts NHS England awarded to the consultancy firms PwC, McKinsey & Company, Deloitte, Ernst & Young, KPMG, PA Consulting in 2022 over the value of £100,000 please provide:

1. Any reference numbers for the service or contract.
2. A description of each service or contract they provided.
3. The start date of each service or contract.
4. The end date of each service or contract.
5. The total value of the service or contract.
6. The number of consultants from the company who worked to provide the service or contract.
7. The lowest and highest day rates of the consultants who worked to provide the service or contract.
8. A list of deliverables for the service or contract.

I would like to receive the information in a spreadsheet..."

6. NHS England acknowledged the request on 8 December 2022. To date, a substantive response has not been issued.

## Scope of the case

---

7. The complainant contacted the Commissioner on 16 January 2023 to complain about NHS England's failure to respond to their request.
8. The Commissioner has considered whether NHS England has complied with its obligations in relation to the time for compliance at section 10(1) of FOIA.

## Reasons for decision

---

9. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him.”

10. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
11. On 26 January 2023 the Commissioner wrote to NHS England, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
12. Despite this intervention NHS England has failed to respond to the complainant.
13. From the evidence provided to the Commissioner in this case, it is clear that NHS England did not deal with the request for information in accordance with FOIA. The Commissioner finds that NHS England has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.

## Right of appeal

---

14. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
