

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 21 June 2023

Public Authority: Cabinet Office Address: 70 Whitehall London SW1A 2AS

## Decision (including any steps ordered)

- 1. The complainant requested information from the Cabinet Office regarding draft articles and distribution of lieutenancy documents.
- 2. The Commissioner's decision is that the Cabinet Office breached section 10(1) of FOIA by failing to provide a valid response to the request within the statutory time frame of 20 working days. No steps are required.

#### Request and response

3. On 26 March 2023, the complainant made the following request for information:

"Please can you release these items

- Lieutenancy validation form (returnable to the Cabinet Office for each nominee assessed)
- Lieutenancy assessment form
- Honours information pack for Deputy Lieutenants
- Draft article for local press
- Draft letter to local organisations promoting honours system
- Text of factsheet for local distribution
- Addressing general misconceptions about the honours system"
- 4. The Cabinet Office responded to the request for information on 8 June 2023.



## **Reasons for decision**

5. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

(a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and

(b) if that is the case, to have that information communicated to him."

- 6. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 7. From the evidence provided to the Commissioner in this case, it is clear that the Cabinet Office did not deal with the request for information in accordance with FOIA. The Commissioner finds that the Cabinet Office has breached section 10(1) by failing to respond to the request within 20 working days.



## **Right of appeal**

8. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
