Freedom of Information Act 2000 (FOIA) Decision notice

Public Authority: The Governing Body of the University of Chester

Decision (including any steps ordered)

- 1. The complainant requested information relating to meeting minutes between specific individuals. By the date of this notice the University of Chester (UoC) had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the UoC has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the UoC to take the following step to ensure compliance with the legislation.
 - The UoC must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. The UoC must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

Request and response

5. On 10 March 2023, the complainant wrote to the UoC and requested information in the following terms:

"This is a request under FOI / EIR for the following:

Reference: IC-235646-B5M7



Dates, agendas and minutes of any meetings that [NAME REDACTED] has attended either online or in person in his capacity as Director of Thornton Energy Research Insitute from 1st September 2022 until today concerning hydrogen development in the North West / Hynet North West;

Any correspondence (emails) and meetings between [NAME REDACTED] and senior executives from Cadent concerning hydrogen / CCS / Hynet North West from 1st September 2022 until today;

Please can you acknowledge receipt?" (sic)

6. To date, the UoC have not acknowledged the information request.

Reasons for decision

7. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 8. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 9. On 2 June 2023 the Commissioner wrote to the UoC, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- Despite this intervention the UoC has failed to respond to the complainant.
- 11. From the evidence provided to the Commissioner in this case, it is clear that the UoC did not deal with the request for information in accordance with FOIA. The Commissioner finds that the UoC has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.
