

Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- 1. The complainant requested information about SKYCovion and COVID-19 Vaccines. By the date of this notice the Commission on Human Medicines (CHM) had not issued a substantive response to this request.
- 2. The Commissioner's decision is that CHM has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires CHM to take the following step to ensure compliance with the legislation.
 - CHM must provide a substantive response to the request in accordance with its obligations under FOIA.
- 4. CHM must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.



Request and response

5. On 10 June 2023, the complainant wrote to CHM and requested information in the following terms:

"On 26 May 2023, SKYCovion, a COVID-19 vaccine developed by SK Chemicals, was authorised by the Medicines and Healthcare products Regulatory Agency (MHRA). This authorisation was based on advice received from the independent Commission on Human Medicines (CHM).

I would be grateful if you could provide copies of the communications/documents evidencing the process of advising the MHRA on authorisation of SKYCovion, as follows:

- 1. The formal request received by the CHM for advice on the safety, quality and efficacy of SKYCovion
- 2. The formal advice provided by CHM to the MHRA on the safety, quality and efficacy of SKYCovion
- 3. Representations, reports and other evidence provided as the basis for the advice provided by the CHM on the safety, quality and efficacy of SKYCovion
- 4. The advice, conclusions, and recommendations received by the CHM from the COVID-19 Vaccines Benefit Risk Expert Working Group on:
 - a. the quality, safety and efficacy of SKYCovion and on the balance of benefit and risks prior to authorisation.
 - b. evidence on the risks and benefits of SKYCovion including measures to minimise risks, and optimise the benefit-risk balance, such as any new precautions or restrictions on use.
 - c. any communications to health professionals and the public.
 - d. measures to monitor impact/effectiveness of any additional risk minimisation
- 5. Any advice provided by CHM on the need for, and content of, a risk management plan for SKYCovion
- 6. The advice provided by CHM on the impact of any safety issues on the balance of risks and benefits of SKYCovion



7. Steps taken to promote the collection and investigation of information about adverse reactions to SKYCovion

In case you feel the scale of the evidence requested above qualifies for a Section 12 exemption, please address the information in the numbered order as far as practicable. Where information cannot be provided due to the scale of effort, please explain the issue."

6. CHM acknowledged the request on 22 June 2023. To date, a substantive response has not been issued.

Reasons for decision

7. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 8. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 9. On 18 July 2023 the Commissioner wrote to CHM, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 10. Despite this intervention CHM has failed to respond to the complainant.
- 11. From the evidence provided to the Commissioner in this case, it is clear that CHM did not deal with the request for information in accordance with FOIA. The Commissioner finds that CHM has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.



Right of appeal

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
