Decision (including any steps ordered)

- 1. The complainant requested information from the Planning Inspectorate (PI) relating to a planning appeal. By the date of this notice the PI had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the PI has failed to respond to the request within 20 working days and has therefore breached regulation 5(2) of the EIR.
- 3. The Commissioner requires the PI to take the following steps to ensure compliance with the legislation.
 - Issue a substantive response to the request in accordance with its obligations under the EIR.
- 4. The PI must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Freedom of Information Act and may be dealt with as a contempt of court.

Request and response

5. On 11 May 2023, the complainant made the following request for information to the PI:

"Please provide the following information relating to this planning appeal:

All correspondence from and to the Planning Inspectorate, Planning Inspector, All and any UK Government departments and employees, the developer and or their agent" (sic)

6. The PI acknowledged the request on 5 June 2023. To date, a substantive response to the request has not been issued.

Reasons for decision

7. Regulation 5(1) of the EIR states that:

"a public authority that holds environmental information shall make it available on request."

8. Regulation 5(2) of the EIR states that:

"Information shall be made available under paragraph (1) as soon as possible and no later than 20 working days after the date of receipt of the request."

- 9. The Commissioner contacted the PI on 2 August 2023 reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days. Despite this intervention the PI has failed to respond to the complainant.
- 10. From the evidence provided to the Commissioner in this case, it is clear that the PI did not deal with the request for information in accordance with the EIR. The Commissioner's decision is that the PI has breached regulation 5(2) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with the EIR.
