Freedom of Information Act 2000 (FOIA) Decision notice

Decision (including any steps ordered)

- 1. The complainant requested information from the Financial Ombudsman Service (the FOS). By the date of this notice the public authority had not issued a substantive response to this request.
- 2. The Commissioner's decision is that the FOS has breached section 10(1) of FOIA in that it failed to provide a valid response to the request within the statutory time frame of 20 working days.
- 3. The Commissioner requires the public authority to take the following step to ensure compliance with the legislation.
 - The FOS must provide a substantive response to the request in accordance with its obligations under FOIA.¹
- 4. The FOS must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

- 5. On 21 July 2023, the complainant wrote to the public authority and requested information in the following terms:
 - "I would also like to request that you send me a copy of the procedures and practises The FOS follows..."
- 6. The FOS requested clarification from the complainant on 10 August 2023.
- 7. The complainant provided the FOS with clarification on 21 August 2023, in the following terms:
 - "...I would also like to know the internal procedures that should have been followed in our case..."

Reasons for decision

- 8. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".
- 9. On 3 October 2023 the Commissioner wrote to the public authority, reminding it of its responsibilities and asking it to provide a substantive response to the complainant's request within 10 working days.
- 10. Despite this intervention the public authority has failed to respond to the complainant.
- 11. From the evidence provided to the Commissioner in this case, it is clear that the public authority did not deal with the request for information in accordance with FOIA. The Commissioner finds that the public authority has breached section 10(1) by failing to respond to the request within 20 working days and it is now required to respond to the request in accordance with FOIA.
