DECISION ON COSTS ONLY

- 1. On 7 January 2014, Mrs Ann Corbett upheld an opposition by CK3 LLC ("the Opponent") to the registration of the trade mark BULLDOG CIDER for cider in Class 33.
- 2. On 4 February 2014, Bulldog Energy Drink Ltd ("the Applicant") lodged an appeal. It was fixed for hearing on 19 June 2014.
- 3. On 10 June, the Applicant wrote asking if I would adjourn the hearing, on the basis that the parties were actively seeking to settle the matter. However, the Opponent objected to the adjournment, so I did not grant the Applicant's request.
- 4. On 17 June I received a skeleton argument from counsel for the Opponent for the substantive appeal, settled by counsel, as well as a skeleton argument for the Applicant settled by its Head of Legal Affairs.
- 5. However, by the following morning, the Applicant had decided to and did withdraw the appeal.
- 6. The Opponent now seeks a contribution towards its costs of preparing for the appeal 'at the top end of the standard scale' on the basis that the appeal was withdrawn so late.
- 7. In my view, it is right that the Applicant should pay something towards the Opponent's costs of preparing for the appeal, and the sum to be paid should reflect the fact that the appeal was withdrawn after counsel had been instructed to appear

- at the hearing and after exchange of skeleton arguments, so that the bulk of the costs relating to the appeal would have been incurred by that time.
- 8. In the circumstances, I will order the Applicant to pay the Opponent £1000 in respect of its costs of the appeal, to be paid within 14 days of today, in addition to the costs awarded by the Hearing Officer.
