BACKGROUND

- 1. On 05 September 2018 Kalpna Kotecha ("the applicant") applied to register the trade mark "Veganiks" for a range of goods in class 30.
- 2. The application was published for opposition purposes on 16 November 2018.
- 3. The application is opposed by Venkatesh Sivaraman ("the opponent") under the fast track procedure. The opposition, which is directed against all of the goods in the contested application, is based upon Section 5(2)(b) of the Trade Marks Act 1994 ("the Act"), for the purpose of which the opponent relies upon UK trade mark number 3157605 for the following series of two marks:

veganics

- 4. The earlier mark covers a range of goods in classes 29, 30, 31 and 32, all of which are relied upon by the opponent in these proceedings.
- 5. The earlier mark was applied for on 1 April 2016 and registered on 8 July 2016. The significance of these dates is that (1) the opponent's mark constitutes an earlier mark in accordance with section 6 of the Act, and (2) it is not subject to the proof of use conditions contained in section 6A of the Act, its registration procedure having been completed less than five years before the publication of the applicant's mark.
- 6. The applicant filed a counterstatement in which he denies the ground of opposition.
- 7. Rules 20(1)-(3) of the Trade Marks Rules (the provisions which provide for the filing of evidence) do not apply to fast track oppositions, but Rule 20(4) does. It reads:
 - "(4) The registrar may, at any time, give leave to either party to file evidence upon such terms as the registrar thinks fit."

8. The net effect of the above is to require parties to seek leave in order to file evidence (other than the proof of use evidence which is filed with the notice of opposition) in fast track oppositions. Neither side sought leave to file evidence. Rule 62(5) (as amended) states that arguments in fast track proceedings shall be heard orally only if 1) the Office requests it or 2) either party to the proceedings requests it and the registrar considers that oral proceedings are necessary to deal with the case justly and at proportionate cost. Otherwise written arguments will be taken.

9. In these proceedings neither party is professionally represented. A hearing was neither requested nor considered necessary. Neither side filed written submissions.

DECISION

Section 5(2)(b)

10. Section 5(2)(b) of the Act states:

"5. -(2) A trade mark shall not be registered if because-

(b) it is similar to an earlier trade mark and is to be registered for goods or services identical with or similar to those for which the earlier trade mark is protected,

there exists a likelihood of confusion on the part of the public, which includes the likelihood of association with the earlier trade mark".

Section 5(2)(b) case law

11. The following principles are gleaned from the decisions of the EU courts in *Sabel BV v Puma AG*, Case C-251/95, *Canon Kabushiki Kaisha v Metro-Goldwyn-Mayer Inc*, Case C-39/97, *Lloyd Schuhfabrik Meyer & Co GmbH v Klijsen Handel B.V.* Case C-342/97, *Marca Mode CV v Adidas AG & Adidas Benelux BV*, Case C-425/98, *Matratzen Concord GmbH v OHIM*, Case C-3/03, *Medion AG v. Thomson Multimedia*

Sales Germany & Austria GmbH, Case C-120/04, Shaker di L. Laudato & C. Sas v OHIM, Case C-334/05P and Bimbo SA v OHIM, Case C-591/12P.

The principles

- (a) The likelihood of confusion must be appreciated globally, taking account of all relevant factors:
- (b) the matter must be judged through the eyes of the average consumer of the goods or services in question, who is deemed to be reasonably well informed and reasonably circumspect and observant, but who rarely has the chance to make direct comparisons between marks and must instead rely upon the imperfect picture of them he has kept in his mind, and whose attention varies according to the category of goods or services in question;
- (c) the average consumer normally perceives a mark as a whole and does not proceed to analyse its various details;
- (d) the visual, aural and conceptual similarities of the marks must normally be assessed by reference to the overall impressions created by the marks bearing in mind their distinctive and dominant components, but it is only when all other components of a complex mark are negligible that it is permissible to make the comparison solely on the basis of the dominant elements;
- (e) nevertheless, the overall impression conveyed to the public by a composite trade mark may be dominated by one or more of its components;
- (f) however, it is also possible that in a particular case an element corresponding to an earlier trade mark may retain an independent distinctive role in a composite mark, without necessarily constituting a dominant element of that mark;
- (g) a lesser degree of similarity between the goods or services may be offset by a great degree of similarity between the marks, and vice versa;

- (h) there is a greater likelihood of confusion where the earlier mark has a highly distinctive character, either per se or because of the use that has been made of it:
- (i) mere association, in the strict sense that the later mark brings the earlier mark to mind, is not sufficient;
- (j) the reputation of a mark does not give grounds for presuming a likelihood of confusion simply because of a likelihood of association in the strict sense;
- (k) if the association between the marks creates a risk that the public might believe that the respective goods or services come from the same or economically-linked undertakings, there is a likelihood of confusion.

Comparison of goods

12. In the judgment of the Court of Justice of the European Union (CJEU) in *Canon*, Case C-39/97, the Court stated at paragraph 23:

"In assessing the similarity of the goods or services concerned, as the French and United Kingdom Governments and the Commission have pointed out, all the relevant factors relating to those goods or services themselves should be taken into account. Those factors include, inter alia, their nature, their intended purpose and their method of use and whether they are in competition with each other or are complementary".

- 13. The relevant factors identified by Jacob J. (as he then was) in the *Treat* case, [1996] R.P.C. 281, for assessing similarity were:
 - (a) The respective uses of the respective goods or services;
 - (b) The respective users of the respective goods or services;
 - (c) The physical nature of the goods or acts of service;
 - (d) The respective trade channels through which the goods or services reach the market:

- (e) In the case of self-serve consumer items, where in practice they are respectively found or likely to be, found in supermarkets and in particular whether they are, or are likely to be, found on the same or different shelves;
- (f) The extent to which the respective goods or services are competitive. This inquiry may take into account how those in trade classify goods, for instance whether market research companies, who of course act for industry, put the goods or services in the same or different sectors.
- 14. In *YouView TV Ltd v Total Ltd,* [2012] EWHC 3158 (Ch), Floyd J. (as he then was) stated that:
 - "... Trade mark registrations should not be allowed such a liberal interpretation that their limits become fuzzy and imprecise: see the observations of the CJEU in Case C-307/10 *The Chartered Institute of Patent Attorneys (Trademarks) (IP TRANSLATOR)* [2012] ETMR 42 at [47]-[49]. Nevertheless, the principle should not be taken too far. Treat was decided the way it was because the ordinary and natural, or core, meaning of 'dessert sauce' did not include jam, or because the ordinary and natural description of jam was not 'a dessert sauce'. Each involved a straining of the relevant language, which is incorrect. Where words or phrases in their ordinary and natural meaning are apt to cover the category of goods in question, there is equally no justification for straining the language unnaturally so as to produce a narrow meaning which does not cover the goods in question."
- 15. In Beautimatic International Ltd v Mitchell International Pharmaceuticals Ltd and Another, [2000] F.S.R. 267 (HC), Neuberger J. (as he then was) stated that:
 - "I should add that I see no reason to give the word "cosmetics" and "toilet preparations"... anything other than their natural meaning, subject, of course, to the normal and necessary principle that the words must be construed by reference to their context."
- 16. In *Kurt Hesse v OHIM*, Case C-50/15 P, the CJEU stated that complementarity is an autonomous criterion capable of being the sole basis for the existence of similarity

between goods. In *Boston Scientific Ltd v OHIM,* Case T-325/06, the General Court (GC) stated that "complementary" means:

"...there is a close connection between them, in the sense that one is indispensable or important for the use of the other in such a way that customers may think that the responsibility for those goods lies with the same undertaking".

17. In Sanco SA v OHIM, Case T-249/11, the GC indicated that goods and services may be regarded as 'complementary' and therefore similar to a degree in circumstances where the nature and purpose of the respective goods and services are very different, i.e. chicken against transport services for chickens. The purpose of examining whether there is a complementary relationship between goods/services is to assess whether the relevant public are liable to believe that responsibility for the goods/services lies with the same undertaking or with economically connected undertakings. As Mr Daniel Alexander Q.C. noted as the Appointed Person in Sandra Amelia Mary Elliot v LRC Holdings Limited BL-0-255-13:

"It may well be the case that wine glasses are almost always used with wine – and are, on any normal view, complementary in that sense - but it does not follow that wine and glassware are similar goods for trade mark purposes."

18. Whilst on the other hand:

"......it is neither necessary nor sufficient for a finding of similarity that the goods in question must be used together or that they are sold together".

19. In Gérard Meric v OHIM, Case T- 133/05, the GC stated:

"29. In addition, the goods can be considered as identical when the goods designated by the earlier mark are included in a more general category, designated by trade mark application (Case T-388/00 Institut fur Lernsysteme v OHIM- Educational Services (ELS) [2002] ECR II-4301, paragraph 53) or

where the goods designated by the trade mark application are included in a more general category designated by the earlier mark".

- 20. For ease of reference, the lists of goods designated by the parties' marks are reproduced in full in the Annex to this decision. As can be seen, the list is very lengthy and contains a lot of duplication; to avoid repetitions, I shall, where possible, refer to each term once.
- 21. In approaching the comparison, I bear in mind that the opponent has not offered any explanation as to why it believes any of the contested goods are identical or similar to the earlier goods. Consequently, where the similarity between the parties' goods is not obvious, I will find that the goods are not similar.
- 22. The goods sought by the applicant are many and varied. I will go through them in turn but grouping them when it is reasonable to do so. I will compare each term (or group of terms) with the opponent's goods. I will focus on what I consider to be the opponent's most similar goods, but I have, of course, borne all the opponent's goods in mind.
- 23. Achar pachranga (fruit pickle). The earlier specification includes *Pickled fruit* (class 29). Regardless of the fact that the parties' goods are in different classes (class 30 and class 29, respectively), they are, at least, highly similar. The goods are, at least, highly similar.
- **24.** Cereals; Cereals for food for consumption by humans. The earlier specification includes Cereal; Prepared Brans; Prepared Grains; Processed Brans; Processed Grains (class 30). The applicant's Cereals are self-evidently identical to the opponent's Cereal. The applicant's Cereals for food for consumption by humans are encompassed by the opponent's broad term Cereal and so are identical (Meric).
- 25. Before proceeding any further, is it worth setting out what the earlier goods in class 30 cover. The Oxford English dictionary contains the following definition:

cereal

noun

- 1. a grain used for food, for example wheat, maize, or rye.
 - a grass producing edible grain that is grown as an agricultural crop: [as modifier] : cereal crops.
- 2. [mass noun] a breakfast food made from roasted grain, typically eaten with milk: *a* bowl of cereal.
- 26. The term *Cereal* covers cereal grains such as wheat, millet, rice, barley, oats and maize (corn) as well as breakfast cereals. I do not consider that the term *Cereal* would cover, per se, cereal preparations, i.e. foodstuff made with cereal flour such as pasta, bread, cakes and other bakery products.
- 27. The earlier mark also includes *Prepared Brans; Prepared Grains; Processed Brans; Processed Grains*. Grains are the seeds of cereals. Brans are pieces of grain husk separated from flour after milling. I consider that *Prepared Brans; Prepared Grains; Processed Brans; Processed Grains* would cover brans and grains that have been prepared or processed for consumption and conservation. On a fair reading of the terms, this would include products consisting of grains that have been roasted, baked, toasted, cut, crushed, milled and grinded, including flour, which is a powder obtained by grinding grains. I approach the comparison on that basis.
- 28. Breakfast cereals; Breakfast cereals containing a mixture of fruit and fibre; Breakfast cereals containing fibre; Breakfast cereals containing fruit; Breakfast cereals containing honey; Breakfast cereals flavoured with honey; Breakfast cereals made of rice; Breakfast cereals, porridge and grits; Cereal breakfast foods. Such goods are all breakfast cereals and are encompassed by the opponent's broad term Cereal and so are identical. The goods are identical.
- 29. Granola; Food mixtures consisting of cereal flakes and dried fruits. Granola is a mixture of oats and various added ingredients (such as brown sugar, raisins, coconut, and nuts) that is eaten for breakfast. Food mixtures consisting of cereal flakes and dried fruits could be in the form of preparations for breakfast. As I have already

said, the earlier goods include *Cereal* which would cover breakfast cereals. **The** goods are identical.

- 30. Cereal preparations coated with sugar and honey; Cereal preparations; Cereal preparations consisting of bran; Cereal preparations consisting of oatbran; Cereal preparations containing oatbran; Bran preparations for human consumption; Cereal based foodstuffs for human consumption; Food preparations based on grains; Extruded food products made of maize; Extruded food products made of wheat; Foodstuffs made from cereals; Foodstuffs made from maize; Foodstuffs made from oats; Foodstuffs made of rice; Food preparations based on grains; Foods produced from baked cereals. Such goods could be in the form of breakfast cereals and must also be considered identical to the opponent's Cereal and Processed Grains. The goods are identical.
- 31. Corn flakes; Cornflakes; Flakes (Corn -); Flaked wheat; Flakes (Corn); Flakes (Maize -); Flakes (Oat -); Instant porridge; Cereal seeds, processed; Barley prepared for human consumption; Barley (Crushed -); Barley flakes; Barley for use as a coffee substitute; Barley (Husked -); Barley meal; Crushed barley; Crushed oats; Corn kernels being roasted; Corn kernels being toasted; Corn, milled; Corn (Processed -); Corn, roasted; Fried corn; Buckwheat, processed; Cracked wheat; Kettle corn [popcorn]; Corn (Pop -). Such goods are all types of cereals or grains which have undergone some sort of preparation and/or processing. As such, they are covered by the earlier Cereal; Prepared Brans; Prepared Grains; Processed Brans; Processed Grains and so are identical. The goods are identical.
- 32. Artificial rice [uncooked]; Brown rice; Wholemeal rice; Instant rice; Flavoured rice; Flavoured rices; Enriched rice; Enriched rice [uncooked]; Cooked rice; Glutinous rice; Dried cooked-rice; Frozen prepared rice. The earlier goods include (unprocessed) *Rice* in class 31 as well as *Cereal* per se (in class 30) which would encompass (processed) rice since rice is a type of cereal and a grain. Consequently, all of these goods fall within the ambit of earlier term *Cereal* (in class 30) or are highly similar to the earlier *Rice* (in class 31). The goods are identical or highly similar.

33. Adlay flour for food; Cereal flour; Cereal powders; Cereals for use in making pasta; Barley flour [for food]; Barley flour for food; Buckwheat flour; Buckwheat flour [for food]; Buckwheat flour for food; Corn flour; Corn flour [for food]; Cornflour; Flour of barley; Flour of corn; Flour of millet; Flour of oats; Flour of rice; Glutinous rice flour; Dough flour; Cake flour; Edible flour; Flour for baking; Flour for doughnuts; Flour for food; Flour for making dumplings of glutinous rice; Flour preparations for food; Flour ready for baking; Flour mixes; Flour mixtures for use in baking; Chinese batter flour; Coixseed flour; Enriched farina [meal]; Farina; Farina [meal]; Flour concentrate for food; Corn meal; Cornmeal; Barley meal; Bread improvers being cereal based preparations. The earlier Processed Grains would encompass products obtained from the milling of grains into flours and would encompass all of the above so must be considered identical. The goods are identical.

34. Corn starch flour; Corn starch [for food]; Cornstarch for culinary purposes. Starch may take the consistency of flour and be used to thicken other foodstuffs on account of their starch content. These goods are in competition with the earlier *Processed Grains* (Flours), will be located near the flour or in the baking aisle (which is close to the flour section) and target the same public. The goods are similar to a medium degree.

35. Batters and mixes therefor; Brownie mixes; Bun mix; Cake mixes; Cake mixures; Cake preparations; Doughnut mixes; Bread mixes; Bread concentrates; Biscuit mixes; Cookie mixes; Instant pancake mixes; Instant doughnut mixes; Batter for making crepes; Cake batter; Batter for making pancakes; Batter mixes for Japanese—style pancakes (Okonomiyaki); Batter mixes for okonomiyaki [Japanese savory pancakes]; Batter mixes for okonomiyaki [Japanese savory pancakes]; Batter mixes. Such goods are batters and mixtures containing flours and other ingredients used for the cooking of various dough-based goods. Grain flours, which is covered by the opponent's *Processed Grains*, are a major constituent of the applied for batters and mixes. That, of itself does not mean that the goods are similar, but neither does it mean that they are not similar: the matter is one that must be considered on the facts. Flour is used to make bread and other dough-based goods, such as those for the preparation of which the applied

for batters and mixes are used, so the uses and users are the same. Flour is complementary to the applied for batters and mixes in the sense of being indispensable and, in my experience, is a product which is found in close proximity to the applied for batters and mixes in the aisle of a supermarket. It is also in competition with the applied for batters and mixes; the choice is either to purchase the applicant's ready-made batters and mixes or to use a separate mix of flour, yeast and other ingredients. The goods are similar to a medium degree.

36. Alimentary paste [dough]; Farinaceous food pastes for human consumption; Farinaceous food pastes; Dough; Bread doughs; Frozen dough; Frozen cookie dough; Frozen biscotti dough; Frozen brownie dough; Brownie dough; Biscotti dough; Cookie Dough; Dough for cakes; Cake dough; Cake doughs; Empanada dough; Filo dough; Filo doughs; Frozen pastry sheets; Filo pastry. The position is somewhat similar to the assessment made with regard to batters and mixes. However, due to the fact that the goods are unlikely to be found in close proximity to the earlier *Processed Grain* (flours), the dough-based and paste-based goods being likely to come in the form of frozen or refrigerated goods, I consider that is a lesser degree of similarity. The goods are similar to a low to medium degree.

37. Instant pudding mixes; Instant dessert puddings; Custard mixes; Custard powder; Instant ice cream mixes; Ice cream powder; Ice cream powders; Kheer mix (rice pudding). Such goods are instant food products that are manufactured in a powder form and used to create instant puddings and desserts. Contrary to the batters and mixes I assessed above, which use flour as an ingredient, these goods are produced using sugar, flavoring agents and thickeners as primary ingredients. The goods are a step removed. However, I still find a similarity with the earlier Fruit Dessert (class 29) as the goods coincide in terms of users, uses and purpose and are competitive to a degree. The goods are similar to a very low degree degree.

38. Cheese flavored puffed corn snacks; Cheese curls [snacks]; Cheese puffs; Cream puffs; Cheese balls [snacks]; Corn curls; Corn chips; Chips [cereal products]; Crisps made of cereals; Grain-based chips; Wholewheat crisps; Cereal snack foods flavoured with cheese; Cereal snacks; Cereal based prepared snack foods; Cereal based snack foods; Cereal based snacks; Cereal-

based savoury snacks; Grain-based snack foods; Corn-based savoury snacks; Corn-based snack foods; Extruded corn snacks; Extruded snacks containing maize; Extruded wheat snacks. The opponent's goods include (potato) Crisps and Potato puffs. Whilst the the nature of the competing goods is different on account of the cereal base of the applied for crisps and puffs, they have the same purpose and method of use, target the same consumers, are directly in competition and will be be located next to each other in the packaged snack foods aisles of supermarkets. I consider that the applied for Cheese flavored puffed corn snacks; Cheese puffs and Cream puffs are highly similar to the opponent's Potato puffs (class 29) and that the applied for Corn chips; Chips [cereal products]; Crisps made of cereals; Grain-based chips; Wholewheat crisps are highly similar to the opponent's Crisps (class 29). I extend the same conclusion to the applied for Cheese balls [snacks]; Cheese curls [snacks]; Corn curls, all of which are puffed corn snacks and Cereal snacks; Cereal based prepared snack foods; Cereal based snack foods; Cereal based snacks; Cereal-based savoury snacks; Grain-based snack foods; Corn-based savoury snacks; Corn-based snack foods; Extruded corn snacks; Extruded snacks containing maize; Extruded wheat snacks; Cereal snack foods flavoured with cheese since, on a fair reading of these terms, they cover cereal puffs and cereal crisps. The goods are similar to a high degree.

39. Cereal bars; Cereal bars and energy bars; Cereal based energy bars; Cereal based food bars; Cereal-based bars; Cereal-based meal replacement bars; Cereal products in bar form; Bars based on wheat; Granola bars; Granola-based snack bars; Cereal-based snack bars; Chocolate-coated bars¹. The opponent goods include Fruit based snack food, which covers fruit bars. The position is somewhat similar to the assessment made with regards to cereal puffs and cereal crisps. The goods are similar to a high degree.

40. Candy coated popcorn; Candy-coated popcorn; Caramel coated popcorn; Caramel coated popcorn with candied nuts; Caramel popcorn; Caramel-coated popcorn; Corn candy; Flavoured popcorn; Glazed popcorn. Such goods are sweet corn-based snacks. The earlier mark cover Cereal, Prepared Grains and

Processed Grains, which would include pop corn. Pop corn is the basic ingredient of these goods. The uses and users, and type of goods is the same and there is complementarity in the sense that the earlier pop corn is indispensable for the popcorn based snack products. **The goods are similar to a high degree.**

41. Alternatively, the goods are normally eaten as sweet snacks the same as the opponent's *Dried Fruit based snacks*, *Candied nuts* and *Flavoured Nuts*. Whilst the nature of the goods is different, the fact that both set of goods can be eaten as a sweet treat creates a point of similarity as the goods have the same use, relevant public and distribution channels. Furthermore, they are in competition and whilst they may not be located next to each other, in my experience, the respective shelves will be in the same aisle together with crisps, nuts and other snacks. **The goods are similar to a medium degree**.

42. Cakes (Rice -); Candied cakes of popped rice; Chocolate-coated rice cakes; Dried sugared cakes of rice flour (rakugan); Glutinous pounded rice cake coated with bean powder (injeolmi); Injeolmi [glutinous rice cakes coated with powdered beans]. Such goods can be classed as sweet rice-based snacks. The position is similar to the assessment made above to the extent that (a) the earlier rice is complementary to the applied for rice-based goods in the sense of being indispensable and (b) there is a similarity in terms of purpose of use beween the applied for rice-based snacks and the opponent's *Dried Fruit based snacks* comparable to that I found in relation pop-corn based snacks. I come to the same finding as above. The goods are similar to, at least, a medium degree.

43. Flapjacks; Flapjacks [griddle cakes]; Cereal cakes for human consumption; Confectionery bars; Cake bars; Fruit cake snacks. Flapjacks are sweet cakes made from oats served in a rectangles and bar form. They can contain dried fruits and nuts, both of which are covered by the earlier goods. On the basis that such goods are normally eaten as sweet snacks the same as the opponent's Dried Fruit based snacks and have a similar nature, there is a high degree of similarity. Since Confectionery bars; Cereal cakes for human consumption; Cake bars; Fruit cake snacks could come in the form of flapjacks, I reach the same conclusion in relation to these goods. The goods are similar to a high degree.

44. Nachos; Crackers; Crackers [edible]; Crackers made of prepared cereals; Crackers filled with cheese; Crackers flavoured with cheese; Crackers flavoured with fruit; Crackers flavoured with herbs; Crackers flavoured with meat; Graham crackers; Crackers flavoured with spices; Crackers flavoured with vegetables; Cream crackers; Crispbread²; Crisp breads; Crispbread snacks; Bread sticks; Breadsticks; Biscuits [savoury]; Soft pretzels; Gingersnaps; Aperitif biscuits; Biscuits for cheese; Cheese-flavored biscuits; Biscuits [sweet]; Biscotti; Biscuits; Biscuits containing fruit; Biscuits flavoured with fruit; Biscuits for human consumption made from cereals; Biscuits for human consumption made from malt; Biscuits containing chocolate flavoured ingredients; Biscuits having a chocolate coating; Biscuits having a chocolate flavoured coating; Chocolate biscuits; Chocolate coated biscuits; Chocolate covered biscuits; Biscuits with an iced topping; Butter biscuits; Chocolate coated marshmallow biscuits containing toffee; Edible wafers; Chocolate caramel wafers; Chocolate wafers; Egg roll cookies; Danish butter cookies; Fortune cookies; Farinaceous foods; Foodstuffs made from dough³. Such goods could be made with cereal flour, which is covered by the earlier Processed Grains and could all be eaten as savoury or sweet snacks, the same as the opponent's Crisps, Potato Puffs, Dried Fruit based snacks and Fruit-based snack food. There is an obvious element of competition and whilst the goods are not of the same nature and may not be located next to each other, in my experience, the respective aisles namely the snack aisle and the crackers and buiscuits aisle, are not that far from each other. The goods are similar to a low degree.

45. Bakery goods; Confectionery; Confectionery (Non-medicated -); Confectionery items (Non-medicated -); Confectionery products (Non-medicated -); Flour confectionery; Dessert pudding; Fresh pies; Fruit pies; Apple pies; Blueberry pies; Apple tarts; Covered tarts; Fruit cakes; Iced fruit cake; Fruit pastries; Fruit pies; Pastries containing fruit; Pastries filled with fruit; Pastries with fruit; Pastries containing creams and fruit; Pastry; Fruit filled

pastry products; Bread casings filled with fruit. The earlier specification includes Fruit Desserts (class 29) and Fruit Jellies which would include fruit-based desserts, such as for example, fruit trifle and fruit jellies. Dessert pudding; Confectionery; Confectionery (Non-medicated -); Confectionery products (Non-medicated -); Confectionery and Bakery goods are all broad terms which would include baked desserts and flour confectionery products containing some sort of fruit. The other goods listed above are all bakery and confectionery products containing fruit. There is an obvious similarity in purpose and nature with the earlier Fruit Desserts and Fruit Jellies as the competing goods (1) are all dessert-type goods which could be eaten as a sweat treat at the end of a meal and (2) on account of the fruit base of the applied for goods. The goods are not complementary, but there may be a degree of competition. The goods are similar to a high degree.

46. Dessert mousses [confectionery]; Chocolate creams; Chocolate mousses; Dessert puddings; Dessert souffles; Chocolate desserts; Cheesecake; Cheesecakes; Crème brûlées; Creme brulees; Crème caramel; Creme caramels; Dulce de leche; Custards; Imitation custard; Custards [baked desserts]; <u>Baklava; Bavarian cream; Meringue; Meringues; Egg tarts; Custard tarts;</u> Creamed rice; Eight-treasure rice pudding; Bread pudding; Brownies; Cakes; Cream cakes; Sponge cake; Sponge cakes; Iced cake; Iced cakes; Iced confectionery (Non-medicated -); Iced sponge cakes; Breakfast cake; Chocolate cake; Chocolate cakes; Chocolate covered cakes; Deep chocolate cake made with chocolate sponge; Candy cake; Cupcakes; Sponge fingers [cakes]; English muffins; Fondants; Fondants [confectionery]; Chocolate pastries; Cream pies; Chocolate waffles; Bean jam buns; Cream buns; Jam buns; Filled buns; Jam filled brioches; Eclairs; Bean-jam filled wafers (monaka); Doughnuts; Fried dough cookies; Fried dough cookies (karintoh); Fried dough twists; Crepes; Croissants; Chocolate topped pretzels; Danish pastries; Flan base wafers; Flans; Floating islands; Gâteaux; Gateaux; Fruited scones; Christmas puddings. Such goods all in the nature of desserts, cakes, bakery and flour confectionery products all of which could be eaten as a sweat treat at the end of a meal. This creates a similarity of purpose with the opponent's Fruit Desserts and Fruit Jellies at the most general of level which is for consumption and a degree of competition. The goods share the same channels of trade as the earlier *Fruit Desserts* and *Fruit Jellies*, as they may all be purchased from supermarkets and the cakes and desserts aisles are likely to be close to each other. **The goods are similar to a medium degree.**

47. Confectionery items formed from chocolate; Chocolate confections; Chocolate confectionery; Dairy confectionery; Confectionery chocolate products; Chocolate confectionery products; Chocolate flavoured confectionery; Chocolate confectionery having a praline flavour; Confectionery containing jam; Confectionery containing jelly. The same applies to these goods, since they are broad enough to include some of the goods listed in para 45 above, i.e. chocolate mousse, chocolate dessert. The goods are similar to a medium degree.

48. Frozen confectionery; Frozen confections; Frozen cakes; Frozen pastries; Frozen pastry⁴; Frozen custards; Frozen dairy confections; ice creams, frozen yogurts and sorbets; Sorbets [ices]; Sorbets [water ices]; Cream (Ice -); Diary ice cream; Fruit ice cream; Fruit ice creams; Frozen confectionery containing ice cream; Ice cream; Ice cream bars; Ice cream cakes; Ice cream <u>confectionery</u>; <u>lce cream confections</u>; <u>lce cream desserts</u>; <u>lce cream gateaux</u>; <u>lce cream sandwiches; lce cream stick bars; lce cream substitute; lce cream</u> with fruit; Ice creams; Ice creams containing chocolate; Ice creams flavoured with chocolate; Imitation ice cream; Frozen yoghurt; Frozen yoghurt [confectionery ices]; Frozen yoghurts; Frozen yogurt; Frozen yogurt cakes; Frozen yogurt [confectionery ices]; Frozen yogurt confections; Frozen yogurt pies. The consideration I made in the preceding paragraph applies muatis mutandi to these products which consist of ice cream, frozen yogurt, sorbets and frozen confectionery (which would include ice cream). Whilst the nature of the goods is different, the earlier Fruit Desserts is broad enough to cover fruit desserts which must be kept in refrigerators and would not be located too far from the applied for frozen sweet goods. The goods are similar to a low degree.

- 49. The application also includes a variety of ices. Although there may be an element of competition between fruit desserts and ice creams, the element of competition does not extend to ices; this would be a step too far. The same is true for a range of applied for confectionery goods not flour based and made primarily of chocolate and sugar, including candies/sweets, chocolates, chuwing gums, bubble gums and bonbons, which although are sweet food that can be eaten as a treat any time of the day, would not be choosen as an alternative to a fruit dessert or a fruit jelly at the end of a meal. I find that those goods are not similar.
- 50. Frozen prepared rice with seasoning; Frozen prepared rice with seasoning and vegerable; Prepared rice dishes; Frozen meals consisting primarily of rice; Freeze-dried dishes with the main ingredient being rice; Dry and liquid ready-toserve meals, mainly consisting of rice; Prepared rice dishes; Bibimbap [Korean dish consisting primarily of cooked rice with added vegetables and beef]; Bibimbap [rice mixed with vegetables and beef]; Gimbap [Korean rice dish]; Boxed lunches consisting of rice, with added meat, fish or vegetables; Freezedried dishes with the main ingredient being rice; Frozen prepared rice with seasonings and vegetables; Fried rice; Dry and liquid ready-to-serve meals, mainly consisting of rice; Glutinous rice wrapped in bamboo leaves (Zongzi). Such goods have a certain similarity with the the earlier Cereal (including rice) (in classes 30) and Rice (in class 31). The main ingredient of these goods is rice. Although there may be a difference between rice as an ingredient and a ready-made meal beased on rice, the goods are similar in nature and purpose, target the same end consumers and are distributed through the same channels. Furthermore, the goods share the same origin, are complementary and competitive to a degree. The goods are similar to a medium degree.
- 51. Couscous; Couscous [semolina]; Dried wheat gluten; Dried pieces of wheat gluten (fu, uncooked); Gluten prepared as foodstuff; Pasta; Dried pasta foods; Dried pasta; Deep frozen pasta; Fresh pasta; Cannelloni; German ravioli [Maultaschen]; Filled pasta; Spaghetti; Flour-based gnocchi; Gnocchi; Dried tortellini; Dried and fresh pastas and noodles; Dried noodles; Asian noodles; Chinese noodles; Egg noodles; Chinese noodles [uncooked]; Chinese rice noodles (bifun, uncooked); Buckwheat noodles; Flat bread; Baguettes; Biscuit

rusk; Dutch rusk; Bread; Breads; Bread and buns; Bread biscuits; Bread buns; Bread crumbs; Breadcrumbs; Bread flavored with spices; Bread flavoured with spices; Bread (Ginger -); Ginger bread; Gingerbread; Dutch gingerbread (taai taai); Bread rolls; Bread-based stuffing mixes; Crumb; Crumble; Crisp rolls; Croutons; Croûtons; Crusty rolls; Currant bread; Danish bread; Danish bread rolls; Bagels; Brioches (which is a sweet bread); Buns; Crumpets; French toast; Fresh bread; Fruit bread; Fruit breads; Gluten-free bread; Barm Cake; Naan Bread; Fruted malt loaf; Garlic bread. Whilst the opponent's goods cover Cereal, Prepared grains and Processed grain, I do not consider that it would cover preparations made of cereal. Grain flour (which is encompassed by the earlier term Processed Grains) is the major ingredient of those goods so the earlier processed grain (flour) is complementary to the aforementioned goods in the sense of being indispensable. The use and users are the same, and the channels of trade are the same. The goods are similar to a low degree.

- 52. However, there is no information (and it is not within my knowledge) as to whether processed grain (flour) may be incorporated into **Bread with soya bean; Bread made with soya beans; Bread with sweet red bean,** or where they may be purchased. **The goods are not similar.**
- <u>53. Fruit coulis [sauces]</u>; <u>Fruit sauces.</u> The earlier goods cover *Fruit Dips and Fruit Jellies* which could be used, for example, as an accompaniment, in a way similar to that of the applied for *Fruit coulies*. The goods have a similar prupose and the nature is not too different. **In my view the goods are similar to a high degree.**
- 54. Aerated drinks [with coffee, cocoa or chocolate base]; Aerated beverages [with coffee, cocoa or chocolate base]; Beverages based on tea; Beverages (Chocolate-based -); Beverages (Cocoa-based -); Beverages (Coffee-based -); Beverages consisting principally of chocolate; Beverages consisting principally of cocoa; Beverages consisting principally of coffee; Beverages containing chocolate; Beverages made from chocolate; Beverages made from cocoa; Beverages made from coffee; Beverages made of coffee; Beverages made of tea; Beverages made with chocolate; Beverages (Tea-based -); Beverages with a chocolate base; Beverages with a coffee base;

Beverages with a tea base; Beverages with coffee base; Chamomile-based beverages; Chocolate based products; Chocolate beverages; Chocolate beverages containing milk; Chocolate beverages with milk; Chocolate-based beverages; Chocolate-based beverages with milk; Chocolate flavoured beverages; Chocolate food beverages not being dairy-based or vegetable based; Cocoa-based beverages; Cocoa beverages; Cocoa beverages with milk; Cocoa drinks; Cocoa products5; Drinking chocolate; Drinks based on chocolate; Drinks based on cocoa; Drinks containing chocolate; Drinks containing cocoa; Drinks flavoured with chocolate; Drinks prepared from chocolate; Drinks prepared from cocoa; Coffee in brewed form; Espresso; Coffee based beverages; Coffee-based beverages; Coffee based drinks; Coffee beverages; Coffee beverages with milk; Coffee drinks; Carbonated and noncarbonated tea based beverages; Coffee-based beverage containing milk; Coffee-based beverages containing ice cream (affogato); Cappuccino; Such goods consist of drinks and beverages products with a coffee, tea, cocoa or chocolate base. The earlier goods include Coconut Drinks; Edible Drinks; Fresh Drinks; Natural Drinks; Organic Drinks; Prepared Drinks; Processed Drinks; Unprocessed Drinks (class 32). The goods have a similar nature, i.e. non-alcoholic beverages/drinks, and method of use, target the same consumers, are distributed through the same channels and are in competition to a certain degree. I consider there to be a medium degree of similarity.

55. Chocolate drink preparations; Chocolate drink preparations flavoured with banana; Chocolate drink preparations flavoured with mint; Chocolate drink preparations flavoured with mocha; Chocolate drink preparations flavoured with orange; Chocolate drink preparations flavoured with orange; Chocolate drink preparations flavoured with toffee; Cocoa [in drinks]; Coffee [in drinks]; Coffee; Coffee (Artificial -); Coffee substitutes; Coffee substitutes [grain or chicory based]; Coffee, teas and cocoa and substitutes therefor; Caffeine-free coffee; Chicory based coffee substitute; Chicory [coffee substitute]; Coffee substitutes [artificial coffee or vegetable preparations for use as coffee]; Chocolate coffee; Flavoured coffee; Acanthopanax tea (Ogapicha); Apple flavoured tea [other than

for medicinal use]; Aromatic teas [other than for medicinal use]; Apple flavoured tea [other than for medicinal use]; Artificial coffee; Artificial coffee and tea; Artificial tea; Artificial tea [other than for medicinal use]; Asian apricot tea (maesilcha); Fruit flavoured tea [other than medicinal]; Barley tea; Barley-leaf tea; Black tea; Black tea [English tea]; Burdock root tea (Wooungcha); Chai tea; Chai tea; Chalupas; Chamomile tea; Chinese matrimony vine tea (Gugijacha); Chrysanthemum tea (Gukhwacha); Citron tea; Darjeeling tea; Earl Grey tea; Earl grey tea; Fruit flavoured tea [other than medicinal]; Ginger tea; Ginseng tea; Ginseng tea [insamcha]; Burdock root tea (Wooungcha); Chrysanthemum tea (Gukhwacha); Citron tea; Fruit flavoured tea [other than medicinal]; Fruit tea [other than for medical purposes]; Fruit teas; Ginger tea; Ginseng tea; Ginseng tea [insamcha]; Iced tea; Iced teas; Iced tea (Non-medicated -). I extend the same conclusions I have reached in the preceding paragraph in relation to these goods, to the extent that they are ready-to-drink prepared beverages, i.e. drink preparations, or could be sold as ready-made drinks, as opposed to in roasted, powdered or granulated form. I consider there to be a medium degree of similarity.

56. However, in relation to other goods, which could be used to make beverages but are not sold in the form of drinks and/or beverages, i.e. *Coffee in whole-bean form; Coffee mixtures; Coffee pods; Instant tea* I find that the goods are two steps removed from the earlier goods and are not similar.

57. Coated nuts [confectionery]; Confectionery items coated with chocolate; Cashew nuts (prepared); Chocolate coated fruits; Chocolate coated macadamia nuts; Chocolate coated nuts; Chocolate-covered nuts; Candy coated apples; Candy coated confections; Chocolate coated fruits; Chocolate coated macadamia nuts; Gongerbread nuts; Chocolate coated fruits. The earlier goods include a range of processed and unprocessed fruits and nuts in classes 29 and 31 including a range of fresh fruits and dried fruits, such as Flavoured Nuts, Candied nuts, Candied fruits and Dried fruit-based snacks. I find the above goods and the earlier goods have a similar nature and purpose, i.e. healthy eating/snacks, target the same consumers and are distributed through the same channels, i.e. supermarkets and health food shops. Further, the goods are competitive and complementary in the sense that "customers may think that responsibility for the

goods lies with the same undertaking". On that basis I find that the goods are similar to a high degree.

- 58. Almond cake; Almond confectionery; Almond cookies; Almond paste; Almond pastries; Almonds covered in chocolate; Marzipan; Chocolate marzipan. The earlier goods include Almond butter (class 29) and Almonds (class 31). The position is somewhat similar to the assessment made with regard to pasta and bread, i.e. the goods are complementary in the sense of being indispensable. I adopt the same finding. The goods are similar to a low degree.
- 59. Chili paste for use as a seasoning; Chili pepper paste being condiment; Chili pepper pastes being condiments; Chili sauce; Fermented hot pepper paste (gochujang); Chili powder; Chili powders; Chili seasoning; Chili seasonings; Dried chili peppers seasoning; Chili oil for use as a seasoning or condiment; Chili oils being condiments. Such goods are all chili-based condiments in the form of powders, pastes, oils and seasoning. The goods are made from chili peppers, which are a type of vegetable. The earlier goods cover (1) Processed vegetable and fruit paste and Processed vegetable and fruit powder in class 29 (2) chillies (unprocessed) in class 31 and (3) Chilli and Chilli oil in class 29. The competing chili oils are, if not identical, highly similar. The applied for chili pastes, chili powders and chili seasoning are higly similar to the opponent's vegetable pastes and powders, which must include pastes and powder made from chillies and red peppers. They are also highly similar to the opponent chillies in the sense of being indispensable. The goods coincide in terms of uses, users, nature and purpose, are competitive and complementary. The goods are similar to a high degree.
- 60. Basil, dried; Cilantro, dried; Coriander, dried; Dried basil; Dried chives; Dried cilantro; Dried and fresh dumplings; Dried coriander; Dried coriander for use as seasoning; Dried coriander seeds for use as seasoning; Dried cumin seeds; Dried herbs; Dried herbs for culinary purposes; Dried mint; Dried sauce in powder form. Such goods are garden herbs, processed for seasoning. It is considered that they are similar to a low degree to the earlier Fresh garden herbs in Class 31 as they usually coincide in relevant public and distribution channels. Furthermore, they are in competition. The goods are similar to a low degree.

- 61. In relation to the remaining goods in the applicant's specification, in the absence of any submission from the opponent as to why I should find that the goods are similar to any of the earlier goods, I find that beyond the fact that the goods in comparison are food products, there is no real similarity with the goods of the earlier mark. In making my comparison between the remainder of the applicant's goods in class 30 and the opponent's goods, I will not list each good separately but will approach the applicant's goods in terms of homogenous categories:
- 62. Sugar, honey, syrups, treacle, yeast, baking-powder, salt, spices, vinegar, food dressing, sauces and other condiments, flavourings, binding agents, gums, essences, extracts [other than essential oils]. The applied for goods include a variety of goods which fall within those categories. These goods are in the nature of condiments or cooking aids. They are not of the same nature as the opponent's cereal-based goods in class 30 and whilst the opponent's specification contains a number of cooking ingredients such as fats and oils and vegetable dips and pastes (class 29), the goods are different in terms of uses, nature, purpose and methods of use. They share the same channels of trade as the opponent's goods insofar as they may all be purchased from supermarkets, but within those channels of trade they are not to be found on the same shelves as the opponent's products. They will not be bought as an alternative to the opponent's cereal-based products, oils and fats and vegetable and fruit pastes/dips. Whilst they can be used together with the opponent's products in various receipes, they are not complementary in the sense of being indispensable to the opponent's products. The goods are not similar.
- **63.** Ices, frappes, ice lollies. I refer to what I have said above at paragraph 49.
- <u>64. Sugar confectionery including bolied confectionery, candies, jellies and chocolates.</u> I refer to what I have said above at paragraph 49.
- **65.** Food based-cake decorations and christmas tree decorations. Beyond the fact that the goods in comparison are food products, I see no real similarity with the goods of the earlier mark.

<u>66. Coffee beans, cocoa powders and mixes (including beverages powders and istant mixes)</u>. I refer to what I have said above at paragraph 56.

67. Bacon buns; Apple fritters; Banana fritters; Instant and fried noodles; Calzone, Canapes, Canned pasta, Canned spaghetti; Cheeseburgers [sandwiches]; Checken pies; Checken sandwiches; Chicken wraps; Pizza; Pizza and prepared meals including pasta dishes; Pastries (savoury); Sausage rolls; Sandwiches; Filled rolls. I see no real similarity with any of the goods of the earlier mark. Whilst I found pasta, bread and noodles to be similar to the earlier processed grain (flours), these goods are prepared meals and are one step removed. The closest one gets is that the opponent's Soup can be eaten as meal as can these goods, however, any complementarity on this basis is not of the type that "customers may think that responsibility for the goods lies with the same undertaking". The nature of the goods is quite different as are their locations in a store and they do not strike me as meaningfully competitive.

68. Accordingly, without knowing more, I find that there is no meaningful similarity between the earlier goods and the following:

Acid drops [confectionery]; Aerated chocolate; Agave syrup for use as a natural sweetener; Agave syrup [natural sweetener]; Aioli; Alimentary seasonings; Allspice; Angelica; Aniseed; Aniseeds for use as a seasoning; Apple fritters; Apple sauce [condiment]; Aromatic preparations for cakes; Aromatic preparations for candies; Aromatic preparations for food; Aromatic preparations for ice-creams; Aromatic preparations for making non-medicated infusions; Aromatic preparations for making non-medicated tisanes; Aromatic preparations for pastries; Artichoke sauce; Bacon buns; Baking powder; Baking powders; Baking soda; Baking soda [bicarbonate of soda for baking purposes]; Baking soda [bicarbonate of soda for cooking purposes]; Baking spices; Baking-powder; Banana fritters; Baozi [stuffed buns]; Baps; Barbecue sauce; Bars of sweet jellied bean paste (Yohkan); Bases for making milk shakes [flavourings]; Bean meal; Bean paste; Bean-starch noodles (harusame, uncooked); Bee glue; Beer vinegar; Beverages (Flavorings [flavourings], other than essential oils, for -); Bicarbonate of soda for cooking purposes; Bicarbonate of soda for cooking purposes [baking soda];

Binding agents for edible ices; Binding agents for ice cream; Binding agents for ice cream [edible ices]; Binding preparations for ice cream [edible ices]; Biological honey for human consumption; Black treacle; Blends of seasonings; Boiled confectionery; Boiled sugar; Boiled sugar confectionery; Boiled sugar sweetmeats; Boiled sweets; Bonbons; Bonbons made of sugar; Bread made with soya beans; Bread with soy bean; Bread with sweet red bean; Breath mints for use as a breath freshener; Breathfreshening chewing gum; Brine for cooking; Brine for pickling; Brine for use in cocktails; Brittle; Brown sauce; Brown sugar; Bubble gum; Bubble gum [confectionery]; Buckwheat jelly (Memilmuk); Bulgur; Burgers contained in bread rolls; Burritos; Butterscotch chips; Cachou [confectionery], other than for pharmaceutical purposes; Cake decorations made of candy; Cake frosting; Cake frosting [icing]; Cake icing; Cake Pops; Cake powder; Cakes (Flavorings [flavourings], other than essential oils, for -); Calzones; Canapes; Candies; Candies (Non-medicated -); Candies (Nonmedicated -) with alcohol; Candies (Non-medicated -) with honey; Candies (Nonmedicated -) with mint; Candies [sweets]; Candy; Candy bars; Candy cake decorations; Candy canes; Candy decorations for cakes; Candy mints; Candy (Nonmedicated -); Candy, other than for medical purposes; Candy [sugar]; Candy with caramel; Candy with cocoa; Canned pasta foods; Canned sauces; Canned spaghetti in tomato sauce; Capers; Caramel; Caramelised sugar; Caramels; Caramels [candy]; Caraway seeds for use as a seasoning; Carbohydrate preparations for food; Castor sugar; Catchup; Catsup; Celery salt; Chalupas; Cheese sauce; Cheeseburgers [sandwiches]; Chemical seasonings [cooking]; Chewing candy; Chewing gum; Chewing gum for breath freshening; Chewing gum, not for medical purposes; Chewing gums; Chewing sweets (Non-medicated -); Chewing sweets (Non-medicated -) having liquid fruit fillings; Chicken gravy; Chicken pies; Chicken sandwiches; Chicken wraps; Chicory and chicory mixtures, all for use as substitutes for coffee; Chicory extracts for use as substitutes for coffee; Chicory for use as substitutes for coffee; Chicory mixtures, all for use as substitutes for coffee; Chicory mixtures for use as substitutes for coffee; Chilled pizzas; Chimichanga; Chimichangas; Chinese steamed dumplings (shumai, cooked); Chinese stuffed dumplings; Chinese stuffed dumplings (gyoza, cooked); Chocolate; Chocolate bark containing ground coffee beans; Chocolate bars; Chocolate based fillings; Chocolate bunnies; Chocolate candies; Chocolate candy with fillings; Chocolate chips; Chocolate coated nougat bars; Chocolate coating; Chocolate confectionery containing pralines; Chocolate decorations for cakes;

69. As some degree of similarity is required for there to be a likelihood of confusion, the application can proceed in respect of the above goods.

The average consumer and the nature of the purchasing act

70. As the case law cited in paragraph 13 indicates, it is necessary for me to determine who the average consumer is for the goods at issue; I must then determine the manner in which these goods will be selected in the course of trade. In *Hearst Holdings Inc, Fleischer Studios Inc v A.V.E.L.A. Inc, Poeticgem Limited, The Partnership (Trading) Limited, U Wear Limited, J Fox Limited,* [2014] EWHC 439 (Ch), Birss J. described the average consumer in these terms:

"60. The trade mark questions have to be approached from the point of view of the presumed expectations of the average consumer who is reasonably well informed and reasonably circumspect. The parties were agreed that the relevant person is a legal construct and that the test is to be applied objectively by the court from the point of view of that constructed person. The words "average" denotes that the person is typical. The term "average" does not denote some form of numerical mean, mode or median."

71. The average consumer is a member of the general public. The various goods will be selected with no more than an average level of care and consideration through

primarily visual means, with the goods most often being selected from supermarket shelves (or the online equivalents).

Comparison of marks

72. It is clear from *Sabel BV v. Puma AG* (particularly paragraph 23) that the average consumer normally perceives a mark as a whole and does not proceed to analyse its various details. The same case also explains that the visual, aural and conceptual similarities of the marks must be assessed by reference to the overall impressions created by them, bearing in mind their distinctive and dominant components. The CJEU stated at paragraph 34 of its judgment in Case C-591/12P, *Bimbo SA v OHIM*, that:

"....it is necessary to ascertain, in each individual case, the overall impression made on the target public by the sign for which registration is sought, by means of, inter alia, an analysis of the components of a sign and of their relative weight in the perception of the target public, and then, in the light of that overall impression and all factors relevant to the circumstances of the case, to assess the likelihood of confusion."

73. It would be wrong, therefore, to dissect the marks artificially, although it is necessary to take into account their distinctive and dominant components and to give due weight to any other features which are not negligible and therefore contribute to the overall impressions created by the marks. The marks to be compared are:

Applied-for mark	Earlier marks
Veganiks	veganic
	veganics

Overall impression

74. All the marks consist of one word, with no other elements or stylasation. This is the overall impression they will convey.

Visual similarity

75. The closest mark I can see in the earlier series is 'veganics'. Both words are made up of 8 letters, seven of which are identical. The marks differ in the penultimate letter, which in the later mark is a K and in the earlier mark is a C. Whilst there is also a difference on account of the first letter being in upper case in the applied for mark and in lower case in the earlier mark, this difference is not relevant because the applied for mark is a word mark which would cover use in the same casing as the earlier mark. The marks are visually similar to a high degree.

Aural similarity

76. Aurally, the letter K in the later mark will be pronounced as the letter C in the earlier mark. The marks are aurally identical.

Conceptual similarity

77. Both marks are invented words however, in the context of the goods, all of which are foodstuffs, they will both be perceived as a play on the word vegan or veganism and, as such, evoke the concept of vegan, i.e. a person who does not eat animal products. To the extent that both words will be perceived as conveying the same concept, the marks are conceptually highly similar.

Distinctive character of the earlier mark

78. In *Lloyd Schuhfabrik Meyer & Co. GmbH* v *Klijsen Handel BV*, Case C-342/97 the CJEU stated at paragraphs 22 and 23 that:

"In determining the distinctive character of a mark and, accordingly, in assessing whether it is highly distinctive, the national court must make an overall assessment of the greater or lesser capacity of the mark to identify the goods or services for which it has been registered as coming from a particular undertaking, and thus to distinguish those goods or services from those of other undertakings (see, to that effect, judgment of 4 May 1999 in Joined Cases C-108/97 and C-109/97 WindsurfingChiemsee v Huber and Attenberger [1999] ECR I-0000, paragraph 49).

In making that assessment, account should be taken, in particular, of the inherent characteristics of the mark, including the fact that it does or does not contain an element descriptive of the goods or services for which it has been registered; the market share held by the mark; how intensive, geographically widespread and long-standing use of the mark has been; the amount invested by the undertaking in promoting the mark; the proportion of the relevant section of the public which, because of the mark, identifies the goods or services as originating from a particular undertaking; and statements from chambers of commerce and industry or other trade and professional associations (see *Windsurfing Chiemsee*, paragraph 51)."

79. As no evidence of use has been filed by the opponent, I have only the inherent distinctive character to consider. The opponent's earlier mark consists of an invented word. Normally invented words are considered to have a very high degree of distinctive characher, however, as the word will be understood as having allusive connotations to the word vegan or veganism, the mark is, as a consequence, only endowed with a normal level of inherent distinctive character.

Likelihood of confusion

80. In determining whether there is a likelihood of confusion, a number of factors need to be borne in mind. The first is the interdependency principle i.e. a lesser degree of similarity between the respective marks may be offset by a greater degree of similarity between the respective goods and vice versa. I must also keep in mind the average consumer for the goods, the nature of the purchasing process and the fact that the

average consumer rarely has the opportunity to make direct comparisons between marks and must instead rely upon the imperfect picture of them he has retained in his mind.

- 81. There are two types of relevant confusion to consider: direct confusion (where one mark is mistaken for the other) and indirect confusion (where the respective similarities lead the consumer to believe that the respective goods come from the same or a related trade source). This distinction was summed up by Mr Iain Purvis Q.C. sitting as the Appointed Person in *L.A. Sugar Limited v By Back Beat Inc*, Case BL-O/375/10:
 - "16. Although direct confusion and indirect confusion both involve mistakes on the part of the consumer, it is important to remember that these mistakes are very different in nature. Direct confusion involves no process of reasoning it is a simple matter of mistaking one mark for another. Indirect confusion, on the other hand, only arises where the consumer has actually recognized that the later mark is different from the earlier mark. It therefore requires a mental process of some kind on the part of the consumer when he or she sees the later mark, which may be conscious or subconscious but, analysed in formal terms, is something along the following lines: "The later mark is different from the earlier mark, but also has something in common with it. Taking account of the common element in the context of the later mark as a whole, I conclude that it is another brand of the owner of the earlier mark."
 - 17. Instances where one may expect the average consumer to reach such a conclusion tend to fall into one or more of three categories:
 - (a) where the common element is so strikingly distinctive (either inherently or through use) that the average consumer would assume that no-one else but the brand owner would be using it in a trade mark at all. This may apply even where the other elements of the later mark are quite distinctive in their own right ("26 RED TESCO" would no doubt be such a case).

- (b) where the later mark simply adds a non-distinctive element to the earlier mark, of the kind which one would expect to find in a sub-brand or brand extension (terms such as "LITE", "EXPRESS", "WORLDWIDE", "MINI" etc.).
- (c) where the earlier mark comprises a number of elements, and a change of one element appears entirely logical and consistent with a brand extension ("FAT FACE" to "BRAT FACE" for example)."
- 82. Earlier in my decision I found that the goods are similar to vaying degrees from very low to high and that some goods are identical. The average consumer will select the goods primarily visually, paying no more than an average degree of attention during that process. The marks are aurally identical and visually and conceptually highly similar. Given that the only difference between the marks consists of one letter which is placed in the penultimate position in both marks and as are both marks will be articulated in the same way, it is highly likely that, taking into account the principle of imperfect recollection, there will be confusion, both direct (in relation to identical or highly similar goods) and indirect (in relation to goods which are similar to a lower degree.) There is a likelihood of confusion.

CONCLUSION

- 83. The opposition has been <u>partially</u> successful. The opposition is successful in respect of all of the goods which I have found to be identical or similar to the earlier goods (see paragraphs 23-60). The goods against which the opposition is successful will be refused regsitration.
- 84. The goods against which the opposition fails (and which can proceed to registration) are the goods which I found to be <u>not</u> similar to the earlier goods. These are listed at paragraph 68, and are as follows:

85. The registration is refused in relation to the remaining goods.

COSTS

86. As the parties are not professionally represented they were asked at the conclusion of the evidence rounds to complete a costs pro-forma if they wished to claim costs. Neither party has responded. Consequently, regardless of the outcome of this decision, I do not make any award of costs.
