# **BACKGROUND AND PLEADINGS**

1. On 23 July 2020, Unilateral Ltd ("the applicant") applied to register the trade mark displayed on the cover page of this decision in the UK, under number 3514964 ("the contested mark"). The contested mark was published for opposition purposes on 28 August 2020. Registration is sought in respect of 'sportswear; clothing, footwear, headgear; gymwear' in class 25.

2. On 24 November 2020, Industria de Diseno Textil, S.A. (Inditex, S.A.) ("the opponent") opposed the application under sections 5(2)(b) and 5(3) of the Trade Marks Act 1994 ("the Act") on the basis of the following trade marks:

("the third earlier mark")

3. The first earlier mark is registered for goods and services in classes 25 and 35, while the second earlier mark is registered for goods and services in classes 3, 9, 14, 16, 24, 25, 28, 37, 40 and 42. The third earlier mark has been applied for in respect of a wide range of goods and services covering all 45 classes. The full specifications of the earlier marks are included as an annex to this decision.

4. For the purposes of the opposition under section 5(2)(b), the opponent relies upon the goods and services underlined in the annex to this decision. The opponent contends that the competing trade marks are similar and that the respective goods are identical,<sup>1</sup> giving rise to a likelihood of confusion, including a likelihood of association. The opponent also submits that its earlier marks benefit from an enhanced distinctive character.

5. Under section 5(3), the opponent claims that its earlier marks have a substantial reputation in the UK and EU. The goods and services in respect of which a reputation is claimed are italicised in the annex to this decision. The opponent submits that this reputation is such that use of the contested mark would give the applicant an unfair commercial advantage as it will benefit from the opponent's marketing efforts. Additionally, the opponent contends that use of the contested mark in relation to goods of inferior quality will cause detriment to the reputation of its earlier marks. Further, the opponent argues that use of the contested mark will cause detriment to the distinctive character of its earlier marks as their ability to uniquely identify goods and services would be weakened. According to the opponent, this is likely to result in a change in economic behaviour of its customers.

6. The applicant filed a counterstatement denying the grounds of opposition. As these are the only comments I have from the applicant, they are reproduced in full below:

The Applicant denies the the marks are similar. There are significant visital, aural and conceptual differenences between ZARA and T.A.R.A

The Applicant denies that the Opponent has a reputation and put the opposnent to the proof thereof.

The Applicant denies that the application offends the provision of Section 5(2) or 5(3) and put the opponent to the proof thereof.

The Applicant request the oppositon to be refused.

7. Given the respective filing dates, the opponent's trade marks are earlier marks, in accordance with section 6 of the Act.<sup>2</sup> The first and second earlier marks had completed their registration processes more than five years before the filing date of the application and would, ordinarily, be subject to the proof of use provisions contained in section 6A of the Act. However, the applicant has not sought to require the opponent to demonstrate proof of use.<sup>3</sup> Moreover, the third earlier mark has not yet completed its registration process. Consequently, the opponent is entitled to rely upon all the goods and services identified, without having to establish genuine use.

8. Both parties have been professionally represented throughout these proceedings; the opponent by Taylor Wessing LLP and the applicant by RevoMark. Only the opponent filed evidence. Both parties were given the option of an oral hearing, though neither asked to be heard on this matter. Only the opponent elected to file written submissions in lieu of a hearing. This decision is taken following a careful perusal of the papers before me, keeping all submissions in mind.

9. Although the UK has left the EU, section 6(3)(a) of the European Union (Withdrawal) Act 2018 requires tribunals to apply EU-derived national law in accordance with EU law as it stood at the end of the transition period. The provisions of the Act relied upon in these proceedings are derived from an EU Directive and, therefore, this decision continues to refer to the trade mark case law of the EU courts.

#### **EVIDENCE AND SUBMISSIONS**

10. The opponent's evidence consists of the witness statement of Ms Julia King, dated 12 April 2021, together with Exhibits JK1 to JK4, and the witness statement of Mr Óscar García Maceiras, dated 10 May 2021, together with Exhibits OGM1 to OGM21.

- 11. Ms King is a Chartered Trade Mark Attorney in the employ of Taylor Wessing LLP, the opponent's representatives in these proceedings. The purpose of her statement is to introduce extracts from prior decisions of the Appointed Persons and the Opposition Division of the EUIPO into evidence. Moreover, Ms King seeks to establish meanings of the words 'ZARA' and 'TARA'.
- 12. Mr Maceiras confirms that he is General Counsel and Secretary for the Board for the opponent, a position he has held since March 2021. He gives evidence as to the history and reputation of the 'ZARA' brand.
- 13. As noted above, the opponent also filed written submissions in lieu of an oral hearing.
- 14. Whilst I do not propose to summarise the evidence and submissions here, I have taken it all into consideration in reaching my decision and will refer to it below, as and where necessary.

# **MY APPROACH**

- 15. As can be seen from the above, the earlier marks are all identical. However, the first earlier mark is a UK registration, while the second and third earlier marks are EUTMs. Furthermore, to my mind, the specifications of the second and third earlier marks do not put the opponent in a more favourable position. As such, I will proceed on the basis of the first earlier mark only, returning to consider the other earlier marks later in this decision if it is necessary to do so.
- 16. I also note that the third earlier mark has not yet completed its registration process as it is subject to an unrelated opposition at the EUIPO. I note that the class 35 services in respect of which the opponent claims to have a reputation are at issue in those proceedings. Therefore, if and to the extent that those services are determinative in this case, my decision will be provisional, pending the outcome of the EUIPO proceedings.

# **DECISION**

# **Section 5(2)(b)**

# Legislation and case law

- 17. Sections 5(2)(b) and 5A of the Act read as follows:
  - "5(2) A trade mark shall not be registered if because -

[...]

(b) it is similar to an earlier trade mark and is to be registered for goods or services identical with or similar to those for which the earlier trade mark is protected,

there exists a likelihood of confusion on the part of the public, which includes the likelihood of association with the earlier trade mark."

"5A Where grounds for refusal of an application for registration of a trade mark exist in respect of only some of the goods or services in respect of which the trade mark is applied for, the application is to be refused in relation to those goods and services only."

- 18. The following principles are gleaned from the decisions of the EU courts in *Sabel BV v Puma AG*, Case C-251/95, *Canon Kabushiki Kaisha v Metro-Goldwyn-Mayer Inc*, Case C-39/97, *Lloyd Schuhfabrik Meyer & Co GmbH v Klijsen Handel B.V.* Case C-342/97, *Marca Mode CV v Adidas AG & Adidas Benelux BV*, Case C-425/98, *Matratzen Concord GmbH v OHIM*, Case C-3/03, *Medion AG v. Thomson Multimedia Sales Germany & Austria GmbH*, Case C-120/04, *Shaker di L. Laudato & C. Sas v OHIM*, Case C-334/05P and *Bimbo SA v OHIM*, Case C-591/12P:
  - (a) The likelihood of confusion must be appreciated globally, taking account of all relevant factors:

- (b) the matter must be judged through the eyes of the average consumer of the goods or services in question, who is deemed to be reasonably well informed and reasonably circumspect and observant, but who rarely has the chance to make direct comparisons between marks and must instead rely upon the imperfect picture of them he has kept in his mind, and whose attention varies according to the category of goods or services in question;
- (c) the average consumer normally perceives a mark as a whole and does not proceed to analyse its various details;
- (d) the visual, aural and conceptual similarities of the marks must normally be assessed by reference to the overall impressions created by the marks bearing in mind their distinctive and dominant components, but it is only when all other components of a complex mark are negligible that it is permissible to make the comparison solely on the basis of the dominant elements;
- (e) nevertheless, the overall impression conveyed to the public by a composite trade mark may be dominated by one or more of its components;
- (f) however, it is also possible that in a particular case an element corresponding to an earlier trade mark may retain an independent distinctive role in a composite mark, without necessarily constituting a dominant element of that mark:
- (g) a lesser degree of similarity between the goods or services may be offset by a great degree of similarity between the marks, and vice versa;
- (h) there is a greater likelihood of confusion where the earlier mark has a highly distinctive character, either per se or because of the use that has been made of it;
- (i) mere association, in the strict sense that the later mark brings the earlier mark to mind, is not sufficient;

- (j) the reputation of a mark does not give grounds for presuming a likelihood of confusion simply because of a likelihood of association in the strict sense;
- (k) if the association between the marks creates a risk that the public might believe that the respective goods or services come from the same or economically-linked undertakings, there is a likelihood of confusion.

# Comparison of goods and services

19. The goods and services to be compared are as follows:

20. The opponent's pleaded case is that the applicant's 'clothing, footwear, headgear' have direct counterparts in its specifications. Further, that the applicant's 'sportswear;

gymwear' fall within its broader term 'clothing articles' and are, therefore, identical.

21. As can be seen from its counterstatement, the applicant has been silent on whether

there is any similarity or identicality between the respective goods and services.

Arguably, this is tantamount to a tacit acceptance of the opponent's pleaded case.4

However, it is not necessary for me to determine this point.

22. The applicant's 'clothing, footwear, headgear' are self-evidently identical to

'clothing articles for men, women and children, [...] footwear, headgear' in class 25 of

the first earlier mark.

23. Moreover, the law requires that goods be considered identical where one party's

description of its goods encompasses the specific goods covered by the other party's

description (and vice versa).5 'Sportswear' and 'gymwear' describe particular kinds of

clothing which are typically worn for sport or physical exercise. In my view, they are

encompassed by the opponent's broader category 'clothing articles for men, women

and children' in class 25 of the first earlier mark.

24. I have also considered the other goods and services relied upon by the opponent.

However, to my mind, none improve the opponent's position.

The average consumer and the nature of the purchasing act

25. The average consumer is deemed to be reasonably well informed, observant and

circumspect. For the purpose of assessing the likelihood of confusion, it must be borne

in mind that the average consumer's level of attention is likely to vary according to the

category of goods or services in question.<sup>6</sup>

26. In Hearst Holdings Inc, Fleischer Studios Inc v A.V.E.L.A. Inc, Poeticgem Limited, The Partnership (Trading) Limited, U Wear Limited, J Fox Limited, [2014] EWHC 439 (Ch), Birss J. described the average consumer in these terms:

"60. The trade mark questions have to be approached from the point of view of the presumed expectations of the average consumer who is reasonably well informed and reasonably circumspect. The parties were agreed that the relevant person is a legal construct and that the test is to be applied objectively by the court from the point of view of that constructed person. The words "average" denotes that the person is typical. The term "average" does not denote some form of numerical mean, mode or median."

# 27. In New Look Limited v OHIM,7 the General Court stated that:

"50. [...] Generally in clothes shops customers can themselves either choose the clothes they wish to buy or be assisted by the sales staff. Whilst oral communication in respect of the product and the trade mark is not excluded, the choice of the item of clothing is generally made visually. Therefore, the visual perception of the marks in question will generally take place prior to purchase. Accordingly the visual aspect plays a greater role in the global assessment of the likelihood of confusion."

28. In line with my approach to the comparison of the respective goods, my assessment below will focus on the average consumer of the class 25 goods at issue.

29. The average consumer of such goods is a member of the general public. The goods are likely to be purchased relatively frequently for the purposes of clothing one's self or self-expression. Their cost may vary, with cheaper items of limited quality at one end of the spectrum and more expensive fashion pieces at the other. However, the purchasing act will not require an overly considered thought process as, overall, they are relatively inexpensive purchases; selection of the goods is likely to be more casual than careful. Nonetheless, the average consumer will consider factors such as

style, quality, size, cost and compatibility with other items. While, to some extent, I agree with the opponent that consumers are likely to exhibit various levels of attention depending on the particular item of clothing, overall, I find that the general public would demonstrate a medium level of attention. The goods are typically sold in bricks-and-mortar retail establishments or their online equivalents, where they are likely to be self-selected from rails and shelves or after viewing information on the Internet. In these circumstances, visual considerations would dominate. Nevertheless, as such goods may also be the subject of, for instance, word of mouth recommendations or oral requests to sales assistants, I do not discount aural considerations entirely.

#### Distinctive character of the earlier mark

30. In *Lloyd Schuhfabrik Meyer & Co. GmbH* v *Klijsen Handel BV,* Case C-342/97, the Court of Justice of the European Union ("CJEU") stated that:

"22. In determining the distinctive character of a mark and, accordingly, in assessing whether it is highly distinctive, the national court must make an overall assessment of the greater or lesser capacity of the mark to identify the goods or services for which it has been registered as coming from a particular undertaking, and thus to distinguish those goods or services from those of other undertakings (see, to that effect, judgment of 4 May 1999 in Joined Cases C-108/97 and C-109/97 WindsurfingChiemsee v Huber and Attenberger [1999] ECR I-0000, paragraph 49).

23. In making that assessment, account should be taken, in particular, of the inherent characteristics of the mark, including the fact that it does or does not contain an element descriptive of the goods or services for which it has been registered; the market share held by the mark; how intensive, geographically widespread and long-standing use of the mark has been; the amount invested by the undertaking in promoting the mark; the proportion of the relevant section of the public which, because of the mark, identifies the goods or services as originating from a particular undertaking; and statements from chambers of commerce and industry or other trade and professional associations (see *Windsurfing Chiemsee*, paragraph 51)."

31. Registered trade marks possess varying degrees of inherent distinctive character. These range from the very low, such as those which are suggestive or allusive of the goods or services, to those with high inherent distinctive character, such as invented words. Dictionary words which do not allude to the goods or services will be somewhere in the middle. The degree of distinctiveness is an important factor as it directly relates to whether there is a likelihood of confusion; the more distinctive the earlier mark, the greater the likelihood of confusion. The distinctive character of a mark may be enhanced as a result of it having been used in the market.

32. The opponent has submitted that the first earlier mark is inherently distinctive and does not contain any descriptive or non-distinctive elements. Moreover, it has claimed that the mark possesses "a substantial reputation and enormous degree of enhanced distinctive character" by virtue of the use made of it. I have no comments from the applicant on the matter, though it has disputed the existence of a reputation.

33. The first earlier mark is in word-only format and consists of the word 'ZARA'. As the mark comprises a plain word with no other elements, its distinctiveness lies indivisibly in the word itself. The opponent has argued that the first earlier mark may be recognised by the average consumer as a female forename. There is also evidence to that effect.<sup>8</sup> I agree. The forename 'ZARA' has no descriptive or allusive qualities and it is my impression that it is not overly common in the UK. Overall, I find that the first earlier mark has a medium level of inherent distinctive character.

34. Evidence has been filed by the opponent and I am now required to assess whether the opponent has demonstrated that the first earlier mark had an enhanced degree of distinctive character, at the relevant date of 23 July 2020.

35. I note that the opponent relies upon extracts from prior decisions in which it demonstrated that the distinctiveness of 'ZARA' had been enhanced through use.<sup>9</sup> While I acknowledge the findings of Mr Daniel Alexander Q.C. as the Appointed

Person and the Opposition Division of the EUIPO in those decisions, it suffices to say that I am not bound by them and must conduct my own assessment on the basis of the evidence before me.

36. Since opening its first store in A Coruña, Spain, in 1975, 'ZARA' has grown its network to over 2000 stores and has a presence (whether physical or online) in 96 markets worldwide. ¹¹¹ It is said to have the most number of fashion retail stores in the world and is described as a dominant presence in the fashion industry. ¹¹ Global turnover under the opponent's 'ZARA' and 'Zara Home' brands rose from over €14,000m in 2015 to in excess of €19,500m in 2019. ¹² The 'ZARA' brand was placed consistently within the top 50 best global brands between 2014 and 2020 by Interbrand; the brand's value rose in this period from \$12,126m to \$14,862m and peaked in 2017 at \$18,873m. ¹³ In 2020, 'ZARA' was listed in second position out of all global apparel brands by Kantar MillwardBrown and also appeared in Forbes' top 50 of the world's most valuable brands. ¹⁴

37. As for the UK, the first 'ZARA' store opened in 1998 and, at the date of Mr Maceiras' statement, there were 58 stores across the UK. 15 Online sales in this territory began in 2010. 16 In my view, use of the mark in the UK has been widespread and relatively long-standing. The opponent's UK pre-tax sales figures achieved in respect of 'ZARA' branded clothing, footwear, headgear, accessories and perfumery between 2011 and 2021 have been provided. 17 These show that the opponent's turnover under the 'ZARA' trade mark in the UK was in excess of £300m in 2011, rising to over £800m in 2019. Turnover decreased in 2020, though still stood at over £600m. Even in the context of a very large market, these figures are clearly significant. Sample documents relating to the delivery of products to 'ZARA' stores in London between January 2016 and July 2020 have been exhibited; although some contain no details (or English

translations) as to what the items are, others show the delivery of clothing and footwear products to these outlets. 18

38. Mr Maceiras states that the brand is predominantly known to consumers throughout the UK due to word of mouth and the strategic locations of its stores in major cities, main shopping streets and shopping malls; further, he says that the architecture, uniform arrangement and window displays are one of the most effective and authentic forms of publicity for the brand. 19 Marketing activities for the 'ZARA' brand are also conducted through its own website at www.zara.com and its social media accounts.<sup>20</sup> Editorials – described as akin to online catalogues – are posted every season via these channels; the publication of these editorials rose from 37 in 2015 to 164 in 2019.<sup>21</sup> The 'ZARA' website and mobile application had over 500m combined unique users worldwide in 2020; those from the UK amounted to over 47m unique users, generating a total of over 240m views at an average of around 660,000 views per day.<sup>22</sup> While parts of the evidence suggest that 'ZARA' does not conduct traditional advertising campaigns, the opponent invested over €400m globally between 2016 and 2020 in marketing and advertising; this included, for example, its spend on online campaigns, editorials and photographs for its website and social media accounts.<sup>23</sup>

39. The 'ZARA' brand featured regularly in national UK newspapers and publications such as, inter alia, The Guardian, The Independent, The Telegraph, Cosmopolitan, BBC News, Hello!, Vogue and The Daily Express, prior to the relevant date.<sup>24</sup> Much of the press coverage attests to the popularity and success of the brand in the UK. 'ZARA' branded clothing, footwear, jewellery and bags can be seen in several multiproduct features. Some of the articles indicate that 'ZARA' branded clothing has been publicly worn by prominent individuals, such as the Duchess of Cambridge. Evidence relating to the circulation figures of these publications has been provided.<sup>25</sup> The

combined multi-platform reach of these publications is extensive. For example, at 29 August 2018, The Guardian and The Telegraph had a daily reach of over 4.7m and 3.6m, respectively, and Cosmopolitan had over 300,000 readers per issue between January and June 2018. Furthermore, 'ZARA' was shortlisted three times at the Creative Retail Awards 2019 for its display at London Fashion Week 2018 and, as a member of the Fashion Pact coalition, was recognised in the environment sector at the British Fashion Awards 2020.<sup>26</sup>

40. In light of the above, I do not hesitate to conclude that the distinctive character of the first earlier mark has been enhanced to the extent that it must be considered to have a very high level of distinctive character. For the purposes of this decision, it is sufficient to record that this finding extends to 'clothing articles for men, women and children, [...] footwear, headgear' in class 25.

#### **Comparison of trade marks**

41. It is clear from *Sabel BV v. Puma AG* (particularly paragraph 23) that the average consumer normally perceives a mark as a whole and does not proceed to analyse its various details. The same case also explains that the visual, aural and conceptual similarities of the marks must be assessed by reference to the overall impressions created by the marks, bearing in mind their distinctive and dominant components. In *Bimbo SA v OHIM*, the CJEU stated (at paragraph 34 of its judgment) that:

"[...] it is necessary to ascertain, in each individual case, the overall impression made on the target public by the sign for which registration is sought, by means of, inter alia, an analysis of the components of a sign and of their relative weight in the perception of the target public, and then, in the light of that overall impression and all factors relevant to the circumstances of the case, to assess the likelihood of confusion."

42. Therefore, it would be wrong to dissect the trade marks artificially, though it is necessary to take into account their distinctive and dominant components. Due weight

must be given to any other features which are not negligible and hence contribute to the overall impressions created by the marks.

# 43. The competing marks are as follows:

The first earlier mark	The contested mark
ZARA	TARAS SPORTSWEAR

#### Overall impressions

- 44. The first earlier mark is in word-only format and consists of the word 'ZARA'. As there are no other elements, the overall impression lies in the word itself.
- 45. The contested mark is figurative and comprises the letters 'T.A.R.A', the word SPORTSWEAR' and a runner device. The 'T.A.R.A' element may be perceived as either the female forename 'Tara' or, alternatively, as an acronym. It is presented in a large, bold font, and has no descriptive or allusive qualities. It is my view that this element will dominate the overall impression of the mark. The pictorial representation of a person sprinting from a block start strongly alludes to goods that are worn for sport or physical exercise, while the incomplete oval shape will be perceived as decorative. Accordingly, it is considered that the device will play a reduced role in the overall impression of the mark. Finally, I agree with the opponent that the word 'SPORTSWEAR' is descriptive of the kind of goods for which registration of the mark is sought, namely, clothing, footwear and headwear that is worn for sport or physical exercise. Therefore, although it will not be entirely overlooked, it certainly plays a much lesser role in the overall impression.

# Visual comparison

46. Visually, I agree with the opponent that the competing marks are similar as the dominant elements, being the word 'ZARA' and 'T.A.R.A', both consist of four letters that share three identical letters in the same order, i.e. 'ARA/A.R.A'. I do not consider the particular font used in the contested mark to be a point of significant visual difference between the competing marks, since notional and fair use would allow the first earlier mark to be presented in any standard typeface. Moreover, in respect of at least a significant proportion of consumers, it is my view that the punctuation marks in the contested mark would be overlooked and, therefore, do not create any significant difference between the marks. In addition, the contested mark contains the word 'SPORTSWEAR', while the first earlier mark does not. However, I have found that this word is descriptive and plays a much lesser role in the overall impression of the contested mark. The competing marks are visually different as the dominant element of the first earlier mark begins with a letter 'Z', while that of the contested mark begins with a letter 'T'. Moreover, the contested mark includes a runner device which is not replicated in the first earlier mark. Although I have found this element to be allusive of the goods, it will not be entirely overlooked by consumers. Bearing in mind my assessment of the overall impressions, I consider there to be a medium degree of visual similarity between the marks.

#### <u>Aural comparison</u>

47. Aurally, the first earlier mark consists of two syllables, i.e. "ZA-RA". In respect of the contested mark, the device will not be articulated in any way. Moreover, given that the word 'SPORTSWEAR' merely describes the goods for which registration is sought, it is unlikely that it would be articulated by consumers. Consequently, the contested mark also comprises two syllables, i.e. "TA-RA". In my view, this would also be true for some consumers who perceive 'T.A.R.A' as an acronym due to the particular arrangement of the letters. The competing marks are aurally similar insofar as they share the "A-RA" element, while they differ in their respective initial sounds. Overall, I find that there is between a medium and high degree of aural similarity between the marks. As this represents what I regard as the opponent's best case, I do not consider

it necessary to go on to consider the position in respect of any other possible pronunciations of the contested mark.

# Conceptual comparison

48. The opponent has contended that some consumers will recognise the word 'ZARA' as its "highly reputed fashion and lifestyle brand". I disagree. It is important to point out that reputation and conceptual meaning are not the same thing. Reputation, in a trade mark sense, concerns the factual extent to which a sign is recognised by a significant part of the public as a trade mark, whereas conceptual meaning is a level of immediately perceptible notoriety or independent meaning, outside of a purely trade mark context.<sup>27</sup> Although there are cases where an extensive reputation has transferred into conceptual meaning, these are the exception rather than the rule and depend on their own facts.<sup>28</sup> Exceptional cases where trade mark reputation evolves into a conceptual meaning need to be properly proven. It is my view that the evidence filed in these proceedings does not establish that 'ZARA' has evolved into a conceptual meaning. Rather, as I have already outlined, the first earlier mark will be understood as a female forename. As for the contested mark, it is my view that at least a significant proportion of consumers will overlook the punctuation marks between the letters in 'T.A.R.A' and will, instead, perceive it as the female forename 'Tara'. The word 'SPORTSWEAR' will be understood as a descriptive reference to goods that can be worn during sport or physical exercise. The runner device alludes to such goods as it conveys the concept of running, or sports more generally. Conceptually, the competing marks overlap insofar as they both contain female forenames, albeit different ones. Nevertheless, the contested mark conveys additional meanings that will not be attributed to the first earlier mark. Bearing in mind my assessment of the overall impressions, I find that there is between a low and medium degree of conceptual similarity between the competing marks. Given that this represents the opponent's best case, I do not consider it necessary to go on to consider the position should the letters in the contested mark be perceived as an acronym.

#### Likelihood of confusion

49. There is no scientific formula to apply in determining whether there is a likelihood of confusion; rather, it is a global assessment where a number of factors need to be borne in mind. One such factor is the interdependency principle i.e. a lesser degree of similarity between the respective trade marks may be offset by a greater degree of similarity between the respective goods, and vice versa. As I mentioned above, it is necessary for me to keep in mind the distinctive character of the earlier trade mark, the average consumer for the goods and the nature of the purchasing process. In doing so, I must be alive to the fact that the average consumer rarely has the opportunity to make direct comparisons between trade marks and must instead rely upon the imperfect picture of them that they have retained in their mind.

50. Confusion can be direct or indirect. Direct confusion involves the average consumer mistaking one mark for the other, while indirect confusion is where the average consumer realises the marks are not the same but puts the similarity that exists between the marks and the goods down to the responsible undertakings being the same or related.

#### 51. Earlier in this decision, I concluded that:

- The applicant's goods are identical to those in class 25 of the first earlier mark;
- The average consumer of the goods is likely to be a member of the general public, who would demonstrate a medium level of attention during the purchasing act;
- The purchasing process is predominantly visual in nature, though aural considerations have not been excluded;

- The first earlier mark has a medium level of inherent distinctive character, which has been enhanced to a very high level through use in relation to 'clothing articles for men, women and children, [...] footwear, headgear';
- The overall impression of the first earlier mark lies in the word 'ZARA', being the only element of the mark;
- The overall impression of the contested mark is dominated by the word or acronym 'T.A.R.A', while the runner device and the word 'SPORTSWEAR' play lesser roles;
- There is a medium degree of visual similarity between the competing marks;
- The competing marks are aurally similar to between a medium and high degree;
- The competing marks are conceptually similar to between a low and medium degree.

52. I acknowledge that the competing marks share three identical letters in the same order, i.e. 'A-R-A', and that this string appears within the dominant elements of the marks. I also accept that there is a conceptual overlap between the competing marks, insofar as the words 'ZARA' and 'T.A.R.A' would both be perceived as female forenames. However, it is important not to dissect the marks artificially and, instead, recognise that consumers will perceive them as wholes. When considering the competing marks in this context, there are differences between them which would not be overlooked by the average consumer during the purchasing process. The contested mark contains additional elements which are not replicated in the first earlier mark. While I have found the runner device and the word 'SPORTSWEAR' to be allusive and descriptive, respectively, it is my view that they would not be entirely overlooked. Further, and perhaps more significantly, although the dominant elements of the competing marks are both female forenames, they are distinct and will be appreciated as such by the average consumer; 'ZARA' and 'Tara' are both recognisable forenames and, to my mind, consumers will be able to differentiate

between them, not least because they begin with different letters. I do not consider that one forename would be mistakenly remembered or recalled as the other, even when accounting for imperfect recollection. In my judgement, notwithstanding the very high level of distinctive character possessed by the first earlier mark, the differences between the competing marks are likely to be sufficient for the average consumer to distinguish between them and avoid mistaking one for the other, even on goods that are identical. Accordingly, it follows that there will be no direct confusion.

53. That leaves indirect confusion to be considered. In *L.A. Sugar Limited v By Back Beat Inc*, Case BL O/375/10, Mr Iain Purvis Q.C., sitting as the Appointed Person, explained that:

"16. Although direct confusion and indirect confusion both involve mistakes on the part of the consumer, it is important to remember that these mistakes are very different in nature. Direct confusion involves no process of reasoning – it is a simple matter of mistaking one mark for another. Indirect confusion, on the other hand, only arises where the consumer has actually recognized that the later mark is different from the earlier mark. It therefore requires a mental process of some kind on the part of the consumer when he or she sees the later mark, which may be conscious or subconscious but, analysed in formal terms, is something along the following lines: "The later mark is different from the earlier mark, but also has something in common with it. Taking account of the common element in the context of the later mark as a whole, I conclude that it is another brand of the owner of the earlier mark.

Instances where one may expect the average consumer to reach such a conclusion tend to fall into one or more of three categories:

(a) where the common element is so strikingly distinctive (either inherently or through use) that the average consumer would assume that no-one else but the brand owner would be using it in a trade mark at all. This may apply even where the other elements of the later mark are quite distinctive in their own right ("26 RED TESCO" would no doubt be such a case).

- (b) where the later mark simply adds a non-distinctive element to the earlier mark, of the kind which one would expect to find in a sub-brand or brand extension (terms such as "LITE", "EXPRESS", "WORLDWIDE", "MINI" etc.).
- (c) where the earlier mark comprises a number of elements, and a change of one element appears entirely logical and consistent with a brand extension ("FAT FACE" to "BRAT FACE" for example)."
- 54. I have borne in mind that these examples are not exhaustive. Rather, they were intended to be illustrative of the general approach. I also recognise that a finding of indirect confusion should not be made merely because the competing marks share a common element. In this connection, it is not sufficient that a mark merely calls to mind another mark: this is mere association not indirect confusion.<sup>29</sup>
- 55. Having regard to all the above principles, I do not believe that consumers will assume the opponent and the applicant are economically linked undertakings on the basis of the competing trade marks, even on goods that are identical. I am unconvinced that consumers would assume a commercial association between the parties, or sponsorship on the part of the opponent, merely because the marks have three identical letters in common, i.e. 'A-R-A', or a shared similar element, i.e. 'ZARA/T.A.R.A'. Whilst the runner device and the word 'SPORTSWEAR' may both appear to be consistent with a brand extension (in the context of a venture into clothing for sport or physical exercise, for example), the same cannot be said of the dominant elements of the marks. Consumers would not separate the letters 'A-R-A' from the respective wholes of the competing marks and would have no reason to believe that it is so strikingly distinctive that only the opponent would be using it in a trade mark. Moreover, altering the first letter from a 'Z' to a 'T' is neither simply adding a nondistinctive element nor is it characteristic of any logical brand extensions with which consumers would be familiar. To my mind, there is no obvious reason why an undertaking would alter a trade mark consisting of one female forename to another,

resulting in the dominant element of the contested mark. In light of the foregoing, I conclude that there is no likelihood of indirect confusion.

56. For the sake of completeness, my conclusions at paragraphs 52 and 55 would be the same for consumers who perceive the 'T.A.R.A' element in the contested mark as an acronym. In circumstances where this element is not perceived as a female forename, there would be less similarity between the competing marks and, as a result, they would be even more easily distinguished. This factor points towards a lesser, rather than a greater, risk of confusion.

57. The opposition under section 5(2)(b) of the Act is dismissed.

# Section 5(3)

#### Legislation and case law

58. At the commencement of these proceedings, sections 5(3) and 5(3A) of the Act stated:

#### "(3) A trade mark which-

- (a) is identical with or similar to an earlier trade mark, shall not be registered if, or to the extent that, the earlier trade mark has a reputation in the United Kingdom (or, in the case of a European Union trade mark or international trade mark (EC), in the European Union) and the use of the later mark without due cause would take unfair advantage of, or be detrimental to, the distinctive character or the repute of the earlier trade mark."
- (3A) Subsection (3) applies irrespective of whether the goods and services for which the trade mark is to be registered are identical with, similar to or not similar to those for which the earlier trade mark is protected".

- 59. The relevant case law can be found in the following judgments of the CJEU: Case C-375/97, *General Motors*, Case 252/07, *Intel*, Case C-408/01, *Adidas-Salomon*, Case C-487/07, *L'Oréal v Bellure*, Case C-323/09, *Marks and Spencer v Interflora* and Case C383/12P, *Environmental Manufacturing LLP v OHIM*. The law appears to be as follows:
  - a) The reputation of a trade mark must be established in relation to the relevant section of the public as regards the goods or services for which the mark is registered; *General Motors, paragraph 24.*
  - (b) The trade mark for which protection is sought must be known by a significant part of that relevant public; General Motors, paragraph 26.
  - (c) It is necessary for the public when confronted with the later mark to make a link with the earlier reputed mark, which is the case where the public calls the earlier mark to mind; *Adidas-Salomon*, *paragraph 29* and *Intel*, *paragraph 63*.
  - (d) Whether such a link exists must be assessed globally taking account of all relevant factors, including the degree of similarity between the respective marks and between the goods/services, the extent of the overlap between the relevant consumers for those goods/services, and the strength of the earlier mark's reputation and distinctiveness; *Intel, paragraph 42.*
  - (e) Where a link is established, the owner of the earlier mark must also establish the existence of one or more of the types of injury set out in the section, or there is a serious likelihood that such an injury will occur in the future; *Intel, paragraph* 68; whether this is the case must also be assessed globally, taking account of all relevant factors; *Intel, paragraph* 79.
  - (f) Detriment to the distinctive character of the earlier mark occurs when the mark's ability to identify the goods/services for which it is registered is weakened as a result of the use of the later mark, and requires evidence of a change in the economic behaviour of the average consumer of the goods/services for which the earlier mark is registered, or a serious risk that

this will happen in future; *Intel, paragraphs 76 and 77* and *Environmental Manufacturing, paragraph 34.* 

- (g) The more unique the earlier mark appears, the greater the likelihood that the use of a later identical or similar mark will be detrimental to its distinctive character; *Intel, paragraph 74.*
- (h) Detriment to the reputation of the earlier mark is caused when goods or services for which the later mark is used may be perceived by the public in such a way that the power of attraction of the earlier mark is reduced, and occurs particularly where the goods or services offered under the later mark have a characteristic or quality which is liable to have a negative impact of the earlier mark; *L'Oréal v Bellure NV*, paragraph 40.
- (i) The advantage arising from the use by a third party of a sign similar to a mark with a reputation is an unfair advantage where it seeks to ride on the coat-tails of the senior mark in order to benefit from the power of attraction, the reputation and the prestige of that mark and to exploit, without paying any financial compensation, the marketing effort expended by the proprietor of the mark in order to create and maintain the mark's image. This covers, in particular, cases where, by reason of a transfer of the image of the mark or of the characteristics which it projects to the goods identified by the identical or similar sign, there is clear exploitation on the coat-tails of the mark with a reputation (*Marks and Spencer v Interflora, paragraph 74 and the court's answer to question 1 in L'Oréal v Bellure*).
- 60. The conditions of section 5(3) are cumulative. Firstly, the opponent must show that the first earlier mark is similar to the contested mark. Secondly, the opponent must show that the mark has achieved a level of knowledge, or reputation, amongst a significant part of the public. Thirdly, the opponent must establish that the public will make a link between the marks, in the sense of the first earlier mark being brought to mind by the contested mark. Fourthly, assuming the foregoing conditions have been met, section 5(3) requires that one or more of three types of damage claimed by the opponent will occur. It is not necessary for the purposes of section 5(3) that the goods

or services are similar, although the relative distance between them is one of the factors which must be assessed in deciding whether the public will make a link between the marks.

61. The relevant date for the assessment under section 5(3) is the filling date of the contested application, namely, 23 July 2020.

#### Reputation

- 62. In *General Motors*, Case C-375/97, the CJEU held that:
  - "25. It cannot be inferred from either the letter or the spirit of Article 5(2) of the Directive that the trade mark must be known by a given percentage of the public so defined.
  - 26. The degree of knowledge required must be considered to be reached when the earlier mark is known by a significant part of the public concerned by the products or services covered by that trade mark.
  - 27. In examining whether this condition is fulfilled, the national court must take into consideration all the relevant facts of the case, in particular the market share held by the trade mark, the intensity, geographical extent and duration of its use, and the size of the investment made by the undertaking in promoting it.
  - 28. Territorially, the condition is fulfilled when, in the terms of Article 5(2) of the Directive, the trade mark has a reputation 'in the Member State'. In the absence of any definition of the Community provision in this respect, a trade mark cannot be required to have a reputation 'throughout' the territory of the Member State. It is sufficient for it to exist in a substantial part of it."
- 63. The opponent has contended that the first earlier mark possesses a substantial reputation in the UK. This, it has argued, is because it has been in continual use throughout the UK for at least 23 years. The opponent has also highlighted the sales figures achieved under the first earlier mark, the promotion of the 'ZARA' brand and

its presence within the world's most valuable brands. Conversely, the applicant has denied that the first earlier mark has a reputation.

64. Taking the evidential picture as a whole into account, and for the same reasons outlined at paragraphs 36 to 39 I do not hesitate to conclude that the first earlier mark had a very strong reputation in the UK at the relevant date. Again, for the purposes of this decision, it is sufficient to note that this finding extends to 'clothing articles for men, women and children, [...] footwear, headgear'.

#### Link

65. As noted above, my assessment of whether the public will make the required mental 'link' between the marks must take into account all relevant factors. The factors identified in *Intel* are:

# The degree of similarity between the conflicting marks

I have found that the competing marks are visually similar to a medium degree, aurally similar to between a medium and high degree and conceptually similar to between a low and medium degree.

The nature of the goods or services for which the conflicting marks are registered, or proposed to be registered, including the degree of closeness or dissimilarity between those goods or services, and the relevant section of the public

The average consumer of the goods at issue has been discussed above at paragraph 29.

I have found that the parties' respective goods in class 25 are identical.

# The strength of the earlier mark's reputation

I have found that the first earlier mark has a very strong reputation in the UK.

# The degree of the earlier mark's distinctive character, whether inherent or acquired through use

I have found that the first earlier mark possesses a medium level of inherent distinctive character, which has been enhanced to a very high level though use.

#### Whether there is a likelihood of confusion

I have found there to be no likelihood of direct or indirect confusion for the reasons stated at paragraphs 52 and 55.

66. The opponent has submitted that it is clear the requisite link would be made in the mind of the average consumer. In addition, the opponent has contended that its reputation is so significant that such a link would be established regardless of the goods or services at issue. I have no comments from the applicant as to whether a link would be made between the competing marks.

67. Taking all of the above factors into account, notwithstanding the strength of the opponent's reputation and the level of distinctive character possessed by the first earlier mark, it is considered that the differences between the competing marks are such that the relevant public is unlikely to make a link between them. Although I have found that the dominant element of the competing marks, i.e. 'ZARA' and 'T.A.R.A', are both likely to be perceived as female forenames by some consumers, they are recognisable and distinct. Having immediately recognised the letters 'T.A.R.A' to be referring to that particular forename upon encountering the contested mark, it is highly unlikely that the first earlier mark - constituting an entirely different forename - would be brought to mind, even in respect of identical goods. This is, in my view, particularly the case, given that, in my experience, consumers are accustomed to differentiating between clothing brands that use names to designate trade origin. If any link is made, it is my view that it will be too fleeting to result in any damage arising. As for consumers who do not perceive 'T.A.R.A' in the contested mark to be a female forename, I find that it is even less likely that the first earlier mark will be brought to mind, given that the competing marks will no longer share this common feature.

68. The opposition based upon section 5(3) is dismissed.

# **CONCLUSION**

69. The opposition under sections 5(2)(b) and 5(3) of the Act has failed. Subject to any successful appeal against my decision, the application will become registered in the UK.

70. I should add that, although this conclusion has been reached on the basis of the first earlier mark only, I have not considered it necessary to assess the opponent's reliance on the second or third earlier marks as these do not improve its position.

71. Further, as the class 35 services of the third earlier mark were not determinative, this decision is final.

# **COSTS**

72. As the applicant has been successful, it is entitled to a contribution towards its costs based upon the scale published in Tribunal Practice Notice 2/2016. In the circumstances, I award the applicant the sum of £650 as a contribution towards the cost of the proceedings. This sum is calculated as follows:

Considering the opponent's statement	£300
and preparing a counterstatement	
Considering the opponent's evidence	£350
and written submissions	

Total £650

73. I therefore order Industria de Diseno Textil, S.A. (Inditex, S.A.) to pay Unilateral Ltd the sum of £650. This sum should be paid within twenty-one days of the expiry of the appeal period or, if there is an appeal, within twenty-one days of the conclusion of the appeal proceedings (subject to any order made by the appellate tribunal).

#### **ANNEX**

#### Goods and services of the first earlier mark

Class 25: <u>Clothing articles for men, women and children, belts, hosiery, footwear,</u> headgear.

Class 35: The bringing together, for the benefit of others, of a variety of goods, enabling customers to conveniently view and purchase those goods in a retail department store; advertising and business management services relating to retail fashion goods; business management and business administration services; sales promotion, compilation and provision of sale information; shop window dressing; advertising including direct distribution of advertising material and catalogues, direct-mail advertising, distribution of samples.

#### Goods and services of the second earlier mark

Class 3: Bleaching preparations and other substances for laundry use; cleaning, polishing, scouring and abrasive preparations; soaps; perfumery, essential oils, cosmetics, hair lotions; dentifrices; abrasive paper; adhesives for affixing false eyelashes; adhesives for affixing false hair; adhesives for cosmetic purposes; alum stones [antiseptic]; bath salts, not for medical purposes; cotton sticks for cosmetic purposes; cotton wool for cosmetic purposes; decorative transfers for cosmetic purposes; denture polishes; emery cloth; emery paper; false eyelashes; false nails; fumigation preparations [perfumes]; glass cloth; glass paper; incense; lacquer-removing preparations; paint stripping preparations; paper guides for eye make-up; polishing paper; potpourris [fragrances]; pumice stone; sachets for perfuming linen; sandcloth; sandpaper; shampoos; shaving stones [antiseptic]; shoemakers' wax; smoothing stones; swabs [toiletries]; tailors' wax; toiletries; tripoli stone for polishing; varnish-removing preparations; scented wood; shampoos for pets; mouth washes, not for medical purposes; cobblers' wax.

Class 9: Scientific, nautical, surveying, electric, photographic, cinematographic, optical, weighing, measuring, signalling, checking (supervision), life-saving and

teaching apparatus and instruments; apparatus for recording, transmission or reproduction of sound or images; magnetic data carriers, recording discs; automatic vending machines and mechanisms for coin-operated apparatus; cash registers, calculating machines, data processing equipment and computers; fire-extinguishing apparatus; animated cartoons; apparatus for changing record player needles; asbestos clothing for protection against fire; asbestos gloves for protection against accidents; bullet-proof vests; bullet-proof waistcoats; cabinets for loudspeakers; cases especially made for photographic apparatus and instruments; cases fitted with dissecting instruments [microscopy]; cleaning apparatus for phonograph records; cleaning apparatus for sound recording discs; clothing for protection against accidents, irradiation and fire; computer programmes [programs], recorded; computer operating programs recorded; computer operating programs, recorded; computer peripheral devices; computer software [recorded]; containers for contact lenses; divers' apparatus; divers' masks; diving suits; earplugs for divers; filters for respiratory masks; fire beaters; fire blankets; fire boats; fire engines; fire hose nozzles; floats for bathing and swimming; furniture especially made for laboratories; garments for protection against fire; gloves for divers; gloves for protection against accidents; gloves for protection against X-rays for industrial purposes; holders for electric coils; interfaces [for computers]; juke boxes [for computers]; knee-pad for workers; magnets; masts for wireless aerials; micrometer screws for optical instruments; monitors [computer programs]; motor fire engines; nets for protection against accidents; pince-nez chains; pince-nez cords; pince-nez cases; pince-nez mountings; plotters; protective helmets; protective masks; protective suits for aviators; protection devices for personal use against accidents; push button for bells; reflecting discs, for wear, for the prevention of traffic accidents; reflecting discs for wear, for the prevention of traffic accidents; respirators [other than for artificial respiration]; respirators for filtering air; respiratory masks [other than for artificial respiration]; retorts' stands; road signs, luminous or mechanical; safety nets; safety restraints [other than for vehicle seats and sports equipment]; safety tarpaulins; signs luminous; shoes for protection against accidents, irradiation and fire; solderers' helmets; spark-guards; stands for photographic apparatus; steering apparatus, automatic, for vehicles; spectacle frames; spectacle cases; swimming belts; swimming jackets; teeth protectors; turnstiles, automatic; tripods for cameras; water wings; workmen's protective face-shields.

Class 14: Precious metals and their alloys and goods in precious metals or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments; agates; anchors [clock and watch-making]; barrels [clock and watchmaking]; clock cases; clockworks; coins; copper tokens; jet, unwrought or semi-wrought; key rings [trinkets or fobs]; medals; movements for clocks and watches; objects of imitation gold; olivine [gems]; olivine [gems]; ormolu ware; ornaments of jet; pearls made of ambroid [pressed amber]; semi-precious stones; spinel [precious stones]; straps for wristwatches; watch bands; watch cases; watch chains; watch crystals; watch glasses; watch springs; watch straps; pendulums [clock-and watchmaking]; dials [clock- and watchmaking]; clock hands [clock- and watchmaking].
