The British North America Act. 1867. 30 VICTORIA, CAP. 3.

An Act for the Union of Canada, Nova Scotia, and New Brunswick, and the Government thereof; and for Purposes connected therewith. [Royal Assent, 29th March 1867.]

WHEREAS the Provinces of Canada, Nova Scotia and New Brunswick, have expressed their desire to be federally united into One Dominion under the Crown of the United Kingdom of Great Britain and Ireland, with a Constitution similar in principle to that of the United Kingdom :

And whereas such a Union would conduce to the welfare of the Provinces and promote the interests of the British Empire :

And whereas on the establishment of the Union by Authority of Parliament, it is expedient, not only that the Constitution of the Legislative Authority in the Dominion be provided for, but also that the nature of the Executive Government therein be declared:

And whereas it is expedient that provision be made for the eventual admission into the Union of other parts of British North America:

Be it therefore enacted and declared by the Queen's Most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, as follows:

I.---PRELIMINARY.

1. This Act may be cited as The British North America Act, 1867.

2. The provisions of this Act referring to Her Majesty the Queen extend Application also to the Heirs and Successors of Her Majesty, Kings and Queens of the of Provisions United Kingdom of Great Britain and Ireland.

II.—UNION.

3. It shall be lawful for the Queen, by and with the advice of Her Majesty's Declaration Most Honourable Privy Council, to declare by Proclamation that, on and after of Union. a day therein appointed, not being more than six months after the passing of this Act, the Provinces of Canada, Nova Scotia, and New Brunswick shall form and be One Dominion under the name of Canada, and on and after that day those Three Provinces shall form and be One Dominion under that name accordingly.

4. The subsequent provisions of this Act shall, unless it is otherwise Construction expressed or implied, commence and have effect on and after the Union, that is of subseto say, on and after the day appointed for the Union taking effect in the Queen's sions of Act.

Short Title.

PARTS II. AND III.

Proclamation; and in the same provisions, unless it is otherwise expressed or implied, the name Canada shall be taken to mean Canada as constituted under this Act.

5. Canada shall be divided into Four Provinces, named Ontario, Quebec, Nova Scotia and New Brunswick.

6. The parts of the Province of Canada (as it exists at the passing of this Act) which formerly constituted respectively the Provinces of Upper Canada and Lower Canada shall be deemed to be severed, and shall form Two separate Provinces. The part which formerly constituted the Province of Upper Canada shall constitute the Province of Ontario, and the part which formerly constituted the Province of Lower Canada shall constitute the Province of Quebec.

7. The Provinces of Nova Scotia and New Brunswick shall have the same limits as at the passing of this Act.

8. In the general census of the population of Canada, which is hereby required to be taken in the year one thousand eight hundred and seventy-one, and in every tenth year thereafter, the respective populations of the Four Provinces shall be distinguished.

III.—EXECUTIVE POWER.

9. The Executive Government and Authority of and over Canada, is hereby declared to continue and be vested in the Queen.

10. The provisions of this Act referring to the Governor General, extend and apply to the Governor General for the time being of Canada, or other the Chief Executive Officer or Administrator for the time being carrying on the Government of Canada on behalf and in the name of the Queen, by whatever title he is designated.

11. There shall be a Council to aid and advise in the Government of Canada, to be styled the Queen's Privy Council for Canada, and the persons who are to be Members of that Council shall be from time to time chosen and summoned by the Governor General and sworn in as Privy Councillors, and Members thereof may be from time to time removed by the Governor General.

12. All Powers, Authorities and Functions which under any Act of the Parliament of Great Britain, or of the Parliament of the United Kingdom of Great Britain and Ireland, or of the Legislature of Upper Canada, Lower Canada, Canada, Nova Scotia or New Brunswick, are at the Union vested in or exerciseable by the respective Governors or Lieutenant Governors of those Provinces, with the advice, or with the advice and consent of the respective Executive Councils thereof, or in conjunction with those Councils, or with any number of Members thereof, or by those Governors or Lieutenant Governors individually, shall, as far as the same continue in existence and capable of being exercised after the Union in relation to the Government of Canada, be vested in and exerciseable by the Governor General, with the advice or with the advice and consent of or in conjunction with the Queen's Privy Council for Canada, or any Members thereof, or by the Governor General individually as the case requires, subject nevertheless

14. It shall be lawful for the Queen, if Her Majesty thinks fit, to authorize Council. the Governor General from time to time to appoint any person or any persons Power to Her Majesty jointly or severally to be his Deputy or Deputies within any part or parts of to authorize Canada, and in that capacity to exercise during the pleasure of the Governor General to General such of the Powers, Authorities and Functions of the Governor General as the Governor General deems it necessary or expedient to assign to him or them, subject to any limitations or directions expressed or given by the Queen. but the appointment of such a Deputy or Deputities shall not affect the exercise by the Governor General himself of any Power, Authority or Function.

15. The Command-in-Chief of the Land and Naval Militia, and of all Naval Command of and Military forces of and in Canada, is hereby declared to continue and be armed Forces vested in the Queen.

16. Until the Queen otherwise directs, the Seat of Government of Canada the Queen. shall be Ottawa.

IV.—LEGISLATIVE POWER.

17. There shall be One Parliament for Canada, consisting of the Queen, an Constitution Upper House, styled the Senate, and the House of Commons.

18. The Privileges, Immunities and Powers to be held, enjoyed and exercised Privileges, by the Senate and by the House of Commons and by the Members thereof Houses. respectively, shall be such as are from time to time defined by Act of the Parliament of Canada, but so that the same shall never exceed those at the passing of this Act held, enjoyed and exercised by the Commons House of Parliament of the United Kingdom of Great Britain and Ireland, and by the Members thereof.

19. The Parliament of Canada shall be called together not later than six First Session months after the Union.

20. There shall be a Session of the Parliament of Canada once at least in every year, so that twelve months shall not intervene between the last Sitting of Session of the the Parliament in one Session and its first Sitting in the next Session.

THE SENATE.

21. The Senate shall, subject to the provisions of this Act, consist of Number of seventy-two Members, who shall be styled Senators.

In the case of Quebec, each of the twenty-four Senators representing that Province shall be appointed for one of the twenty-four Electoral Divisions of Lower Canada specified in Schedule A, to Chapter One of the Consolidated Statutes of Canada.

Qualifications of Senator.

- 23. The Qualifications of a Senator shall be as follows :
- (1.) He shall be of the full age of thirty years :
- (2.) He shall be either a natural-born subject of the Queen, or a subject of the Queen naturalized by an Act of the Parliament of Great Britain, or of the Parliament of the United Kingdom of Great Britain and Ireland, or of the Legislature of one of the Provinces of Upper Canada, Lower Canada, Canada, Nova Scotia or New Brunswick, before the Union, or of the Parliament of Canada after the Union :
- (3.) He shall be legally or equitably seised as of freehold for his own use and benefit of lands or tenements held in free and common socage, or seised or possessed for his own use and benefit of lands or tenements held in francalleu or in roture, within the Province for which he is appointed, of the value of Four thousand dollars, over and above all rents, dues, debts, charges, mortgages and incumbrances due or payable out of or charged on or affecting the same :
- (4.) His real and personal property shall be together worth Four thousand dollars over and above his debts and liabilities :
- (5.) He shall be resident in the Province for which he is appointed :
- (6.) In the case of Quebec, he shall have his real property qualification in the Electoral Division for which he is appointed, or shall be resident in that Division.

24. The Governor General shall from time to time, in the Queen's Name, by instrument under the Great Seal of Canada, summon qualified persons to the Senate, and, subject to the provisions of this Act, every person so summoned shall become and be a Member of the Senate and a Senator.

25. Such persons shall be first summoned to the Senate, as the Queen by Warrant under Her Majesty's Royal Sign Manual thinks fit to approve, and their names shall be inserted in the Queen's Proclamation of Union.

26. If at any time on the recommendation of the Governor General the Queen thinks fit to direct that three or six Members be added to the Senate, the Governor General may by summons to three or six qualified persons (as the case may be) representing equally the Three Divisions of Canada, add to the Senate accordingly.

27. In case of such addition being at any time made, the Governor General shall not summon any person to the Senate, except on a further like direction by the Queen on the like recommendation, until each of the Three Divisions of Canada is represented by twenty-four Senators and no more.

28. The number of Senators shall not at any time exceed seventy-eight.

40. Until the Parliament of Canada otherwise provides, Ontario, Quebec, Commons. Electoral Districts of

the Four Provinces. Nova Scotia and New Brunswick shall, for the purposes of the Election of Members to serve in the House of Commons, be divided into Electoral Districts as follows:

1.—ONTARIO.

Ontario shall be divided into the Counties, Ridings of Counties, Cities, Parts of Cities and Towns enumerated in the First Schedule to this Act, each whereof shall be an Electoral District, each such District as numbered in that Schedule being entitled to return one Member.

2.—QUEBEC.

Quebec shall be divided into sixty-five Electoral Districts, composed of the sixty-five Electoral Divisions into which Lower Canada is at the passing of this Act divided under Chapter Two of the Consolidated Statutes of Canada, Chapter Seventy-five of the Consolidated Statutes for Lower Canada, and the Act of the Province of Canada of the Twenty-third year of the Queen, Chapter One, or any other Act amending the same in force at the Union, so that each such Electoral Division shall be for the purposes of this Act an Electoral District entitled to return one Member.

3.--NOVA SCOTIA.

Each of the Eighteen Counties of Nova Scotia shall be an Electoral District. The County of Halifax shall be entitled to return two Members, and each of the other Counties one Member.

4.—NEW BRUNSWICK.

Each of the Fourteen Counties into which New Brunswick is divided, including the City and County of St. John, shall be an Electoral District. The. City of St. John shall also be a separate Electoral District. Each of those Fifteen Electoral Districts shall be entitled to return one Member.

Continuance of existing Election Laws until Parliament of Canada otherwise provides. 41. Until the Parliament of Canada otherwise povides, all Laws in force in the several Provinces at the Union relative to the following matters or any of them, namely,—the qualifications and disqualifications of persons to be elected or to set or vote as Members of the House of Assembly or Legislative Assembly in the several Provinces, the Voters at Elections of such Members, the Oaths to be taken by Voters, the Returning Officers, their Powers and Duties, the Proceedings at Elections, the periods during which Elections may be continued, the Trial of controverted Elections, and proceedings incident thereto, the vacating of seats of Members, and the Execution of new Writs in case of seats vacated otherwise than by Dissolution,—shall respectively apply to Elections of Members to serve in the House of Commons for the same several Provinces.

Provided that, until the Parliament of Canada otherwise provides, at any Election for a Member of the House of Commons for the District of Algoma, in addition to persons qualified by the Law of the Province of Canada to vote, every male British subject, aged twenty-one years or upwards, being a householder, shall have a Vote.

Writs for 42. For the first Election of Members to serve in the House of Commons First the Governor General shall cause Writs to be issued by such person, in such Election. form, and addressed to such Returning Officers as he thinks fit.

The person issuing Writs under this section shall have the like powers as are possessed at the Union by the Officers charged with the issuing of Writs for the Election of Members to serve in the respective House of Assembly or Legislative Assembly of the Province of Canada, Nova Scotia, or New Brunswick; and the Returning Officers to whom Writs are directed under this section shall have the like powers as are possessed at the Union by the Officers charged with the returning of Writs for the Election of Members to serve in the same respective House of Assembly or Legislative Assembly.

43. In case a vacancy in the Representation in the House of Commons of $\frac{As}{Vacancies}$. any electoral district happens before the meeting of the Parliament, or after the meeting of the Parliament before provision is made by the Parliament in this behalf, the provisions of the last foregoing section of this Act shall extend and apply to the issuing and returning of a Writ in respect of such vacant district.

44. The House of Commons on its first assembling after a general Election Election of shall proceed with all practicable speed to elect one of its Members to be Speaker.

45. In case of a vacancy happening in the Office of Speaker by death, resignation, or otherwise, the House of Commons shall with all practicable speed proceed to elect another of its Members to be Speaker.

46. The Speaker shall preside at all Meetings of the House of Commons.

47. Until the Parliament of Canada otherwise provides, in case of the absence for any reason of the Speaker from the Chair of the House of Commons for a period of forty-eight consecutive hours, the House may elect another of its Absence of Members to act as Speaker, and the Member so elected shall during the Speaker. continuance of such absence of the Speaker have and execute all the powers, privileges, and duties of Speaker.

48. The presence of at least twenty Members of the House of Commons Quorum of House of shall be necessary to constitute a Meeting of the House for the exercise of its Commons powers, and for that purpose the Speaker shall be reckoned as a Member.

49. Questions arising in the House of Commons shall be decided by a House of majority of voices other than that of the Speaker, and when the voices are equal, Commons. but not otherwise, the Speaker shall have a vote.

50. Every House of Commons shall continue for five years from the day Duration of of the return of the Writs for choosing the House (subject to be sooner dissolved Commons. by the Governor General), and no longer.

51. - (3.) In the computation of the number of Members for a Province a fractional part not exceeding one-half of the whole number requisite for entitling the Province to a Member shall be disregarded; but a fractional part exceeding one-half of that number shall be equivalent to the whole number :
- (4.) On any such re-adjustment the number of Members for a Province shall not be reduced unless the proportion which the number of the population of the Province bore to the number of the aggregate population of Canada at the then last preceding re-adjustment of the number of Members for the Province is ascertained at the then latest census to be diminished by one-twentieth part or upwards:
- (5.) Such re-adjustments shall not take effect until the termination of the then existing Parliament.

52. The number of Members of the House of Commons may be from time to time increased by the Parliament of Canada, provided the proportionate representation of the Provinces prescribed by this Act is not thereby disturbed.

MONEY VOTES; ROYAL ASSENT.

53. Bills for appropriating any part of the Public Revenue, or for inposing any Tax or impost, shall originate in the House of Commons.

54. It shall not be lawful for the House of Commons to adopt or pass any vote, resolution, address, or bill for the appropriation of any part of the Public Revenue, or of any Tax or impost, to any purpose that has not been first recommended to that House by Message of the Governor General in the Session in which such vote, resolution, address, or bill is proposed.

55. Where a bill passed by the House of Parliament is presented to the Governor General for the Queen's assent, he shall declare, according to his discretion, but subject to the Provisions of this Act and to Her Majesty's instructions, either that he assents thereto in the Queen's name, or that he withholds the Queen's assent, or that he reserves the bill for the signification of the Queen's pleasure.

56. Where the Governor General assents to a bill in the Queen's name he shall by the first convenient opportunity send an authentic copy of the Act to one of Her Majesty's Principal Secretaries of State, and if the Queen in Council within two years after receipt thereof by the Secretary of State thinks fit to disallow the Act, such disallowance (with a Certificate of the Secretary of State of the day on which the Act was received by him) being signified by the Governor General, by Speech or Message to each of the Houses of Parliament or by Proclamation, shall annul the Act from and after the day of such signification.

57. A bill reserved for the signification of the Queen's pleasure shall not have any force unless and until within two years from the day on which it was presented to the Governor General for the Queen's assent, the Governor General signifies, by Speech or Message to each of the Houses of the Parliament or by Proclamation, that it has received the assent of the Queen in Council.

PARTS IV. AND V.

An entry of every such Speech, Message, or Proclamation shall be made in the Journal of each House, and a Duplicate thereof duly attested shall be delivered to the proper Officer to be kept among the records of Canada.

V — PROVINCIAL CONSTITUTIONS.

EXECUTIVE POWER.

58. For each Province there shall be an Officer, styled the Lieutenant Appointment Governor, appointed by the Governor General in Council by Instrument under the Governors of Great Seal of Canada. Tenure of

59. A Lieutenant Governor shall hold Office during the pleasure of the Governor General; but any Lieutenant Governor appointed after the commencement of the first Session of the Parliament of Canada shall not be removeable within five years from his appointment, except for cause assigned, which shall be communicated to him in writing within one month after the order for his removal is made, and shall be communicated by Message to the Senate and to the House of Commons within one week thereafter if the Parliament is then sitting, and if not then within one week after the commencement of the next Session of the Parliament.

60. The salaries of the Lieutenant Governors shall be fixed and provided Salaries of by the Parliament of Canada.

61. Every Lieutenant Governor shall, before assuming the duties of his Lieutenant Office, make and subscribe before the Governor General or some person authorized Governor. by him Oaths of Allegiance and Office similar to those taken by the Governor General.

62. The Provisions of this Act referring to the Lieutenant Governor extend Application and apply to the Lieutenant Governor for the time being of each Province, or other the Chief Executive Officer or Administrator for the time being carrying Lieutenan Governor. on the Government of the Province, by whatever title he is designated.

63. The Executive Council of Ontario and of Quebec shall be composed of Appointment of Executive such persons as the Lieutenant Governor from time to time thinks fit, and in the Officers for first instance of the following Officers, namely,---the Attorney General, the Secretary and Registrar of the Province, the Treasurer of the Province, the Commissioner of Crown Lands, and the Commissioner of Agriculture and Public Works with, in Quebec, the Speaker of the Legislative Council and the Solicitor General.

64. The Constitution of the Executive Authority in each of the Provinces of Executive Nova Scotia and New Brunswick shall, subject to the provisions of this Act, continue as it exists at the Union until altered under the Authority of this Act.

65. All Powers, Authorities and Functions which under any Act of the Parliament of Great Britain, or of the Parliament of the United Kingdom of Powers to be Great Britain and Ireland, or of the Legislature of Upper Canada, Lower Canada, or Canada, were or are before or at the Union vested in or exerciseable by the respective Governors or Lieutenant Governors of those Provinces, with the advice or with the advice and consent of the respective Executive Councils thereof, or in conjunction with those Councils, or with any number of Members thereof, or by

those Governors or Lieutenant Governors individually, shall, as far as the same are capable of being exercised after the Union in relation to the Government of Ontario and Quebec respectively, be vested in and shall or may be exercised by the Lieutenant Governor of Ontario and Quebec respectively, with the advice or with the advice and consent of or in conjunction with the respective Executive Councils, or any Members thereof, or by the Lieutenant Governor individually, as the case requires, subject nevertheless (except with respect to such as exist under Acts of the Parliament of Great Britain, or of the Parliament of the United Kingdom of Great Britain and Ireland,) to be abolished or altered by the respective Legislatures of Ontario and Quebec.

66. The provisions of this Act referring to the Lieutenant Governor in Council shall be construed as referring to the Lieutenant Governor of the Province acting by and with the advice of the Executive Council thereof.

67. The Governor General in Council may from time to time appoint an Administrator to execute the office and functions of Lieutenant Governor during his absence, illness or other inability.

68. Unless and until the Executive Government of any Province otherwise directs with respect to that Province, the Seats of Government of the Provinces shall be as follows, namely,—of Ontario, the City of Toronto; of Quebec, the City of Quebec; of Nova Scotia, the City of Halifax; and of New Brunswick, the City of Fredericton.

LEGISLATIVE POWER.

1.—ONTARIO.

69. There shall be a Legislature for Ontario consisting of the Lieutenant Governor and of one House, styled the Legislative Assembly of Ontario.

70. The Legislative Assemby of Ontario shall be composed of Eighty-two Members, to be elected to represent the Eighty-two Electoral Districts set forth in the First Schedule to this Act.

2.—QUEBEC.

71. There shall be a Legislature for Quebec consisting of the Lieutenant Governor and of two Houses, styled the Legislative Council of Quebec and the Legislative Assembly of Quebec.

72. The Legislative Council of Quebec shall be composed of Twenty-four Members, to be appointed by the Lieutenant Governor, in the Queen's name, by instrument under the Great Seal of Quebec, one being appointed to represent each of the Twenty-four Electoral Divisions of Lower Canada in this Act referred to, and each holding office for the term of his life, unless the Legislature of Quebec otherwise provides under the provisions of this Act.

73. The qualifications of the Legislative Councillors of Quebec shall be the same as those of the Senators for Quebec.

74. The place of a Legislative Councillor of Quebec shall become vacant in the cases, *mutatis mutandis*, in which the place of Senator becomes vacant.

75. When a vacancy happens in the Legislative Council of Quebec by

77. The Lieutenant Governor may from time to time, by instrument under Speaker of the Great Seal of Quebec, appoint a Member of the Legislative Council of Quebec Legislative Council of Quebec to be Speaker thereof, and may remove him and appoint another in his stead.

78. Until the Legislature of Quebec otherwise provides, the presence of at Quorum of least Ten Members of the Legislative Council, including the Speaker, shall be Legislative Council. necessary to constitute a Meeting for the exercise of its Powers.

79. Questions arising in the Legislative Council of Quebec shall be decided Voting in by a majority of voices, and the Speaker shall in all cases have a vote, and when Legislative Council. the voices are equal the decision shall be deemed to be in the negative.

80. The Legislative Assembly of Quebec shall be composed of Sixty-five Constitution Members, to be elected to represent the Sixty-five Electoral Divisions or Districts Assembly of of Lower Canada in this Act referred to, subject to alteration thereof by the Quebec. Legislature of Quebec: provided that it shall not be lawful to present to the Lieutenant Governor of Quebec for assent, any Bill for altering the limits of any of the Electoral Divisions or Districts mentioned in the Second Schedule to this Act, unless the Second and Third Readings of such Bill have been passed in the Legislative Assembly with the concurrence of the majority of the Members representing all those Electoral Divisions or Districts, and the assent shall not be given to such Bill unless an Address has been presented by the Legislative Assembly to the Lieutenant Governor stating that it has been so passed.

3.—ONTARIO AND QUEBEC.

81. The Legislatures of Ontario and Quebec respectively shall be called First Session together not later than six months after the Union.

82. The Lieutenant Governor of Ontario and of Quebec shall from time to Summoning time, in the Queen's name, by instrument under the Great Seal of the Province, Assemblication summon and call together the Legislative Assembly of the Province.

83. Until the Legislature of Ontario or of Quebec otherwise provides, a person accepting or holding in Ontario or in Quebec any office, commission or of Holders employment, permanent or temporary, at the nomination of the Lieutenant Governor, to which an annual salary, or any fee, allowance, emolument or profit of any kind or amount whatever from the Province is attached, shall not be eligible as a Member of the Legislative Assembly of the respective Province, nor shall he sit or vote as such; but nothing in this Section shall make ineligible any person being a Member of the Executive Council of the respective Province, or holding any of the following offices, that is to say, the offices of Attorney General, Secretary and Registrar of the Province, Treasurer of the Province, Commissioner of Crown Lands, and Commissioner of Agriculture and Public Works, and in Quebec Solicitor General, or shall disqualify him to sit or vote in the House for which he is elected, provided he is elected while holding such office.

84. Until the Legislatures of Ontario and Quebec respectively otherwise provide, all Laws which at the Union are in force in those Provinces respectively, relative to the following matters, or any of them, namely,—the qualifications and disqualifications of persons to be elected or to sit or vote as Members of the Assembly of Canada, the qualifications or disqualifications of voters, the oaths to be taken by voters, the Returning Officers, their powers and duties, the proceedings at Elections, the periods during which such Elections may be continued, and the trial of controverted Elections and the proceedings incident thereto, the vacating of the Seats of Members and the issuing and execution of new Writs in case of Seats vacated otherwise than by dissolution,—shall respectively apply to Elections of Members to serve in the respective Legislative Assemblies of Ontario and Quebec.

Provided that, until the Legislature of Ontario otherwise provides, at any Election for a Member of the Legislative Assembly of Ontario for the District of Algoma, in addition to persons qualified by the Law of the Province of Canada to vote, every male British subject, aged twenty-one years or upwards, being a householder, shall have a vote.

85. Every Legislative Assembly of Ontario and every Legislative Assembly of Quebec, shall continue for four years from the day of the return of the Writs for choosing the same (subject nevertheless to either the Legislative Assembly of Ontario or the Legislative Assembly of Quebec being sooner dissolved by the Lieutenant Governor of the Province), and no longer.

86. There shall be a Session of the Ligislature of Ontario and of that of Quebec once at least in every year, so that twelve months shall not intervene between the last sitting of the Legislature in each Province in one session and its first sitting in the next session.

87. The following provisions of this Act respecting the House of Commons of Canada shall extend and apply to the Legislative Assemblies of Ontario and Quebec, that is to say,—the provisions relating to the election of a Speaker originally and on vacancies, the duties of the Speaker, the absence of the Speaker, the quorum, and the mode of voting, as if those provisions were here re-enacted and made applicable in terms to each such Legislative Assembly.

4.—NOVA SCOTIA AND NEW BRUNSWICK.

88. The constitution of the Legislature of each of the Provinces of Nova Scotia and New Brunswick shall, subject to the provisions of this Act, continue at it exists at the Union until altered under the authority of this Act; and the House of Assembly of New Brunswick existing at the passing of this Act shall, unless sooner dissolved, continue for the period for which it was elected.

5—ONTARIO, QUEBEC, AND NOVA SCOTIA.

89. Each of the Lieutenant Governors of Ontario, Quebec, and Nova Scotia shall cause Writs to be issued for the first election of Members of the Legislative Assembly thereof in such form and by such person as he thinks fit, and at such time and addressed to such Returning Officer as the Governor General directs, and so that the first election of Member of Assembly for any Electoral District or

any subdivision thereof shall be held at the same time and at the same places as the election for a Member to serve in the House of Commons of Canada for that Electoral District.

6.—THE FOUR PROVINCES.

90. The following provisions of this Act respecting the Parliament of Application to Canada, namely,—the provisions relating to Appropriation and Tax Bills, the Legislatures of Provisions recommendation of Money Votes, the assent to Bills, the disallowance of Acts, respecting Money Votes, and the signification of pleasure on Bills reserved,-shall extend and apply to de the Legislatures of the several Provinces as if those provisions were here reenacted and made applicable in terms to the respective Provinces and the Legislatures thereof, with the substitution of the Lieutenant Governor of the Province for the Governor General, of the Governor General for the Queen and for a Secretary of State, of one year for two years, and of the Province for Canada.

VI.-DISTRIBUTION OF LEGISLATIVE POWERS.

POWERS OF THE PARLIAMENT.

91. It shall be lawful for the Queen, by and with the advice and consent of Authority of the Senate and House of Commons, to make laws for the peace, order, and good Parliament government of Canada, in relation to all matters not coming within the classes of Canada. of subjects by this Act assigned exclusively to the Legislatures of the Provinces; and for greater certainty, but not so as to restrict the generality of the foregoing terms of this section, it is hereby declared that (notwithstanding anything in this Act) the exclusive legislative authority of the Parliament of Canada extends to all matters coming within the classes of subjects next hereinafter enumerated; that is to say,---

- 1. The Public Debt and Property.
- 2. The regulation of Trade and Commerce.
- 3. The raising of Money by any mode or system of taxation.
- 4. The borrowing of Money on the public credit.
- 5. Postal Service.

- 6. The Census and Statistics.
- 7. Militia, Military and Naval Service, and Defence.
- 8. The fixing of and providing for the Salaries and Allowances of Civil and other Officers of the Government of Canada.
- 9. Beacons, Buoys, Lighthouses, and Sable Island.

- 11. Quarantine and the establishment and maintenance of Marine Hospitals.
- 12. Sea Coast and Inland Fisheries.
- 13. Ferries between a Province and any British or Foreign country or between two Provinces.
- 14. Currency and Coinage.
- 15. Banking, Incorporation of Banks, and the issue of Paper Money,
- 16. Savings Banks.
- 17. Weights and Measures.

And any matter coming within any of the classes of subjects enumerated in this Section shall not be deemed to come within the class of matters of a local or private nature comprised in the enumeration of the classes of subjects by this Act assigned exclusively to the Legislatures of the Provinces.

EXCLUSIVE POWERS OF PROVINCIAL LEGISLATURES.

Subjects of exclusive Provincial Legislation. 92. In each Province the Legislature may exclusively make laws in relation to matters coming within the classes of subjects next hereinafter enumerated; that is to say:—

- 1. The Amendment from time to time, notwithstanding anything in this Act, of the constitution of the Province, except as regards the office of Lieutenant Governor.
- 2. Direct taxation within the Province in order to the raising of a Revenue for Provincial purposes.
- 3. The borrowing of money on the sole credit of the Province.
- 4. The establishment and tenure of Provincial offices, and the appointment and payment of Provincial officers.
- 5. The management and sale of the public lands belonging to the Province, and of the timber and wood thereon.
- 6. The establishment, maintenance and management of Public and Reformatory Prisons in and for the Province.
- 7. The establishment, maintenance and management of Hospitals, Asylums, Charities, and Eleemosynary Institutions in and for the Province, other than Marine Hospitals.
- 8. Municipal Institutions in the Province.
- 9. Shop, Saloon, Tavern, Auctioneer, and other Licences in order to the raising of a Revenue for Provincial, Local, or Municipal purposes.
- 10. Local Works and undertakings other than such as are of the following classes :----

a. Lines of Steam or other Ships, Railways, Canals, Telegraphs,

and other works and undertakings connecting the Province with any other or others of the Provinces, or extending beyond the limits of the Province:

- b. Lines of Steam Ships between the Province and any British or Foreign Country:
- c. Such works as although wholly situate within the Province, are before or after their execution declared by the Parliament of Canada to be for the general advantage of Canada, or for the advantage of two or more of the Provinces.
- 11. The Incorporation of Companies with Provincial objects.
- 12. The Solemnization of Marriage in the Province.
- 13. Property and Civil Rights in the Province.
- 14. The Administration of Justice in the Province. including the Constitution. maintenance and organization of Provincial Courts, both of Civil and of Criminal jurisdiction, and including procedure in Civil matters in those Courts.
- 15. The imposition of punishment by Fine, Penalty, or Imprisonment for enforcing any Law of the Province made in relation to any matter coming within any of the classes of subjects enumerated in this section.
- 16. Generally all matters of a merely local or private nature in the Province.

EDUCATION.

93. In and for each Province the Legislature may exclusively make Laws in Legislation relation to Education, subject and according to the following provisions :---

- (1.) Nothing in any such Law shall prejudicially affect any right or privilege with respect to Denominational Schools which any class of persons have by Law in the Province at the Union:
- (2.) All the powers, privileges and duties at the Union by Law conferred and imposed in Upper Canada on the separate schools and school trustees of the Queen's Roman Catholic subjects shall be and the same are hereby extended to the Dissentient Schools of the Queen's Protestant and Roman Catholic subjects in Quebec:
- (3.) Where in any Province a system of separate or Dissentient Schools exists by Law at the Union, or is thereafter established by the Legislature of the Province, an appeal shall lie to the Governor-General in Council from any act or decision of any Provincial authority affecting any right or privilege of the Protestant or Roman Catholic minority of the Queen's subjects in relation to education.
- (4.) In case any such Provincial Law as from time to time seems to the Governor-General in Council requisite for the due execution of the provisions of this Section is not made, or in case any decision of the Governor-General in Council on any appeal under this Section is not duly executed by the proper Provincial authority in that behalf, then and in every such case, and as far only as the circumstances of each

case require, the Parliament of Canada may make remedial Laws for the due execution of the provisions of this Section and of any decision of the Governor-General in Council under this Section.

UNIFORMITY OF LAWS IN ONTARIO, NOVA SCOTIA, AND NEW BRUNSWICK.

94. Notwithstanding anything in this Act, the Parliament of Canada may Uniformity of make provision for the uniformity of all or any of the Laws relative to property and civil rights in Ontario, Nova Scotia, and New Brunswick, and of the procedure of all or any of the Courts in those three Provinces, and from and after the passing of any Act in that behalf the power of the Parliament of Canada to make Laws in relation to any matter comprised in any such Act shall, notwithstanding anything in this Act, be unrestricted; but any Act of the Parliament of Canada making provision for such uniformity shall not have effect in any Province unless and until it is adopted and enacted as Law by the Legislature thereof.

AGRICULTURE AND IMMIGRATION.

95. In each Province the Legislature may make Laws in relation to Agriculture in the Province, and to immigration into the Province; and it is hereby declared that the Parliament of Canada may from time to time make Laws in relation to Agriculture in all or any of the Provinces; and to Immigration into all or any of the Provinces, and any Law of the Legislature of a Province relative to Agriculture or to Immigration shall have effect in and for the Province as long and as far only as it is not repugnant to any Act of the Parliament of Canada.

VII.—JUDICATURE.

96. The Governor-General shall appoint the Judges of the Superior, District, and County Courts in each Province, except those of the Courts of Probate in Nova Scotia and New Brunswick.

97. Until the Laws relative to Property and Civil Rights in Ontario, Nova Scotia and New Brunswick, and the Procedure of the Courts in those Provinces. are made uniform, the Judges of the Courts of those Provinces appointed by the Governor General shall be selected from the respective Bars of those Provinces.

98. The Judges of the Courts of Quebec shall be selected from the Bar of that Province.

99. The Judges of the Superior Courts shall hold Office during good behaviour, but shall be removable by the Governor General on address of the Senate and House of Commons.

100. The Salaries, Allowances and Pensions of the Judges of the Superior, District and County Courts (except the Courts of Probate in Nova Scotia and New Brunswick), and of the Admiralty Courts in cases where the Judges thereof are for the time being paid by salary, shall be fixed and provided by the Parliament of Canada.

101. The Parliament of Canada may, notwithstanding anything in this Act, from time to time provide for the constitution, maintenance and organization of a General Court of Appeal for Canada, and for the establishment of any additional Courts for the better administration of the Laws of Canada.

VIII.—REVENUES; DEBTS; ASSETS; TAXATION.

102. All Duties and Revenues over which the respective Legislatures of Creation of Consolidated Canada, Nova Scotia and New Brunswick before and at the Union had and have Revenue Power of Appropriation, except such portions thereof as are by this Act reserved to the respective Legislatures of the Provinces, or are raised by them in accordance with the special Powers conferred on them by this Act, shall form one Consolidated Revenue Fund, to be appropriated for the public service of Canada in the manner and subject to the charges in this Act provided.

103. The Consolidated Revenue Fund of Canada shall be permanently Expenses of charged with the costs, charges and expenses incident to the collection, manage- &c. ment and receipt thereof, and the same shall form the first charge thereon. subject to be reviewed and audited in such manner as shall be ordered by the Governor General in Council until the Parliament otherwise provides.

104. The annual Interest of the public debts of the several Provinces of Interest of Canada, Nova Scotia, and New Brunswick at the Union shall form the second Public charge on the Consolidated Revenue Fund of Canada.

105. Unless altered by the Parliament of Canada, the salary of the Governor Salary of General shall be Ten thousand pounds sterling money of the United Kingdom of General. Great Britain and Ireland, payable out of the Consolidated Revenue Fund of Canada, and the same shall form the third charge thereon.

106. Subject to the several payments by this Act charged on the Consolidated Appropria-Revenue Fund of Canada, the same shall be appropriated by the Parliament of Canada for the public Service.

107. All Stocks, Cash, Banker's Balances and Securities for money Transfer of belonging to each Province at the time of the Union, except as in this Act mentioned, shall be the property of Canada, and shall be taken in reduction of the amount of the respective debts of the Provinces at the Union.

108. The public Works and Property of each Province, enumerated in the Transfer of third Schedule to this Act, shall be the property of Canada.

109. All Lands, Mines, Minerals, and Royalties belonging to the several Property in Provinces of Canada, Nova Scotia, and New Brunswick at the Union, and all data &c. sums then due or payable for such Lands, Mines, Minerals, or Royalties, shall belong to the several Provinces of Ontario, Quebec, Nova Scotia, and New Brunswick in which the same are situate or arise, subject to any Trusts existing in respect thereof, and to any interest other than that of the Province in the same.

110. All assets connected with such portions of the public debt of each Assets Province as are assumed by that Province shall belong to that Province.

111. Canada shall be liable for the debts and liabilities of each Province Provincial existing at the Union.

112. Ontario and Quebec conjointly shall be liable to Canada for the amount liable to Pro-(if any) by which the debt of the Province of Canada exceeds at the Union Sixty- Debts of two millions five hundred thousand dollars, and shall be charged with Interest Quebec. at the rate of five per centum per annum thereon.

Grants to Provinces. 113. The assets enumerated in the fourth Schedule to this Act belonging at the Union to the Province of Canada shall be the property of Ontario and Quebec conjointly.

114. Nova Scotia shall be liable to Canada for the amount (if any) by which its public debt exceeds at the Union Eight million dollars, and shall be charged with Interest at the rate of five per centum per annum thereon.

115. New Brunswick shall be liable to Canada for the amount (if any) by which its public debt exceeds at the Union Seven million dollars, and shall be charged with Interest at the rate of five per centum per annum thereon.

116. In case the public debts of Nova Scotia and New Brunswick do not at the Union amount to Eight million and seven million dollars respectively, they shall respectively receive by half-yearly payments in advance from the Government of Canada Interest at five per centum per annum on the difference between the actual amount of their respective debts and such stipulated amounts.

117. The several Provinces shall retain all their respective public property not otherwise disposed of in this Act, subject to the right of Canada to assume any Lands or public Property required for fortifications or for the defence of the Country.

118. The following sums shall be paid yearly by Canada to the several Provinces for the support of their Governments and Legislatures :

and an annual grant in aid of each Province shall be made, equal to eighty cents per head of the population as ascertained by the Census of One thousand eight hundred and sixty one, and in the case of Nova Scotia and New Brunswick, by each subsequent Decennial Census until the population of each of those two Provinces amounts to Four thousand souls, at which rate such grant shall thereafter remain. Such grants shall be in full settlement of all future demands on Canada, and shall be paid half-yearly in advance to each Province; but the Government of Canada shall deduct from such grants, as against any Province, all sums chargeable as interest on the Public Debt of that Province in excess of the several amounts stipulated in this Act.

Further Grant to New Brunswick.

Form of Payments. 119. New Brunswick shall receive by half-yearly payments in advance from Canada for the period of Ten years from the Union, an additional allowance of of Sixty-three thousand dollars per annum; but as long as the Public Debt of that Province remains under Seven million dollars, a deduction equal to the interest at five per centum per annum on such deficiency shall be made from that allowance of Sixty-three thousand dollars.

120. All payments to be made under this Act, or in discharge of liabilities created under any Act of the Provinces of Canada, Nova Scotia and New PARTS VIII. AND IX.

Brunswick respectively, and assumed by Canada, shall, until the Parliament of Canada otherwise directs, be made in such form and manner as may from time to time be ordered by the Governor General in Council.

121. All articles of the growth, produce or manufacture of any one of the Canadian Provinces shall, from and after the Union, be admitted free into each of the Manufacother Provinces.

122. The Customs and Excise Laws of each Province shall, subject to the Continuance of Customs provisions of this Act, continue in force until altered by the Parliament of Canada. and Excise

123. Where Customs duties are, at the Union, leviable on any goods, wares Laws. 124. Nothing in this Act shall affect the right of New Brunswick to levy the Lumber Dues lumber dues provided in Chapter Fifteen of Title Three of the Revised Statutes Brunswick. of New Brunswick, or in any Act amending that Act before or after the Union, and not increasing the amount of such dues; but the lumber of any of the Provinces other than New Brunswick shall not be subject to such dues.

125. No lands or property belonging to Canada or any Province shall be Exemption of Public liable to taxation.

126. Such portions of the duties and revenues over which the respective Provincial Legislatures of Canada, Nova Scotia and New Brunswick had before the Union Revenue Power of Appropriation as are by this Act reserved to the respective Governments or Legislatures of the Provinces, and all duties and revenues raised by them in accordance with the special Powers conferred upon them by this Act, shall in each Province form one Consolidated Revenue Fund to be appropriated for the Public Service of the Province.

IX.—MISCELLANEOUS PROVISIONS.

GENERAL.

127. authorized by him, the Oath of Allegiance contained in the Fifth Schedule to this Act; and every Member of the Senate of Canada and every Member of the Legislative Council of Quebec shall also, before taking his Seat therein, take and subscribe before the Governor General, or some person authorized by him, the declaration of qualification contained in the same Schedule.

129. Except as otherwise provided by this Act, all Laws in force in Canada, Nova Scotia or New Brunswick at the Union, and all Courts of Civil and Criminal Jurisdiction, and all legal Commissions, Powers and Authorities, and all Officers, Judicial, Administrative and Ministerial existing therein at the Union, shall continue in Ontario, Quebec, Nova Scotia and New Brunswick respectively, as if the Union had not been made; subject nevertheless (except with respect to such as are enacted by or exist under Acts of the Parliament of Great Britain or of the Parliament of the United Kingdom of Great Britain and Ireland,) to be repealed, abolished or altered by the Parliament of Canada, or by the Legislature of the respective Province, according to the Authority of the Parliament or of that Legislature under this Act.

130. Until the Parliament of Canada otherwise provides, all Officers of the several Provinces having duties to discharge in relation to matters other than those coming within the classes of subjects by this Act assigned exclusively to the Legislatures of the Provinces shall be Officers of Canada, and shall continue to discharge the duties of their respective offices under the same liabilities, responsibilities and penalties as if the Union had not been made.

131. Until the Parliament of Canada otherwise provides, the Governor General in Council may from time to time appoint such Officers as the Governor General in Council deems necessary or proper for the effectual execution of this Act.

132. The Parliament and Government of Canada shall have all Powers necessary or proper for performing the obligations of Canada or of any Province thereof, as part of the British Empire, towards Foreign Countries, arising under Treaties between the Empire and such Foreign Countries.

133. Either the English or the French language may be used by any person in the Debates of the Houses of the Parliament of Canada and of the Houses of the Legislature of Quebec, and both those languages shall be used in the respective Records and Journals of those Houses; and either of those languages may be used by any person or in any pleading or process in or issuing from any Court of Canada established under this Act, and in or from all or any of the Courts of Quebec.

The Acts of the Parliament of Canada and of the Legislature of Quebec shall be printed and published in both those languages.

ONTARIO AND QUEBEC.

134. Until the Legislature of Ontario or of Quebec otherwise provides, the Lieutenant Governors of Ontario and Quebec may each appoint under the Great Seal of the Province the following Officers, to hold Office during pleasure, that is to say,—the Attorney General, the Secretary and Registrar of the Province, the Treasurer of the Province, the Commissioner of Crown Lands, and the Com-

missioner of Agriculture and Public Works, and in the case of Quebec the Solicitor General, and may, by order of the Lieutenant Governor in Council, from time to time prescribe the duties of those Officers, and of the several departments over which they shall preside or to which they shall belong, and of the Officers and Clerks thereof, and may also appoint other and additional Officers to hold office during pleasure, and may from time to time prescribe the duties of those Officers, and of the several departments over which they shall preside or to which they shall belong, and of the Officers and Clerks thereof.

135. Until the Legislature of Ontario or Quebec otherwise provides, all Powers, Duties, &c. Rights, Powers, Duties, Functions, Responsibilities or Authorities at the passing of this Act vested in or imposed on the Attorney General. Solicitor General. Secretary and Registrar of the Province of Canada, Minister of Finance, Commissioner of Crown Lands, Commissioner of Public Works, and Minister of Agriculture and Receiver General, by any Law, Statute or Ordinance of Upper Canada, Lower Canada or Canada, and not repugnant to this Act, shall be vested in or imposed on any Officer to be appointed by the Lieutenant Governor for the discharge of the same or any of them; and the Commissioner of Agriculture and Public Works shall perform the Duties and Functions of the Office of Minister of Agriculture at the passing of this Act imposed by the Law of the Province of Canada, as well as those of the Commissioner of Public Works.

136. Until altered by the Lieutenant Governor in Council, the Great Seals. Great Seals. of Ontario and Quebec respectively shall be the same, or of the same design as those used in the Provinces of Upper Canada and Lower Canada respectively before their Union as the Province of Canada.

137. The words "and from thence to the end of the then next ensuing Construction Session of the Legislature," or words to the same effect, used in any temporary Acts. Act of the Province of Canada not expired before the Union, shall be construed to extend and apply to the next Session of the Parliament of Canada if the subject matter of the Act is within the Powers of the same as defined by this Act or to the next Sessions of the Legislatures of Ontario and Quebec respectively if the subject matter of the Act is within the Powers of the same as defined by this Act.

141. The Penitentiary of the Province of Canada shall, until the Parliament of Canada otherwise provides, be and continue the Penitentiary of Ontario and of Quebec.

142. The division and adjustment of the debts, credits, liabilities, properties and assets of Upper Canada and Lower Canada shall be referred to the Arbitrament of three Arbitrators, one chosen by the Government of Ontario, one by the Government of Quebec, and one by the Government of Canada, and the selection of the Arbitrators shall not be made until the Parliament of Canada and the Legislatures of Ontario and Quebec have met, and the Arbitrator chosen by the Government of Canada shall not be a resident either in Ontario or in Quebec.

143. The Governor General in Council may from time to time order that such and so many of the Records, Books and Documents of the Province of Canada as he thinks fit shall be appropriated and delivered either to Ontario or to Quebec. and the same shall thenceforth be the property of that Province: and any Copy thereof or Extract therefrom, duly certified by the Officer having charge of the original thereof, shall be admitted as evidence.

144. The Lieutenant Governor of Quebec may from time to time, by Proclamation under the Great Seal of the Province, to take effect from a day to be appointed therein, constitute Townships in those parts of the Province of Quebec in which Townships are not then already constituted, and fix the metes and bounds thereof.

X.—INTERCOLONIAL RAILWAY.

145. Inasmuch as the Provinces of Canada, Nova Scotia and New Brunswick have joined in a declaration that the construction of the Intercolonial Railway is Parliament of essential to the consolidation of the Union of British North America, and to the assent thereto of Nova Scotia and New Brunswick, and have consequently agreed that provision should be made for its immediate construction by the Government of Canada: Therefore, in order to give effect to that Agreement, it shall be the duty of the Government and Parliament of Canada to provide for the commencement. within Six months after the Union, of a Railway connecting the River St. Lawrence with the City of Halifax in Nova Scotia, and for the construction thereof without intermission, and the completion thereof with all practicable speed.

XI.-ADMISSION OF OTHER COLONIES.

146. It shall be lawful for the Queen by and with the advice of Her Majesty's Most Honourable Privy Council, on Addresses from the Houses of the Parliament of Canada, and from the Houses of the respective Legislatures of the Colonies or Provinces of Newfoundland, Prince Edward Island and British Columbia, to admit those Colonies or Provinces, or any of them, into the Union, and on

147. - 74. The East Riding to consist of the Townships of Aspodel, Belmont and Methuen, Douro, Dummer, Galway, Harvey Minden, Stanhope and Dysart, Otonabee and Snowden, and the Village of Ashburnham, and any other surveyed Townships lying to the North of the said East Riding.

The County of HASTINGS, divided into Three•Ridings, to be called respectively the West, East, and North Ridings :---

- 75. The West Riding to consist of the Town of Belleville, the Township of Sydney, and the Village of Trenton.

DECLARATION OF QUALIFICATION.

I, A.B., do declare and testify, That I am by Law duly qualified to be appointed a Member of the Senate of Canada [or as the case may be], and that I am legally or equitably seised as of Freehold for my own use and benefit of Lands or Tenements held in Free and Common Socage [or seised or possessed for my own use and benefit of Lands or Tenements held in Franc-alleu or in Roture (as the case may be),] in the Province of Nova Scotia [or as the case may be] of the value of Four thousand Dollars over and above all Rents, Dues, Debts, Mortgages, Charges, and Incumbrances due or payable out of or charged on or affecting the same, and that I have not collusively or colourably obtained a title to or become possessed of the said Lands and Tenements or any part thereof for the purpose of enabling me to become a Member of the Senate of Canada [or as the case may be], and that my Real and Personal Property are together worth Four thousand Dollars over and above my debts and liabilities. 34 VIC., c. 28.

An Act respecting the establishment of Provinces in the Dominion of Canada.

[29th June, 1871.]

WHEREAS doubts have been entertained respecting the powers of the Parliament of Canada to establish Provinces in territories admitted, or which may hereafter be admitted, into the Dominion of Canada, and to provide for the representation of such Provinces in the said Parliament, and it is expedient to remove such doubts, and to vest such powers in the said Parliament:

Be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same as follows :

1. This Act may be cited for all purposes as "The British North Short title. America Act, 1871."

2. The Parliament of Canada may from time to time establish new Parliament of Provinces in any territories forming for the time being part of the Dominion of establish new Canada, but not included in any province thereof, and may, at the time of such Provinces and Canada, but not included in any province thereof, and may, at the time of such provide for the constitution and administration of any such constitution, Province, and for the passing of laws for the peace, order, and good government &c., thereof. of such Province and for its representation in the said Parliament.

The Parliament of Canada may from time to time, with the consent Alteration of 3. of the Legislature of any Province of the said Dominion, increase, diminish or limits of Provinces, otherwise alter the limits of such Province, upon such terms and conditions as may be agreed to by the said Legislature, and may, with the like consent, make provision respecting the effect and operation of any such increase or diminution or alteration of territory in relation to any Province affected thereby.

4. The Parliament of Canada may from time to time make provision for Parliament of Canada may the administration, peace, order and good government of any territory, not for legislate for the time being included in any province.

5. The following Acts passed by the said Parliament of Canada, and Confirmation intituled respectively :---

"An Act for the temporary government of Rupert's Land and the Canada, 32 & 33 Vic. " North Western Territory when united with Canada"; and

"An Act to amend and continue the Act 32 & 33 Vic., ch. 3, and 33 Vic. "to establish and provide for the government of the Province of (Canadian) cap. 3. " Manitoba,"

shall be and be deemed to have been valid and effectual for all purposes whatsoever from the date at which they respectively received the assent, in the Queen's name, of the Governor-General of the said Dominion of Canada.

Limitation of Canada to legislate for an established Province.

Except as provided by the third section of this Act, it shall not be 6. powers of Parliament of Canada to alter the provisions of the lastmentioned Act of the said Parliament in so far as it relates to the Province of Manitoba, or of any other Act hereafter establishing new Provinces in the said Dominion, subject always to the right of the Legislature of the Province of Manitoba, to alter from time to time the provisions of any law respecting the qualification of electors and members of the Legislative Assembly and to make laws respecting elections in the said Province.

An Act to amend and continue the Act 32 and 33 Victoria, chapter 3; and to establish and provide for the Government of the Province of Manitoba.

Assented to 12th May 1870.

WHEREAS it is probable that Her Majesty The Queen may, pursuant to Preamble. the British North America Act 1867 be pleased to admit Rupert's Land and the North-Western Territory into the Union or Dominion of Canada, before the next Session of the Parliament of Canada:

And Whereas it is expedient to prepare for the transfer of the said Territories to the Government of Canada at the time appointed by the Queen for such admission :

And Whereas it is expedient also to provide for the organization of part of the said Territories as a Province, and for the establishment of a Government therefor, and to make provision for the Civil Government of the remaining part of the said Territories, not included within the limits of the Province:

Therefore Her Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:

1. On, from and after the day upon which the Queen, by and with the be formed advice and consent of Her Majesty's Most Honorable Privy Council, under the out of N.W. authority of the 146th Section of the British North America Act, 1867, shall, by when united Order in Council in that behalf, admit Rupert's Land and the North-Western to Canada. Territory into the Union or Dominion of Canada, there shall be formed out of Its name and the same a Province, which shall be one of the Provinces of the Dominion of boundaries. Canada, and which shall be called the Province of Manitoba, and be bounded as follows: that is to say, commencing at the point where the meridian of ninetysix degrees west longitude from Greenwich intersects the parallel of forty-nine degrees north latitude,-thence due west along the said parallel of forty-nine degrees north latitude (which forms a portion of the boundary line between the United States of America and the said North-Western Territory) to the meridian of ninety-nine degrees of west longitude,-thence due north along the said meridian of ninety-nine degrees west longitude, to the intersection of the same with the parallel of fifty degrees and thirty minutes north latitude,—thence due east along the said parallel of fifty degrees and thirty minutes north latitude to its intersection with the before-mentioned meridian of ninety-six degrees west longitude,-thence due south along the said meridian of ninety-six degrees west longitude to the place of beginning.

2. On, from and after the said day on which the Order of the Queen in Certain pro-Council shall take effect as aforesaid, the provisions of the British North America visions of B. N. A. Act Act 1867, shall, except those parts thereof which are in terms made, or by 1867 to apply reasonable intendment, may be held to be specially applicable to, or only to affect to Manitoba. one or more, but not the whole of the Provinces now composing the Dominion, and except so far as the same may be varied by this Act, be applicable to the Province of Manitoba, in the same way, and to the like extent as they apply to

the several Provinces of Canada, and as if the Province of Manitoba had been one of the Provinces originally united by the said Act.

3. The said Province shall be represented in the Senate of Canada by two Members, until it shall have, according to the decennial census, a population of fifty thousand souls, and from thenceforth it shall be represented therein by three Members, until it shall have, according to decennial census, a population of seventy-five thousand souls, and from thenceforth it shall be represented therein by four Members.

4. The said Province shall be represented, in the first instance, in the House of Commons of Canada, by four Members, and for that purpose shall be divided by proclamation of the Governor General, into four Electoral Districts, each of which shall be represented by one Member: Provided that on the completion of the census in the year 1881, and of each decennial census afterwards, the representation of the said Province shall be re-adjusted according to the provisions of the fifty-first section of the British North America Act, 1867.

5. Until the Parliament of Canada otherwise provides, the qualification of voters at Elections of Members of the House of Commons shall be the same as for the Legislative Assembly hereinafter mentioned : And no person shall be qualified to be elected, or to sit and vote as a Member for any Electoral District, unless he is a duly qualified voter within the said Province.

6. For the said Province there shall be an officer styled the Lieutenant-Governor, appointed by the Governor General in Council by instrument under the Great Seal of Canada.

7. The Executive Council of the Province shall be composed of such persons, and under such designations, as the Lieutenant-Governor shall, from time to time think fit; and, in the first instance, of not more than five persons.

8. Unless and until the Executive Government of the Province otherwise directs, the seat of Government of the same shall be at Fort Garry, or within one mile thereof.

9. There shall be a Legislature for the Province, consisting of the Lieutenant-Governor, and of two Houses, styled respectively, the Legislative Council of Manitoba, and the Legislative Assembly of Manitoba.

10. The Legislative Conncil shall, in the first instance, be composed of seven Members, and after the expiration of four years from the time of the first appointment of such seven Members, may be increased to not more than twelve Members. Every Member of the Legislative Council shall be appointed by the Lieutenant-Governor in the Queen's name, by Instrument under the Great Seal of Manitoba, and shall hold office for the term of his life, unless and until the Legislature of Manitoba otherwise provides under the British North America Act, 1867.

11. The Lieutenant-Governor may, from time to time, by Instrument under the Great Seal, appoint a Member of the Legislative Council to be Speaker thereof, and may remove him and appoint another in his stead.

12. Until the Legislature of the Province otherwise provides, the presence of a majority of the whole number of the Legislative Council, including the

Speaker, shall be necessary to constitute a meeting for the exercise of its powers.

Questions arising in the Legislative Council shall be decided by a Voting. 13. majority of voices, and the Speaker shall, in all cases, have a vote, and when the Equality of votes. voices are equal the decision shall be deemed to be in the negative.

14. The Legislative Assembly shall be composed of twenty-four Members, Legislative Assembly. to be elected to represent the Electoral Divisions into which the said Province may be divided by the Lieutenant-Governor, as hereinafter mentioned.

The presence of a majority of the Members of the Legislative Assembly Quorum. 15. shall be necessary to constitute a meeting of the House for the exercise of its powers; and for that purpose the Speaker shall be reckoned as a Member.

The Lieutenant-Governor shall (within six months of the date of the Electoral Divisions. 16. Order of Her Majesty in Council, admitting Rupert's Land and the North-Western Territory into the Union), by Proclamation under the Great Seal, divide the said Province into twenty-four Electoral Divisions, due regard being had to existing Local Divisions and population.

Every male person shall be entitled to vote for a Member to serve in Qualification 17 of voters. the Legislative Assembly for any Electoral Division, who is qualified as follows, that is to say, if he is :---

1. Of the full age of twenty one years, and not subject to any legal incapacity:

2. A subject of Her Majesty by birth or naturalization :

And a bona fide householder within the Electoral Division, at the 3. date of the Writ of Election for the same, and has been a bond fide householder for one year next before the said date; or,

4. If, being of the full age of twenty-one years, and not subject to any Special,-for legal incapacity, and a subject of Her Majesty by birth or naturalization, he only. was, at any time within twelve months prior to the passing of this Act, and (though in the interim temporarily absent) is at the time of such election a bona fide householder, and was resident within the Electoral Division at the date of the Writ of Election for the same:

But this fourth sub-section shall apply only to the first election to be Proviso. held under this Act for Members to serve in the Legislative Assembly aforesaid.

For the first election of Members to serve in the Legislative Assembly, Proceedings 18. and until the Legislature of the Province otherwise provides, the Lieutenant- at first election, &c.,-Governor shall cause writs to be issued, by such person, in such form, and how regulated. addressed to such Returning Officers as he thinks fit; and for such first election, and until the Legislature of the Province otherwise provides, the Lieutenant-Governor shall, by Proclamation, prescribe and declare the oaths to be taken by voters, the powers and duties of Returning and Deputy Returning Officers, the proceedings to be observed at such election, and the period during which such election may be continued, and such other provisions in respect to such first election as he may think fit.

Every Legislative Assembly shall continue for four years from the date Duration of 19. of the return of the writs for returning the same (subject nevertheless to being Assembly,

first election

sooner dissolved by the Lieutenant-Governor), and no longer; and the first Session thereof shall be called at such time as the Lieutenant-Governor shall appoint.

20. There shall be a Session of the Legislature once at least in every year, so that twelve months shall not intervene between the last sitting of the Legislature in one Session and its first sitting in the next Session.

21. The following provisions of the British North America Act, 1867, respecting the House of Commons of Canada, shall extend and apply to the Legislative Assembly, that is to say: — Provisions relating to the election of a Speaker, originally, and on vacancies — the duties of the Speaker, —the absence of the Speaker and the mode of voting, as if those provisions were here re-enacted and made applicable in terms to the Legislative Assembly.

22. In and for the Province, the said Legislature may exclusively make Laws in relation to Education, subject and according to the following provisions :---

(1.) Nothing in any such Law shall prejudicially affect any right or privilege with respect to Denominational Schools which any class of persons have by Law or practice in the Province at the Union :

(2.) An appeal shall lie to the Governor-General in Council from any Act or decision of the Legislature of the Province, or of any Provincial Authority, affecting any right or privilege of the Protestant or Roman Catholic minority of the Queen's subjects in relation to Education:

(3.) In case any such Provincial Law, as from time to time seems to the Governor-General in Council requisite for the due execution of the provisions of this section, is not made, or in case any decision of the Governor-General in Council on any appeal under this section is not duly executed by the proper Provincial Authority in that behalf, then, and in every such case, and as far only as the circumstances of each case require, the Parliament of Canada may make remedial Laws for the due execution of the provisions of this section, and of any decision of the Governor-General in Council under this section.

23. Either the English or the French language may be used by any person in the debates of the Houses of the Legislature, and both those languages shall be used in the respective Records and Journals of those Houses; and either of those languages may be used by any person, or in any Pleading or Process, in or issuing from any Court of Canada established under the British North America Act, 1867, or in or from all or any of the Courts of the Province. The Acts of the Legislature shall be printed and published in both those languages.

24. Inasmuch as the Province is not in debt, the said Province shall be entitled to be paid, and to receive from the Government of Canada, by half-yearly payments in advance, interest at the rate of five per centum per annum on the sum of four hundred and seventy-two thousand and ninety dollars.

25. The sum of thirty thousand dollars shall be paid yearly by Canada to the Province, for the support of its Government and Legislature, and an annual grant, in aid of the said Province, shall be made, equal to eighty cents per head of the population, estimated at seventeen thousand souls; and such grant of eighty cents per head shall be augmented in proportion to the increase of

Sessions at least once a year.

28. Such provisions of the Customs Laws of Canada (other than such as Customs prescribe the rate of duties payable) as may be from time to time declared by the Governor General in Council to apply to the Province of Manitoba, shall be applicable thereto, and in force therein accordingly.

Such provisions of the Laws of Canada respecting the Inland Revenue, Inland 29.including those fixing the amount of duties, as may be from time to time declared and duties. by the Governor General in Council applicable to the said Province, shall apply thereto, and be in force therein accordingly.

30. All ungranted or waste lands in the Province shall be, from and after Ungranted the date of the said transfer, vested in the Crown, and administered by the lands vested in the Crown Government of Canada for the purposes of the Dominion, subject to, and except for Dominion and so far as the same may be affected by, the conditions and stipulations ^{purposes.} contained in the agreement for the surrender of Rupert's Land by the Hudson's Bay Company to Her Majesty.

31. 32. For the quieting of titles, and assuring to the settlers in the Province the peaceable possession of the lands now held by them, it is enacted as follows:—

1. All grants of land in freehold made by the Hudson's Bay Company up to the eighth day of March, in the year 1869, shall, if required by the owner, be confirmed by grant from the Crown.

2. All grants of estates less than freehold in land made by the Hudson's Bay Company up to the eighth day of March aforesaid, shall, if required by the owner, be converted into an estate in freehold by grant from the Crown.

3. All titles by occupancy with the sanction and under the license and authority of the Hudson's Bay Company up to the eighth day of March aforesaid, of land in that part of the Province in which the Indian Title has been extinguished, shall, if required by the owner, be converted into an estate in freehold by grant from the Crown.

4. All persons in peaceable possession of tracts of land at the time of the transfer to Canada, in those parts of the Province in which the Indian Title has not been extinguished, shall have the right of pre-emption of the same, on such terms and conditions as may be determined by the Governor in Council.

5. The Lieutenant-Governor is hereby authorised, under regulations to be made from time to time by the Governor General in Council, to make all such provisions for ascertaining and adjusting, on fair and equitable terms, the rights of Common, and rights of cutting Hay held and enjoyed by the settlers in the Province, and for the commutation of the same by grants of land from the Crown.

33. The Governor General in Council shall from time to time settle and appoint the mode and form of Grants of Land from the Crown, and any Order in Council for that purpose when published in the *Canada Gazette*, shall have the same force and effect as if it were a portion of this Act.

34. Nothing in this Act shall in any way prejudice or affect the rights or properties of the Hudson's Bay Company, as contained in the conditions under which that Company surrendered Rupert's Land to Her Majesty.

35. And with respect to such portion of Rupert's Land and the North-Western Territory, as is not included in the Province of Manitoba, it is hereby enacted, that the Lieutenant-Governor of the said Province shall be appointed, by Commission under the Great Seal of Canada, to be the Lieutenant-Governor of the same, under the name of the North-West Territories, and subject to the provisions of the Act in the next section mentioned.

36. Except as hereinbefore is enacted and provided, the Act of the Paliament of Canada, passed in the now last Session thereof, and entitled, "An Act for the Temporary Government of Rupert's Land, and the North-Western Territory when united with Canada," is hereby re-enacted, extended and continued in force until the first day of January, 1871, and until the end of the Session of Parliament then next succeeding.

[Assented to May 3rd, 1871.]

HER MAJESTY by and with the advice and consent of the Legislative Council and Legislative Assembly of Manitoba, enacts as follows:

The Lieutenant-Governor in Council may appoint not less than ten nor Constitution 1. more than fourteen persons to be a Board of Education for the Province of ^{of Board} of Education. Manitoba, of whom one-half shall be Protestants, and the other half Catholics.

20. On the first Monday of February in each year after the passing of this Act beginning with the year 1872, a meeting of the male inhabitants of each school district, of the age of 21 years and upwards, shall be called by the superintendent of the section to which the district belongs by notice posted by him in public places in the district.

It shall be the duty of the Council of the municipalities to establish and alter when necessary the school districts within their bounds, and if any of the said Councils shall refuse or neglect so to do, then, on the petition of at least five of the ratepayers of the school district or proposed school district of the section of the Board of Education to which the same belongs, the said section of the Board shall establish or alter the same as may by them be deemed expedient.

(a) The establishment of a school district of one denomination shall not prevent the establishment of a school district of the other denomination in the same place, and a Protestant and a Catholic district may include the same territory in whole or in part.

(b) In territory not lying within the limits of an organized municipality, the Protestant section of the Board of Education shall have power to establish and alter school districts for Protestants, and the Catholic section shall have the same power with regard to Catholics.

13. The municipal councils or sections of the board of education shall make such regulations, in accordance with this act as to them respectively may seem fit, as to the mode of proceeding in effecting the establishment or alteration of school districts; they shall appoint a day for the first school meeting, but no alteration or re-adjustment of any school district made after the first day of September, shall take effect until the first day of February following.

(a) In cases where it may be considered desirable to form school districts out of territories within the bounds of different municipalities, the establishment or re-adjustment of such districts shall be effected by the joint action of the municipalities concerned, and in such manner, consistent with the provisions of this Act, as to the councils of the said municipalities may seem convenient.

(b) In all cases of the establishment or re-adjustment of school districts by one or more municipalities, an appeal from the decision of the council of such municipality or municipalities, on any question of boundary, shall lie to the Protestant or Catholic section of the board of education as the case may be, and the decision of the section it concerns shall be final; provided that no such appeal shall lie, unless the notice thereof signed by at least five of the resident freeholders and householders of the Territory affected be Protestants or Catholics, as the case may be, be lodged with the superintendent of the section to which the districts belongs, within one month from the date of the operation complained of, the notice of appeal shall state in full the question at issue, the action taken thereon, and the relief prayed for.

(c) In all cases where application is made to a municipality or to either of the sections of the board of education, by five heads of families, resident within territory, that will form a reasonably sized school district, containing at least fifteen children of school age, none of whom reside in an existing district of the same denomination, a school district shall be formed under this Act.

At the first election of school trustees in cities and towns, the first person nominated and having the majority of votes in each ward shall continue in office for two years to be reckoned from the annual meeting next after his election and until his successor has been elected; the second person elected in each ward shall continue in office one year to be reckoned from the same period and until his successor has been elected, and the third or last person to be elected in each ward shall continue in office until the next ensuing annual school meeting, and until his successor has been elected, and each of the successors so elected as aforesaid.

ANNUAL SCHOOL MEETINGS.

20. On the first Monday of February in each year, a meeting of the ratepayers of each school district of the age of twenty-one years and upwards, shall be called by the Board of Trustees by notice posted by them on a school-house if there is one, or in public places in the district, at least three weeks in advance; and the majority of the electors present shall choose one or more persons, as the case may be, to be school trustees for the district; if such notice to be given, is not so given, the proceedings of the annual meeting, if held on the day prescribed by law, shall not be invalidated thereby.

21. When in a district for any cause, the annual school meeting has not been held on the first Monday in February, the trustees shall appoint another day for the holding of such meeting, provided that if the trustees fail to call such meeting, the superintendent of the section to which the district belongs shall call it.

22. In incorporated cities and towns all annual meetings in each ward shall be held on the first Monday of February in every year, commencing at ten o'clock in the forenoon, and shall be called by the chairman of the respective boards of school trustees. It shall be the duty of the said boards to furnish the chairman of every such meeting with a copy of the Protestant or Catholic voters' list for such ward, as the case may be.

SCHOOL ASSESSMENT.

25. For the purpose of supplementing the legislative grant it shall be School the duty of the boards of trustees of all school districts, the whole territory of which is comprised within the limits of a single municipality, from time to time to prepare and lay before the Municipal Council an estimate of such sums as may be required for school purposes during the current school year. This estimate shall be laid before the Council on or before the first day of September, whereupon the said Council, employing their own lawful authority, shall forthwith levy and collect the said sums by assessment on the real and personal property within the school district, and shall pay over the same to the Board of Trustees as collected; or the Council may from time to time advance to any such Board of Trustees any sum or sums which they may think proper pending the collection of the said moneys.

26. estimated value of the property and provided also that nothing in this Act shall prevent any Board of School Trustees from levying and collecting the school rates and taxes themselves by their own machinery, in districts lying outside of municipalities or when a Municipal Council refuses or neglects to do so.

And be it further provided, that in cases where resort must be had to the sale of lands and tenements for the collection of school rates the proceedings therefor shall be taken by the Council of the municipality under the Muncipalities Act.

27. The school assessment shall be laid equally according to valuation upon rateable real and personal property, in the school district and shall be payable by and recoverable from the owner, occupier or possessor of the property liable to be rated, and shall, if not paid, be a special mortgage, and not requiring registration to preserve it, on all real estate, except live stock and farming implements to the value of five hundred dollars belonging to *bonâ fide* owners of real estate of at least forty acres.

28. The corporations situated in a locality where different school districts are established and persons who are neither Protestants nor Catholics shall be assessed only for the school district of the majority; yet out of such assessment they shall give to the school district of the minority a part of such assessment in proportion to the number of children of school age, and the majority shall be determined by the number of Protestant or Catholic children of school age, as the case may be, according to the census.

 of 29. The following real and personal property shall be exempt from $_{ty}$ taxation under this Act—

(1.) Real estate held in trust for Her Majesty, or for the public uses of the Province :

(2.) Real estate vested in, or held in trust for the municipality, and used for municipal purposes :

(3.) Real estate held in trust for any tribe or body of Indians :

(4.) Every place of public worship, churchyard, burying grounds, educational or charitable institutions, public roadway, square, gaol, hospital, agricultural and horticultural societies, with the land requisite for the due enjoyment thereof:

(5.) Lands allotted by the Dominion Lands Act to half-breed children of heads of families under the age of eighteen years, not disposed of by them.

30. The ratepayers of a school district, including religious, benevolent, or educational corporations, shall pay their respective assessments to the schools of their respective denominations; and in no case shall a Protestant ratepayer be obliged to pay for a Catholic school, or a Catholic ratepayer for a Protestant school.

31. When property owned by a Protestant is occupied by a Roman Catholic and vice versa, the tenant in such cases shall only be assessed for the amount of property he owns, whether real or personal, but the school taxes on said rented or leased property shall, in all cases, and whether or not the same has been, or is stipulated in any deed, contract or lease whatever, be paid to the trustees of the section to which belongs the owner of the property so leased or rented, and to no other, subject to the exemptions aforesaid.

32. Whenever property is held jointly as tenants or as tenants in common,

SCHOOL TRUSTEES.

The school trustees in each school district, shall be a corporation under School Trus-34. tees to be a the name of "the school trustees for the Protestant (or Catholic, as the case may be) corporation. ;" they shall have school district of in the county of perpetual succession, and a common seal, if they think proper to have one; they may sue, and be sued, and shall generally have the same powers which any other body politic or corporate has, or ought to have, with regard to the purposes for which it is constituted.

35. Except as elsewhere provided, the time of holding office as school Exception. Trustee shall be three years.

36. Every trustee shall within eight days after his election, make the following declaration before the chairman of the school meeting at which he was elected, or before a Justice of the Peace :

"I will truly and faithfully, to the best of my judgment and ability, Declaration of school trustee. discharge the duties of the office of school trustee, to which I have been elected"; and a certificate of the declaration shall be produced at the first meeting of the board of trustees which he attends.

37. The school trustees shall meet within ten days after receiving notice Choosing a of their election, for the purpose of choosing a chairman and a secretary-treasurer, chairman and secretary. and transacting such other business as may be required.

(a.) In case of absence of the chairman from any meeting of the board, the then assembled school trustees shall elect one of their number to act in that capacity for the time being, who shall then be vested with the same powers and privileges as the ordinary chairman.

In the meetings of the school trustees all questions shall be decided by Questions to 38. the majority of votes, and the chairman shall have the right to vote, but in case be decided by a majority. of an equality of votes the question shall be decided in the negative.

39. It shall be the duty of the board of trustees :

To take possession and have the custody and safe keeping of all Trustees. (a)common school property, which has been acquired or given for common school purposes under this Act, in their district, and such corporation shall be empowered to acquire and hold, as a corporation, by any title whatsoever, any land, moveable property, moneys, or income for school purposes, and to apply the same according to the terms on which the same was acquired, or received, but they shall not without the sanction of the section of the Board of Education to which they belong have power to alienate or dispose of any school real estate.

(b) To do whatever they may judge expedient with regard to building, repairing, renting, warming, furnishing, and keeping in order the schoolhouse or

schoolhouses in their district, its furniture and appendages, and the school land and enclosures held by them, and for procuring apparatus and school books for their school, and when there is no suitable schoolhouse belonging to the district, or when a second schoolhouse is required, then, to build, rent, repair, furnish, warm, and keep in order, a house and its appendages to be used as a schoolhouse.

(c) To contract with and employ such teachers exclusively who hold certificates from that section of the Board of Education, through which they receive the legislative grant, and such contract shall be in writing and signed by the contract ing parties.

(d) To provide for the salaries of teachers, and all other expenses of the school.

(e) To visit the school once a month, for the purpose of seeing that it is conducted according to the prescribed regulations of the Board of Education; and the school trustees, or any of them, shall, if necessary, make any suggestions in accordance with the said regulations, with a view to the more efficient working of the school, and should the teacher fail to act upon them, the matter shall be referred to the whole body of trustees, who shall report to the superintendent.

(f) To see that the discipline of the school is properly enforced; at duly called meetings of the board of trustees to expel unmanageable pupils, on the complaint of the teacher; to deal with complaints and appeals from parents or the teacher; and hold meetings to enquire into the same.

(g) To keep a record of their proceedings, signed for each sitting by the chairman and secretary, and also correct accounts of their receipts and expenditures, with reference to the school or schools under their control, mentioning specially what relates to each school, and such account shall at all reasonable hours be open to the inspection of the ratepayers of the school district.

(h) To admit as pupils of the school any non-resident or other children whose parents are not ratepayers to the school district and who reside nearer to such school than to the school in their own district; and to charge a sum not exceeding 50 cents per month for each of such pupils: provided, that in case of dispute as to the distance the inspector shall decide.

40. No act or proceeding of a board of trustees shall be deemed valid or binding on any party which is not adopted at a regular or special meeting of the corporation, of which notice shall have been given by either one of their body, or the person chosen by them to act as secretary-treasurer, to all the trustees, and a majority of the trustees at such meeting shall have full authority to perform any lawful business.

41. It shall not be lawful for any trustee to enter into a contract with the corporation of which he is a member, or to have any pecuniary claim on such corporation, except for a school site, or as a collector of school rates, and then only when he shall have been appointed by the other two members of the corporation.

 $\frac{42}{10}$ No school trustee shall be teacher or inspector of any school in his school district.

43. No school trustee shall be re-elected, except by his own consent, during the four years next after his going out of office.

44. Any person chosen as trustee may resign with the consent expressed May resign. in writing of his colleagues in office, and a continuous non-residence of three months, shall cause the vacation of his office.

45. In all cases of vacancy, another trustee shall be elected at a meeting Vacancy. called by the trustees or trustee remaining in office, and the person so elected shall hold office for the unexpired term of the trustee whom he replaces: provided that if the vacancy is not filled within one month, the superintendent shall appoint some qualified person to fill it.

46. In all cases of prolonged incapacity arising from sickness, no election Incapacity. or appointment to fill the said office shall take place, upless the said incapacity has been established by the certificate of a physician, deposited with the secretarytreasurer, and the vacancy arising from such incapacity shall date from the day of the deposit of such certificate.

47. The board of school trustees or their secretary-treasurer shall have at school trusall times during office hours free access to the assessment roll of the municipality, and they shall be permitted to copy therefrom that portion of it having sessment roll. reference to their respective school districts, together with the names and amount for which each individual is assessed.

48. In any city or town, incorporated, or that may hereafter be incor- Incorporated porat ed, divided into wards, there shall be elected on a day to be named by the city-three trustees for Lieu tenant-Governor-in-Council, three school trustees for each ward, to be each ward to be elected. elected by the ratepayers of such ward, and such trustees shall be the trustees of the school district, provided that the minority be Roman Catholic or Protestant ratepayers, as the case may be, shall be at liberty to elect three trustees as provided for ordinary districts, and the trustees so in anywise elected shall be the trustees of such district.

49. If any trustee in cities and towns shall absent himself for three months Absence of from the meetings of the board of school trustees, without being authorized so to three months. do by a resolution of the board, or if he ceases to reside in the school district for a period of three months consecutively, his seat shall thereby become vacant.

50. The Boards of Trustees in cities and towns shall have power:

(a) To appoint a school inspector, to fix the remuneration to be paid boards of trustees in him, and to determine his duties; but such appointment requires the approval of cities and the respective sections of the Board of Education :

(b) To levy at their discretion any school rates upon the parents or guardians of children attending the schools of the town or city, such rates not to exceed fifty cents per month, on resident pupils or pupils whose parents or guardians own property in the city or town, and not more than one dollar per month, on non-resident pupils, or pupils whose parents or guardians live outside of such city or town and are not the owners of property therein; and to employ the same means of collecting such rates as by the city collector are possessed for the collection of property tax, and and all school rates collected shall be paid into the hands of the secretary-treasurer for public school purposes, and subject to the disposal of the Board of School Trustees;

The school Trustees in cities or towns shall have power to make (c)by-laws, which however must, before they can be enforced, receive the approval of the section of the Board of Education concerned.

51. In case the Board of School Trustees of any city or town deem it Estimates.

advisable so to do, they may make out an estimate of the sum required in any year for educational purposes, and on or before the first day of September in each and every year they shall provide the clerk of the city or town with such estimate, accompanied with a list of the names of the persons liable to be assessed for the support of the public school or schools of which the Board applying are the Trustees; and it shall be the duty of the Council of such city or town to levy and collect the amount demanded with the corporation taxes, and to pay over the same to the Board of School Trustees when elected; or the Council may from time to time advance to any Board of School Trustees within their municipality any sum or sums which they may think proper, pending the collection of the school taxes.

52. It shall be the duty of the board of school trustees in cities and towns on or before the fifteenth day of January in each year :

(a.) To prepare and publish in one or more public newspapers, or on printed sheets, for the information of ratepayers of the city or town, an annual report of the proceedings and of the progress and state of the schools under their charge and of their receipts and expenditures of all school moneys and to make all returns required by the Board of Education for the province, or the sectional board under whose jurisdiction the schools are.

DISQUALIFICATION OF SCHOOL TRUSTEES.

53. Except as provided in clause sixteen, no person shall be eligible to be elected or to serve as a school Trustee who is not a resident ratepayer of the district or ward which he proposes to represent.

54. No person convicted of felony or of an infamous crime shall be eligible to be elected as a school trustee.

SECRETARY-TREASURER.

55. The trustees shall appoint as secretary-treasurer one of their own number, or some other competent person, and the duties of such secretary-treasurer shall include:

(a.) The correct and safe-keeping and producing (when called for) of the papers and moneys belonging to the corporation:

(b.) The correct keeping of a record of all their proceedings in a book procured for that purpose; and

(c.) The collecting, receiving and accounting for, of all school moneys whether from the Government or otherwise, for the purpose of public school education within his district and the distributing of such moneys in the manner directed by the majority of the trustees.

56. Every secretary-treasurer shall, before entering upon his duties as such, give security to the school Trustees by a bond signed and acknowledged before a Justice of the Peace, and such security shall be given by at least two solvent sureties, jointly and severally, to the satisfaction of the Board of School Trustees, and for the total amount of the moneys for which the secretary-treasurer may at any time be responsible, whether arising from the local school fund or from any particular contribution or donation paid into his hands for the support of schools, and such security shall be renewed or changed whenever its renewal or change is required by the school Trustees.

57. When the assessment is made by the trustees, the secretary-treasurer To receive shall receive the assessment roll from the assessors, and shall thereupon notify roll each person whose name appears on said roll of the amount for which he is assessed, and such assessment roll shall be open at all reasonable hours to the inspection of any ratepayer of the school district, and every such ratepayer shall be entitled to receive a copy thereof on payment to the secretary-treasurer at the rate of five-cents per name on such roll.

The secretary-treasurer shall notify, in accordance with schedule, each Court of re-(a)person whose name appears on the assessment roll, of the date and the place fixed by the school trustees for the sitting of the court of revision.

(b) The secretary-treasurer shall, within one month after receiving the Assessment assessment roll from the assessors, lay the same before the board of trustees, before board. and after the said board have struck the rate, he shall receive the roll from them for the purpose of collection.

58. Every secretary-treasurer shall prepare and submit to the board of Statement of school trustees annually, previous to the general meeting of the ratepayers, a expenditures. detailed statement of receipts and expenditures of the school district for the current school year then expiring, and such statement after being approved by the school trustees shall be by them submitted at the annual meeting of the school district, and the secretary-treasurer shall, on the payment to him of the sum of one dollar, furnish to any ratepayer a copy of such statement.

59. The remuneration of the secretary-treasurer may, in the discretion of Remuneration the school trustees, be fixed at any amount not exceeding eight per cent. on the discretary-treasurer. moneys received by him in such capacity, but such remuneration shall include every service which the trustees may require from time to time from the secretarytreasurer, and shall cover all contingent expenses whatever, except such as may be specially authorized by rules and regulations of the respective section of the board of education, and shall not in any case exceed the sum of one hundred dollars.

60. In incorporated cities and towns the board of trustees shall have power School trustees in cities to appoint one of their number or some other person, as the majority of the to appoint board may decide, to be their secretary-treasurer, to determine the amount of secretary-treasurer. salary to be paid such officer, and to impose by by-law such additional duties as Duties. may be required by the board of school trustees; and he shall be subject to the same duties, obligations and penalties as are imposed by this Act.

PROSECUTION BY OR OF SCHOOL TRUSTEES.

The school trustees of any school district may institute suits, or pro-Suits for col-61. secutions for the school assessments, assessment for school houses, and for all rates, &c. arrears of the said assessments and monthly fees, and such suits or prosecutions may be instituted before the county court or before two justices of the peace of the county, and the justices may after judgment cause the amount of the judgment, together with the costs thereof to be levied under warrant, by the seizure and sale of the goods and chattels of the defendant, such seizure and sale to be effected by the secretary-treasurer, who shall for that purpose have and execute the power of sheriff, and who shall be entitled for such services to the same fees as the said officer.

Court of revision. 62. In all such suits of prosecutions judgment may be rendered with costs, and no judgment rendered on any such suits or prosecutions shall be liable to be appealed from, nor shall any such suit or prosecution be renewed by writ of certiorari.

63. No member of any board of school trustees shall engage in any suit at law as such trustee, as plaintiff without a special authorization from the trustees, duly entered in the minutes, after deliberation; and every such action may be brought either by the chairman or by the secretary-treasurer, in the name of the corporation, as the board may see fit.

64. All persons entrusted in any manner with the carrying of this Act into effect, or qualified to vote at the election of school trustees, shall be competent to institute proceedings under this Act except in cases where it is specially provided to the contrary.

65. All contestations with regard to the election of school trustees, and to the functions and powers assumed by school trustees or any of them, or their officers, or by any person or persons claiming to be such trustee or trustees, or officer or officers, may by any competent person be brought, by a petition setting forth the case, of which a copy must have been served on the parties concerned, before the County Court at its next sitting, and shall then be determined in a summary manner on the evidence adduced.

66. Any school trustee whose election has been obtained by fraud or stratagem or by the votes of persons not qualified as electors, or any person usurping the functions of school trustee, or illegally holding that office, may be summarily prosecuted, at the instance of any party interested, or several collectively interested, before any one of the judges of the county court of the county in which such election, usurpation or illegal retention of office has taken place for the purpose of declaring such election, or such retention of office, illegal and such seat vacant.

67. It shall be the duty of any judge of the Court of Queen's Bench or of the County Court of this Province or any stipendiary magistrate, to investigate and decide any complaints which may be made in the manner provided by the statute in that behalf, in regard to the election of any school trustee, or in regard to any proceeding at any school meeting : provided always that no complaints in regard to any election or proceeding at any school meeting shall be entertained, unless made in writing within twenty days after the holding of such election or meeting. The costs and expenses of any such investigation shall be paid by the parties concerned in it, as such judge or magistrate may decide.

68. The school trustees shall be constituted a court of revision for hearing and deciding any complaints that may be made against any assessment made under their authority, and shall sit as such at any time fixed by the trustees after eight days notice given by posters in three public places of the district, by the secretary-treasurer; and the decision of the said court of revision shall be final, when the amount to be paid shall not exceed twenty dollars; and the members of the said court of revision shall be empowered to administer oath while sitting as such; and every appeal from the decision of such court of revision shall be heard and determined finally at the next sitting of the county court, within the jurisdiction of which the school district is situated.

QUORUM.

The quorum of any corporation, board or body constituted under this Quorum. **6**9. Act. shall (unless otherwise expressly declared) be an absolute majority of all the members thereof: and the majority of the members present at any meeting regularly held, at which there shall be a quorum, may validly exercise the powers of the corporation.

ASSESSORS.

The school trustees may within twenty days after the annual school Assessors. 70. meeting, appoint one or more assessors from the resident ratepayers, provided the district is not included within a municipality, or the municipal council refuses or neglects to do so, and such remuneration shall be paid to such assessor as the board shall see fit.

71. Before entering upon the discharge of their duties, such assessors shall Assessors to be sworn, before a justice of the peace, to the faithful discharge of their duties. and they shall within two weeks after their appointment, proceed to make out an assessment roll of the rateable property of each ratepayer in the school district, and shall deliver the same into the hands of the secretary-treasurer of the school trustees within one month thereafter.

COLLECTORS.

When a school district is not included within a municipality, or a Collectors. 72.Municipal Council refuses or neglects to do so, the Trustees of any school district may appoint a fit person to be a collector of school taxes, the collector may be one of the school Trustees or the secretary treasurer, and in all such cases, the school Trustees shall have power to provide for the remuneration of such collector.

73. In incorporated cities and towns the Boards of Trustees of the minority In incorpomay appoint a fit and proper person to act as collector of school rates and school rate of paytaxes, and to pay such collector not more than five per cent. on the moneys ment to collected by him, such collector shall give satisfactory security to the Board of School Trustees; he shall have the same powers in the collection of school taxes that the collector of the city or town possesses for the collection of municipal taxes, and all moneys collected by him, shall, on demand, be paid over into the hands of the secretary-treasurer of the Board of School Trustees for public school purposes.

AUDITORS.

74. At every annual meeting of any school district there may be appointed Auditors. by the ratepayers, one or more auditors or persons to examine the accounts of the secretary-treasurer of the school Trustees and report thereon at the next annual meeting, and who shall certify to the correctness or otherwise of such accounts.

(d.) To keep a visitors' book (which the trustees shall provide) and enter therein the visits made to his school, and to present such book to every visitor, and request him to make therein any remarks suggested by his visit:

(e.) To give the trustees and visitors access at all times, when desired by them, to the registers and visitors' book appertaining to the school:

(f.) To deliver up any school registers, visitors' book, schoolhouse key, or other school property in his possession, on the demand or order of the board of school trustees employing him:

(g.) To have at the end of every half-year at least, a public examination of his school, of which he shall give due public notice :

(h.) To furnish to his superintendent, or to the inspector of such schools concerned, any information which it may be in his power to give, respecting anything connected with the working of his school, or in anywise affecting his interests or character.

76. All agreements between trustees and teachers, to be valid and binding, shall be in writing and signed by the teacher and the chairman of the board of school trustees employing him, and sealed with the corporate seal, if any, of the trustees.

77. In case of sickness, certified by a medical man, every teacher shall be entitled to his salary during such sickness for a period not to exceed four weeks for the entire year, which period may be increased by the board of school trustees; provided that such trustees employ a legally qualified person to supply his place during sickness.

INSPECTORS.

78. The sections of the board of education shall have power to appoint inspectors who shall hold office during the pleasure of the section appointing them; to define their duties, and to provide for their remuneration, and such inspectors shall visit the schools and report thereon at least twice a year.

79. The Boards of Trustees of cities or towns shall respectively, with the approval of the section of the Board of Education concerned, have power to appoint a fit and proper person to be inspector of all public schools within the jurisdiction of the Board of Trustees appointing him, who shall by frequent visits to the schools, and in every other way, do all in his power to improve their character and efficiency; such inspector shall report quarterly to the Trustees, who shall transmit a copy of all such reports to the Superintendent of the section having jurisdiction over such schools.

VISITORS.

80. The visitors in each school district may be :

(a.) The resident priest or minister of any denomination, provided always that such priest or minister or ecclesiastic shall only have the right to visit schools under the jurisdiction of the section, whether Protestant or Catholic, to which such priest, minister or ecclesiastic may belong:

(b.) The members of the Provincial Legislature :

(c.) The judges of the court of Queen's Bench and county court :

Agreements between teachers and trustees

(d.) The members of each section of the Board of Education in their respective schools: and

(e.) The trustees of each school district in their own district.

81. In incorporated cities or towns a general meeting of the visitors may be held at any time or place appointed by any two visitors, on sufficient notice being given to the other visitors; and the visitors thus assembled may devise such means as they may deem expedient for the efficient visitation of the schools. and, in concert with the school authorities, for promoting the establishment of libraries and the diffusion of knowledge.

SCHOOL ATTENDANCE.

The teacher of each school in this Province, receiving public aid shall School atten-82. within ten days after the close of each semi-annual school-term, transmit to his superintendent a correct statement of the names of the children attending such school, with their respective ages, and distinguishing between the sexes, together with the average attendance during the preceding school term, and a statement of the number of months during which the school has been kept open, with such Record of, to additional information as the superintendent may from time to time require.

ANNUAL CENSUS OF CHILDREN.

83. The school trustees in each school district shall between the first Annual and thirtieth day of November in each year, cause to be made by their secretarytreasurer a census of the children in such school district from the age of five years inclusive to the age of fifteen years inclusive, giving the age in each case and mentioning those who attend the school, and such census after being certified by the secretary-treasurer and at least one of the school trustees of the district under oath, made before a justice of the peace, shall on or before the tenth of the month of December following, be presented to the proper superintendent, whose duty it shall be to forward the same to the provincial secretary within the eight days following, and no census shall be received by the superintendents respectively after the said date of the tenth day of December in each year.

APPORTIONMENT OF PUBLIC MONIES.

84. The sum appropriated by the legislature for common school purposes, Apportionshall be divided between the Protestant and Roman Catholic section of the Board moneys. of Education, in the manner hereinafter provided, in proportion to the number of children between the ages of five and fitteen inclusive, residing in the various Protestant and Roman Catholic school districts in the Province where schools are in operation, as shown in the census returns.

85. Arbitration.

86. It shall be the duty of such committee on or before the fifteenth day of January in each year to apportion the education fund, and within two weeks after the prorogation of the session of the legislature at which the grant for education is voted, to apportion said grant between the Protestant and the Catholic sections of the Board of Education, according to the aggregate number of children being respectively Protestant and Catholic between the ages of five inclusive and fifteen inclusive who shall be found from the census hereinbefore prescribed, to be residing within all the school districts existing in the Province.

87. If the census returns upon which such apportionment is at any time to be made, or any of them be defective in any respect, the said committee shall have power to require school trustees to supply to the committee such information as will enable them to correct the same.

88. After such apportionment shall have been made to the Protestant and Catholic sections of the said Board of Education, the sum due to each section shall be paid by two semi-annual payments.

89. The superintendent of each section shall deposit such money in such bank as the Lieutenant-Governor in council may direct.

EXPENDITURE OF SCHOOL MONEYS.

90. From the sum so appropriated to each section there shall first be paid the incidental expenses of that section, and such sums to the superintendents of education as the Lieutenant-Governor in council may deem just, and each section of the board may reserve for unforeseen contingencies, a sum not exceeding ten per cent. of its share of the appropriation.

(b.) Then the sum of fifty dollars shall be paid semi-annually to each school which has been in operation during the previous term; and in the case of newly established schools, to those which have been in operation for at least one month of said term;

(c.) The residue then remaining may be divided annually or semi-annually among all the schools, upon the basis of the average attendance of pupils attending said schools as shown in the semi-annual returns made by the teachers.

(d.) No school shall be entitled to receive any portion of the legislative grant, whose trustees have neglected to transmit within the time provided by law in the preceding year, the census returns which form the basis of the apportionment of the public fund.

91. All payments authorized by the section shall be made by the superintendent by cheque upon the bank in which the moneys have been deposited, or, in case of the absence of the superintendent, by some person duly authorized to act for him.

92. Any school not conducted according to all the provisions of this or any other Act in force for the time being, shall not be deemed a public school within the meaning of the law, and such school shall neither participate in the educational funds nor in the legislative grant.

ARBITRATION.

93. In case of any difference between school trustees and teacher in regard to his salary or the sum due him or claimed to be due, or any other matter connected with his duty, the same shall be submitted to arbitration, in which case each party shall choose an arbitrator.

94. In case either party in the first instance neglects or refuses to appoint when either an arbitrator on his behalf, the party requiring the arbitration may, by notice party neglects in writing to be served upon the party so neglecting or refusing, require the last arbitrator. named, within three days exclusive of the day of service of such notice, to appoint an arbitrator on his behalf and such notice shall name the arbitrator on his behalf and such notice shall name the arbitrator of the party requiring the arbitration: and in case the party served with such notice does not. within the three days mentioned therein, name and appoint an arbitrator, then the party requiring the arbitration may appoint the second arbitrator.

95. The superintendent or a member of the sectional board to be nominated Third Arbiby such superintendent, shall be the third arbitrator.

97. The said arbitrators or any two of them may issue their warrant, to Arbitrators any person named therein, to enforce the collection of any moneys by them warrant. awarded to be paid, and the person named in such warrant shall have the same power and authority to enforce the collection of the moneys mentioned in the said warrant with all reasonable costs, by seizure and sale of the property of the party or corporation against whom the same has issued, as any bailiff of the county court has in enforcing a judgment and execution issued out of such court.

98. In case of any dispute or difference arising between any two boards In case of disof school trustees in regard to any sum of money due or claimed to be due under pute between two boards. any Act of the Province of Manitoba, the same shall be referred to arbitration in the manner hereinbefore provided; and, provided always, that in differences between any two boards of school trustees, the third arbitrator shall be chosen by the other two and the decision of such three arbitrators shall be final.

MUNICIPAL OFFICERS.

99. It shall be the duty of the city or town clerk, or clerks of municipalities Municipal to furnish to the board of school trustees five days before the annual school officers. meeting authorized to be held under this Act, a certified copy of the last revised municipal voters' list for each ward in the city, town or municipality in which such Acts are in force.

HOLIDAYS.

Every Saturday and every statutory holiday shall be a holiday in the Holidays. 100. public schools; subject however to such regulations respecting holidays as either section of the Board of Education may from time to time make for the schools under their jurisdiction.

BY-LAWS FOR COMPULSORY ATTENDANCE OF CHILDREN.

101. Every board of school trustees may, with the sanction of their section By-laws for of the board of education, make, amend or revoke any by-laws for their school compulsory attendance of district, for any of the following purposes :

(a) Requiring the parents or guardians of children of not less than seven years nor more than twelve years of age, as may be fixed by the law, to send

children.

such children to school for a certain period in each year, unless sufficient evidence be produced by such parents or guardians, that they cannot do so; and any of the following shall be considered a reasonable excuse :

(1) That the child is under instruction in some other manner satisfactory to the magistrate before whom the complaint may be brought;

(2) That the child has been prevented from attending school by sickness or any unavoidable cause;

(3) That such child has reached a standard of education of the same as or greater degree than that to be obtained in such public school, by children of twelve years of age :

(b) Determining the time during which such children are to attend school;

(c) Imposing penalties upon parents or guardians for the breach of any by-law, thus:

(1) Admonition in the form of a note of warning, signed by the chairman of the board of school trustees;

(2) Summons to appear before the board of school trustees, and to receive reprimand from the chairman, if merited;

(3) Complaints by the board of school trustees to any justice of the peace of the district, who may impose a fine not exceeding twenty-five cents for the first offence, fifty cents for the second, and so on, doubling the last fine for any repetition of the offence.

102. It shall be competent for any judge of the county court or stipendary magistrate to investigate and decide upon any complaints made by the trustees or any person authorized by them against any parent or guardian for the violation of any such by-law as is, by the previous section provided as may be enacted; and it shall be the duty of such judge of the county court to ascertain, as far as may be, the circumstances of any party complained of, for not sending his or their child to school or otherwise educating him or them, and whether the alleged violation has been caused by poverty or ill-health, and in any such case the judge shall not award punishment, but shall report the circumstances to the trustees making the complaint.

REGISTRATION OF SCHOOL TAXES.

103. Previous to the first day of August in each year the boards of school trustees, if they themselves collect the school taxes, shall cause to be made a list of the names of all persons in their district in arrears for school taxes, the amount due by them, the lot or lots on which such taxes are due: and if such taxes remain unpaid, it shall be the duty of the said board of school trustees on or previous to the last day of August in each year, to register the said lots, with the amount due on real estate only, with the treasurer of the municipality in which such lots are situated, and if such lots are not within a municipality then in the registry office of the county in which such lands are situated, by filing a copy of the tax list, after which such taxes shall become a first lien or mortgage on the lot or lots on which they are respectively due and payable, and any sale of such property or transfer made thereafter shall be subject to such taxes.

BORROWING MONEY.

104. If the ratepayers of any school district at a public meeting duly Borrowing monev. called, require the trustees to borrow any sum of money for the purchase of school sites, or erection of school houses and their appendages, or for the purchase or erection of a teacher's residence, or for the purpose of paying off any debt, charge or lien against such school house, or residence, or against the trustees of any school district, incurred by them as such trustees for any of the purposes aforesaid, the said trustees shall forward to the Lieutenant-Governor-in-Council, a certified copy of the minutes of such meeting, and the Lieutenant-Governor-in-Council may thereupon sanction such loans, and such sanction shall bind the ratepavers of the said school district to cause to be levied a sum sufficient for the payment of the principal and interest on any such loan at the times when the same shall become payable, as provided between trustees and the lender.

(a) No loan shall be made for any term exceeding twenty years.

(b) The principal on such loan may be made payable by annual Payable by instalments.

(c) Notice of such meeting shall be duly given by posting up on the door Notice of meeting. of the school house (if any), and in two or more conspicuous places within the school district, for which such loan is sought to be obtained at least two weeks previous to such meeting, a notice in the form or to the effect of that set forth in Schedule A of this Act.

(d) A majority of the rate payers of any such school district present at Majority. such meeting shall be sufficient to authorize such loan, and the assent of the Lieutenant-Governor shall be obtained before such loan is completed.

(e) The assent of the Lieutenant-Governor to any such loan shall be Assent of Lieutenantconclusive evidence of all the necessary formalities having been complied with, Governor. and that such loan is one which such school district may lawfully make.

(f) Any school district having obtained the assent of the Lieutenant- May issue Governor to a loan, may issue debentures therefor in the form set forth in Schedule B of this Act, to secure the amount of the principal and interest upon such loan, upon such terms as such loan can be obtained, and the said debentures shall be sufficient when signed by the secretary-treasurer, and countersigned by one or more trustees, to bind the said trustees and to create a charge or lien against all school property in the school district for which such loan is made.

105. In incorporated cities and towns the board of school trustees shall each have power to borrow money for the purchase of school lands or the erection of school buildings or other school purposes in the manner hereinafter provided.

To enable such Board to borrow money the respective Boards of 106. School Trustees shall have power to issue debentures in the form given in Schedule C to this Act, for such sums as may be decided upon at an annual school meeting or a special meeting of the ratepayers represented by any such Board called for that purpose, redeemable within twenty years from the date thereof with interest not exceeding eight per cent. per annum payable semiannually which debentures shall be a charge upon the school district and the interest on them shall be the first charge on the annual school taxes, and such Board of Trustees shall make provision out of the annual school taxes for the formation of a sinking fund for the repayment of said debentures : they shall be sealed with the corporate seal of the Board of School Trustees and signed by the chairman and countersigned by the secretary-treasurer. FINES AND PENALTIES.

Any person elected as trustee who shall refuse to serve shall incur Fines and 107 a penalty of five dollars, and any trustee or secretary-treasurer neglecting to prosting trustees, etc., refusing to discharge any duty assigned to him or them by this Act, shall be refusing to liable to a penalty of ten dollars for each offence, and said penalties may be recovered within three months of the time when such offence was committed.

108. Whenever any school trustee, or secretary-treasurer, after his dis- Penalty for missal, resignation, or ceasing to hold office, detains any money. book, paper or detaining books or property belonging to the school trustees of any school, he shall thereby incur papers. a penalty of not less than five dollars, nor more than twenty dollars, for each day during which he shall retain possession of any such money, book, paper or property after having received a notice from his superintendent of education requiring him to deposit the same in the hands of some person mentioned in such notice.

110. Every father, head of family, or guardian, who refuses to give to the rrustees of any school district the information required by them, to enable them to make up the census of children required by this Act, or who makes a false declaration, shall incur a penalty of not less than five nor more than twenty-five dollars.

111. Any justice of the peace, assessor, constable, or other officer neglecting or refusing to discharge any duty assigned to him by the provisions of this Act, shall be liable to a penalty for each offence of a sum not exceeding fifty dollars.

112. If any person wilfully makes a false declaration of his right to vote, he shall be liable to a penalty of not less than fifty nor more than one hundred dollars.

113. The proceeding of every school meeting shall, within eight days thereafter, be reported by the chairman of such meeting to the superintendent of his section, under a penalty of five dollars.

114. Any person who wilfully disturbs, interrupts or disquiets the proceeding of any school meeting, or anyone who interrupts or disturbs any public school by rude or indecent behaviour, or by making a noise either within the place where school is kept or held, or so near thereto as to disturb the order or exercises of the school, shall for each offence, on conviction thereof, before a justice of the peace, forfeit and pay a sum not exceeding twenty dollars, together with the costs of the conviction, as the said justice may think fit.

115. Any person chosen as trustee who has not refused to accept office, and who at any time refuses or neglects to perform his duties shall forfeit the sum of twenty dollars.

116. Should the trustees of any public school wilfully neglect or refuse to exercise all the corporate powers vested in them by this Act or any other Act or Acts of this Province, for the fulfilment of any contract or agreement made by them, any trustee or trustees so neglecting or refusing to exercise such powers shall be held to be personally responsible for the fulfilment of such contract or agreement.

117. All such prosecutions for fines and penalties may be instituted by any competent person, before any justice of the peace who may convict the offender on the oath of one credible witness, other than the prosecutor; and if upon conviction, the penalty, with costs if not paid forthwith, the same shall, under warrant of such justice, be levied with costs of distress and sale of the goods and chattels of the offender; and such penalty when so paid and collected shall, by such justice, be paid over to the school fund of the district to which such delinquent belongs.

118. This Act may be cited as "The Manitoba School Act" and shall be deemed a Public Act.

119. All former school Acts and amendments thereto shall be and are hereby repealed; but the board of education, superintendents, and inspectors, shall continue in office until replaced under the provisions of the present Act; and the school trustees now in office, elected before the passing of this Act, shall remain in office for the term elected; further, all Acts, proceedings, and regulations of the board of education, its sections, and boards of school trustees under the previous Act, shall continue in force, until changed under the provisions of the present Act. 45 VIC., Chapitre 8.

Preambie.

HER MAJESTY by and with the advice and consent of the Legislative Assembly of the Province of Manitoba enacts as follows:

1. Sub-section (a) of section 10 of 44 Victoria, cap. 4 (3rd session) is amended by adding thereto the following: "And also to call any school meeting required to be held under this Act when the parties who are otherwise invested with the power to do so, either neglect or refuse to exercise it."

2. Section 12 is repealed and the following substitued therefor :---

"XII. It shall be the duty of the Council of any municipality to establish and alter, when necessary, the school districts within its own bounds, but in no case shall action be taken except on the petition of parties directly interested. and if any Municipal Council shall refuse or neglect to take the necessary action when so petitioned, then, on the petition of at least five of the resident heads of families of the school district, or proposed school districts, to the section of the Board of Education to which the same belongs, the said section of the board shall establish or alter the same, provided always that no petition for the formation or the re-adjustment of any school district shall be considered by any council, or by either of the sections of the Board of Education, unless a copy of it, with the names of the petitioners attached, has been posted up for a fortnight in a post office in the municipality in which said district or proposed district is situate, and within the bounds of said district or proposed district, or if there be no post office within the limits of the proposed district, then in the nearest post office thereto, and a declaration made before a justice of the peace by at least two of the said petitioners, stating that the petition had been so posted up, must accompany such petition."

3. Section 13 is amended by inserting the word "other" therein after the word "such," and before the word "regulation" in the 1st part of said section.

4. Sub-section (a) of section 13 is repealed and the following substituted therefor :—

"(a.) When a school district is formed or re-adjusted out of territory lying in more than one municipality, its formation or re-adjustment shall always be effected by the section of the Board of Education concerned."

5. Sub-section (b) of said section B is repealed.

6. Section 15 is amended by striking out the proviso in the latter part thereof, and substituting the following: "Provided always that the minority shall have power, by the action of their section of the Board of Education, to maintain their own district as it existed before the incorporation of said city or town, or so to extend their district as to include members of their denomination residing in the vicinity where no school of the same is in operation, but in such cases the children of the residents within the city or town limits only shall be computed in the division of school taxes levied on the incorporated bodies within the city or town.

An Act to Amend the Manitoba School Act and the Acts Amending the same.

[Assented to 29th April, 1884.]

HER MAJESTY, by and with the advice and consent of the Legislative section 5 Assembly of Manitoba, enacts as follows:—

1. Section 5 of "The Manitoba School Act" is hereby amended by adding thereto the following sub-section :—

(e.) To make regulations regarding the selection of school site, the size of school grounds and the formation and alteration of all school districts under its authority.

2. Sub-section (b) of section 10 of the said Act is hereby amended by $\frac{\text{Section 10 (b)}}{\text{amended.}}$ adding the following thereto :—

"And to have authority to take measures to enforce and carry into effect all the provisions of this Act and the regulations issued under its authority that relate to the schools within their respective jurisdictions."

3. Sections 12 and 13 of the said Act as amended by Chapter 46, of 46 sections 12 and 47 Victoria sections 2 and 3 are hereby repealed and the following $\frac{13 \text{ fursended}}{13 \text{ fursended}}$ substituted therefor:—

"(12.) "SCHOOL MEETINGS.

"(20.) On the first Monday of February in each year a meeting of the Annual meetings of ratepayers of each school district, of the age of 21 years and upwards, shall be ratepayers. called by the board of trustees, by notice posted by them on the school house, if there be one, or in three public places in the district at least two weeks in advance; and the majority of the electors present shall choose one or more persons (as the case may be) to be school trustees for the district, and two auditors, and shall receive and decide upon the annual report of the trustees and the report of the auditors and transact such other business as may have been set forth in the notice calling the meeting."

"(a.) All special meetings of the ratepayers in a school district shall be $\frac{\text{Special}}{\text{meeting of}}$ called by the trustees or the superintendent by posting up notices in at $\frac{\text{meeting of}}{\text{ratepayers.}}$ least three public places within the school district, at least two weeks previous to such meeting; the business to be considered at such meeting shall be plainly set forth in the notices calling the same, and no other business may be legally transacted at a special meeting but such as may be held in accordance with these provisions."

The boards of trustees of cities or towns shall respectively, with Inspectors in the approval of the section of the Board of Education concerned, have power to appoint a fit and proper person to be inspector, or manager of all public schools within the jurisdiction of the board of trustees appointing him, who shall by frequent visits to the schools and in every other way do all in his power to improve their character and efficiency; he shall have control of the organization and management of the schools of such city or town and report monthly to the trustees as to their condition and progress; but the schools of such city or town shall be under the supervision of the inspector appointed by the Board of Education for the county in which such city or town is situate, except that in cities and towns in which a collegiate department is or may be established the collegiate inspectors shall have such supervision and report half-yearly to the superintendent."

"(a.) Any such note or debt for money so borrowed may be enforced against Suits for the board of school trustees and the ratepayers liable to contribute to its revenues in the same manner as claims against or debts of municipalties may be enforced under "The Manitoba Municipal Act, 1884."

"(b.) Upon the payment to the board by a municipality of any portion of Application the sums to be levied for the trustees by a municipality it shall be the duty $\frac{of \text{ sums}}{\text{levied.}}$ of the board of school trustees to apply one half of such sum so paid to it to the reduction of the debt or debts incurred for monies so borrowed or upon such note or notes or in the event of no such debt or note or not sufficient thereof to exhaust the one half of the sum so paid being then overdue, then to deposit such half, or the unexhausted portion thereof in some chartered bank and to apply the same to such debts or notes as they become due and payable."

An Act to Amend the Manitoba School Act and the Manitoba School Amendments Acts, 1884.

[Assented to 3rd June, 1884.]

HER MAJESTY by and with the advice and consent of the Legislative Assembly of Manitoba enacts as follows :---

1. Section 35 of the "Manitoba School Act" is hereby amended by adding Proviso added to section 35.

"Provided that the trustees in any year elected shall remain in office until their successors are elected; and to remove all doubts as to the past, it is hereby declared and enacted that this clause as hereby amended shall have a retroactive effect up to the 1st of January 1882, and that all acts and things done and passed by a board of trustees, the term of office of some or all of whom should have expired by lapse of time or by some provision of law, are legal and binding to all intents and purposes."

2. Sub-section (a) of section 15 of "The Manitoba School Act" as amended by section 4 of "The Manitoba School Amendments Act 1884" passed during the present session is hereby amended by adding in the third line thereof, after the word "includes" the words "or is included in," and in the ninth line thereof after the word "sub-division," the words "which election shall take place in each ward at the call of the superintendent, and in such case the the trustees that may then be in office will so remain in office only until such election takes place irrespective of the date of their appointment."

3. HER MAJESTY by and with the advice and consent of the Legislative Assembly of Manitoba, enacts as follows :---

The Manitoba School Act section 90 is hereby amended by striking Manitoba School Act section (A) and (A) thereaf and multituding thereaf and following school Act out sub section (b) and (d) thereof and substituting therefor the following:----

(b.) Then the sum of fifty dollars shall be paid semi-annually to striking out each school which has been in operation during the whole of the previous and (d) and (d) and term, and a proportionate part thereof to each school in operation for a substituting part of the same; and in the case of newly established schools to those therefor. which have been in operation for at least one month of said term; Provided that except in the case of new school districts no school shall be entitled to receive a larger amount than one-half the sum incurred by the trustees thereof for its current expenses during the term for which such grant is made; Provided further that a reduction in the amount to be made may in the discretion of its section of the Board of Education be made in the case of any school district in which the average attendance of the resident pupils enrolled for the term has been less than one-third of such enrolled number.

(d.) No school shall be entitled to receive any portion of the Legislative grant whose trustees have neglected to transmit within the time provided by law, in the preceding year the census returns which form the basis of the apportionment of the public funds or whose annual or semi-annual returns are not transmitted as required by the regulations of their section of the Board of Education or whose school has not been kept in operation at least six months during the school year, unless with the sanction of the section of the Board.

2. The Manitoba School Act section 91 is hereby repealed and the following substituted therefor :---

All payments authorized by the section shall be made by the superin-Manitoba tendent by cheque upon the bank in which the moneys have been deposited, School Act or in case of the absence of the superintendent, by some person duly repealed and **a**uthorized to act for him, and in the case of payment to school districts the thesesaid cheque or cheques shall be made payable to the order of the duly substituted qualified teacher or teachers of the school unless it be shown that such teacher or teachers' salaries have been paid in full, or are paid at least quarterly, and in that case the cheque or cheques shall be made payable to the secretary-treasurer of the school district, or to the trustees.

3. Section 92 of the Manitoba School Act is hereby repealed and the following substituted therefor :----

Any school not conducted according to all the provisions of this or any Act in force for the time or the regulations of the Board of Education or either of its sections in force under its authority shall not be deemed a public school within the meaning of the law and such school shall neither participate in the educational funds nor in the legislative grant.

It is hereby provided that all school districts within the province in whatever manner established in which school houses have been built teachers engaged or liabilities incurred for school purposes previous to the twenty ninth day of April 1884, shall be considered to have been legally established school districts to all intents and purposes.

The Reeves or Mayors and the local Inspector or Inspectors of schools engaged in the formation or alteration of school districts extending within the bounds of two or more municipalities shall be entitled to the same remuneration per day with travelling expenses for their attendance as municipal Councillors for attendance at meetings of their respective Councils and each Reeve or Mayor shall be paid by the Counil of his own municipality and the local Inspector by all the municipalities concerned in equal parts.

(b.) It shall be the duty of the trustees of each school district wholly situated in a municipality to lay before the Council at its first meeting after the thirty-first day of July in each year a statement of the number of months in the current school year during which they have kept and will keep a teacher engaged at a salary in each of their schools and before the thirty-first day of January following shall notify the clerk of the municipality if they have failed to keep a teacher engaged as so stated by them and in such case give the actual number of months they have had such teacher engaged.

(c.) It shall be the duty of the trustees of each school district that extends within the bounds of two or more municipalities or of a city or town and rural municipality to obtain from the last revised assessment roll of each municipality concerned a copy of that part of the said roll relating to the school district as included within the three miles limit as defined in this Act and forward the said copies before the first of July to the local inspector with a statement of the number of months in the current school year during which they have kept and will keep a teacher

under engegement at a salary in each of their schools and the amounts of their estimates exclusive of the legislative grant required for the use of their schools and the said inspector shall equalize the rate of assessment of the portion of each municipality including within the school district as hereinbefore described and shall allot to each municipality its due proportion of the sum of twenty dollars per month of the current school year that the said trustees have declared their school has been and will be kept in operation and shall send notice thereof by mail to the clerk of each municipality concerned before the fifteenth day of July and the said inspector shall in like manner allot the remainder of the trustees estimate and return the copies of the rolls with his equalization and on allotment duty made out thereon to the trustees and the said trustees if they fail to keep a teacher nnder engagement during the school year for the full time stated by them shall before the thirty-first day of January following notify the local inspector of the actual time and he shall make another allotment based upon such time and notify each council concerned and the said trustees and the said inspector shall be entitled to receive from the trustees for each allotment made as hereinbefore required the sum of five dollars.

Any board of school trustees that fails to notify their Council or the local Inspector (as the case may be) in due time of the uumber of months their school is to be kept in operation during any school year as hereinbefore required shall not be entitled to receive a larger amount in such year from the municipal levy than the Council or the local Inspector (as the case may be) may in their discretion fix for them, and any board of trustees failing to keep a teacher under engagement the full time stated by them shall not be entitled to receive their second instalment of school moneys due on January thirty first until they have notified the clerk of the municipality of the actual time such teacher has been under engagement and any board of trustees wilfully making a false statement in regard to such time shall forfeit their second instalment.

(e.) Any moneys collected by a Council from a general levy for school purposes that remain over in any year after all due payments therefrom have been made to the school districts entitled to the same shall be deposited in some chartered Bank by the said Council and afterwards used only to pay or advance moneys to school districts within the municipality in the year or years following unless the proper section of the Board of Education shall require the same moneys or any portion of them to be paid over at any time to any school district or school districts wholly or partly included in the municipality that the said board may consider in especial need of such assistance.

(f.) In levying an assessment for Protestant or Catholic School purposes (as the case may be) the Council of each municipality shall assess all lands the denomination of whose owners as Catholics or Protestants cannot be ascertained before the time of making such levy in the manner provided in section 28 of the Manitoba School Act.

10. The Manitoba School Act section 26 as amended by 47 Vic. Cap. 37, Manitoba School Act section 9 is hereby repealed and the following substituted therefor :— Sec. 26 as amended by

For the purpose of supplementing the legislative grant and the ⁴⁷/_{87 sec 9} municipal levy it shall be the duty of the Board of Trustees of each repealed and school district wholly or partially included in a rural municipality before substituted the first day of July in each year at a meeting of the said board to therefor. make an estimate of the sum over and above the amount of the said legislative grant and municipal levy that they shall require for school purposes during the current school year and resolve whether the said estimate shall be collected by the municipal Council or Councils concerned or by a collector or collectors appointed by the said board.

(a.) In case the board of trustees resolve to levy and collect by their own authority the amount of their estimate it shall be the duty of the said board if their school district be wholly included within a single municipality, to obtain a copy of the last revised assessment roll of that portion of the municipality that includes all the lands liable for taxation for their school district any portion of which lands lie within three miles in a direct line from the school house or site, except such as are partially included within the said limit, but with the ordinary residence of the occupant thereof situated upon the same beyond the said limit, or a distance of four miles or over by the public road from the said school house or site, and the said board of trustees shall then strike and levy a rate for raising the amount of the said estimate, and place the amount of tax to be collected from each person or property included within the aforesaid limit opposite his name, or the description of his property, and place the roll in their collector's hands for collection, and such roll handed to him shall be his warrant for the collection of the taxes entered upon the same, and in collecting he shall possess and be vested with the same power and authority, and be subject to similar obligations and penalties as a collector employed by the municipality. The said collector may be the secretary-treasurer of the trustees, or some other person not a trustee, and his remuneration shall in no case exceed five per cent. of the amount collected; and if the secretary-treasurer act as collector his remuneration for both offices shall not exceed the amount fixed for the office of secretarytreasurer by the Manitoba School Act. The said collector shall give security to the satisfaction of the trustees for the faithful performance of his duties to the amount of the trustees' estimates, and if such security be not given the trustees shall, ipso facto, be his sureties.

(b.) The said collector shall pay over the taxes as collected to the secretary-treasurer, and shall return his roll to the trustees on or before the thirty-first day of January following his appointment, and the trustees shall forthwith forward the said roll, showing the uncollected taxes, to the clerk of the municipality, whose duty it shall be to forward the same to the judicial board for collection in the same manner as uncollected municipal taxes, and to pay the same to the trustees when collected.

(c.) In case the school district is included within the limits of two or more municipalities, whether city, town, or rural municipalities, the trustees shall levy and collect the amount of their estimate according to the allotment made for them upon the equalized assessment rolls returned to them by the local inspector in the same manner, under the same conditions, and with the same powers given by this Act to trustees of school districts wholly included within the limits of a single municipality for the collection of their estimates.

In case the board of trustees resolve to have their estimates levied (d.)and collected by the council or councils of the municipality or municipalities in which their school district is wholly or partially included they shall transmit a copy of such resolution with the amount of their estimate or in the case of school districts included within the limits of two or more municipalities the proportion of their estimate allotted by the local inspector to the Council of the municipality concerned, at or before its first meeting after the thirty-first day of July of the year in which such estimate is made, and it shall be the duty of the Council of such municipality, employing their own lawful authority to levy and collect such estimate or proportion thereof upon the real and personal property within the three miles limit in each school district as hereinbefore described and pay the whole amount so collected to the trustees at the dates upon which they are required to pay them the amounts due from the municipal levy and the said Council shall transmit the uncollected taxes of the said estimate to the judicial board for collection with the uncollected municipal taxes and when collected pay over the said school taxes to the trustees.

For the purpose of collecting the arrears of school taxes for any vear the trustees of any school district wholly or partially included in a city town or rural municipality may, in any year transmit a list of such arrears to the Council of the municipality concerned with the estimate of the taxes to be collected for them for the current school year, and thereupon the said Council shall levy and collect the said arrears and pay them over to the trustees on the same dates as they are required to pay over their taxes collected for the current year and shall return the amounts uncollected to the judicial board with the uncollected municipal taxes or the trustees may, employing their own lawful authority bring a suit in a Court of competent jurisdiction for the collection of such arrears whether they had been assessed by the said trustees or by the Council of the municipality and forward to the said Council a list of the amounts they may be unable to collect for transmission by them to the judicial board for collection; and upon receiving from the judicial board any moneys realized from the collection of school taxes it shall be the duty of each Council, forthwith to pay the same over to the trustees entitled to receive them.

The trustees of any school district, the school house of which is built upon grounds for which the owner thereof neglects or refuses to give them a title, may appoint an arbitrator, and notify the said owner, who shall also appoint an arbitrator; and these two, with the local inspector or any two of them, or in case of the owner not appointing an arbitrator within ten days after receiving notice of the appointment of the trustees' arbitrator, then the local inspector and the trustees' arbitrator shall value the said grounds, and award in writing to the parties concerned the amount to be paid for the same and to whom it shall be paid; and the trustees upon paying or tendering payment of the sum so awarded, and registering the award of the arbitrators, shall thereby become the owners of the said grounds, and said registered award shall be their indefeasable title to the same.

(b.) The said arbitrators shall be entitled to the sum of five dollars each for their services which shall be paid by the trustees.

(8.) "The said arbitrators duly appointed, or a majority of them, shall value the said land and make an award in writing, and fix the amount of the costs of the arbitration, not to exceed 3 dollars per day for each arbitrator, and 10 cents per mile each way for travelling expenses, and they shall further direct which of the parties should pay the said costs, and if a portion, in what proportion."

(9.) "An appeal to the judge of the county court shall lie upon application filed and served, within ten days of the award, for the revision of the costs taxed."

(10.) "The compensation money agreed upon by the trustees or awarded by the arbitrators for any such land or property, shall stand in the stead of such land or property, and any claim thereto or incumbrance upon said land or property shall be converted into a claim for such compensation money, or to a proportionate amount thereof, and shall be void as respects the land or property which shall by the fact of the making of said tender or award, and of the payment of the money, become and be absolutely invested in the trustees for the purposes of this Act.

(5) "Ratepayer" shall mean an assessed householder, owner or tenant, "Ratepayer." or any person entered on the assessment roll as a farmer's son.

(6) "Inspector" shall mean the school inspector for the territory in "Inspector." which the school district is situate. R.S.O., c. 225, s. 2.

"Rural School District" shall mean a school district situate wholly Bural School District. in a rural municipality or rural municipalities.

5. All Public Schools shall be free schools, and every person in rural municipalities between the age of five and sixteen years, and in cities, towns and villages between the age of six and sixteen, shall have the right to attend some school. R.S.O., c. 225, s. 6.

RELIGIOUS EXERCISES.

6. Religious exercises in the Public Schools shall be conducted according to the regulations of the Advisory Board. The time for such religious exercises shall be just before the closing hour in the afternoon. In case the parent or guardian of any pupil notifies the teacher that he does not wish such pupil to attend such religious exercises, then such pupil shall be dismissed before such religious exercises take place.

7. Religious exercises shall be held in a Public School entirely at the option of the school trustees for the district, and upon receiving written authority from the trustees, it shall be the duty of the teachers to hold such religious exercises.

8. The Public Schools shall be entirely non-sectarian, and no religious exercises shall be allowed therein except as above provided.

NEW SCHOOL DISTRICTS.

9. The council of each rural municipality shall form portions of the municipality where no schools have been established into school districts. Provided, no school district shall be so formed unless there shall be at least ten children of school age living within the same, and none distant more than three miles by the most direct road from the site for the school house. Provided, that no school district shall include more territory than twenty square miles, exclusive of public roads. There shall be an appeal from the action of the council in so forming school districts in the manner provided in section 69. R.S.O., c. 225, s. 9; 47 Vic., c. 37, s. 3; 48 Vic., c. 27, s. 4.

SCHOOL TRUSTEES FOR RURAL DISTRICTS.

10. For each rural school district there shall be three trustees, each of whom, after the first election of trustees, shall hold office for three years, and until his successor has been elected. R.S.O., c. 225, s. 12.

11. The trustees elected at a first school meeting in a rural school district shall respectively continue in office as follows:

(1) The first person elected shall continue in office for two years, to be reckoned from the annual school meeting next after his election, and thence until his successor has been elected;

(2) The second person elected shall continue in office for one year, to be reckoned from the same period, and until his successor has been elected.

(3) The third or last person elected shall continue in office until the next ensuing annual school meeting in such district, and until his successor has been elected;

(4) In case of a poll being taken for one or more trustees at a first school meeting, then the trustees shall rank in seniority according to the number of votes polled, and, in case of a tie, then in the order of their nomination. R.S.O., c. 225, s. 30; 44 Vic., c. 4, s. 18.

In rural school districts every ratepayer of the full age of twenty-one Electors in years, rated on the last revised assessment roll of the municipality, or one of the districts. municipalities in which the school district is situate, shall be entitled to vote at any election for school trustee or on any question whatsoever, at any annual or special meeting in the district except as is herein otherwise provided. R.S.O., c. 225, s. 14; 47 Vic, c. 37, s. 7; 48 Vic., c. 27, s. 6.

ANNUAL SCHOOL MEETINGS IN RURAL DISTRICTS.

14. On the first Monday in December in each year (provided the day is Annual school not a statutory holiday, in which case then on the following Wednesday) a meeting. meeting of the ratepayers of each rural school district shall be held, commencing at ten o'clock in the forenoon, for the purpose (among other things) of electing a school trustee or trustees. Notice of such meeting shall be given by the trustees (except as is herein otherwise provided) by notice posted on the school house, if there be one, and in one other public place in the district at least two weeks before such day. R.S.O., c. 225, s. 15; 44 Vic., c. 4, s. 16; 47 Vic., c. 37, s. 5.

15. In case, from the want of proper notice or other cause, any first Meetings to or annual school meeting, required to be held for the election of trustees, was be called in default of first not held at the proper time, the inspector, or any two ratepayers in the district, or annual may call a school meeting, by giving six days' notice, to be posted in at least meetings. three of the most public places in the school district; and the meeting thus called shall possess all the powers and perform all the duties of the meeting in the place of which it is called. R.S.O., c. 225, s. 16; 44 Vic., c. 4, s. 21; 47 Vic., c. 37, s. 6.

16—(1) The electors of such school district present at such meetings order of shall elect one of their own number to preside over its proceedings, and shall business. also appoint a secretary, who shall record the proceedings of the meeting, and perform such other duties as may be required of him by this Act.

(2) The business of such meeting may be conducted in the following order :--

(a) Receiving the annual report of the trustees, and disposing of the same;

(b) Receiving the annual report of the auditor or auditors, and disposing of the same:

 (\mathbf{c}) Electing an auditor for the current year;

(d) Miscellaneous business;

(e) Electing a trustee or trustees to fill any vacancy or vacancies. R.S.O., c. 225, s. 17; 44 Vic., c. 4, s. 17; 47 Vic., c. 37, s. 5.

17. The election of trustees shall proceed by way of nomination, each Proceedings nomination requiring a mover and seconder, both of whom must be present and at election of qualified electors. Nominations shall be kept open until eleven o'clock in the Trustee. forenoon. In case, at the said hour of eleven o'clock, the number of nominations

does not exceed the number of vacancies to be filled, then the chairman shall declare the person or persons so nominated to be elected. In case the number of nominations exceed the number of vacancies to be filled, a show of hands shall be taken, and the person or persons having the majority of votes shall be declared elected by the chairman, should no ratepayer demand a poll. If a poll is demanded by a ratepayer present, the chairman shall be the returning officer, and shall open the poll forthwith. The secretary shall record the votes given. The poll shall be closed at four o'clock in the afternoon. Provided, that if at any time one hour elapse during such poll without a vote having been recorded, the poll shall then be closed. After the poll is closed the chairman shall declare the person or persons receiving the highest number of votes elected. R.S.O., c. 225, ss. 19, 20-22.

18. The chairman shall preside and submit all motions to the meeting in the manner desired by the majority. In case of an equality of votes, he shall give the casting vote, but no other vote. He shall decide all questions of order, subject to an appeal to the meeting. R.S.O., c. 225, s. 18.

19. In case an objection is made to the right of any person to vote at any annual or special meeting, either for trustee or upon any school question, the chairman of the meeting, or other officer presiding, shall require the person whose right of voting is objected to, to make the following declaration :

(1) I, A. B., do declare that I am an assessed ratepayer (or farmer's son, as the case may be) in school district

(2) That I am of the full age of 21 years.

(3) That I have the right to vote at this election.

Whereupon the person making such declaration shall be entitled to vote, except as is herein otherwise provided. R.S.O., c. 225, s. 2.

20. Any public school question raised at such annual meeting, or any special meeting, may be submitted to vote and a poll demanded. In case of a poll being demanded, the proceedings shall be similar to those above provided for election of trustee.

21. The secretary of every school meeting at which any person or persons were elected as school trustees, shall forthwith notify in writing each of such persons of his election, and every person so notified shall be considered as having accepted such office, unless a notice to the contrary effect has been delivered by him to such secretary within twenty days after the date of such election. R. S. O., c. 225, s. 23.

22. Any trustee elected to fill a vacancy shall hold office only for the unexpired term of the person in whose place he has been elected. R. S. O., c. 225, s. 24.

23—(1) No school corporation shall cease to exist by reason of the want of trustees, but in case of such want any two ratepayers of the district, or the inspector, may, by giving six days' notice, to be posted in at least three of the most public places of the district, call a meeting of the ratepayers, who shall proceed to elect three trustees in the manner prescribed in Section 17 and the following sections of this Act; and the trustees thus elected shall hold and retire from office in the manner prescribed by Section 11 of this Act.

30. Notice of all meetings shall be given by the secretary to each of the trustees, or by any one of the trustees to the others, by notifying them personally, or in writing or by sending a written notice to their residences. R.S.O., c. 225, s. 35.

31. No act or proceeding of a rural school corporation, which is not adopted at a regular or special meeting of the trustees, shall be valid or binding on any person affected thereby, unless notice has been given, as required by this Act, and unless at least two trustees are present. R.S.O., c. 225, s. 36.

32. Every secretary-treasurer of a rural school district shall prepare and submit to the board of school trustees annually, previous to the annual election of trustees, a detailed statement of the receipts and expenditures of the school district for the current school year then expiring, and such statement, after being approved by the school trustees, shall be by them submitted at the annual meeting. The secretary-treasurer shall, on the payment to him of the sum of one dollar, furnish to any ratepayer a copy of such statement. 44 Vic., c. 4, s. 58.

33. The remuneration of a secretary-treasurer of a rural school district may, in the discretion of the school trustees, be fixed at any amount not exceeding the sum of ten dollars per annum. Such remuneration shall cover all services rendered and all contingent expenses whatever except such as may be specially authorized by the board. 44 Vic., c. 4, s. 59.

AUDITORS.

34.—(1) Every board of rural school trustees shall, on or before the fifteenth day of November, appoint an auditor, and in case of their neglect, or the neglect of the ratepayers at an annual or special meeting to do so, or in case of an auditor being appointed or elected who refuses or is unable to act, then the inspector shall (at the request in writing of any two ratepayers) make the appointment.

(2) It shall be the duty of the trustees, or their secretary-treasurer, to lay all their accounts before the school auditors of the district, or either of them, together with the agreements, vouchers, contracts and books in their possession, and the trustees, or their secretary-treasurer, shall afford to the auditors, or either of them, all the information in their or his power as to the receipts and expenditures of school moneys. R.S.O., c. 225, s. 37; 44 Vic., c. 4, s. 74.

35. The auditors appointed, or one of them, shall, on or immediately after the first day of November in each year, appoint a time, before the day of the next ensuing annual school meeting, for examining the accounts of the school district. R.S.O. c. 225, s. 38.

(3) If both of the auditors object to the lawfulness of any expenditures made by the trustees, they shall submit the matters in difference to the annual meeting, which may either determine the same or submit the matter to the Inspector, whose decision shall be final;

It shall be competent for the auditors, or one of them : (4)

(a) To require the attendance of all or any of the persons interested in the accounts, and of their witnesses, with all such books, papers, and writings as the auditor or auditors may direct them or either of them to produce;

To administer oaths to such persons and witnesses :

To issue their or his warrant to any person named therein; to enforce (c)the collection of any moneys by them awarded to be paid; and the person named in the warrant shall have the same power and authority to enforce the collection of the moneys mentioned in the said warrant, with all reasonable costs, by seizure and sale of the property of the party or corporation against whom the same has been issued, as any bailiff of a County Court has in enforcing a judgment and execution issued out of such court;

(d) The auditors shall remain in office until their audit is completed. R.S.O., c. 225, s. 39.

DUTIES OF TRUSTEES OF RURAL DISTRICTS.

37.It shall be the duty of the trustees of rural school districts:

To appoint the place of each annual school meeting of the rate- Meetings to be (1)payers of the district, and the time and place of a special meeting of the same appointed by the Trustees. for (1) the filling up of any vacancy or vacancies in the trustee corporation occasioned by death, removal, or other cause; or (2) for the selection of a new Filling school site; or (3) the appointment of a school auditor; or (4) any other lawful school purpose, as they may think proper; and to cause notices of the time and Notice. place, and of the objects of such meetings, to be posted in three or more public places of the district at least six days before the time of holding such meeting :

(a) Every such meeting shall be organized, and its proceedings recorded in the manner provided for in Section 16, and the following sections of this Act.

To provide adequate accommodation and a legally qualified teacher Adequate (2)or teachers, according to the regulations prescribed by the Department of accommoda-Education, for two-thirds of the actual resident children, between the ages of five and sixteen years, as ascertained by the census taken by the municipal council for the next preceding year;

(3) To apply to the municipal council at or before its first meeting after Apply to the thirty-first day of July for the levying and collecting by rate of all sums for for school the support of their school or schools, and for any other school purposes moneys. authorized by this Act to be collected from the ratepayers of such district, or to raise the amount necessary for the purchase of school sites, the erection or

otherwise acquiring of school houses and their appendages, either by one yearly rate or by debentures, as provided in Section 101 of this Act, as may be required by the trustees;

(4) To arrange for the payment of teachers' salaries at least quarterly, and, if necessary, to borrow on their promissory note, under the seal of the corporation, at interest not exceeding ten per cent. per annum, such moneys as may be required for that purpose, until the taxes imposed therefor are collected;

(5) To keep the school house, furniture, out-buildings and enclosures in proper repair, and where there is no suitable school house belonging to the district, or where two or more school houses are required, to build or rent a house or houses, and to keep such house or houses, its or their furniture, outbuildings and enclosures in proper repair;

(6) To give notice in writing, before the first day of January in each year, to the Inspector and to the clerk of the municipality in which their school is situate, of the names and post office addresses of the several trustees then in office, of the secretary-treasurer and of the teachers employed by them, and to give reasonable notice in writing, from time to time of any changes therein;

(7) To exempt, in their discretion, from the payment of school rates, wholly or in part, any indigent persons, notice of such exemption to be given by the trustees to the clerk of the municipality, on or before the first day of August;

(8) To dismiss from the school, any pupil who shall be adjudged so refractory by the trustees (or by a majority of them), and the teacher, that his presence in school is deemed injurious to the other pupils;

(9) To take possession, and have the custody and safe keeping of all Public School property which has been acquired or given for Public School purposes in the district; and to acquire and hold as a corporation, by any title whatsoever, any land, moveable property, moneys or income given or acquired at any time for Public School purposes, and to hold or apply the same according to the terms on which the same were acquired or received; and to dispose, by sale or otherwise, of any school site or school property not required by them in consequence of a change of school site or other cause; to convey the same under their corporate seal, and to apply the proceeds thereof to their lawful school purposes, or as directed by this Act;

(10) To visit, from time to time, every school under their charge, and see that it is conducted according to law and the authorized regulations, and to provide school registers and a visitors' book, in the form prescribed by the Department of Education;

(11) To see that no unauthorized books are used in the school, and that the pupils are duly supplied with an uniform series of authorized text-books, sanctioned by the Advisory Board; and to do whatever they may deem expedient in regard to procuring apparatus, maps, prize and library books for their schools;

(12) To cause to be prepared and read at the annual meeting of the ratepayers, a report for the year then ending, containing, among other things, a summary of their proceedings during the year, together with a full and detailed account of the receipt and expenditure of all school moneys received and expended in behalf of the district for any purpose whatever, during such year, and signed by the trustees, and by either or both of the school auditors of the district;

(13) To transmit to the Department of Education the semi-annual and

38-(1) In unorganized territory it shall be lawful for the inspector of the Formation of school district to form a portion or the whole of such territory into a school district. districts.

(2) No such district shall, in length or breadth, exceed five miles in a Limits of straight line, and, subject to this restriction, the boundaries may be altered by school districts. the same authority from time to time, and the alteration shall go into operation on the twenty-fifth day of November next after such alteration; Provided always, no such school district shall be formed except on the petition of five heads of families resident therein. R.S.O., c. 225, s. 41.

(39) After the formation of such a school district, it shall be lawful for Election of school trustees any two of the petitioners, by notice posted for at least six days in not less than three of the most public places in the district, to appoint a time and place for a meeting for the election, as provided by law, of three school trustees for the district. R S. O., c. 225, s. 43.

(40) The trustees elected at such meetings, or at any subsequent school Powers and meetings of the district, as provided by law, shall have all the powers and be obligations of trustees. subject to all the obligations of public school trustees generally. R. S. O., c. 225, s. 44.

(41) The Inspector shall assume the functions of court of revision for Inspector to any such district, and all the proceedings of the Inspector in the matter of the court of court of revision or correction of the assessment roll, shall be subject to the provisions of revision. this Act, and shall have the same effect as if made in a court of revision. R. S.O., c. 225, s. 44.

(42) The trustees of all school districts in unorganised territory shall, Annual assessannually, appoint a duly qualified person to make out an assessment roll for the district. R. S. O., c. 225, s. 45.

(43) A copy of the said roll shall be opened to inspection by all persons Appeal interested, at some convenient place in the district, notice whereof, signed by the against assessment. secretary-treasurer of the district, shall be annually posted in at least three of the most public places in the district, and shall state the place and the time at which the Inspector will hear appeals against said assessment roll, and such notice shall be posted as aforesaid by the trustees for at least three weeks prior to the time appointed for hearing the appeals. R. S. O., c, 225, s. 46.

(44) All appeals shall be made in the same manner and after the same Manner of notice, as nearly as may be, as appeals are made to a court of revision in the case ^{appeal}. of ordinary municipal assessments, and the Inspector shall have the same power as ordinary municipal courts of revision. Provided, that the court of revision need not be held in the district, R.S.O., c. 225, s. 47.

In forming union schools districts between, and out of, an organized municipality and an unorganized locality, it shall be lawful for such union school district to be formed or altered according to the provisions of this Act, except that the Inspector shall act for the unorganized locality, and the reeve of the organized municipality for his municipality. R.S.O., c. 225, s. 50.

48. The trustees shall appoint some fit and proper person, or one of themselves, to be a collector (who may also be secretary-treasurer), to collect the rates imposed by them upon the ratepayers of their school district, or the sums which the inhabitants or others may have subscribed; or a rate-bill imposed on any person; and pay to such collector, at the rate of not less than five, or more than ten per centum on the moneys collected by him; and every such collector shall give such security as shall be satisfactory to the trustees, which security shall be lodged for safe keeping with the Inspector by the trustees. R.S.O., c. 225, s. 51.

49. Every such collector shall have the same powers in collecting the school rate, rate-bill of subscriptions, shall be under the same liabilities and obligations, and proceed in the same manner in his school district as a municipal collector does in his municipality, in collecting rates, as provided in the Municipal and Assessment Acts, from time to time, in force. R.S.O., c. 225, s. 52.

50. A statement of arrears of taxes on lands may be returned by the collector to the secretary-treasurer of a rural municipality, near to such school district to be designated by the Inspector. Upon receipt of such statement of arrears of taxes by the secretary-treasurer, such municipality shall proceed to collect the same by sale of such land for taxes or otherwise, in the same manner, and with the same effect as if such lands were situate in and such taxes had been levied by such municipality. All moneys collected on account of such arrears, shall be paid over by such rural municipality to such board of school trustees, less a charge of five per cent. for collecting the same.

51. The above provisions as to unorganized territory shall apply to school districts formed but not within the limits of any organized municipality.

RURAL SCHOOL SITES.

52. Before any steps are taken by the trustees for securing a new school site on which to erect a new school house, they shall call a special meeting of the ratepayers of the district to consider the site proposed; and no change of school site shall be made except in the manner hereinafter provided, without the consent of the majority of such special meeting. R.S.O., c. 225, s. 64.

53. In case a majority of the trustees and a majority of the ratepayers present at such special meeting differ as to the situation of a new site, each party shall then and there choose an arbitrator, and the Inspector, or, in case of his inability to attend, any person appointed by him to act on his behalf, shall be a third arbitrator; and such three arbitrators, or a majority of them present at any lawful meeting, shall have authority to make and publish an award upon the matter or matters submitted to them. R.S.O., c. 225, s. 65.

54. With the consent, or at the request of the parties to the reference, the arbitrators, or a majority of them, shall have authority, within three months

from the date of their award, to reconsider such award and make and publish a second award, which award (or the previous one, if not reconsidered by the arbitrators) shall be binding upon all parties concerned for at least one year from the date thereof. R.S.O., c. 225, s. 66.

If the owner of the land selected for a new school site, or required When owner 55.for the enlargement of school premises, refuses to sell the same, or demands therefor a price deemed unreasonable by the trustees of any district, then such owner and the trustees shall each forthwith appoint an arbitrator, and the arbitrators thus appointed, together with the inspector, or in case of his inability to attend, any person appointed by him on his behalf as third arbitrator, or any two of them, shall appraise the damages for such land. R.S.O., c. 225, s. 67.

56. If the majority of the school trustees, or the majority of a public Appointment school meeting, neglect or refuse, where there is a difference in regard to the of arbitrators selection of a school site, to appoint an arbitrator, as provided in the preceding section, or if the owner of the land selected as a school site, as provided by the said section, neglects or refuses to appoint an arbitrator, it shall be competent for the Inspector, with the arbitrator appointed, to meet and determine the matter; and the Inspector, in case of such refusal or neglect, shall have a second or casting vote, if he and the arbitrator appointed do not agree. R.S.O., c 225, s. 68.

57-(1) The arbitrators aforesaid, or any two or them, shall have the Additional power to settle all claims or rights of incumbrancers, lessees, tenants or other arbitrators. persons, as well as those of the owner, in respect of the land required for the purpose of the school site, upon notice in writing to every such claimant, and after hearing and determining his claims or rights.

Upon the tender or payment of the amount of such damage to the Taking land. (2)owner or other person entitled thereto, or to any part of such amount, by the school trustees, the land shall be taken and used for the purpose aforesaid. R.S.O., c. 225, s. 69.

58. If only a majority of the arbitrators appointed to decide any case Proceedings arising under the authority of this Act are present at any lawful meeting, in where an arbitrator is consequence of the neglect or the refusal of the other arbitrator to meet them, it absent. shall be competent for those present to make and publish an award upon the matter or matters submitted to them. or to adjourn the meeting for any period not exceeding ten days, and give the absent arbitrator notice of the adjournment. R.S.O., c. 225, s. 70.

59. Any award for a school site, made and published under this Act, if Award to conthere be no conveyance, shall thereafter be deemed to be the title of the trustees to the land mentioned in it, and shall be a good title thereto against all persons interested in the property in any manner whatever, and shall be registered in the proper Registry Office or Land Titles Office, on the affidavit of one of the trustees verifying the same. for and on behalf of themselves, their heirs and successors, but also for and on behalf of those they represent, whether infants, issue unborn, lunatics, idiots, femmes-couvertes, or other person seized, possessed of or interested in any land, may contract for, sell or convey all or part thereof to school trustees for a school site, or an addition to the school site, or for a teacher's residence ; and any contract, agreement, sale, conveyance and assurance so made, shall be valid and effectual to all intents and purposes whatsoever; and the corporations or persons so conveying, are hereby indemnified for what they respectively do by virtue of. or in pursuance of this Act. R.S.O., c. 225, s. 75. If the owner of land, duly selected for said purpose, is absent from 63.

the municipality in which the land lies, or is unknown, the trustees may procure from a sworn surveyor, a certificate that he is not interested in the matter: that he knows the land, and that some certain sum therein named is, in his opinion a fair compensation for the same; and on filing the said certificate with the Judge of the County Court of the district in which the land lies, accompanied by an affidavit or affidavits which satisfy the Judge that the owner is absent from the municipality, and that, after diligent enquiry, he cannot be found, the Judge may order a notice to be inserted, for such time as he sees fit, in some newspaper published in the district; and he may, in addition thereto, order a notice to be sent to any person by mail, or may direct service of the same, to be effected in such other way as he sees fit. (3) Any such by-law shall not be passed later than the first day of May, By-laws unitin any year, and shall not take effect before the twenty-fifth day of November ing districts. next thereafter, and it shall be the duty of the clerk to send forthwith, after such by-law has been passed, a copy of the by-law and minutes relating to the formation or alteration or union to the trustees of every school district affected thereby, and to the Inspector. R.S.O., c. 225, s. 81; 44 Vic., c. 4, s. 14; 47 Vic., c. 37, s. 3.

69.—(1) A majority of the trustees, or any five ratepayers of one or Appeal to more of the school districts concerned, may appeal to the County Court Judge County Judge of the district in which such district or districts is or are situated, against any by-law or resolution passed at any time previously by the municipal council, for the formation, division, union or alteration of their school district or districts, or against the neglect or refusal of the municipal council (on application being made to it by the trustees, or any five ratepayers concerned) to form, divide, unite, or alter the boundaries of a school district or school districts within the municipality. 48 Vic., c. 49, s. 82 (1); 50 Vic., c. 39, s. 14 (1).

(2) Such County Court Judge shall have power to revise, determine, or Appointment alter the boundaries of the school district or school districts so far as to settle the matters complained of; but the alterations or determination of the said matters shall not take effect before the twenty-fifth day of November in the year in which the Judge so decides, and shall thence continue in full force for the period of three years at least, and until lawfully changed by the municipal council, but such change shall be subject to the like appeal to the County Court Judge; Provided, that where the decision of the Judge does not affirm that of Proviso. the council, and an application for reconsideration signed by a majority of the ratepayers affected by the decision, or signed by a majority of the trustees of

the district or districts affected by the decision, is delivered to the Judge of the County Court within three months of the giving of the decision, the said Judge may reconsider the matter, and if he thinks fit, may vary such decision, and shall, in such case, direct at what time the decision as varied shall go into effect, and the three years hereinbefore limited shall, in such case, be computed from the time when the decision varying the former decision is given.

(3) Due notice of the alterations or the determination of the said matters made by the Judge, shall be given by the Judge to the clerk of the municipality, and to the trustees of the school districts concerned.

(4) Such Judge shall be entitled to be paid the sum of five dollars per day, and actual travelling expenses in connection with said appeals, by the municipality in which the district or districts involved are situate. In case such district or districts is or are situate in more municipalities than one, then such payment shall be made by such municipalities in the proportion ordered by such Judge. R.S.O., c. 225, s. 82.

70. On the formation, dissolution, division or alteration of any school district in the same municipality, in case the trustees of the districts interested are unable to agree, the Inspector and two other persons appointed by the council as arbitrators shall value and adjust in an equitable manner all rights and claims consequent upon such formation, division, dissolution or alteration between the respective portions of the municipality affected, and determine in what manner and by what portion or by whom the same shall be settled; and the determination of the said arbitrators, or any two of them, shall be final and conclusive. R.S.O., c. 225, s. 83.

71. In case a school site or school house or other school property is no longer required in the district, in consequence of the alteration or the union of school districts, the same shall be disposed of, by sale or otherwise, in such a manner as a majority of the ratepayers in the altered or united school districts may decide at a public meeting called for that purpose; and the inhabitants transferred from one school district to another shall be entitled, for the public school purposes of the district to which they are attached, to such a proportion of the proceeds of the sale of such school house or other public school property as the assessed value of their property bears to that of the other inhabitants of the school district from which they have been so separated; and the residue of such proceeds shall be applied to the erection of a new school house in the old school district, or to other public school purposes of such old district. In the case of united districts, the proceeds of the sale shall be applied to the like public school purposes of such united districts. R.S.O., c. 225, s. 84.

FORMATION AND DISSOLUTION OF UNION SCHOOL DISTRICTS COMPOSED OF PARTS OF TWO OR MORE MUNICIPALITIES.

72. A union school district may be formed between (a) parts of two or ^d more adjoining rural municipalities; (b) parts of one or more rural municipalities and an adjoining town or village. R.S.O., c. 225, s. 85.

73. The following shall be the procedure for the formation, alteration or dissolution of union school districts:

(1) On the joint petition of five ratepayers of the territory in question from each of the municipalities concerned, to their respective municipal councils

Procedure for formation, alteration or dissolution of union. asking for the formation, alteration or dissolution of a union school district, each municipal council so petitioned may appoint an arbitrator (who must not be a member of the council), notice of which shall be sent by the respective clerks to the Inspector or Inspectors, who shall be ex-officio arbitrators.

(2) In cases where the persons so appointed arbitrators would be an even number, the Senior County Court Judge shall be added, or in the case of an arbitration affecting two or more judicial districts, then the Senior County Court Judge of the judicial district having the largest population according to the last Dominion census.

(3)The first meeting of the arbitrators appointed under this section shall be called by the Inspector representing the greatest number of schools, and such Inspector shall give reasonable notice in writing of such meeting to the clerks of the municipalities concerned.

(4) The arbitrators, or a majority of them, shall report to the municipalities concerned upon the expediency of such union, alteration or dissolution, the specific parcels of land to be included in such union, and the proportion in which the part in each municipality shall be liable to contribute towards the erection and maintenance of the school and other requisite expenses; and shall at the same time value and adjust in an equitable manner all rights and claims consequent upon the formation, alteration or dissolution of such union between the respective municipalities and school districts concerned, and shall also determine in what manner and by what municipality or municipalities or what portions thereof the same shall be settled and the sum or sums of money to be paid by one portion of the municipalities or school districts concerned to the union school so formed, altered or dissolved, and the disposition of the property of the union and any payment by one portion to the other, and such valuation, adjustment and determination shall form and be considered as an integral portion of their report, and such report shall be taken as the award of the said arbitrators, and shall be binding on the the municipalities and school districts concerned subject to the provisions of this Act.

(5) The Inspector entitled under Sub-section 3 to call the meeting of the arbitrators, shall call the first meeting for the election of trustees.

(6) Such union alteration, or dissolution, shall not take effect until the 25th day of the month of November, which will be at least three months after the award of the arbitrators is filed with the clerks of the municipalities concerned.

Nothing herein contained shall be construed as restraining any (7)municipal council from enlarging the boundaries of any union school district as may be deemed expedient. R.S.O., c. 225, s. 86; 52 Vic., (Ont.) c. 52.

74-(1) The union of part of one or more rural municipalities with a Union of parts town or village shall be deemed one school district, and as belonging to such of municipali-ties to be one town or village, and the provisions of this Act respecting public schools in towns school district or villages shall apply thereto; and such part of the rural municipality for all school purposes shall be deemed to be united to such town or village.

(2) In the case of a town or village divided into wards to which a part of an adjoining rural muncipality or municipalities is attached for school purposes purposes, the board of trustees of such union school district shall by resolution determine in which ward or wards the ratepayers in such part shall vote for the election of school trustees and at elections on other school questions, and in case

of no such resolution, then such portion of the rural municipality shall be considered for all election purposes as attached to the ward or wards adjacent. R.S.O., c. 225, s. 90.

75-(1) Once in every three years the assessors of the municipalities in which a union school district is situated, shall after they have completed their respective assessments and before the 1st day of July, meet and determine what proportion of the annual requisition made by the trustees for school purposes shall be levied upon, and collected from the taxable property of the respective municipalities out of which the union school district is formed, and in the event of the assessors disagreeing as to such proportion, the Inspector in whose district the union school is situate, shall name a third person, who with the assessors aforesaid shall determine the said matter and report the same to the clerks of the respective municipalities, and the decision of a majority shall be final and conclusive for the said period of three years.

(2) When the union school district is composed of two adjoining inspectoral districts then on the disagreement of the assessors the Inspector of the district concerned containing the greatest number of schools shall name an arbitrator. R.S.O., c. 225, s. 91.

76. Any by-law passed for the formation, alteration or dissolution of school districts, shall become absolutely legal and valid, and the jurisdiction of any court to question the same shall be deemed to be ousted when such by-law has been submitted to and confirmed by the Department of Education, who shall require notice to be given of such application by the parties applying, by advertisement or otherwise, as they may direct, and the certificate of the Provincial Secretary endorsed on a certified copy of such by-law shall be conclusive evidence of such confirmation, and the provisions of this section may be taken advantage of for the confirmation of any by-law for any of such purposes heretofore passed and not quashed or otherwise declared invalid, and this section shall be deemed to apply to any such by-law. R.S.O., c. 225, s. 92.

77. In case a portion of the territory composing one or more school districts becomes incorporated as a village or town, the boundaries of such school district or districts shall continue in force and be deemed a union school district, notwithstanding such Act of incorporation, until altered as provided in Sec. 73 of this Act. R.S.O., c. 225, s. 93.

PUBLIC SCHOOL BOARDS IN CITIES TOWNS AND VILLAGES.

78-(1) In case any village, town or city, is incorporated, the trustees having jurisdiction over the school property situated within such village, town or city, prior to its incorporation, shall exercise all the powers conferred by this Act, upon the trustees of villages, towns or cities, until a new election of trustees is held, and such trustees shall call a meeting of the ratepayers of such village, New election. town or city, within one month after the date of such incorporation for the election of a new public school board.

(2) In calling the meeting of the rate payers of such newly incorporated village, town or city, the provisions of Section 82 shall be complied with, so far as the same are applicable. R.S.O., c. 225, s. 94.

(2) A separate set of ballot papers shall be prepared by the clerk of the Ballot papers. municipality for all the wards or polling sub-divisions, containing the names of the candidates nominated for school trustees, of the same form as those used for councillors, except the substitution of the words "school trustee" for councillors or alderman, as the case may be, on said ballot papers. R.S.O., c. 225, s. 103; 44 Vic., c. 4, s. 24; 48 Vic., c. 27, s. 16.

83. Any actual resident ratepayer of the full age of twenty-one years, who may be able to read and write and not disqualified under this Act, shall be eligible to be elected trustee elected a public school trustee in any city, town or village. R. S. O., c. 225, s. 106.

All contestations with regard to the election or qualification of school contestations. 84. trustees in cities, towns and villages shall be regulated by the same law as that of municipal councillors and aldermen. (a.) The collector or collectors, and secretary, and treasurer, or secretarytreasurer (who may be of their own number), shall discharge similar duties, and be subject to similar obligations and penalties and have similar powers as the like officers in the municipality;

(2). To provide adequate accommodation, according to the regulations of the Department of Education, for all the children between the ages of six and sixteen, resident in the municipality, as ascertained by the census taken by the municipal council for the next preceding year;

(3) To purchase or rent school sites and premises, and to build, repair, furnish and keep in order the school houses and appendages, lands, enclosures and moveable property, and procure registers in the prescribed form, suitable maps, apparatus and prize books, and, if they deem it expedient, establish and maintain school libraries;

(4) To determine the number, kind, grade and description of schools (such as male, female, infant, central or ward schools), to be established and maintained; the teachers to be employed; the terms on which they are to be employed; the amount of their remuneration, and the duties which they are to perform;

(5) To prepare, from time to time, and lay before the municipal council of the city, town or village, on or before the first day of August, an estimate of the sums which they think requisite for all necessary expenses of the schools under their charge;

(6) To collect, at their discretion, from the parents or guardians of children attending any public school under their charge, a sum not exceeding twenty cents per month per pupil, to defray the cost of text-books, stationery and other contingencies, and to see that all the pupils in the schools are duly supplied with a uniform series of authorized text books, and to collect, at their discretion, from the parents or guardians of children who do not reside or are not assessed within the school district a sum not exceeding one dollar per month for each pupil attending school;

(7) To submit all accounts, books and vouchers to be audited by the municipal auditors, and it shall be the duty of such auditors to audit the same;

(8) To give orders on the treasurer of the public school board for all moneys expended for school purposes;

(9) To constitute, at their discretion, one or more of the public schools of such city to be a model school for the preliminary training of public school teachers therein, subject to the regulations of the Department of Education;

(10) To publish at the end of every year, in one or more of the public newspapers, or otherwise, the annual report of the auditors, and to prepare and transmit annually, before the 15th January, to the Department of Education, in the form prescribed by said Department, a report signed by the chairman containing all the information required by the regulations of the Department of Education;

(11) Every public school board in a city, town or village shall have the same power to take and acquire land for a school site, or for enlarging school premises already held, as the trustees of rural schools; and shall have the same powers in regard to school property generally as are conferred upon the trustees of rural schools by Sub-section 9 of Section 37 of this Act; Provided always, that vacant land only shall be taken in such city, town or village for a school site Exceptions. without the consent of the owner, and in the event of disputes between the owner of the land selected and the trustees, Sections 52 to 60 of this Act shall apply;

To provide, if deemed expedient, for children between three and Kindergarten (12)schools. six years of ago a course of instruction and training according to the methods practised in kindergarten schools, subject, however, to the regulations of the Department of Education in that behalf;

(13) To dismiss from the school any pupil who shall be adjudged Dismissal of refactory so refractory by the trustees (or by a majority of them) and the teacher that his pupils. presence in school is deemed injurious to the other pupils. R. S. O., c. 225, s. 113; 44 Vic., c. 4, s. 39; 46 and 47 Vic., c. 46, s. 11; 47 Vic., c. 37, ss. 12 and 13; 48 V., c. 27, s. 17.

(14) To appoint a superintendent for the city, town or village.

SCHOOL CENSUS.

87. The municipal council of every rural municipality, city, town and Census. village shall cause the assessor or assessors, in preparing his or their annual assessment roll, to set down therein, in separate columns, the number of children in rural municipalities between the ages of five and sixteen, and in cities, towns, and villages between the ages of six and sixteen, opposite the name of each person on the assessment roll who are resident with him, and the clerk of the municipality shall furnish the secretary-treasurer of each district, or the secretary of the board of trustees for the city, town or village (as the case may be) and the Public School Inspector with a statement of the total number of children aforesaid in each school district, or in the city, town or village (as the case may be). R. S. O., c. 225, s. 114; 44 Vic, c. 4, s. 83.

The clerk of every municipality shall also, upon request, and free Clerk to give 88 of any charge, furnish the Public School Inspector with a true statement of the copy of assessed value of each school district, as shewn by the revised assessment roll Inspector. for that year, and also of the several requisitions of the trustees for school moneys. R. S. O., c. 225, s. 116.

SCHOOL ASSESSMENT.

89.—(1) For the purpose of supplementing the Legislative grant, it shall Amounts to be the duty of the council of each rural municipality, to levy and collect each be levied by year, by assessment upon the taxable property within the municipality, a sum rural municipality. equal to twenty dollars for each month, for which school has been kept open in palities. each school district in the municipality during the current year; and for each school district partially included within the municipality, they shall levy and collect in like manner, a proportionate part of twenty dollars per month as fixed in the manner hereinafter provided. A school district which employs more than one teacher, shall receive said sum of twenty dollars per month for each teacher employed.

From the moneys so levied and collected, the council shall, upon Apportion-(2)the first day of December following, pay over to each school district, wholly or ment of amounts partially included in the municipality, one half the sum of twenty dollars per levied. month, or the proportion thereof allotted to such district as hereinbefore provided;

and upon the thirty-first day of January following, shall pay over the whole of the balance due to the said trustees, whether the necessary amount has been fully collected or not from the tax levied for the same; Provided that no board of trustees shall be entitled to receive a larger total amount for the school year than twenty dollars for each teacher, for each month within the same that they have actually had a teacher engaged at a salary, and, in case of doubt or dispute as to the number of months, the certificate of the Inspector shall decide.

(3) It shall be the duty of the trustees of each school district wholly situated in a municipality, to lay before the council, at its first meeting after the thirty-first day July in each year, a statement of the number of months in the current school year, during which they have kept and will keep school open, and the number of teachers employed; and before the thirty-first day of January following shall notify the clerk of the municipality if they have failed to keep a teacher engaged as so stated by them, and, in such case, give the actual number of months they have had such teacher engaged.

(4) In the case of union school districts the municipal council of each municipality of which the union school district is composed shall levy and collect upon the taxable property of the municipality the said sum in the proportion which the assessment of the part of such union school within the municipality bears to the whole assessment of such union school district, as equalized under Section 75 of this Act.

(5) Any board of school trustees that fails to notify their council, in due time, of the number of months their school is to be kept in operation during any school year, as hereinbefore required, shall not be entitled to receive a larger amount in such year from the municipal levy than the council may, in their discretion, fix for them; and any board of trustees failing to keep a teacher under engagement the full time stated by them, shall not be entitled to receive their second instalment of school moneys due on January thirty-first, until they have notified the clerk of the municipality of the actual time such teacher has been under engagement; any board of trustees wilfully making a false statement in regard to such time shall forfeit their second instalment.

100.-(1.) No loan under two thousand dollars shall be made for any term exceeding ten years, nor shall a loan be made, in any case, for a term exceeding twenty years.

(2.) The principal of such loan shall be made payable by annual instalments, unless with the sanction of the Department of Education. All school boards that have heretofore issued, or may hereafter issue, sufficient to meet such debentures when due; such sinking fund may be invested with the Provincial Treasurer, who shall pay interest upon the same at the rate of 4 per cent. per annum, compounded annually. The names under which the corporations of school districts existing at the date of the coming into force of this Act are known, shall continue to be their respective corporate names until altered by the Department of Education under the provisions of this section, and no change in the corporate name of any school district made in accordance with the provisions of this Act shall effect any obligations, rights, actions or property incurred, established, done or acquired prior to such change.

> To furnish to the Department of Education, or to the School Inspector, (9.)from the trustees' report or otherwise, any information which it may be in his power to give respecting anything connected with the operations of his school, or in any wise affecting its interests or character;

> (10.) To prepare, so far as the school registers supply the information, such reports of the corporation employing him as are required by the regulations of the Department of Education;

> To notify the medical health officer of the municipality, or where there (11.)is none to notify the local board of health or the trustees, whenever he has reason to believe that any pupil attending school is affected with or exposed to smallpox, cholera, scarlatina, diphtheria, whooping-cough, measles, mumps or other contagious disease, and to prevent the attendance of all pupils so exposed, or suspected of being exposed, until furnished with a written statement of the health officer, or of the local board of health, or of a physician, that such contagious diseases did not exist, or that all danger from exposure to any of them had passed away. R.S.O, c. 225, s. 153; 44 Vic., c. 4, s. 75.

Every qualified teacher of a public school employed for any period not 128.which teacher less than three months shall be entitled to be paid his salary in the proportion which the number of teaching days during which he has taught in the calendar year bears to the whole number of teaching days in such year, unless otherwise expressly agreed. It shall be the duty of the trustees of every rural school district and of every public school board to admit, on payment in advance of fees not exceeding fifty cents per pupil for every month, any non-resident pupils who reside nearer to such school than the school in their own district; and in case of dispute as to the distance from the school the Inspector shall decide; but no trustee shall be required to admit any such children, unless they have sufficient school accommodation and a sufficient teaching staff besides what is required for the children attending such school from their own district.

HOLIDAYS.

140. Every Saturday, every statutory holiday, and every day proclaimed a holiday by the municipal authorities in which the school district is situated, shall be a holiday in the public schools. R.S.O., c. 225, s. 204; 44 Vic., c. 4, s. 100.

AUTHORISED BOOKS.

141. No teacher shall use or permit to be used as text books any books in a model or public school, except such as are authorized by the Advisory Board, and no portion of the legislative grant shall be paid to any school in which unauthorized books are used. R.S.O., c. 225, s. 205.

142. Any authorized text book in actual use in any public or model school may be changed by the teacher of such school for any other authorized text book in the same subject on the written approval of the trustees and the inspector, provided always such change is made at the beginning of a school term, and at least six months after such approval has been given. R.S.O. c. 225, s. 206.

143. In case any teacher or other person shall negligently or wilfully substitute any unauthorized text book in place of any authorized text book in actual use upon the same subject in his school, he shall for each such offence, on conviction thereof before a Police Magistrate or Justice of the Peace, as the case may be, be liable to a penalty not exceeding \$10 payable to the municipality for public school purposes, together with costs, as the Police Magistrate or Justice may think fit. R.S.O., c. 225, s. 207.

LIBRARIES.

144. The council of every municipality may raise by assessment such sums as it may judge expedient for the establishment and maintenance of a public school library, subject to the regulations of the Department of Education. R. S. O., c. 225, s. 208.

SPECIAL INQUIRIES.

145. The Department of Education shall have power to appoint one or more persons, as the Department from time to time deems necessary, to inquire into and report to the Department upon any school matter; such person or persons shall be entitled to such remuneration out of any moneys appropriated by the Legislature for that purpose as may be deemed just and equitable,

Such person or persons, or any of them, shall have power to administer oaths to witnesses, or Power to require them to make solemn affirmation of the truth of the matters they may be commissioners to administer examined upon. (7.) The above clauses, one to six, both inclusive, shall be applicable to executions against a school district lying within more than one municipality, but in such case the said sheriff shall strike a rate on the assessable lands in said school district from the assessment rolls of the several municipalities in which said school district is situate, and shall deliver to the treasurer of each of the municipalities the precept or precepts aforesaid. 52 Vic., c. 21, s. 2.

GENERAL PROHIBITIONS.

176. No teacher, trustee, inspector, or other person, officially connected with the Department of Education, or Model, Public, or High Schools, shall become or act as agent for any person or persons to sell, or in any way to promote the sale for such person or persons, of any school, library, prize or textbook, map, chart, school apparatus, furniture or stationery, or to receive compensation or other remuneration or equivalent for such sale, or for the promotion of sale in any way whatsoever. R.S.O., c. 225, s. 266.

HOW FINES AND PENAL/TIES MAY BE RECOVERED.

177.—(1.) Unless it is in this Act otherwise provided, all fines, penalties and forfeitures may be sued for, recovered and enforced, with costs, by and before any police magistrate, or justice of the peace.

(2.) If the fine, or penalty and costs, are not forthwith paid, the police magistrate or justice shall, by his warrant, cause the offender to be imprisoned for any time not exceeding thirty days, unless the fine and costs are sooner paid.

(3.) On receiving such fine or penalty the police magistrate or justice shall pay the same over to the secretary-treasurer of the school district or other party entitled thereto, except as otherwise provided in this Act.

(4.) The provisions of the Act of the Parliament of Canada, known as the Summary Convictions Act, shall apply to all such prosecutions so far as the same are applicable. R.S.O., c. 225, s. 267; 44 Vic., c. 4, s. 117.

PROVISIONS AS TO CATHOLIC SCHOOL DISTRICTS.

Catholic X 178. In cases where, before the coming into force of this Act, Catholic school districts covering school districts have been established, covering the same territory as any

Protestant school district, and such Protestant school district has incurred same territory as Protestant indebtedness, the Department of Education shall cause an inquiry to be made as school to the amount of the indebtedness of such Protestant school district and the districts. amount of its assets. Such of the assets as consist of property shall be valued on the basis of their actual value at the time of the coming into force of this Act. In case the amount of the indebtedness exceeds the amount of the assets, then all the property assessed in the year 1889, to supporters of such Catholic school districts shall be exempt from any taxation for the purpose of paying the principal and interest of an amount of the indebtedness of such school district equal to the difference between its indebtedness and assets. Such exemption shall continue only so long as such property is owned by the person to whom the same was assessed as owner in the year 1889.

179. In cases where, before the coming into force of this Act, Catholic school districts have been established as in the next preceding section mentioned, school such Catholic school districts shall, upon the coming into force of this Act, cease districts to to exist, and all the assets of such Catholic school districts shall belong to, and all the liabilities thereof be paid by the public school district. In case the liabilities of any such Catholic school district exceed its assets then the difference shall be deducted from the amount to be allowed as an exemption, as provided in the next preceding section. In case the assets of any such Catholic school district exceed its liabilities, the difference shall be added to the amount to be allowed as an exemption, as provided in the next preceding section.

180. All arrears of taxes levied under the authority of any such Catholic school board shall be considered as part of its assets, and shall be handed over taxes levied to the municipal council to be collected on behalf of the public school board.

181. The municipal council shall have all the power provided by the Assessment Act for the collection of such arrears, the same as if they were arrears of municipal taxes.

182. Chapter 4 of 44 Victoria, Chapters 8 and 11 of 45 Victoria, Chapter 46 of 46 and 47 Victoria, Chapters 37 and 54 of 47 Victoria, Chapter 27 of 48 Victoria, Chapters 18 and 19 of 50 Victoria, Chapter 31 of 51 Victoria, and Chapters 5 and 21 of 52 Victoria, are hereby repealed.

183. This Act shall come into force on the first day of May, A.D. 1890.
