Reasons for Judgment of Baxter C.J.

Baxter C.J. BAXTER C.J.:

Upon an originating summons I am asked:-

- 1. Who are entitled to the shares in the capital stock of Ganong Bros., Limited, either common or preferred, bequeathed under any clauses of either the last Will and Testament of Maria Famicha Ganong or the second codicil thereto?
- 2. When are the beneficiaries of the said shares entitled to delivery thereof?

During the argument the further question was asked:—

3. "Under the circumstances of the present case are any dividends "and if so, what, apportionable?"

Mrs. Ganong made a will dated 25th September 1924 to which she made a codicil dated 21st August 1926 on which nothing turns. She made a second codicil dated 13th October 1934.

On 15th March 1918 she entered into a trust deed which I have admitted in evidence but which I do not think has any material bearing upon the 40 questions raised. It is enough to say that it came to an end because of a

default under its terms by which 3790 preferred shares and 3600 common shares of the Ganong Company reverted to the estate of Mrs. Ganong, she having died before the actual revestment. By the 14th paragraph of the second codicil on the assumption that revocation of the trust deed will become operative she says "I do hereby give, devise and bequeath unto the several persons hereinafter named, relatives of my late husband, the number of "said Preferred Shares of the Capital Stock of Ganong Bros., Limited, here-"inafter mentioned, if, as and when the said Trust Shares are returned to Baxter C.J. "and vested in me or my estate." Here follow fourteen specific bequests of 10 these shares and the testatrix declared that the gift is conditional upon their revesting in her or her estate.

The answer to the questions involves the construction of Paragraph 20 of the second codicil which is as follows:-

"20. I hereby revoke and make void Paragraph 17 of my said last "Will and Testament dated the twenty-fifth of September, 1924, and in "lieu thereof and in substitution therefor I Will and declare that my "Executors and Trustees shall pay out of my personal estate any and "all Succession Duties which may at my death become payable upon any " of the bequests made in my said last Will and Testament or in any "Codicil thereto, including this Codicil, it being my intention that all "gifts and bequests, including gifts of shares in the Capital Stock of Ganong Bros., Limited, either Preferred or Common, to any nephew or "niece of my late husband, shall be free from Succession Duty."

"But while I make the aforegoing provision with respect to Suc-"cession Duty, it is my express Will and intention and I hereby direct "that notwithstanding anything hereinbefore contained any and all of "the shares of the Capital Stock of Ganong Bros., Limited, in and by "my said Last Will and Testament and in and by this Second Codicil "to my said last Will and Testament bequeathed by me, shall be and "remain the property of my Estate and be held by my Executors and "Trustees as part of my Estate until all dividends on the Preferred "Shares accrued to the date of my death have been paid in full and also "until the two half yearly dividends which shall accrue immediately "subsequent to the date of my death shall have been paid in full to my estate for the benefit thereof, it being my intention by this paragraph "of this Second Codicil to my will that all dividends on said Preferred " shares accrued due to the date of my death, whether earned or declared "or not, together with a full year's dividends accruing due after my "death, whether earned or declared or not, shall be paid to my Executors "and Trustees for the benefit of my Estate before making any transfers " of the stock or shares of Ganong Bros., Limited, Common or Preferred, "devised and bequeathed under my said last Will and Testament and "under this Second Codicil thereto."

Mrs. Ganong died 30th November 1934. At that time she owned or was entitled to 4890 preferred shares of Ganong Bros., Limited, of which

3790 shares had come from her husband the late Gilbert W. Ganong, and she also was entitled to 4036 shares of common stock of which 3600 had come from him. On 29th September 1934 she had given notice of revocation of the Trust Deed. She died before the notice became operative and the shares came to her executor after her death.

No. 3. Reasons for Baxter C.J. ---continued.

The contention on the part of the residuary legatees is that there was Judgment of no vesting of the shares in the persons to whom they were given until after the payment of the dividends referred to, and as the dividends have not yet been paid and as no one can tell that any ever will be paid the rule against perpetuities applies and the shares pass into residue.

> The executor would not have been bound to hand over the shares until a year after the testatrix's death. Williams on Executors (12th Ed.) p. 909, citing Wood v. Penoyre, 13 Ves. 333, 4, and Lord Redesdale in Pearson v. Pearson, 1 Sch. & Lef. 11. The shares would pass to the executor upon the death of the testatrix and what she has said in Clause 20 is only to my mind an extension of this rule. The time of annual meetings is fixed by the Directors of the Company under its by-laws and it is quite possible that the time of declaring a second half yearly dividend might be after something more than a year had elapsed after Mrs. Ganong's death. All she has said is that the shares are to remain in her estate until that time. She speaks of the 20 "two half yearly dividends which shall accrue immediately subsequent to "the date of my death." It is true that in the declaration of her intention which follows she does not repeat the word "immediately" but its use reveals her intention and there is no reason why I should not give effect to The explanation of her intention is directed to the simple fact that she wanted to give the shares but not to give the new holders any rights to dividends accruing—not a very apt term—before her death or to the dividends which should be earned or payable within a full year after her death. When she savs that these dividends "shall be paid to my executors and trustees "for the benefit of my estate" what can she mean? She is speaking of the 30 Ganong Company of which by-law 48 provides that "the Directors may "declare dividends out of the net profits of the company whenever and so "often as in their opinion the state of the company will permit." these dividends are paid no transfers were to be made. But there were no dividends nor any funds from which dividends could be declared. She died 30th November 1934. There was a net loss in 1934, 1935, 1936 and 1937 and an accumulated deficit at the end of that year of \$103,118.88. This appears from a statement by A. E. Cox, C.A., which by agreement has been put in at my request after the hearing. Now, who did she mean was to pay or, in fact, who could pay dividends except the company? It has been con-40 tended that she intended to impose a charge of two years dividends or of an amount equal thereto, \$68,460 upon the shares she was giving. To my mind this is inconceivable. Neither the financial condition of the company nor the language used warrants such an interpretation. It is "dividends" which she says are to be paid and that term can mean only one thing—a return to the

shareholders to be paid out of the profits of the company.

It is clear to my mind that the intention of the testatrix has been considerably obscured by the draftsman's confusion between preferential shares per se and the right of preferential shares upon a winding up. In Palmer's Company Precedents 12th ed. Vol. 1, page 800, I find: "Prima facie a pre-"ferential dividend is payable only out of the profits made whilst the company " is a going concern and it wants a special provision to give the holders a right "to have the arrears paid out of assets in winding up." Crichton's Oil Co. Reasons for (1902) 2 Ch. 86. If by the articles, arrears are to be paid they are payable Baxter C.J. Re Sprinkbok Agricultural Estates. although no profits have been made. 10 Ltd. (1920) 1 Ch. 563. The words generally used for this purpose are "as to "arrears of dividends whether declared or not up to the commencement of "the winding up." The trust deed, which was put in evidence, but which does not affect the case in any way, is full of instances of this confusion: Apparently there was an attempt to apply some of its irrelevant terminology in the drafting of Clause 20 of the second codicil. The shares dealt with were those of Ganong Bros., Limited. The by-laws of that company provided for the declaration of dividends by the Directors out of the net profits of the company "whenever and so often as in their opinion the state of the "company will permit." Dividends could not be declared if there were no 20 net profits. By-law number 54 provided for the issue of 10,000 shares of preference stock having fixed cumulative preferential dividends and priority in any division of the assets of the company to the extent of its repayment in full at par together with any dividends thereon then accrued due and remaining unpaid. They were to carry seven per cent. which is "payable as "may be convenient, half yearly," and the dividends were to be "payable "only out of the net profits of the company." Any attempt by the trust deed or by the will to alter the set up of the company is futile. The words in the will "whether earned or declared or not" would be apt with reference to the right of these preferential shares to rank upon the assets of the company 30 upon a winding up but are utterly meaningless in the connection in which they have been introduced. There were no dividends due at the date of the testatrix's death nor in the year immediately succeeding her death have any dividends been declared nor throughout the whole period could any dividends have lawfully been declared.

In my opinion the shares vested immediately in the persons to whom they were given by the 14th and 16th paragraphs of the second codicil. The revesting under the provisions of the Trust Deed became complete after the death of the testatrix.

"When the will is silent the legacy vests immediately if the time of pay-40" ment is postponed only for convenience. It is a material circumstance if "the legacy be severed from the rest of the estate." Per Joyce, J., in Couturier v. Shea 76 L. J., Ch. 296. In that case a legacy was to be set apart by the executors to be paid, part at 21, a further part at 25 and the balance at 30.

In the present case the shares are set apart from the rest of the estate by the mere designation of them. There can be no doubt as to the thing given or as to the takers. For the convenience of the testatrix, so that she or her estate may receive directly any dividends which there may be unpaid

at her death or any dividends which may accrue in the two half yearly periods after her death, the shares are not to be transferred until after those dividends are paid. Against this I am asked to conjecture that the testatrix meant that the shares were not to vest until after two half yearly dividends had been declared and paid even though that might not take place in fifty years. Then, it was said the rule against perpetuities came into play. I cannot accept a construction so contrary to what, to me, is the plain object of the testatrix. As said by Lord James of Hereford in Comiskey v. Bowring-Hanbury 74 L.J., Ch. 263, "our only duty is to discover what was the inten-"tion of the testator and we must make that discovery from the words used 10 "in the will." That I think I have done despite the embarrassment created by the technical language of the draftsman which has to some extent obscured but has not obliterated, the intention of his client. I find that the shares vested in the takers at the death of the testatrix but that the executor could not transfer them upon the books of the Company until certain dividends were paid; that no such dividends ever accrued; that the time fixed by the will have elapsed and that the legatees are entitled to receive their legacies. No separate or special questions arise as to the Old Folks Home or the Chipman Memorial Hospital which are included in the general answers. 20 categorical answers are:—

1. The persons and institutions named therein.

2. Immediately.

3. No question of apportionment arises.

All parties will be entitled to their costs as between solicitor and client.

GRIMMER J.:

This case arose under an originating summons by which Baxter C.J. was asked to interpret certain provisions of the will of the said Maria F. Ganong and answer the following questions:—

- (1) Who are entitled to the shares in the capital stock of Ganong Brothers Limited either common or preferred bequeathed under any clauses of either the last will and testament of Maria Famicha Ganong 30 or the second codicil thereto?
- (2) When are the beneficiaries of the said shares entitled to delivery thereof?
- (3) Under the circumstances of the present case are any dividends and if so, what, apportionable?

On the 12th of January last the learned Chief Justice delivered a judgment in which he answered the above questions as follows:—

- (1) The persons and institutions named therein.
- (2) Immediately.
- (3) No question of apportionment arises.

The facts are fully and in detail set forth in the judgment and this appeal

being taken, the result depends upon the construction to be placed upon the said will and two codicils thereto, under which a large number of preferred and common shares of the capital stock of Ganong Bros. While the learned Chief Justice states the answers to the questions involve the construction of paragraph 20 of the second codicil, I think they Reasons for Judgment of involve to some extent the provisions of the whole will, for it is our duty to Grimmer J. discover what was the intention of the testatrix, and that discovery we must 10 make from the words used in the will. This is one rule and another is that the general interest is to prevail against the particular interest; and if the Court can arrive at a general result as to what the testatrix intended, that general result will prevail over every particular construction. Comiskey vs. Bowring-Hanbury (1905) 74 L.J., Čh. p. 268. Haybergham vs. Ridehalgh (1879) L.R. 9 Eq. 395 at 400, and others to the same effect.

By her will Mrs. Ganong in section 20 said:—

"20. I hereby further will and declare that it is my intention and "purpose that any and all of the shares of Ganong Bros. Limited, so "hereby bequeathed as aforesaid, shall be and remain the property of "" my estate and be held by my Executors and Trustees as part of my "estate until after the first annual meeting of Ganong Bros. Limited, "shall have been held subsequent to my decease and until all dividends "accruing on said shares of stock from the business of the year in which "my decease may occur shall have been paid to my estate for the benefit "of my estate intending by this section of my will to show that both "semi-annual dividends on the Preferred shares that will be paid during "the fiscal year subsequent to my decease but which will have been "earned during the fiscal year my decease may occur must be paid to "my estate before making any transfers of the stock, shares devised and "bequeathed as aforesaid."

This plainly provides that no transfers of shares shall be made until certain dividends are paid out of profits earned during the fiscal year in which her decease occurs, and is a perfectly clear, distinct and positive indication of what she had in her mind and intended when the will was made, apparently realising that dividends could only be paid out of profits earned by the company. The expression "dividends accruing" used in this paragraph, wherein also is found the words "profits earned," must I think be considered as dividends in the "process of being earned." By paragraph 20 of the second codicil, which is quoted in full in the judgment appealed from, the testatrix 40 does not limit the condition to the payment of dividends which have been earned, but requires payment whether the dividends have been "earned or declared or not," and these words "earned, declared or not" in view of the trend of Mrs. Ganong's mind as expressed in her will, being as I think inconsiderately included in section 20 of the codicil, have created all the doubt and difficulty, for it is too clear for argument that had the draughtsman of the codicil followed or employed the language of the will as expressed in section

20 thereof, no question would ever have arisen as to the interpretation thereof. It is upon his interpretation of the meaning of these words, and the intention of the testatrix in using them, that my brother Harrison, in his judgment herein, which I have had the privilege of reading, but with regret cannot agree with, bases the conclusion he arrived at, and to these words I must make reference. First then I may say a "dividend" means prima facie a payment made to the shareholders while the company is a going concern and can only be paid out of the profits and not out of the capital. It is distinct law that no dividend shall be payable except out of the profits of the company. Crichton Oil Co. in re, 2 Ch. D. (1902) 95 per Sterling J. Palmer's Company 10 Precedents p. 749. Benefits Building Society, 35 Ch. D. 35. National Funds Association Society, 10 Ch. D. 124.

I think the expression "until all dividends on the preferred shares accrued "to the date of my death have been paid in full, and also until the two half "vearly dividends which shall accrue immediately subsequent to the date " of my death shall have been paid in full to my estate for the benefit thereof" is plain enough. It does not suggest that the legatees are to pay dividends, and no words are used creating a charge, as the shares are to remain under the control of the executors until certain dividends are paid, the idea that the dividends are in any way charged upon the shares is excluded. It is so clear 20 that the testatrix wanted her estate to get the dividends accruing up to the date of her death, that there is no excuse for any such construction as would suggest or involve the above mentioned idea, that the legatees and not the company were to pay them, for as I have already pointed out the term "dividend" relates only to a company and nothing else. If Mrs. Ganong intended that before getting the shares, the legatees must pay to her estate a sum of money equal to the maximum dividends which the Company could pay in respect of these shares, it could have been very simply expressed in practically the words I above suggested. The event that releases the shares is a payment out of dividends, not a charge against them. From her will it can 30 reasonably be deduced that Mrs. Ganong was fully aware of By-law 54 of the Company creating the preferential shares, which were to be issued having fixed cumulative preferred dividends, and having priority in any division of the assets of the company, to the extent of their repayment in full at par, together with any dividends thereon then accrued due and remaining unpaid. To carry this out the by-law makes the issue of preference stock a lien upon the assets of the company, so that on any dissolution or winding up of the company, or liquidation of its business or assets, or in any division of capital or assets of the company among the shareholders thereof, the holders of preference stock, shall be entitled to payment for their stock in full at par (together with any 40 dividends in arrears, etc.). These as the learned Chief Justice has pointed out are proper and relevant provisions to ensure preference and priority for their shares on a winding up. But they cannot make dividends payable when there is nothing out of which to pay them.

By-law 48 only expresses the general law when it says that the directors may declare dividends out of the "net profits of the company." Out of what else it may be asked could they declare them? Certainly as I have

pointed out, not out of capital. Making the shares cumulative implies that there may not in some years be a full 7% dividend, and that the shortage will be carried forward until the company is able to pay the arrears, but never out of anything else than profits. Mr. Inches contended for the payment of two years preferential dividends by the legatees, though the company was unable to pay a single cent during that period, because it had no profits out of which to pay them. Suppose there had been enough profits to pay 2% Reasons for on the preferential shares and no more, how could it be contended that the Grimmer, J. remaining 5% could be assessed upon the legatees. Of course if such had -continued. 10 been the case the cumulative dividend would have been payable in some subsequent year when there were sufficient net profits to do so, or if there never was such a period, then upon winding up. But the testatrix has spoken of dividends alone. She has not said they were to be of the full amount of seven per cent. Is not the natural meaning of her language that she wanted such dividends as there were, whatever the amount might be, to go to her estate, and not to go with the shares to the legatees. This is to me plainly implied in the language of the will and in fact is so expressed. Now there might be a half years dividend accrued, at the date of her death. There might be more. She provides for whatever there was and adds "the two 20 " half yearly dividends which shall accrue immediately subsequent to the date " of my death." Later she calls these a full years dividends accruing due after my death whether "earned or declared or not." It seems to me that her plan is fairly clear. She did not intend the legatees to get a possible control of the company and perhaps manipulate its affairs, so that though there would be sufficient profits to pay them, yet the dividends would not be declared. One thing is clear however, there cannot be such a thing as a dividend, as I have stated, until it is earned, and the use of the words "earned or declared or not" by the testatrix is as stated by the learned Chief Justice meaningless, except in cases of winding up when preferential shares may get 30 their dividends out of capital assets. The very use of the word dividend (to repeat) implies that it was money to be paid to her by the company and out of the earnings. There is no language imposing a charge of an amount equal to the dividends, upon the legatees, and there is no reason for implying anything of the kind. It would be absurd to think that the testatrix intended to take 14 per cent of the nominal capital value of the shares bequeathed, especially at a time when the company could not pay any dividend at all. What would be the point in saying that the shares bequeathed should "be "and remain the property of my estate, and be held by my executors and "trustees, as part of my estate until all dividends, etc., have been paid in full" 40 unless it was to have her executors collect and receive these dividends from the company? If she meant to charge the shares in the hands of the legatees, with such payment, she would undoubtedly have allowed them to pass at once, and charged them specifically with whatever amount she intended the legatees to pay. The answer is plain. She was not selling the shares to her legatees; she was giving them, but she was retaining sufficient control, to assure to her estate, whatever dividends might accrue during certain periods, and being dividends, were a claim against the company and against it alone.

Further, there is no clear direction that the amount of the dividends is to be paid by the legatees, or charged upon their legacies. Then why is it necessary to import words into the will, to produce that unnecessary effect which would make the gifts by the testatrix largely illusory? Or as stated by Lord Cranworth in Abbott vs. Middleton 7 H. L. C. 68 at 84 "when by acting "on one interpretation of the words used we are driven to the conclusion, "that the person using them is acting capriciously, contrary to the ordinary Judgment of "mode in which men in general act in similar cases. Then if the language -continued. "admits of two constructions, we may reasonably and properly adopt that "which avoid these anomalies, even though the construction adopted is not 10 "the most obvious or the most grammatically accurate." And by the same authority in Roddy v. Fitzgerald 6 H. L. C. 823 "When a testator shows "upon the face of his will that he must have used technical words in another "than their technical sense, there is no rule that prevents us from saying "that he may be his own interpreter." In the present case the intention is so clear that the legatees shall have the shares, and that the testator's estate shall have the dividends, that the words must have been used in other than their technical sense, which sense would have relation only to a winding up. They then become words of abundant precaution against the diversion by any means of the dividends if there are any from the estate of the testatrix. 20 Also Malins, V. C. in *Unsworth* vs. Speakman L. R. 4 Ch. D. 620 at 625 says "I agree entirely with the observations of Vice Chancellor James in "Haybergham vs. Rideholgh (1879) L.R. 9 Eq. 395 as to the principles which "ought to guide the Court in the construction of wills, that is to say, they "ought to be so interpreted as not to defeat the intention of the testator by "technical rules of construction; but by considering the language in a free, "liberal and common sense spirit, to give effect to his manifest intention." In the present case it is obvious that the solicitor employed to give expression to the intention of the testatrix, used expressions which are technical, and which relate only to the position of preference shares upon a winding up. 30 They could have no possible application to the circumstances envisaged by the testatrix or which have arisen since her death. It is impossible to give effect to such (as the learned Chief Justice has described them as) "meaningless" expressions. That does not however prevent us from carrying into effect the manifest intention of the testatrix who vested the shares in the Nothing was said in her will about creating a charge on those shares, and why should we write words into her will to express something of which there is no evidence that she had ever intended. In this connection I think the remarks of Halsbury L.C. in Corns vs. Harrison (1908) 2 Ch. D. 124 are pertinent when he said, "I repudiate any kind of canon of construction 40 "applying to the will and it seems to me that the last thing one ought to "do would be to attempt to make a canon of construction which would "guide the Court in interpreting all rules." Of importance also is the fact that the shares were the principal to which the dividends were accruing. The whole scheme of codicil 2 clause 20 was to vest the principal in the legatees and retain just sufficient control over it, so that the accessory might not follow it, but be diverted from the principal to her own estate. Moreover

I think clause 20 of the codicil referred to, applies to the common as well as the preferred shares. It says "any and all of the shares of the capital stock " of Ganong Brothers, Limited, etc., shall be and remain the property of my "estate, and be held by my executors and trustees as part of my estate until "all dividends on the preferred shares accrued to the date of my death, have "been paid in full, etc." Can we change this language so as to confine it to the preferred shares only? Assuredly not. Also take the last words of Reasons for the clause "before making any transfers of the stock or shares of Ganong Grimmer J. "Bros. Ltd. common or preferred devised and bequeathed under my said last 10 " will and testament and under this second codicil thereto." The residuary legatees as I have said, claim a charge for dividends which have accrued due to the date of her death and a full years dividends afterwards (I am not now discussing the terms employed) not upon any and all of the capital stock, not upon the common or preferred shares or stock, but upon the preferred shares only. Let us refer briefly to the provisions of the codicil by which she gave the common shares to a number of legatees and rather apologised to them for the small present value of the bequest. In sub-section 28 of section 16 of the said second codicil she said "In allotting these common shares to the "nephews named in clauses (1) to (4) both inclusive of this paragraph 16, 20 "etc., and to the employees named in clauses (5) to (28) both inclusive, I " realise that at the present time the said common shares have no monetary "value, have been issued against good will, yet it is my hope that eventually "such common shares may become of sufficient worth and value to serve as " a reward to the recipients for faithful service in the past and as an incentive "to greater effort on the part of the recipients for the future." Yet when she makes what the residuary legatees claim is a charge she draws no distinction between common and preferred shares. There can be no clearer indication that she never intended to impose such a charge and there is no language by which such a charge is created. It is impossible to separate the 30 common shares from the preferred in the operation of said clause 20. Both classes are to be withheld from transfer until the payment of dividends (as has herein been frequently stated) is made to her estate. Would it be contended that the charge should be imposed pari passu on all the shares? If so the result as regards the common shares would be so unjust, that no Court would assume it to have been the intention of the testatrix unless so expressly declared. It would not be impossible to comply with the language of the will, if the Company had the means to do so. Suppose no dividends were earned, as none were. Suppose also that the company had a surplus or rest account, it could be possible that the demands could be met from such a 40 source. It is compatible with the language she has used that she did not intend her legatees to get anything more than shares, and that anything which the company had available for distribution among them is to be paid to her estate. The language could have been clearer, but the draftsman chose to use terms which have no application to a going concern, though they have an apt relationship to a winding up. Being unable to give literal effect to them I must treat them in the way the learned Chief Justice did and pronounce them as "utterly meaningless" in the connection in which

they have been introduced. I am also of the opinion the shares vested immediately in the persons to whom they were given, wherein I agree with my brother Harrison, but which fact I think has a good deal to do with a proper construction of the intention of the will. See Couturier vs. Couturier (1907) 1 Ch. D. 472, where Joyce J. said: "The general rule when the will is silent "as to the period of vesting, is that the gift is vested immediately on the "donee coming into existence or on the instrument coming into operation." Reading the whole will (in which I include the codicils) and for the reasons herein set forth I am convinced the reservations in section 20 of the second codicil were not designed to deprive the legatees of their legacies, but merely 10 to ensure that the dividends, if any, should go into the estate, and while an argument thereunder in favour of a postponement of vesting has been strongly presented, taken as a whole it seems to me that the expressions used must give way to the general intention as expressed by James V.C. in the case supra—"The general intent is to prevail against the particular interest." I do not and cannot think that the language in section 20 of the codicil in respect to the dividends "whether accrued or declared or not" though dividends for two years, if paid, were to be returned to the estate, were ever intended by the testatrix to control the bequest of the shares or stock to the named legatees so as to deprive them thereof, or make it impossible that they should ever 20 receive the same unless by purchase. I therefore accept and adopt the judgment of the learned Chief Justice herein, but agree with my brother Harrison as to the disposition of costs.

but which differs enough to show a different intention. Paragraph 20 in the Will is as follows:—

"20. I hereby further will and declare that it is my intention and purpose that any and all of the shares of Ganong Bros. Limited, so hereby bequeathed as aforesaid, shall be and remain the property of my estate and be held by my Executors and Trustees as part of my estate until after the first annual meeting of Ganong Bros. Limited, shall have been held subsequent to my decease and until all dividends accruing on said shares of stock from the business of the year in which my decease may occur shall have been paid to my estate for the benefit 10 of my estate intending by this Section of my Will to show that both semi-annual dividends on the Preferred Shares that will be paid during the fiscal year subsequent to my decease but which will have been earned during the fiscal year my decease may occur must be paid to my estate before making any transfers of the stock, shares devised and bequeathed as aforesaid."

Paragraph 20 in the Will provides that no transfers of shares shall be made until certain dividends are paid out of profits earned during the fiscal year in which testatrix's decease occurs, Para. 20 of the codicil does not limit the condition to the payment of dividends which have been earned but requires 20 payment whether these dividends have been "earned or declared or not."

The residue of the estate was given to the brother and sister of the testatrix by the will and these residuary legatees appealed from the judgment of the learned Chief Justice alleging error on his part:—

- (1) In finding that the shares vested in the specific legatees at the death of the testatrix.
- (2) In not finding that by Clause 20 of the codicil there is a gift to the executors and trustees until the specified dividends amounting to \$68,460 are paid.

Certain confusion was introduced into the argument by the references 30 to the intention of the testatrix. It was said by counsel for the specific legatees that Mrs. Ganong never could have intended to give stock to her husband's relatives and then make a provision which would withhold it from them indefinitely, and certainly not a provision which would make the bequests altogether void. This contention would be conceded at once if we were trying to ascertain the actual thoughts in the mind of the testatrix when making her will, but that is not the object of a Court of construction. True the object of the Court is to find out the testatrix's intention but it must be the intention as expressed by the words in the will, not the intention which was in her mind, unless that intention has been expressed.

The principle is clearly stated in 28 Halsbury, p. 627:—

"The first duty of a Court of construction is, therefore, to ascertain the language of the will, to read the words used and ascertain the intention of the testator from them; it is not merely to ascertain what the testator's actual mental intentions were. Where the will must be

"in writing the only question is what is the meaning of the words used "in that writing. The expressed intention in all cases is considered to "be the actual intention, and the Court cannot give effect to any inten-"tion which is not expressed or implied in the language of the will."

In support of these propositions several cases are cited. Thus in Doe v. Gwillim 5 B. & Ad. 122; 110 E.R. 737, Parke J. said:—

"In expounding a will the Court has to ascertain, not what the "testator actually intended as contra distinguished from what his words "express, but what is the meaning of the words he has used. I consider JJ, "it doubtful what the testator actually meant should be done, but I delivered by Harrison J. "have no doubt as to the meaning of the words used by him."

In Scale v. Rawlins (1892) A.C. 342, Lord Halsbury L.C. said:—

"I might be perfectly satisfied that he (the testator) intended that "this lady should have an estate of inheritance in this property. I "might be satisfied that that was his intention otherwise than by the "words of the will; but I should be compelled to come to the same "conclusion as I do now, namely, that the intention is not sufficiently " expressed."

And Lord Watson said, at p. 349:—

"We are not at liberty to speculate upon what the testator may "have intended to do or may have thought that he had actually done. "We cannot give effect to any intention which is not expressed or plainly "implied in the language of his will."

In a judgment of the Court of Appeal in re Duke of Cleveland's Settled Estates (1893) 3 Ch. 244 at p. 251, it is said after citing two or three cases:—

"All of these are striking instances of the rigidity of the rule which "preclude a Court when construing a will, from giving effect to an "intention not expressed by a testator, and which cannot be extracted "from his language, when that language is clear in itself and is strictly "applicable to some subject-matter with which the testator was dealing."

And Sir Gorell Barnes, President of the Probate Division, says in Simpson v. Foxon (1907) p. 54 at p. 57:—

"But what a man intends and the expression of his intention are "two different things. He is bound, and those who take after him are "bound, by his expressed intention. If that expressed intention is "unfortunately different from what he really desires, so much the worse "for those who wish the actual intention to prevail."

In In re Brown (1934) S.C.R. 324, the Court says at p. 328: "And the "only safe method of determining what was the real intention of a testator 40 " is to give the fair and literal meaning to the actual language of the will," citing Auger v. Beaudry (1920) A.C. 1010 in which the Judicial Committee say at p. 1014: "Human motives are too uncertain to render it wise or safe " to leave the firm guide of the words used for the uncertain direction of what "it must be assumed that a reasonable man would mean."

I make the above quotations to emphasise the point that while it is incredible that Mrs. Ganong ever actually intended by her will to put in a clause which would result in depriving the specific legatees of their legacies, still the duty of the Court is to give effect to the language she has used even though it may be quite contrary to her actual intention.

No. 7. In Paragraph 20 of the second codicil the draughtsman took particular Reasons for pains to state the intention of the testatrix and by the use of the non obstante Judgment of Harrison and clause we are obliged to consider the provisions in this paragraph as paramount

to any conflicting provisions in the will.

For the residuary legatees it was argued that the language prevents any 10 vesting of the shares until those dividends are paid because the words are that these shares "shall be and remain the property of my estate and be held "by my executors and trustees as part of my estate until," etc.

We do not agree with this contention, however, but agree with the learned Chief Justice that the shares in question vested immediately in the persons to whom they were given by the codicil, but we also consider that there was a charge upon these shares which vested in the executors and trustees. In making this construction we consider full effect is given to the whole will, namely, the absolute gifts of the shares and the very definite provision that the beneficial enjoyment of those shares should be postponed until a certain 20 condition was fulfilled, namely, "until all dividends on the Preferred shares "accrued to the date of my death have been paid in full and also until the

"two half-yearly dividends which shall accrue immediately subsequent to "the date of my death shall have been paid in full to my estate for the benefit "thereof," with the further provision that dividends accrued or accruing

means dividends "whether earned or declared or not."

The statement of facts shows that no dividends on the preferred shares have been earned or declared since 1933. Mrs. Ganong died on November 30, 1934, and the company has been run at a loss until the year 1938 when a small profit was made, leaving the company with an accumulated deficit and 30 no funds out of which dividends can be declared.

The learned Chief Justice held that the provision as to payment of these dividends was meaningless and void because there could be no "accrued" dividends unless there were profits out of which they could be paid and unless they had been declared by the directors.

We cannot agree that the provision as to accrued dividends in the codicil is meaningless.

By-law No. 54 of Ganong Brothers, Limited, reads in part as follows:-

"Whereas it is deemed advisable that ten thousand shares of the "Capital Stock of the Company, each of the par value of One Hundred 40 "Dollars, be created and issued as Preference Stock, having fixed, "cumulative, preferential dividends and having priority in any division of the assets of the company to the extent of its repayment in full at par, together with any dividends thereon then accrued due and remaining unpaid but, conferring no right to any further participation in profits or assets.

"Now therefore, be it enacted and it is hereby enacted as a By-law " of Ganong Brothers, Limited, that Ten Thousand shares of the Capital "Stock of the Company shall be created as Preference Stock, and that "the said Shares shall have a fixed cumulative preferential dividend of "Seven per cent. per annum, payable as may be convenient half-yearly, " and the said Shares shall be issued and allotted by the Board of Directors "of the Company as they may direct, and the parties to whom the said Reasons for "shares shall respectively issue and any subsequent holders thereof shall "be entitled to receive the said dividends and shall hold the shares "upon the following terms, namely:

"The issue of the Preference Stock shall become and remain a lien "upon the assets of the Company superior to any claim or claims belong-"ing to the ordinary or common stock, so that on any dissolution or "winding up of the Company or liquidation of its business or assets, or "in any division of capital or assets of the company among the share-"holders thereof, the holders of Preference Stock shall be entitled to "payment for their stock in full at par (together with any dividends in "arrear) and no more, and shall as between themselves and the holders " of the Common Stock have the standing of Creditors of the Company "whose claims shall be paid, after satisfaction of all other indebtedness "of the Company, in preference and priority to any payments to the "holders of the Common Stock, but only out of the Assets of the Com-"pany and subject to the prior rights of creditors to be first paid in full."

We consider the words "accrued due" in the first paragraph of this By-law refer to the half-yearly dates on which the preferred dividends are payable irrespective of whether there are profits available out of which to pay such dividends or whether such dividends are declared. It is to be noted that in the third paragraph of the By-law reference is made to "dividends in arrear"; This expression undoubtedly refers to dividends to which the 30 preference shareholders would be entitled on the half-yearly dates when they were supposed to be paid and means, in the language of the codicil, dividends whether "earned or declared or not."

In the case of In re New Chinese Antimony Co. Ltd. (1916) 2 Ch. 115, where a company with preference shares went into liquidation, the preference shareholders were entitled to cumulative dividends of ten per cent. and in a winding up to have the surplus assets applied first in paying off their capital, secondly in paying the arrears if any of the preference dividends. The articles of association provided that no dividends should be declared except out of profits. No dividends had been declared and the balance sheet showed a The stock of antimony held by the company, however, went up in price to such an extent that the surplus assets were sufficient to cover the loss and pay all arrears of preference dividends. It was held by Neville J. that the arrears of preference dividends payable could not be limited to dividends actually declared and the holders of preference shares were entitled to be paid the amount of the cumulative dividends. In his judgment he said:

"The only point is what is meant by arrears of the preferential dividend aforesaid. Arrears of the dividend might mean only arrears of dividend which had been declared. But I do not think that is what the words do mean. The clause in my opinion means that in the case of a winding up the preference shareholders are to have their capital repaid in full and also the accumulative preference dividend of ten per cent., that is to say the amount they would have had if there had been profits enough to enable the company to declare dividends."

In Fairhall v. Butler (1928) S.C.R. 369, defendant gave an option to purchase a block of common shares and furnished an affidavit that the 10 company's liabilities did not exceed a certain amount. Preferred shares had been issued by the company entitling the holders to an accumulative dividend. It was held that accumulative dividends on the preference shares undeclared and unpaid constituted a liability of the company within the meaning of the contract and should have been included as such in the statement. The Court said "for a purchaser of common stock of the motor corporation "undeclared but overdue dividends on its preference shares were certainly a "liability of the company in the sense that he could obtain no dividends on "his common shares before the payment of all the accrued dividends on "preference shares whether in fact a dividend had or had not been declared." 20

It will be noted that the Supreme Court of Canada use the word "accrued" in reference to dividends whether declared or not. In our opinion the word "accrued" though perhaps not technically correct can be used in respect of preference dividends to mean the same as "accumulated" and clearly the word is used in that sense in this codicil which refers to "dividends accrued due to the date of my death whether earned or declared or not, together with a full year's dividends accruing due after my death whether earned or declared or not."

We are, therefore, of the opinion that the provision in the codicil for the payment to the estate of two years dividends on the preferred shares of 30 Ganong Bros. Limited bequeathed by the will and second codicil whether such dividends were earned or declared or not, has a perfectly definite meaning and has the effect of charging the preferred and common shares bequeathed by the will and second codicil with the amount of two years dividends at seven per cent. upon the preferred shares amounting to \$68,460.

The next question is as to the effect of such provision. Reading all the provisions of the will together we find that certain shares in Ganong Bros. Limited were given outright to specific legatees by paragraphs 14 and 16 of the codicil the words in paragraph 14 being—"I do hereby give devise and "bequeath unto the several persons hereinafter named, relatives of my late 40 "husband, the number of said preferred shares of the capital stock of Ganong "Bros. Limited, hereinafter mentioned." And the same provision is made regarding the common shares. The residuary clause in the will also included some shares in Ganong Bros. Limited.

Although the words in Para. 20 of the codicil are that these shares "shall be and remain the property of my estate and be held by my executors and

"trustees as part of my estate, until all dividends, etc." have been paid in full, this provision is followed by a further declaration of intention that the dividends on said preferred shares for two years "whether earned or declared " or not shall be paid to my executors and trustees for the benefit of my estate " before making any transfers of the stock or shares of Ganong Bros. Limited, " etc."

It is obvious we think that the legatees were to have the entire beneficial Judgment of interest in these shares excepting only the amount of two years dividends Harrison and Fairweather on the preferred shares.

In Clause 16 of the codicil the testatrix says regarding the common Harrison J. shares "It is my hope that eventually such common shares may become of "sufficient worth in value to serve as a reward to the recipients for faithful "service in the past and as an incentive to greater effort on the part of the "recipients for the future." And in Clause 17 of the codicil which provides for cash bequests to employees it is further provided "And I will and direct that any employee or employees in receipt of a legacy of stock herein or under my said will shall not participate in such cash distribution."

It is possible to give full effect to the language requiring the executors and trustees to hold these shares of stock until the amount of two years 20 dividends on the preferred shares have been paid, while holding that the shares vested in the legatees.

In Paragraph 20 of the second codicil provision is made for the payment of succession duties upon all legacies. Under the will the succession duties if any on the larger portion of the shares of Ganong Bros. Limited, dealt with in a certain trust deed which has since become inoperative had to be paid by the donees themselves, so that this is a new provision which would make a further charge against the residuary estate. On the other hand the retention by the estate of an amount equal to two years dividends on the preferred shares would provide a fund for payment of these extra succession duties.

It has been held that a direction to accumulate income for payment of a testator's debts gives the creditors an immediate present charge on the property, and that since they can stop the accumulation at any time the direction to accumulate is not void for remoteness. In the same way the executors and trustees under this will have an immediate present charge on the shares of stock of Ganong Bros. Limited to the amount of \$68,460 and they might sell the shares in order to realise the amount of the charge against them. The shares might also be redeemed by the legatees paying the amount of the charge thereon. The rule against perpetuities therefore would not apply, see Gray on Perpetuities, 3rd ed. p. 524, para. 676, citing Bacon v. 40 Proctor, T. & R. 31; 37 E.R. 1005; and Bateman v. Hotchkin 10 Bea. 426; 50 E.R. 646; also Tewart v. Lawson L.R. 18 Eq. 490.

In the case of Hale v. Herring 208 Mass. 319, a clause in a will directed the executor to carry on the testator's business and credit one-seventh of the annual profits to each of five persons and that these amounts should be allowed

to accumulate until they reached a certain value when three of these persons should receive a one-seventh undivided interest in the business. The period of the accumulation was entirely indefinite and would have been bad under the rule against perpetuities except for the fact that all the parties beneficially interested were in being and could together stop the accumulation and convey the entire interest in the estate. The Court says at p. 322: "The persons "named as beneficiaries were all living at the death of the testator and it is plain that the interests of the legatees vested, if at all, during their lives, and that there has been no time since the death of the testator when the "property could not have been conveyed by the joint action of all parties 10 delivered by "property could not have been consultant Harrison, J. "interested. The clause, is, therefore, valid."

So in the present case the legatees have a vested interest in the shares bequeathed to them subject to a charge on all the shares of stock of Ganong Bros. Ltd. bequeathed which charge is held by the executors and trustees for the benefit of the two residuary legatees both of whom are living. By the joint action of all these parties the shares of stock could be conveyed at any time after the death of the testatrix.

The answers to the questions submitted, therefore, in our opinion should be :—

- (1) The persons and institutions named therein subject to a charge 20 upon the shares bequeathed by the will and second codicil in favour of the executors and trustees to the amount of two years dividends on the preferred shares so bequeathed namely \$68,460.
- (2) When the amount of the said charge has been paid to the estate or the said charge released.
 - (3) No question of apportionment arises.

We confirm the judgment of the learned Chief Justice as to costs in the Court below. The costs on the appeal of all parties as between solicitor and client should also be paid by the estate, but the solicitor for the executor is not entitled to any costs for his factum.

CROCKET J.:-

This is an appeal from a judgment of the Appeal Division of the Supreme Court of New Brunswick, varying the judgment of Baxter C.J., on an originating summons taken out by the sole executor of the estate of Maria Famicha Ganong, late of the town of Saint Stephen, N.B., widow, deceased, for the interpretation of certain provisions of a codicil to her will concerning the disposition of some 4,800 and odd preferred shares and 4,000 and odd 20 common shares of the capital stock of Ganong Bros. Ltd.

Thirty-seven hundred and ninety (3790) of these preferred shares and 3600 of the common shares had been bequeathed to her by her late husband, Gilbert W. Ganong, who died as Lieutenant-Governor of New Brunswick in the year 1916. All these shares she assigned to the Eastern Trust Company on March 15th, 1918, by a trust indenture made between herself as party of the first part, the said Trust Company as party of the second part, and William F. Ganong, James E. Ganong, Walter K. Ganong and Arthur D. Ganong, four nephews of her late husband, as parties of the third part. The indenture provided that all dividends payable thereon should be paid direct 30 by the company to her "under a sufficient order or orders therefor to be deposited by the trustee with the company," and that upon her death, provided there should not theretofore have occurred any default thereunder the trustee should assign and transfer to the said four nephews all the said common shares to be divided amongst them as they should think proper, and the preference shares to a sister and fourteen nephews and nieces, including the said four nephews of her late husband, in the numbers respectively specified in a schedule annexed to the trust indenture, or to their legal representatives in the event of the death of any of them.

This indenture Mrs. Ganong expressly confirmed by para. 15 of her will, 40 executed on September 25th, 1924, and declared to be binding on herself and her estate. At this time she was possessed of several hundred additional

preferred and common shares of the capital stock of Ganong Bros. Ltd., of which she bequeathed 600 preferred shares to her brother, Edgar M. Robinson, in trust for his three children and 200 more to the children themselves. One hundred more preferred shares were to go to an Old Folks Home fund, 20 to the Chipman Memorial Hospital, while a further number of 120 Reasons for were to be distributed as bequests to four named beneficiaries. No specific Crocket J. mention is made in the will of her common shares, and they would consequently fall into the residue of the estate, which was devised and bequeathed to Kerwin, her brother and sister in equal shares.

The trust deed provided for its revocation in the event of default in payment of the dividends, and the company having failed in the years 1933 and 1934 to earn and declare the customary dividend upon the preferred shares, Mrs. Ganong, on September 29th, 1934, gave the necessary notice of default and of her intention to revoke the trust. Two weeks later, in anticipation of the reversion to her or her estate of these trust shares she executed the codicil, which created the difficulty it became necessary to submit to the Supreme Court of New Brunswick for solution. Shortly after doing so Mrs. Ganong went to Florida, where it had been her custom for some years to spend the winter months, and there contracted pneumonia, 20 from which she died on November 30th, 1934, and the Trust Company some time later returned the trust shares to the executors of her estate.

The principal change the codicil made concerning the disposition of the 3,790 preferred and 3,600 common shares, which were still in the hands of the Eastern Trust Company at that time, was the revocation of para. 15 of the will, by which the testatrix had confirmed the trust assignment of March 15th, 1918, and their distribution among the beneficiaries named in paras. 14, 15 and 16 of the codicil. Of the 3,790 preferred shares, which were allotted by the schedule of the trust deed to the testatrix's deceased husband's sister, seven nephews and seven nieces, 3,290 were apportioned 30 by para. 14 among the same nephews and nieces, except that one of the nephews, Frank Ganong, was replaced by his son, Edwin M. Ganong. The sister, Mrs. Perkins, to whom 583 shares had been allotted by the schedule of 1918, was not named. Para. 15 of the codicil, however, provided for the handing over of the remaining 500 of the 3,790 preferred shares to the Trustees of the Maria F. Ganong Old Folks Home, as an additional endowment, when that institution should be incorporated by a proposed provincial statute, as "The Gilbert White Ganong Memorial." Thus did paras. 14 and 15 of the codicil provide for the disposition of the full 3,790 preferred shares, then in the hands of the Trust Company. Two thousand of them were divided 40 between the nephew Arthur D. Ganong and three of the surviving nieces, Mrs. Hyslop, Mrs. Christmas and Mrs. Caldwell, the last named being a daughter of Mrs. Perkins, and the remaining 1,290 among the other surviving nephews and nieces in varying lots of from 200 to 90 shares.

Para. 16 of the codicil provided for the disposition of the common shares, then in the hands of the Trust Company. Of these the testatrix bequeathed 2,694 shares to the four nephews, who joined her in the execution of the trust deed of 1918, and 250 to Arthur D. Ganong's son. The remainder of the

3,600 shares were bequeathed to old employees and representatives of the company throughout Canada.

As regards the 1,040 additional preferred shares, which the testatrix held independently of the trust, the codicil made no material alteration in the provisions of her will of September 25th, 1924, for their disposition, except that she expressly revoked one of the bequests for 50 of these shares and directed her executors to purchase in lieu thereof a government annuity sufficient to yield an annual income to the legatee named of \$400 for the Hudson and term of her natural life.

The rights and interests of every beneficiary, to whom any lot of either 10 -continued. the preferred or the common stock of the company was bequeathed, whether by the original will or by the codicil, are, however, materially affected by the provisions of para. 20 of the codicil. This paragraph revokes para. 17 of the will of September 25th, 1924, and provides in lieu thereof that her executors and trustees

> "shall pay out of my personal estate any and all succession duties, "which may at my death become payable upon any of the bequests "made in my said last will and testament or in any codicil thereto, "including this codicil, it being my intention that all gifts and bequests, "including gifts of shares in the capital stock of Ganong Bros. Ltd., 20 "either preferred or common, to any nephew or niece of my late husband "shall be free from succession duty?"

Para. 17 of the original will, while providing that her executors should pay out of her personal estate all succession duties payable upon the bequests made thereby, distinctly provided that her estate should not be liable:

"for any succession duties or other dues, duties, taxes or other charges " or expenses of any kind payable . . . upon or in respect of any moneys, "stocks, shares of stocks, gifts or other benefits which have passed or "which may hereafter pass under the provisions of the said trust agree-"ment"

of March 15th, 1918. Having thus declared that all bequests of shares in the capital stock of Ganong Bros. Ltd., either preferred or common, to any nephew or niece of her late husband should be free from succession duty, as well as all other bequests, whether made by the original will or by the codicil, para. 20 of the codicil goes on to say:—

"But while I make the aforegoing provision with respect to "succession duty it is my express will and intention and I hereby direct "that notwithstanding anything hereinbefore contained any and all " of the shares of the capital stock of Ganong Bros. Limited, in and by "my said last will and testament and in and by this second codicil 40 "to my said last will and testament bequeathed by me, shall be and "remain the property of my estate until all dividends on the preferred "shares accrued to the date of my death have been paid in full and also "until the two half-yearly dividends which shall accrue immediately "subsequent to the date of my death shall have been paid in full to "my estate for the benefit thereof, it being my intention by this

paragraph of this second codicil to my will that all dividends on said preferred shares accrued due to the date of my death, whether earned "or declared or not, together with a full year's dividends accruing due "after my death, whether earned or declared or not, shall be paid to "my executors and trustees for the benefit of my estate before making Reasons for "any transfers of the stock or shares of Ganong Bros. Limited, common Judgment of Crocket J. "or preferred, devised and bequeathed under my said last will and (concurred in by Davis, "testament and under this second codicil thereto."

These last provisions of para. 20 of the codicil were clearly intended as 10 a substitution for para. 20 of the original will, which applied to "any and all JJ.) "of the shares of Ganong Bros. Ltd.," bequeathed by the will, and not to any of the shares, which the testatrix had assigned to the Trust Company six years before she made the will. The codicil, however, did not expressly revoke para. 20 of the will, the provisions of which must be examined closely for the purpose of determining whether any and what portions thereof are inconsistent with and consequently replaced by the provisions of clause 20 of the codicil, the testatrix having declared by the concluding paragraph of the codicil that she ratified and confirmed her said last will and testament "save in so far as any part thereof shall be revoked or altered by this codicil 20 thereto or any previous codicil." Para. 20 of the will read as follows:—

"I hereby further will and declare that it is my intention and "purpose that any and all of the shares of Ganong Bros. Limited, so "hereby bequeathed as aforesaid, shall be and remain the property "of my estate and be held by my executors and trustees as part of my "estate until after the first annual meeting of Ganong Bros. Limited, "shall have been held subsequent to my decease and until all dividends "my decease may occur shall have been paid to my estate for the benefit "of my estate intending by this section of my will to show that both "semi-annual dividends on the preferred shares that will be paid during

"accruing on said shares of stock from the business of the year in which "the fiscal year subsequent to my decease but which will have been "earned during the fiscal year my decease may occur must be paid "to my estate before making any transfers of the stock, shares devised "and bequeathed as aforesaid." When one compares the language of these provisions of the codicil

with that of para. 20 of the will it is not surprising that the sole remaining executor and trustee, who was responsible for the administration of this estate and who more than five years after the death of the testatrix still held in his possession all the bequeathed preferred and common shares of Ganong 40 Bros. Ltd. should have sought the intervention of the Supreme Court to straighten out the apparent confusion, and proposed the following questions on his application for an originating summons:-

1. Who are entitled to the shares in the capital stock of Ganong Bros. Limited either common or preferred bequeathed under any clauses of either the last will and testament of Maria Famicha Ganong or the second codicil thereto?

2. When are the beneficiaries of the said shares entitled to delivery thereof?

During the argument another question was added as follows:-

3. Under the circumstances of the present case are any dividends and if so, what, apportionable?

On the hearing, which took place before the learned Chief Justice on documentary evidence only, it was contended on behalf of the residuary Hudson and legatees that there was no vesting of the shares in the persons to whom they were given until after the payment of two years' dividends, and that, no dividends having yet been paid and as no one could tell that any ever would 10 be paid, the rule against perpetuities applied and the shares consequently passed into residue. The Chief Justice, however, held that this contention could not prevail and that the persons and institutions named in the will and codicil were entitled to delivery of the shares immediately. He also held that no question of apportionment arose.

On an appeal from this judgment to the Appeal Division of the Supreme Court, which was heard by Grimmer, Harrison and Fairweather JJ., all three of the learned justices agreed that the shares vested in the beneficiaries on the death of the testatrix: but Harrison and Fairweather JJ., Grimmer J. dissenting, held that the Chief Justice was in error in holding that the 20 beneficiaries, to whom the shares had been bequeathed, were entitled to their delivery immediately. They took the view that para. 20 of the codicil created a charge upon these shares in favour of the executor and trustee to the amount of a sum of money representing two years' dividends at 7 per cent. on the bequeathed preferred shares, which they calculated at \$68,460, and that the beneficiaries were not entitled to their delivery until that amount of money had been paid to the estate or the charge released.

No contention is now made on this appeal that the shares did not vest in the beneficiaries, to whom they were bequeathed, but the respondent residuary legatees contend that in the light of other provisions of the will 30 and of the circumstances, as they existed at the time of the execution of the codicil, no other construction can consistently be placed upon the relevant language of the codicil than that adopted by Harrison J., in the majority judgment of the Appeal Division. Having conceded that all the shares vested in the several beneficiaries on the death of the testator, it is obvious that this

is the only position they could possibly take.

There is no ambiguity whatever regarding the bequests of the preferred shares as made in paras. 14 and 15 of the codicil or of the common shares as made in para. 16. Each one of them is distinct and definite as to the number of shares bequeathed and the persons and institutions to whom the shares 40 are given. The whole difficulty has been created by the language of para. 20 of the codicil, which, while indicating clearly enough an intention to postpone the transfer by the executor and trustee of the bequeathed shares to the various beneficiaries pending the payment to him of dividends accrued to the date of the testatrix's death and two prospective half-yearly dividends during the following year, enshrouds the intended reservation in such

apparent ambiguity and uncertainty as to endanger its entire validity. The difficulty arises primarily from the insertion of the phrase "whether earned or declared or not" in reference first to the payment of "all dividends on said preferred shares accrued due" to the date of the testator's death, and its repetition in reference to "a full year's dividends accruing due" after her Reasons for death.

The words "all dividends accrued due" can surely only mean dividends (concurred in which have become payable by the corporation to the shareholder, as the Kerwin, words "dividends accruing due" during any stated period can only mean Hudson and 10 dividends as they become payable by the corporation to the shareholder. JJ.) The share certificates by a condition endorsed thereon state that the holders shall be entitled out of the net profits whenever ascertained to a fixed cumulative preference dividend at the rate of 7 per cent. per annum . . . in priority to any payment of dividend upon the common stock,

"such dividend to be paid at such times as the directors may determine, "but to be payable only out of the profits, and the holder shall not be "entitled to participate in further dividends or profits."

This condition is in accordance with the provisions of the by-law of June 28th, 1916, under which these shares were issued. This by-law provides that 20 the preference shares shall have a fixed cumulative preference dividend of 7 per cent. per annum, payable as may be convenient half yearly, and that such dividend

"shall be payable only out of the net profits of the company, but they "shall be cumulative dividends, that is to say, if not earned fully and " paid in each year, the amount of such dividend or any portion thereof "remaining unpaid from time to time shall be paid out of the first net "profits of the company accumulated or earned thereafter."

The by-law also provides that the said dividend shall begin to run from July 1st, 1916.

A preferential dividend at a fixed rate may be said, of course, to be always running between fixed dividend periods and perhaps in that sense to be accruing from day to day, but how can these dividends in the face of the express terms of the share certificates and of the by-law, in pursuance of which they were issued, possibly be said to have "accrued due" or to be "accruing due" when no profits have been earned to provide for their payment and no declaration has been made by the directors fixing any date therefor? shareholders acquire no right to payment of any dividends until there are net profits, out of which alone they can be paid, and until such time as the directors determine they shall be paid. See judgment of Farwell J., in Bond v. Barrow 40 Haematite Steel Co. (1902) Ch. D., at p. 362; also judgment of Lord Sterndale, M.R., in re Wakely (1920) Ch. D. at p. 217.

That the clause is directed wholly to the payment of dividends on the bequeathed preferred shares during the anticipated period of the administration of the estate cannot be doubted, now that it is conceded that it was the testatrix's intention that the shares themselves should vest in the various legatees at her death. This can only apply to the payment of dividends as

such to the executors and trustees of the estate, as the registered holders of the bequeathed preferred shares, by the corporation itself as a going concern, and clearly excludes, to my mind, the payment of any sum or sums of money in lieu thereof by or on behalf of the beneficiaries, in whom the shares themselves were vested. The qualifying phrase is so obviously repugnant to the principal phrase that one or the other must be disregarded and the whole clause recast in order to express any such intention as that contended for by the residuary legatees.

If the clause be read without the qualifying phrase, and the words "all dividends on said preferred shares accrued due to the date of my death 10 "... together with a full year's dividends accruing due after my death "shall be paid to my executors and trustees for the benefit of my estate "before making any transfers," etc., be given their ordinary meaning, they clearly contemplate only the payment of dividends, which the directors of the corporation might legally declare to be payable thereon on definitely appointed dates. The corporation admittedly never having since earned sufficient profits to justify the declaration of any dividend to cover 7 per cent. of the par value of the preferred shares remaining unpaid at the time of the testatrix's death, in November, 1934, or any part thereof or any proportion of the two half yearly dividends, which ordinarily would have 20 matured during the following year, the executors and trustees of her estate, as the registered holders of all the bequeathed shares, have never acquired the right to demand payment from the corporation of any dividends thereon to cover either the year 1934 or the year 1935. They have consequently never "accrued due" within the intendment of the reservation.

But how upon this basis does the non-payment of the dividends affect the condition prescribed by the concluding lines of the paragraph as a prerequisite to the executors' right to transfer the shares? Did the testatrix intend that the executors should not withhold their transfer to the legatees for more than a year after her death in the event of the company's failure up 30 to that time to earn the necessary profits to enable them to declare dividends to cover the arrears for the two years 1934 and 1935, or did she intend that the condition should continue, unlimited as to time, with the inevitable result of indefinitely tieing up the administration of her estate until the actual payment of the deferred dividends, which might possibly never happen? The latter hypothesis may at once be dismissed, I think, as wholly inadmissible. The former, though not entirely consistent with the testatrix's undisputed intention to vest the shares in the various legatees at her death, may surely be more reasonably harmonised with it as a modification of the absolute bequests to the extent of withholding from the legatees their right to receive 40 the deferred dividends for the two years in question in the event, and only in the event, of their being paid by the corporation to the executors and trustees as the registered holders of the shares for the purpose of administering the estate, within a period of one year following the death of the testatrix.

If no limitation of the prescribed condition for the transfer of the shares to the legatees can reasonably be inferred from the clause as framed, the reservation itself in my opinion must be held to be void for uncertainty,

whether the alleged qualifying phrase be eliminated or not. As already pointed out, the residuary legatees contended before the learned Chief Justice below that the bequests of the shares were themselves void for uncertainty for the reason that no one could tell when the dividends would be paid or indeed whether they ever would be paid at all. This uncertainty, however, goes, not to the validity of the bequests, but to the validity of the reservation. As Lord Truro expressed it in *Egerton* v. *Earl Brownlow* 5 H.L.C., in 1853, at p. 181:—

"Where a gift is good in itself, but is followed by an unlawful or Hud Task repugnant condition or qualification in a distinct clause, the gift is JJ.) upheld and the condition or qualification, which alone is obnoxious, is rejected."

In Hancock v. Watson, 1902 A.C., 14, Lord Davey said:—

10

"It is settled law that if you find an absolute gift to a legatee in the "first instance and trusts are engrafted or imposed on that absolute "interest which fail, either from lapse or invalidity or any other reason, "then the absolute gift takes effect so far as the trusts have failed to "the exclusion of the residuary legatee or next of kin, as the case may be."

This statement was expressly reaffirmed by the House of Lords in Fyfe v. 20 Irwin (1939) 2 All Eng. Rep. 271.

The learned majority judges in the Appeal Division apparently agreed with the Chief Justice and Grimmer J., that the clause should be read as indicating that the condition was intended to lapse upon the expiration of one year after the death of the testatrix, but in their natural anxiety to give some effect to the phrase, "whether earned or declared or not," sought very properly to solve the perplexing problem by deducing from it and the language of the entire para. 20 of the codicil and other provisions of the will an intention to impose a charge in favour of the estate, either upon the bequeathed preferred shares themselves, or upon the donees, to the amount of the unpaid 30 dividends for the years 1934 and 1935. They relied especially upon the change made by the opening clause of the paragraph, providing for the payment out of the testatrix's personal estate of all succession duties in respect of the gifts of all shares in the capital stock of the corporation as evidencing an intention to accumulate a fund, equal to two years' dividends on all the bequeathed preferred shares, for the special purpose of compensating the estate for relieving them of the payment of succession duties.

While the opening lines of the long clause immediately following the succession duties provision would seem to impart no little colour to this view, I find myself, after anxious consideration of the entire will and codicil, quite 40 unable to adopt it. In the first place para. 20 of the codicil contains nothing in the nature of a direction to the executors and trustees to collect the two years' unpaid dividends from the beneficiaries, in whom the shares were vested, or to fund them, if and when collected, for any such purpose. The creation of such a charge seems to me to be wholly inconsistent with her wish to relieve all gifts and bequests made in both the will and the codicil from any and all succession duties at the expense of her personal estate, including gifts of

shares in the capital stock of Ganong Bros. Limited, either preferred or common, as so explicitly stated in the opening clause of the paragraph. Having thus clearly indicated her desire to relieve the bequeathed shares from any and all liability for the payment of succession duties and thus place them on a footing of equality with all other gifts provided for in the will and codicil, I cannot believe that she intended by the succeeding clause, not only (concurred in to immediately cancel this additional bounty to the specific legatees of the preferred shares, including her late husband's nearest relatives, and her own brother and his wife and children and such institutions as the Old Folks Home and the Chipman Memorial Hospital, but to charge from \$14 a share in the 10 event of the corporation's inability to earn sufficient profits to pay anything on account of the deferred dividends, and this for no other apparent purpose than that of increasing the value of the residuary estate.

The appeal should be allowed and the judgment of the learned Chief Justice on the originating summons restored. We were informed that practically all the estate had been distributed apart from the shares of the company. We think in the circumstances the costs of the appellants on this appeal and of the executor should be paid by the executor and charged by him against the residue of the estate and not against the specific legatees, those of the executor as between solicitor and client; the disposition of costs of the 20 appeal to the Appeal Division to stand as unanimously directed by that Court.

No. 1.—By-Laws of Ganong Brothers, Limited.

(No. 1—J.B.M.B., C.J., 5 Jan. 40)

Whereas, it is deemed expedient that certain By-laws for regulating the affairs of Ganong Brothers, Limited, should be made.

Now Therefore, be it enacted and it is hereby enacted as follows:-

ALLOTMENT OF SHARES.

1. The shares of the Company shall be under the control of the Directors, who may allot or otherwise dispose of the same to such persons, on such 10 terms and conditions, and at such times as the Directors may see fit, save and except that the Directors shall have no power to allot stock below par value.

CERTIFICATES.

- 2. The Certificates of Shares shall be issued under the Seal of the Company and signed by the President or Vice-President, and the Secretary-Treasurer of the Company.
- 3. Every shareholder shall be entitled to one Certificate for all the shares registered in his or her name, or to several Certificates, each for a part of such shares.
- 4. Every Certificate shall specify the number of shares in respect of 20 which it is issued, and the amount paid up thereon.

CALLS.

- 5. The Directors may from time to time make such calls as they think fit upon the Shareholders in respect of all moneys unpaid on the shares held by them respectively, and such Shareholder shall pay the amount of every call so made on him or her to the persons, and at the times and places appointed by the Directors.
- 6. Any call may be made payable either in one sum or by two or more instalments, as the Directors may think fit.
- 7. A call shall be deemed to have been made at the time when the 30 Resolution of the Directors authorising such call was passed.
 - 8. Ten days' notice of the first call and thirty days' notice of all subsequent calls shall be given specifying the time and place of payment, and to whom such call shall be paid.

Transfers.

9. Any Shareholder not being in arrears for any call may transfer his or her share or shares, or any one or more of them by registering with the Secretary an instrument of Transfer signed by the Transferrer or his representatives; and the Transferrer shall be deemed to remain the holder of such share or shares until the name of the Transferee is entered with the Registrar 40 in respect thereof. Provided, however, that if the whole amount of such

shares has not been paid in, then and in such case such transfer shall not be effectual unless and until approved by a Resolution of the Directors.

- 10. In case of the death, insolvency or incapacity of any Shareholder, the legal representative of such Shareholder shall, before becoming entitled to the privileges of an original Shareholder, procure his address or place of abode and the particulars of his title to be registered in the books of the Company, and shall at the same time exhibit the Will and probate thereof, or grant of Letters of Administration, or other documents, as the case may be, for the inspection and satisfaction of the Directors, and furnish a certified copy of the same when so required.
- 11. The Instrument of Transfer of any share shall be in the following form, or as near thereto as circumstances will admit:—

" As Witness my hand the day of A.D. 19 "Witness:"

- 12. All Instruments of Transfer which shall be registered shall be retained by the Company.
- 13. All transfer books may be closed prior to the Annual Meeting in each year, or prior to the dates of payment of dividends, for such period as the Directors may see fit, not exceeding fifteen days in each year.

FORFEITURE.

- 14. If any Shareholder fails to pay any call on or before the day appointed 30 for the payment of same, the Directors may at any time thereafter during such time as the call remains unpaid serve a notice on such Shareholder requiring him or her to pay same with interest and all expenses that may have been incurred to the Company by reason of such non-payment.
- 15. The notice shall name the date, being not less than twenty days from the date of service, by mailing or otherwise, and the place in and at which such call and such interest and expenses as aforesaid are to be paid. The notice shall also state that in the event of non-payment at or before the time, and at the place specified the shares in respect of which the call was made will be liable to be forfeited. Such notice shall be deemed to have been 40 validly given if mailed postage prepaid and registered to the address of the Shareholders, as shown by the Register of the Company.
- 16. If payment be not made as provided for in such notice as aforesaid, any share in respect of which such notice has been given may at any time

thereafter before payment of all calls, interest and expenses due in respect thereof, be forfeited by resolution of the Directors to that effect.

LIENS.

- 18. The Company shall have a first and paramount lien upon all the shares registered in the name of each Shareholder, whether solely or jointly with others, for his debts, liabilities and engagements, solely or jointly with 10 any other person to or with the Company, whether the period for the payment, fulfilment or discharge shall have actually arrived or not.
 - 19. For the purpose of enforcing such lien the Directors may sell the shares subject thereto in such manner as they think fit; but no sale shall be made until such period as aforesaid shall have arrived and until notice in writing of the intention to sell shall have been served on such member, his executors or administrators and default shall have been made by him or them in the payment, fulfilment or discharge of such debts, liabilities or engagements for thirty days after such notice.
- 20. The net proceeds of any such sale shall be applied in or towards 20 satisfaction of the debts, liabilities or engagements, and the residue (if any) paid to such member, his executors, administrators or assigns.
 - 21. Upon any sale in purported exercise of the powers given by Clauses 19 and 20 hereof respectively, the Directors may cause the Purchaser's name to be entered in the Register in respect of the shares sold, and the Purchaser shall not be bound to see to the regularity of the proceedings or to the application of the purchase money, and after his name has been entered in the Register the validity of the sale shall not be impeached by any person, and the remedy of any person aggrieved by the sale shall be in damages only and against the Company exclusively.

GENERAL MEETINGS.

- 22. An Annual General Meeting of the Company shall be held on such date, at such place, and at such hour as the Directors may determine, in each year.
- 23. The Directors or any two of them may whenever they think fit convene a Special General Meeting of the Shareholders.
- 24. Shareholders holding one-tenth part of the allotted shares of the Company may at any time call a Special Meeting of the Shareholders for the transaction of any business specified in such written requisition or notice as they may issue to that effect.
- 25. At all meetings of Shareholders every Shareholder shall be entitled to as many votes as he holds shares of Capital Stock of the Company, and may vote by proxy in the person of another Shareholder present at such meeting.

Amendment to By-law No. 30, adopted March 15, 1918:—

If any Director shall go or reside abroad on the Company's business or otherwise perform services whether of a temporary or continuing nature 30 for which in the opinion of the Board, his ordinary remuneration as a Director under the provisions of By-Law 39 hereof may be inadequate, the Board may arrange with such Director for such special remuneration for the said services, either by way of salary, commission or the payment of a stated sum of money or otherwise as they shall think fit, such special remuneration to be of such amount and to be payable during any period or periods and to be in addition to any remuneration to which such Director would be entitled under the provisions of By-Law 39 hereof or otherwise as the Directors in their absolute discretion think fit.
- 41. A Director shall not be disqualified by his office from entering into 40 contracts, arrangements or dealings with the Company, nor shall a Director be liable to account to the Company for any profit arising out of any contract, arrangement or dealing with the Company by reason of such Director being a party to or interested in or deriving profit from any such contract, arrangement or dealing and being at the same time a Director of the Company, provided that such Director discloses to the Board at or before the time when

such contract, arrangement or dealing is determined upon his interest therein, or if his interest be subsequently acquired, provided that he on the first occasion possible discloses to the Board the fact that he has acquired such interest; but no Director shall vote as a Director in regard to any contract, arrangement or dealing in which he is interested, or upon any matter arising thereout, and if he shall so vote his vote shall not be counted nor shall he be reckoned for the purpose of constituting a quorum of Directors. Provided however, that no Director shall be deemed to be in any way interested in any contract or arrangement, nor shall he be disqualified from voting, or be held liable to account to the Company by reason of his holding shares in or 10 being a Director of any other Company with which a contract or arrangement is made or contemplated.

- 42. All deeds executed on behalf of the Company may be in such form and contain such powers, provisos, conditions, covenants, clauses and agreements as the Directors shall think fit, and in addition to being sealed with the Seal of the Company, shall be signed by the President or Vice-President, or in their absence by a Director appointed so to do, and countersigned by the Secretary, or such other officer as the Directors may from time to time appoint, and any Instrument bearing the Common Seal of the Company attested by the Officers of the Company above-mentioned and issued for 20 valuable consideration, shall be binding on the Company, notwithstanding any irregularity touching the authority of the Directors to issue the same.
- 43. The Directors may make such arrangements with any of the chartered Banks in Canada, Great Britain or the United States for the deposit of moneys and securities and for conducting other financial matters as they shall from time to time deem necessary, and no moneys shall be drawn from the Bank without the signature of the President or the Secretary-Treasurer; and the President or Secretary-Treasurer shall have power to endorse for deposit in said banks only all cheques, bills of exchange, drafts, notes or orders for money which shall be made payable to the Company.

Amendment to By-Law No. 43, adopted February 22, 1923:

The words after "deem necessary" shall be omitted and replaced by the following: "And no moneys shall be drawn from the Bank without the "signature of such officer or officers as the Directors shall authorise to sign "negotiable instruments on the Company's behalf and that such officer or "officers shall have power to endorse for deposit in said banks only, all "cheques, bills of exchange, drafts, notes or orders for money which shall be "made payable to the Company."

Whereas it is deemed advisable that ten thousand shares of the Capital 10 Stock of the Company, each of the par value of One Hundred Dollars, be created and issued as Preference Stock, having fixed cumulative preferential dividends and having priority in any division of the assets of the Company to the extent of its repayment in full at par, together with any dividends thereon then accrued due and remaining unpaid, but conferring no right to any further participation in profits or assets.

Now Therefore, be it enacted and it is hereby enacted as a By-Law of Ganong Brothers, Limited, that Ten Thousand Shares of the Capital Stock of the Company shall be created as Preference Stock, and that the said Shares shall have a fixed cumulative preferential dividend of seven per cent. per 20 annum, payable as may be convenient half-yearly, and the said Shares shall be issued and allotted by the Board of Directors of the Company as they may direct, and the parties to whom the said shares shall respectively issue and any subsequent holders thereof shall be entitled to receive the said dividends and shall hold the shares upon the following terms, namely:

The issue of the Preference Stock shall become and remain a lien upon the assets of the Company superior to any claim or claims belonging to the ordinary or Common Stock, so that on any dissolution or winding up of the Company or liquidation of its business or assets, or in any division of capital or assets of the Company among the Shareholders, thereof, the holders of 30 Preference Stock shall be entitled to payment for their stock in full at par (together with any dividends in arrear) and no more, and shall, as between themselves and the holders of the Common Stock have the standing of creditors of the Company whose claims shall be paid, after satisfaction of all other indebtedness of the Company, in preference and priority to any payments to the holders of the Common Stock, but only out of the Assets of the Company and subject to the prior rights of creditors to be first paid in full.

By-Law No. 61.

Respecting the Borrowing of Money by the Company.

Whereas, it is necessary for the purposes of the Company to borrow money on the credit of the Company from time to time from one of the chartered banks of Canada;

Therefore be it Enacted by the Directors of Ganong Brothers, Limited, as a By-Law thereof:

- 1. That the Directors of the Company be and they are hereby authorised to borrow moneys from time to time from the Bank of Montreal upon the credit of the Company in such amounts as they deem proper and by way of 10 overdraft or otherwise.
- 2. That any promissory notes or other negotiable paper (including renewals thereof in whole or in part) signed on behalf of the Company by the Secretary or any other officer of the Company authorised from time to time to sign negotiable instruments in its behalf and granted to said Bank for the moneys so borrowed and interest thereon as may be agreed upon, shall be binding upon the Company.
- 3. That the Directors may from time to time, if they see fit to do so, grant securities by way of Mortgage, hypothecation or pledge covering all or any of the property and assets of the Company as security for all or any 20 moneys borrowed by the Company from the Bank or any other indebtedness of the Company to the Bank, and all such securities shall be valid and binding upon the Company if signed by any of the officers authorised to sign negotiable instruments on the Company's behalf.
- 4. The Directors may from time to time authorise any officer or officers of the Company to make arrangements with said Bank with reference to the moneys from time to time to be borrowed as aforesaid and as to the terms and conditions of the loan thereof and as to the securities to be given therefor, and every such officer shall have authority from time to time to vary or modify such arrangements, terms and conditions, and to give additional 30 security for any moneys remaining due.
