IN THE MATTER of the estate of ROBERT WINTON GILLESPIE late of Sydney in the State of New South Wales, Knight, deceased.

AND IN THE MATTER of the Stamp Duties Act 1920-1940.

AND IN THE MATTER OF the appeal of FRANCIS HARMSWORTH WAY, GEORGE ROLAND LOVE, WILLIAM GARRICK WILSON, JOHN

CADWALLADER and MILTON REWI DUNKLEY executors of the Will of the said deceased against the assessment by the Commissioner of Stamp Duties of death duty payable in respect of the said estate.

1.—The above-named Robert Winton Gillespie (who is hereinafter called "the testator") died on the second day of August 1945 within the State of New South Wales.

2.—Probate of the last will of the testator dated the twenty-first day of April 1945 has been duly granted by the Supreme Court of New South Wales in its Probate Jurisdiction to the executors therein named, namely, Francis Harmsworth Way, George Roland Love, William Garrick Wilson,

John Cadwallader and Milton Rewi Dunkley (hereinafter called the appellants ").

3.--By an Indenture made the fifth day of September 1928 between the testator (therein called the Settlor) of the one part and the testator, George Gillespie, Edward Charles Hadley and Frank Gordon Blair of the other part it was witnessed that the testator thereby transferred and assigned unto the parties thereto of the second part all those the moneys debts securities for moneys and property enumerated in the first part of the Schedule thereto to the intent that the same should be conveyed transferred and assigned into the names of the said parties thereto of the 10 second part and held by them upon the trusts and subject to the conditions and provisions thereinafter set out.

4.—The said Indenture contained the following amongst other clauses

that is to say: "2. The said parties hereto of the second part or the "survivors of them or other the trustees for the time being "of these presents (all of whom are hereinafter included in "the expression 'the Trustees) shall hold the said moneys "debts and securities for moneys and property and all other "the investments securities and property for the time being 20 "representing the same hereinafter referred to as 'the Trust "'fund' upon trust out of the corpus to pay any duty or duties "the payment of which may be demanded and enforced by the "Government of any of the State(s) of the Commonwealth upon "the execution of this Indenture and upon further trust on and "after the date of these presents to hold the Trust Fund or the " balance thereof as the case may be upon trust to apply and "appropriate such Trust Fund and the annual income thereof " after payment of all salaries expenses costs charges and outgoings " hereinafter authorised towards lawful charitable purposes under 30 "the following heads vide licet

"(a) Educational.

"(b) The relief of poverty in Australia.

"(c) The general benefit of the community in Australia not " falling under the preceding head

" but subject to all the provisions and conditions set out in these " presents.

"3. The time manner and the head or heads under which "the application and appropriation of the said Trust Fund and " the said income shall be made and all other details and particulars 40" as to such application and appropriation shall be in the absolute "discretion of the Trustees but during the lifetime of the "Settlor subject to his direction and approval and the "Settlor places on record his belief that it will be found advisable "to have completely distributed the trust fund and wound up " the trust within ten or fifteen years.

"24. The Trustees may also apply and appropriate any In the "property belonging to the Trust in its then present condition " for any Trust purposes and may also use any of the moneys of "the Trust either corpus or income or both in purchasing any " land or land and buildings or in crecting buildings or in altering " or in improving buildings to be used or applied for any such "purpose." The Trustees may whether during the lifetime of the "Settlor or afterwards and shall during the lifetime of the Settlor " if he so directs apply and appropriate any property including $\frac{1949}{1949-1}$ "moneys belonging to the Trust for the purposes of acquiring continued. " by purchase or exchange from the Settlor or his executors any " real or personal property valued for the purposes of such purchase " or exchange at a sum at least five per cent. below the valuation " of such real or personal property so acquired as ascertained by "some independent valuator appointed by the Trustees other " than the Settlor."

Supreme Court of New South Wales.

5.--By an Indenture made the first day of November 1929 between the same parties the aforesaid Indenture of the fifth day of September 1928 was varied as was in the later Indenture provided but was 20 otherwise confirmed. The said variation related to the property agreed to be transferred and assigned by the testator and not to the trusts upon which property transferred and assigned by him were to be held.

6.—A true copy of the said Indenture of the fifth day of September 1928 and a true copy of the said Indenture of the first day of November 1929 are hereunto annexed marked "A" and "B" respectively and form part of this case.

7.—The transfer of the cash deposit mentioned in the first of the said Indentures was completed by the testator and the sum of money mentioned in the second of the said Indentures was duly paid by him 30, to the trustees of the settlement constituted by the said Indentures.

8.—From time to time after the execution of the said Indentures. the testator transferred assigned or paid other property and moneys of the testator to the trustees of the said settlement to be held by them upon the trusts and subject to the conditions and provisions contained in the said Indentures. All such property and moneys were transferred assigned or paid to the said trustees more than three years prior to the date of the death of the testator.

9.—Immediately prior to the death of the testator the trustees of the said settlement were the testator, Jessie Jean Gillespie, Francis Harmsworth 40 Way, and William Garrick Wilson. The testator was one of the trustees of the said settlement at all times up to the date of his death.

10.---During the life of the Testator the trustees of the said settlement applied or appropriated moneys belonging to the Trust totalling the sum of £52,088 15s. 0d. in the acquisition by purchase from the Testator of In the supreme the undermentioned personal property, being shares in certain companies, on the respective dates and at the respective prices hereunder shown in relation to such purchases :

11.—None of the said shares were acquired at sums fixed in accordance with valuations as required by the provisions of clause 24 of the said Indenture of the fifth day of September 1928.

12.—At the date of the death of the testator the value of the property subject to the trusts of the said settlement was $\pounds 81,403$ 19s. 6d.

13.—For the purposes of the assessment of death duty the Commissioner of Stamp Duties included in the estate of the testator the property which was at the time of his death subject to the trusts of the said settlement.

14.—The Commissioner of Stamp Duties assessed death duty on the estate of the testator on the basis that the final balance of the estate as determined in accordance with the said Act was $\pounds 319,926$, and assessed such death duty at $\pounds 100,964$ 10s. 0d.

15.—The appellants contend that the estate of the testator ought not for the purposes of the assessment and payment of death duty to be 40 deemed to include the property which was at the date of his death subject to the trusts of the said settlement or any part thereof but do not otherwise dispute the correctness of the said assessment.

16.—The appellants have paid the death duty assessed as aforesaid In the by the Commissioner of Stamp Duties and have deposited the sum of Supreme £20 as security for costs and have by notice in writing required the Court of New South Commissioner of Stamp Duties to state a case for the opinion of the Supreme Wales. Court of New South Wales.

17.—If the appellants are correct in their contention the amount of death duty payable in respect of the estate of the testator will be reduced by £26,049 5s. 8d.

18.—The questions for the determination of the Court are :—

- continued. (1) Should the property which was at the date of death of the testator subject to the trusts of the said settlement be deemed to be included in his estate for the purposes of the assessment and payment of death duty thereon?
- (2) What was the amount of death duty payable in respect of the estate of the testator?
- (3) How should the costs of this case be borne and paid ?

dated 5th THIS INDENTURE made the fifth day of September One thousand nine September, hundred and twenty-cight Between ROBERT WINTON GILLESPIE of Sydney 1928.in the State of New South Wales Miller (hereinafter called the Settlor) of the one part and the said ROBERT WINTON GILLESPIE GEORGE GILLESPIE of Sydney aforesaid Miller Edward Charles Hadley of Sydney aforesaid Company Director and FRANK GORDON BLAIR O. Sydney aforesaid Company Director of the other part WITNESSETH as follows that is to say :

1.—The said Settlor hereby transfers and assigns unto the parties hereto of the second part ALL THOSE the moneys debts securities for moneys and property enumerated in the first part of the schedule herete to the intent that the same shall be conveyed transferred and assigned into the names of the said parties hereto of the second part and held by them upon the trusts and subject to the conditions and provisions hereinafter set out.

2.—The said parties hereto of the second part or the survivors of them or other the Trustees for the time being of these presents (all of whom are hereinafter included in the expression "the Trustees") shall hold the 40 said moneys debts and securities for moneys and property and all other

but subject to all the provisions and conditions set out in these presents.

3.—The time manner and the head or heads under which the application and appropriation of the said Trust Fund and the said income shall be made and all other details and particulars as to such application and appropriation shall be in the absolute discretion of the Trustees but during the lifetime of the Sottlor subject to his direction and approval and 20 the Settlor places on record his belief that it will be found advisable to have completely distributed the trust fund and wound up the trust within ten or fifteen years.

4.—There shall be three or more Trustees of the said Trust and the first Trustees shall be the said parties hereto of the second part.

5.—The Trust Fund shall be known as "The R.W. Gillespie Trust."

6.—No person shall be qualified to act as Trustee whether upon his first or any subsequent appointment until he shall being a first Trustee have executed these presents or being any other Trustee shall have signed a declaration as prescribed by the regulations hereinafter referred to to the 30 effect that he accepts the office of Trustee and is willing to act in the trusts of this Indenture.

7.—No person being

(a) A Minister of religion or

(b) Not a Protestant

(c) A Manager Secretary or Treasurer of any charitable institution or charitable trust

shall be at any time eligible for election or to act as a Trustee in this Trust.

8.—Meetings of the Trustees shall be held at least quarterly and any Trustee except the Settlor who omits to attend four consecutive ordinary 40 meetings of the Trustees without obtaining leave of absence from the other Trustees shall thereupon cease to be a Trustee.

9.—Any Trustee may with the written consent of all his co-trustees appoint in writing some person of whom they may approve to act in his

place for such period as they may approve and during the currency of his In the appointment such person shall have all the powers duties and liabilities of Supreme a Trustee and such first mentioned Trustee shall not during the period of $\frac{\text{Court of}}{\text{New South}}$ such appointment be liable for the acts or defaults of the person so wales. appointed.

10.—Any Trustee who has been requested in writing by all the other Case Stated, Trustees to retire from the trust and fails within seven days to communicate 12th in writing to the Trustees his resignation of the trust or is adjudicated January, bankrupt or insolvent or makes a composition with his creditors or goes to ¹⁹⁴⁹⁻ 10 reside permanently out of New South Wales or becomes incapacitated or continued. ineligible to act or who communicates in writing to the Trustees his resignation of the Trust shall thereupon cease to be a Trustee.

11.—Upon the occurrence of a vacancy then the Trustees shall at their Settlement, next ensuing meeting cause a note thereof to be entered as prescribed by dated 5th the said regulations and they shall upon such vacancy appoint a new September, Trustee. No person who has ceased to be a Trustee shall by reason of that ¹⁹²⁸fact alone be ineligible for re-appointment. If at any time the number of continued. Trustees be reduced to one such Trustee shall apply forthwith to the Settlor or his executors to fill the vacancies as such Settlor is hereby authorised 20 te do.

12.—In all cases where a new Trustee is appointed all necssary documents and deeds shall be executed for the purpose of vesting the property of this Trustee in the surviving and continuing Trustees and the new Trustee or Trustees and in the event of there being any difficulty in obtaining such execution or refusal to execute such deeds and documents the continuing Trustees or any two of them may apply to the proper Court for a vesting order or such other order as they may think fit and shall pay the cost of such proceedings out of the income of the Trust.

13.—In the event of the Trustees failing or refusing to act as regards 30 appointment of any new trustee or trustees application for that purpose may be made by two or more of the Trustees to the proper Court and the cost of such proceedings shall be paid out of the income of the trust.

14.—The head office of the Trust shall be in Sydney and the Trustees may from time to time if necessary lease suitable premises for any such offices for such term or terms at such rent or rents and subject to such covenants and conditions as they think advisable and pay the rents and outgoings thereunder out of the said income. The Trustees may also from time to time sell or surrender any lease they have obtained and lease other premises for any such offices as aforesaid.

MEETINGS AND PROCEEDINGS OF TRUSTEES

15.—There shall be a quorum when two Trustees are present at any meeting. Pending any vacancy in the office of Trustee the Trustees for the

Settlement, dated 5th Sept mber, 1928 continued. time being not less in number than a quorum may act for all purposes in the administration of this trust or scheme.

16.—The first meeting of the Trustees shall be summoned by the Settlor upon some day to be determined by him within three calendar months from the date hereof or if he shall fail to fix a day then on some day to be fixed by any Trustee.

17.—Every question arising at any meeting of the Trustees shall be determined by the majority of the Trustees present and voting on the question. The Chairman of any meeting shall have a casting vote whether or not he shall have previously voted on the same question but no Trustee 10 shall in any other circumstances give more than one vote.

18.—Any resolution of the Trustees may be rescinded or varied from time to time by the Trustees at a special meeting.

19.—Any matter or proposition requiring the decision of the Trustees may be submitted to them by the Secretary or some other person under the direction of the Trustees by letter sent through the post or by telegram and the votes thereon may be given by the Trustees by letter in reply to or by telegram and such votes of the Trustees or the majority of them shall be as binding as a resolution or decision given by the Trustees or a majority of them in general meeting. 20

OFFICERS AND GENERAL MANAGEMENT.

20.—The office of Trustee is to be entirely honorary but the Trustees may from time to time appoint on such terms and conditions as they may think fit a Secretary Auditors Clerks and all such other officers and agents for their assistance in the administration and management of the trust as they may think fit. The Trustees may pay out of the said income to their Secretary and to their other officers and agents such annual salaries or other remuneration as from time to time think fit. Subject as herein provided the Trustees shall from time to time prescribe and appoint the duties to be performed by their officers and agents. 30

21.—Proper accounts shall be kept in proper books of account to be provided for the purpose of all moneys received and paid respectively on account of the Trust. Such books of account shall be made up for each year and shall be from time to time examined and shall be passed by the Trustees at their first ordinary meeting in the ensuing year or at some other meeting appointed for the purpose and shall thereupon be signed by the Chairman of the meeting. All proper accounts in relation to the Trust shall be kept and made out and a balance sheet shall in each year be made out and certified to by one or more qualified accountants and copies thereof transmitted to each Trustee and published within three months of 40 the end of each year in such manner as may be prescribed by the said regulations.

APPLICATION OF INCOME.

22.-All the proper costs charges salaries and expenses of and incidental Court of to the administration and management of the Trust including all out of pocket expenses incurred by the Trustees in connection with the Trust shall be first defrayed out of the income of the Trust.

23.—Subject to the payments aforesaid and to the provisions hereof 12th the Trust Fund and/or the yearly income available shall be applied by the January, Trustees or under their direction according to their discretion within the $^{1949-}$ limits hereby prescribed but it shall not be necessary for the Trustees to so 10 apply any part of the Trust Fund or the whole of the income received in any one year in that year and as regards any balance in any year remaining unapplied the Trustees may capitalise same and add it to the Trust Funds or carry such balance forward to the next year for application in that or Settlement, any other year provided that the benefit of any such capitalisation or carry- dated 5th ing forward of unapplied income shall enure for the benefit of the aforesaid $\frac{1928}{1928}$ charitable purposes in or in respect of which such balance of income continu d. remains unexpended.

24.—The Trustees may also apply and appropriate any property belonging to the Trust in its then present condition for any Trust purposes and 20 may also use any of the moneys of the Trust either corpus or income or both in purchasing any land or land and buildings or in erecting buildings or in altering or in improving buildings to be used or applied for any such purpose. The Trustees may whether during the lifetime of the Settlor or afterwards and shall during the lifetime of the Settlor if he so directs apply and appropriate any property including moneys belonging to the Trust for the purposes of acquiring by purchase or exchange from the Settlor or his executors any real or personal property valued for the purposes of such purchase or exchange at a sum at least five per cent. below the valuation of such real or personal property so acquired as ascertained by some 30 independent valuator appointed by the Trustees other than the Settlor.

25.—(1) The Trustees may retain unrealised so long as they may think fit any of the properties or securities hereby assigned or which may hereafter be vested in them by gift bequest or devise and may realise any of them when they think fit and may from time to time invest any moneys part of the Trust Funds available for investment in any one or more of the following investments :

- (a) Upon mortgages of freehold property and of conditional purchase land and conditional leasehold land anywhere within the State of New South Wales.
- (b) In the purchase of or advances on public or government securities of the Commonwealth of Australia or of any State thereof.
- (c) In the purchase of real estate of freehold tenure.

- (d) In purchasing or otherwise acquiring equities of redemption of any other outstanding interest in respect of any property the subject of a security held by the Trustees under which default has been made.
- (e) On deposit with any Bank carrying on business in the Commonwealth of Australia or with any company of which the Settlor or some person in trust for him is a shareholder.
- (f) In advances upon the security of City Municipal Shire Borough or other rates tolls or dues which may be authorised to be raised or charged by or under the authority of any Act of the 10 Commonwealth of Australia or any State therein.
- (g) In the purchase of or advances upon any bonds debentures mortgages or other securities of any city Municipal Shire borough public commissioners or trust public body corporation c1 company secured upon any undertakings or works or upon the rates tolls dues or revenue leviable or obtainable therefrom provided that the power to carry on cr construct such undertakings or works and to issue or give bonds debentures mortgages or other securities in connection therewith has been duly conferred under or by virtue of any Act of the Parliament 20 of the Commonwealth of Australia or of any State thereof PROVIDED FURTHER that in the case of a Company registered under the Companies Act such undertakings cr works aforesaid shall have been authorised by some express enactment extending to the Company.
- (h) In the shares of any company whose shares are approved by the Settlor.

(2) The Trustees shall have full power to place investments of the trust fund for convenience in the name of any trust or other company approved by the Settlor or his executors and vary any such investments from time 30 to time for any other or others of the kinds prescribed and full power to sell any property or investments so purchased or acquired for money or other valuable consideration and purchase other or others or otherwise invest the proceeds of sale and the Trustees may also leave money for any period at current account with any Bank.

26.—The Trustees shall have full power of management of the property of the Trust and may make out of the Trust funds or the income thereof any outlay they may think proper for the benefit of such property and generally manage same as if they were the absolute owners thereof.

27.-- Without prejudice to the general powers of management contained 40 in the preceding clause the Trustees shall have and may in their absolute discretion exercise the following powers with regard to the property of the Trust :

- (a) Power to repair and insure houses and buildings.
- (b) Power to make compromise with or grant indulgences to any tenants or tenant or any person or persons.
- (c) Power to accept surrenders of leases or tenancies.
- (d) Power to grant any lease or leases tenancy or tenancies for such term or terms at such rent or rents and generally on Case Stated, such conditions as they think advisable.
- (e) Power to enter into arrangements with and erect buildings on any vacant land for any prospective tenant or tenants.
- (f) Power to expend either capital or income or both on repairs to or improvements or additions to buildings or in the development of the property of the Trust.
- (g) Power to erect buildings.
- (h) Power to pull down existing buildings and re-erect others.
- (i) Power to adjust all such expenditure as between capital and 1928income and the decision of the Trustees shall be final and conclusive in respect of any adjustment so made.
- (i) Power to pay any debts of and claims on the trust upon evidence which they shall think sufficient.
- (k) Power to accept any composition or security real or personal for any debt due to the Trust.
- (1) Power to allow any time for the payment of any such debt.
- (m) Power to release without payment any debt or security.
- (n) Power to accept payment of any debt in other than cash value.
- (o) Power to compromise compound or submit to arbitration all debts accounts claims and things whatsoever belonging or relating to the Trust.

28.—In exercising the power of sale hereby given the Trustees may sell by public auction or private contract and for each or on terms or for any valuable consideration and with or subject to any special conditions they may think desirable with full power to dedicate roads or to sell lands in the subdivision and to buy in rescind or vary any contract for sale and reself as aforesaid without being answerable for any loss and generally sell or otherwise deal with any property of the trust in such manner as the Trustees 40 shall in their uncontrolled discretion think fit with all the powers in that behalf of absolute owners.

In particular Counsel considers that Clauses 10 & 11 are irrelevant on the ground that the meaning of the settlement now must be the same as the meaning it bore on the day on which it was executed, namely 5th September 1928. Any facts which occurred after the date of execution are irrelevant.

The Trustees therefore desire these clauses omitted. If you are not prepared to leave them out we should be glad if at the end of paragraph 11 you would insert the following words :--New South-

This is an appeal under s. 124 of the Stamp Duties Act 1920 as amended Reasons for by the executors of the will of the late Sir Robert Winton Gillespie against Judgment, an assessment by the Commissioner of Stamp Duties of death duty claimed 26th May, to be payable in respect of the estate of the deceased. 1949.

The material facts are as follows. The testator, hereinafter called (a) the settlor, by an indenture made the 5th September, 1928 between himself C.J., (a) Jordan, 10 of the one part, and himself, George Gillespie, Edward Charles Hadley and Frank Gordon Blair, hereinafter called the trustees of the other part, transferred and assigned to the trustees ten thousand fully paid $\pounds 1$ shares in Gillespie Bros. Ltd. and £7,500 cash deposit with Mungo Scott Limited to be held by them upon the trusts and subject to the conditions and provisions thereinafter set out. The indenture contained, inter alia, the following clauses :---

> "2. The said parties hereto of the second part or the survivors " of them or other the trustees for the time being of these presents " (all of whom are hereinafter included in the expression ' the "' Trustees) shall hold the said moneys debts and securities " for moneys and property and all other the investments securities " and property for the time being representing the same hereinafter "referred to as 'the Trust fund 'upon trust out of the corpus "to pay any duty or duties the payment of which may be "demanded and enforced by the Government of any of the "State(s) of the Commonwealth upon the execution of this " Indenture and upon further trust on and after the date of those " presents to hold the Trust Fund or the balance thereof as the " case may be upon trust to apply and appropriate such Trust "Fund and the annual income thereof after payment of all "salaries expenses costs charges and outgoings hereinafter " authorised towards lawful charitable purposes under the following " heads vide licet.

" (a) Educational.

" (b) The relief of poverty in Australia.

"(c) The general benefit of the community in Australia not " falling under the preceding head.

" but subject to all the provisions and conditions set out in these " presents.

"3. The time manner and the head or heads under which "the application and appropriation of the said Trust Fund and " the said income shall be made and all other details and particulars

" as to such application and appropriation shall be in the absolute "discretion of the Trustees but during the lifetime of the Settlor "subject to his direction and approval and the Settlor places on "record his belief that it will be found advisable to have completely "distributed the trust fund and wound up the trust within ten " or fifteen years.

"24. The Trustees may also apply and appropriate any property belonging to the Trust in its then present condition " for any Trust purposes and may also use any of the moneys of "the Trust either corpus or income or both in purchasing any 10 " land or land and buildings or in crecting buildings or in altering " or in improving buildings to be used or applied for any such " purpose. The Trustees may whether during the lifetime of the "Settlor or afterwards and shall during the lifetime of the Settlor " if he so directs apply and appropriate any property including "moneys belonging to the Trust for the purposes of acquiring by " purchase or exchange from the Settlor or his executors any real " or personal property valued for the purposes of such purchase " or exchange at a sum at least five per cent. below the valuation " of such real or personal property so acquired as ascertained by 20 "some independent valuator appointed by the Trustees other "than the Settlor."

By an indenture made the 1st November, 1929 the said indenture was varied as to the property agreed to be transferred and assigned but not as to the trusts upon which the property was to be held.

From time to time thereafter, but more than three years prior to the settlor's death, the settlor transferred assigned or paid other property and moneys to the trustees of the settlement constituted by the said indentures, to be held by them upon the trusts and subject to the conditions and provisions contained in the said indentures.

30

Between 30th October, 1929 and 24th February, 1934 the settlor on six occasions paid to the trustees by cheques sums totalling £51,807 as gifts to be held on the trusts of the settlement, and the trustees used the said sums in buying from the settlor in all 50,000 shares in Gillespie Bros. Pty. Ltd. and 25,896 shares in seven other companies. Each of the said six gifts and purchases was made in the following way. The trustees in the first place received a gift from the settlor of a cheque for a certain sum, to be held on the trusts of the settlement. The settlor then intimated that he would make available to the trust certain specified shares, and the trustees resolved to authorise the payment of a sum, which was always the same as 40 the amount of the cheque, to purchase those shares. They were then purchased accordingly.

On 30th June, 1945 about a month before the settlor's death, the trustees used £281 15s. 0d. of moneys the subject of the trusts in buying from the settlor 625 shares in two companies.

None of the shares bought by the trustees from the settlor was acquired In the in accordance with valuations pursuant to Clause 24 of the indenture of Supreme Court of 5th September 1928. New South

The settlor died on 2nd August, 1945. He was one of the trustees at Wales. all times prior to his death, and immediately prior to his death the trustees were himself, Jessie Jean Gillespie, Francis Harmsworth Way, and William Garrick Wilson.

No. 3. Reasons for 26th May, 1949

At the date of the settlor's death the value of the property then subject Judgment. to the trusts of the settlement was £81,403 19s. 6d.

The relevant questions for the determination of this Court are-

- (a) Jordan, C.J.,— (1) Should the property which was at the date of the death of the testator subject to the trusts of the said settlement be continued. deemed to be included in his estate for the purposes of the assessment and payment of death duty thereon?
- (3) How should the costs of this case be borne and paid ?

For the Commissioner it was claimed that the estate of the deceased should be deemed to include and consist of the settled property by reason of the provisions of s. 102(2)(a) or alternatively of s. 102(2)(c) or s. 102(2)(d)of the Stamp Duties Act 1920 as amended.

S. 102 provides that for the purposes of the assessment and payment of 20death duty the estate of a deceased person shall be deemed to include and consist of :--

> (2) (a) All property which the deceased has disposed of, whether before or after the passing of this Act, by will or by a settlement containing any trust in respect of that property to take effect after his death, including a will or settlement made in the exercise of any general power of appointment, whether exercisable by the deceased alone or jointly with another person :

Provided that the property deemed to be included in the estate of the deceased shall be the property which at the time of his death is subject to such trust.

The question arising under Clause (a) is whether the settlements constituted by the two indentures, and the subsequent settlements made on the terms of the trusts set out in the indenture of 5th September, 1928, contained any trust in respect of the property thereby settled to take effect after the settlor's death.

In Commissioner of Stamp Duties (N.S.W.) v. Thomson (40 C.L.R. 394 at 426) it was said by Higgins J. that "It is enough, for the purposes " of the section, that the settlement contain any trust intended to take 40 "effect after his death"; and in Rabett v. Commissioner of Stamp Duties (1929 A. C. 444 at 448) the Privy Council said "The section assumes that " the testator has disposed of the property, and the only condition required " for duty to attach is that the settlement contains trusts to take effect "after his death." Their Lordships instanced as trusts which would possess that character trusts taking effect after the settlor's death enabling his widow alone to sell and vary investments, or enabling her, if a joint power

had not been exercised, to appoint to children. Thus, it does not matter whether the trust is a machinery trust for the management of the trust property or a trust for the selection of beneficiaries, so long as it is to take effect after his death.

In Commissioner of Succession Duties (S.A.) v. Isbister (64 C. L. R. 375) a settlor by deed poll declared himself trustee of certain property upon Reasons for trust to pay the income to his daughter for life and after her death upon trust for her children or remoter issue in such shares as she should appoint and in default of appointment for her children upon certain contingencies, and the settlor reserved to himself power to revoke wholly or partially 10 the trusts thereby declared. He died without having exercised his power of revocation. It was held that the fact that his death would prevent him from revoking the trusts did not cause the settlement to contain a trust to take effect after his death. It was true that upon his death the trusts would become indefeasible, but his death would not bring into effect a new trust, it would merely increase the value of an existing trust.

> If a settlor conveyed property to a sole trustee upon trusts to apply all or any part of the income or corpus thereof for the benefit of such one or more of the six children of X and at such times and in such proportions as the trustee for the time being should think fit and so far as any part of the 20trust fund should remain unapplied twenty years after the date of the settlement, over, it would be obvious that the value of the interest of each child of X would depend to some extent upon the personality of the trustee for the time being, since each succeeding trustee might have a different conception of what constituted meritoriousness on the part of possible participants, but it could not be said that new trusts came into existence whenever a new trustee was substituted for his predecessor; the trusts would remain the same, notwithstanding that the values, of the interests of the respective beneficiaries were varied. If, however, the settlor conveyed the property to A upon trust during A's life to apply all or any part etc. for 30 the benefit of such one or more of the six children of X and at such times etc. as A should think fit, and upon trust, after the death of A, for the benefit of such one or more of the six children of X, etc. as the trustee of the settlement for the time being should think fit, there would be two trusts for the benefit of the ehildren of X, one intended to be dependent on the discretion of A during his life, and another intended to come into effect on A's death and be dependent on the discretion of whoever might for the time being be the trustee of the settlement; cf. Commissioner of Stamp Duties (N.S.W.) v. Perpetual Trustee Co. Ltd. (21 C. L. R. 69 at 80-81). Burrell v. A. G. 1937 A. C. 286 at 297 and 299-302. 40

In the present case, by Clause 2 of the indenture of 5th September, 1928 the trustees were to hold the trust fund upon trust to apply and appropriate the same towards lawful charitable purposes under the heads (a) educational, (b) the relief of poverty in Australia, (c) the general benefit of the community in Australia not falling under the preceding heads, but subject to all the provisions and conditions set out in the indenture. Clause 3 goes on to provide that the time, manner and the head or heads under which the application and appropriation of the trust fund and income shall In the be made, and all other details and particulars as to such application and Supreme appropriation, shall be in the absolute discretion of the trustees, but during Court of the lifetime of the settlor, subject to his direction and approval. As a matter of construction, I think that this means that during the lifetime of the settlor the application and appropriation of the trust fund, whether beneficially or by way of machinery, are to be subject to the direction and Reasons for approval of the settlor, and that it is only after his death that the application Judgment, and appropriation of the trust fund are in the absolute discretion of the

10 trustees. That is to say, during the settlor's lifetime the trusts which take effect depend on his discretion, and it is only after his death that trusts (a) Jordan, take effect which depend on the discretion of other persons : cf. Burrell v. C.J. A. G., 1937 A. C. 286 at 297, 299-302. In these circumstances, I am of opinion that the property which was at the settlor's death subject to the trusts of the settlements must be deemed to be included in his estate for death duty purposes.

S. 102(2) (c) brings within the dutiable estate :---

(c) Any property passing under any settlement trust, or other disposition of property made by the deceased whether before or after the passing of this Act

- (i) by which an interest in or benefit out of or connected with that property, or in the proceeds of sale thereof, is reserved either expressly or by implication to the deceased for his life or for the life of any other person, or for any period determined by reference to the death of the deceased or of any other person; or
- (ii) which is accompanied by the reservation or assurance of, or a contract for, any benefit to the deceased for the term of his life or of the life of any other person, or for any period determined by reference to the death of the deceased or of any other person; or
- (iii) by which the deceased has reserved to himself the right, by the exercise of any power, to restore to himself or reclaim that property or the proceeds of sale thereof.

The first question under this clause is whether by the settlements, which were all made upon the trusts set out in the deed of 5th September, 1928, an interest in or benefit out of or connected with the property settled was reserved either expressly or by implication to the settlor for his life. Clause 24 of the deed provides that the trustees shall during his life if he so 40 directs apply any property belonging to the trust for the purpose of acquiring

by purchase or exchange from him or his executors any real or personal property valued for the purpose at a sum of at least 5 per cent. below its value as ascertained by an independent valuator appointed by the trustees other than the settlor. In other words, the settlor expressly reserved to himself for his life the right to take any property the subject of the

settlements on his giving in exchange property valued at at least 5 per cent. below its true value. That is to say, if, for example, the trustees held one thousand shares having a market value of $\pounds 1,000$, and the settlor wanted them, he could compel the trustees to transfer them to him on his transferring to the trustees property worth at least \pounds ,050. This right was an interest in the settled property and it was expressly reserved to the Reasons for settlor for his life. No doubt the life interest was one which enabled him to acquire the settled property for greater than a life estate, and no doubt such an interest could hardly be regarded as having a market value. But this is immaterial. The reservation of an option to purchase, available 10 during the settlor's life, would clearly be hit by the clause, and the clause draws an antithesis between an interest in and a benefit out of; the interest need not be marketable. In these circumstances, it is unnecessary to consider whether s. 102(2) (c) (iii) is restricted in its application to cases in which the deceased has reserved the right to restore the settled property to himself without giving any consideration for it. As at present advised, I am disposed to think that it is not so restricted. For these reasons, I am of opinion that the settlements are caught by Clause (c).

> As regards s. 102(2) (d) as at present advised I am of opinion that this clause is directed to gifts which are gifts in the ordinary sense or gifts in the 20 sense set out in s. 100, but by reason of matters subsequent specified in the There is no evidence of any such matter subsequent clause are dutiable. in the present case.

For the reasons which I have stated, I am of opinion that Question 1 should be answered in the affirmative and that the costs of the case should be borne and paid by the executors.

By deed dated 5th September, 1928, the late Sir Robert Gillespie (hereinafter called the settlor) created a trust fund to be held and applied 30 by trustees, of whom he himself was one, for various charitable purposes. Clause 2 of the deed provided that the trustees should hold the trust fund on and after the date of the deed upon trust to "apply and appropriate "it and the annual income thereof towards lawful charitable " purposes, under the following heads, vide licet, (a) educational; (b) the "relief of poverty in Australia; (c) the general benefit of the community " in Australia not falling under the preceding head." Clause 3 was in these terms, "The time, manner and the head or heads under which the " application and appropriation of the said trust fund and the said income " shall be made and all other details and particulars as to such application 40" and appropriation shall be in the absolute discretion of the trustees but "during the lifetime of the settlor subject to his direction and "approval" Clause 24 provided that "The trustees may, whether "during the lifetime of the settlor if he so directs apply and appropriate " any property including money belonging to the trust for the purposes of

" acquiring by purchase or exchange from the settlor or his executors any In the "real or personal property valued for the purposes of such purchase or Supreme "exchange at a sum at least five per cent. below the valuation of such Court of " real or personal property so acquired as ascertained by some independent "valuator appointed by the trustees other than the settlor." In 1929 a supplementary deed was executed varying the first deed in certain respects

not material to this case. By a number of transactions between October, Reasons for 1929 and June, 1945 the settlor made substantial additions totalling over Judgment, £50,000 to the Trust Fund. In thirteen of these transactions a similar 10 procedure was adopted, and I quote one as an example-on November 7th,

1929 the secretary of the Trust reported to a meeting of the trustees that (c) Owen, J. he had received the gift of a cheque for ± 3.150 from the settlor to be held —continued. on the terms of the trust set out in the original deed. The settlor, who was present at the meeting, thereupon intimated that he would make available to the Trust 2,800 shares in Gillespie Bros. Ltd., and the trustees resolved to authorise the payment of £3,150 to purchase these shares at 22s. 6d. each. In other words, the settlor presented the Trust with 2,800 shares in Gillespie Bros. Ltd. In the remaining two instances the trustees appropriated sums totalling £281 15s. 0d. belonging to the Trust and 20 purchased from the settlor shares in two mining companies.

The Commissioner claims that the whole of the trust property which was subject to the Trust at the date of the settlor's death, amounting to £81,403 19s. 6d., is to be included in his estate for the purpose of the assessment and payment of death duty, the amount of additional duty involved being £26,049 5s. 8d. This claim is based upon the provisions of Section 102 (2) (a), (c) and (d) of the Stamp Duties Act.

Section 102 (2) (a) provides, inter alia, that for the purposes of the assessment and payment of death duty the estate of a deceased person shall be deemed to include property of which he has disposed in his lifetime by 30 a settlement containing a trust to take effect after his death; and it is submitted that the deed in the present case created such a settlement, because by Clause 3 it gave the settlor during his life, and if he wished to use it, an overriding voice in the choice of beneficiaries, whereas after his death they were to be selected by the remaining trustees. It is said that the deed thus created two trusts, the first in favour of those whom the settlor might select during his life, the second a trust taking effect after his death in favour of those who might thereafter be chosen by the remaining trustees. The question then is-does the deed create two trusts, or does Clause 3 merely provide the machinery to give effect to one trust to be found in 40 Clause 2? My mind has fluctuated, but on the whole I think the latter view is the correct one. Reliance was placed by the Commissioner on a passage from the judgment of the Privy Council in Rabett's case (1929 A.C. 444 at 448) where their Lordships said, "The section assumes that the testator " has disposed of the property, and the only condition required for duty

"to attach is that the settlement contains trusts to take effect after his "death. In the present case the trusts that took effect after his death "were (1) (2) a trust enabling her" (the testator's widow) "if

"the joint power was unexercised to appoint among the children by "deed or will, and (3) a trust for the benefit of the children in "default of appointment" But every judgment must be read in the light of the facts of the particular case and the deed of settlement there under consideration, a copy of which has been made available to us, made clear and express provision for a series of trusts to take effect after Reasons for the death of the settlor. I recognise the force of the argument that the deed now before us sets up two trusts, one in favour of persons (within the designated classes) chosen by A, and after A's death a further trust in favour of persons within the same classes chosen by B; but I think it would be 10 (c) Owen, J. more accurate to describe the settlement as one whereby one trust was *—continued* declared in favour of such persons or bodies (within a class) as might be chosen at different times by different selectors, the qualifications for selection as a beneficiary being the same in each case. The subsection seems to me to be directed at the disposition of assets during the settlor's life in such a way that on or after his death and by reference to it the whole, or some limited or potential beneficial interest passes from one person or set of persons to another, and not to a case such as the present where the settlor's death made no change in the class which was to or might benefit by the settlement. Both before and after the settlor's death the qualifications 20 of those who might partake in the distribution of the trust fund remained the same. The only alteration which his death occasioned was the replacement of himself as a selector by someone else. I think some light is thrown on the problem by a consideration of the way in which the House of Lords dealt with a not dissimilar question arising under Section 1 of the Finance Act of 1894, in Burrell & Kinnaird v. Attorney-General (1937 A. C. 286), a decision which was applied in Haldane v. Eckford (1948 1 Ch. 665). The section under consideration in that case was concerned with the liability to duty of property which " passed " on the death of a settlor or testator, and the test which their Lordships applied in deciding 30whether there has been a "passing" of settled property on the death of the settlor was whether the class or group, some or all members of which were eligible to benefit after the settlor's death, differed from the class or group eligible to benefit it before his death. That test, it seems to me, is applicable here and, applying it, it appears that the qualifications necessary to entitle a person to become a potential beneficiary were the same both before and after the settlor's death. I am of opinion therefore that the Commissioner's claim based upon Section 102(2)(a) fails. If I may adapt the words used by Williams J. in Commissioner for Succession Duties v. Isbister (64 C. L. R. 375 at 380) I think the method of selecting beneficiaries provided by Clause 3 40 of the Deed was simply an incident of the one and only trust created by Clause 2.

> I have come to the conclusion, however, that by reason of the provisions of both Section 102(2)(c)(i) and (iii) the Commissioner is entitled to succeed. By the deed the settler reserved to himself a right exercisable during his life to require the trustees to use trust assets for the purpose of buying property of which he was the owner, or to exchange trust assets for property

of which he was the owner. Now, if the deed had reserved to the settlor In the an option to purchase trust property, I think it would have been impossible Supreme to say that he had not thereby reserved to himself an interest in that Court of property nor could it have been denied that he had reserved to himself the right to reclaim possession of the property settled, and I cannot see any sound distinction in this respect between the reservation of a right to purchase and the reservation of a right to acquire or re-assume possession Reasons for of trust property by exchange. It is, I think, irrelevant in this connection Judgment, that the settlor was at pains to ensure that any such purchase from him

10 by the trustees or any such exchange of assets would benefit the Trust and not himself, since in any such transaction the trustees would get the (c) Owen, J. settlor's property at less than its true value. That part of the subsection -continued. with which we are now concerned does not make the value of the right reserved to the settlor the test of whether he has for the purposes of the Act completely disposed of property during his life. It is concerned with the question whether or not the disposition is an absolute gift; and if it is found that the settlor has retained an interest in or reserved a right to re-assume ownership of the property given, then for the purposes of the Act and regardless of the value of that interest or right, he is deemed not to 20 have made an out and out gift.

In these circumstances it is unnecessary to decide the argument based upon Section 102(2)(d). It is a provision which has regard not to the terms of the deed but to events occurring afterwards. As at present advised I find some difficulty in seeing in what respect it can properly be said that after the execution of the deed and before his death the settlor in fact came back into possession of any part of the property given. The transactions whereby the Trust was enriched by the settlor do not seem to me to establish the Commissioner's claim, but it is unnecessary and perhaps unwise to enlarge upon the point. The first question asked should be answered 30 in the affirmative, and the second question should be answered

"£100.964 10s. 0d."

I think it right to add that from beginning to end of the case no suggestion has, or could have been made, that the settlor was acting otherwise than bona fide and for reasons which did him the greatest credit. The case is one in which a public spirited citizen in his lifetime generously provided large sums of money and valuable assets for charitable purposes. Unfortunately, the means adopted to carry out his purpose were such as to leave the settled property part of his estate for the purposes of death duty.

JUDGMENT.

(Reasons prepared by WILLIAMS, J.)

This is an appeal by the executors of R. W. Gillespie deceased from an order of the Full Supreme Court of New South Wales answering the first question submitted in a case stated under sec. 124 of the Stamp Duties Act 30 1920–1940 (N.S.W.) by the respondent the Commissioner of Stamp Duties in favour of the Commissioner.

The question is whether certain trust funds known as the R. W. Gillespie trust of the value of £81,403 19s. 6d. form part of the dutiable estate of R. W. Gillespie, deceased, for the purposes of death duty under the provisions of the Act. The respondent claims that these funds are made part of the notional estate of the deceased by virtue of the provisions of sec. 102(2) (a), or alternatively of sec. 102(2) (c), or alternatively of sec. 102(2) (d) of the Act. Jordan C.J. and Maxwell J. were of opinion that they were made part of the notional estate by both sec. 102(2) (a) and

In the High sec. 102(2) (c), while Owen J. was of opinion that they were so made by sec. 102(2) (c). The funds in question consisted of the whole of the assets which at the date of the death of the deceased on 2nd August 1945 were still subject to the trusts of a certain indenture of settlement dated 5th September 1928. By this indenture made between the deceased as settlor of the one part and the settlor and three other persons as trustees of the other part, as varied by a subsequent indenture made between the same parties on 1st November 1929, the settlor transferred and assigned certain moneys totalling $\pounds 18,750$ to the trustees of the settlement to be held by them upon the trusts and subject to the conditions and provisions 10thereinafter set forth.

The indenture contained the following clauses :

"2. The said parties hereto of the second part or the "survivors of them or other the trustees for the time being of "these presents (all of whom are hereinafter included in the "expression ' the Trustees ') shall hold the said moneys debts and " securities for moneys and property and all other the investments "securities and property for the time being representing the "same hereinafter referred to as ' the Trust fund ' upon trust out " of the corpus to pay any duty or duties the payment of which 20 "may be demanded and enforced by the Government of any of "the State(s) of the Commonwealth upon the execution of this "Indenture and upon further trust on and after the date of these presents to hold the Trust Fund or the balance thereof as the "case may be upon trust to apply and appropriate such Trust "Fund and the annual income thereof after payment of all "salaries expenses costs charges and outgoings hereinafter "authorised towards lawful charitable purposes under the "following heads vide licet (a) Educational; (b) The relief of " poverty in Australia ; (c) The general benefit of the community 30" in Australia not falling under the preceding head; but subject " to all the provisions and conditions set out in these presents. "3. The time manner and the head or heads under which the "application and appropriation of the said Trust Fund and the "said income shall be made and all other details and particulars " as to such application and appropriation shall be in the absolute " discretion of the Trustees but during the lifetime of the Settlor "subject to his direction and approval and the Settlor places on "record his belief that it will be found advisable to have " completely distributed the trust fund and wound up the trust 40"within ten or fifteen years. 24. The Trustees may also apply " and appropriate any property belonging to the Trust in its " then present condition for any Trust purposes and may also use " any of the moneys of the Trust either corpus or income or both " in purchasing any land or land and buildings or in erecting " buildings or in altering or in improving buildings to be used or "applied for any such purpose. The Trustees may whether

" during the lifetime of the Settlor or afterwards and shall during In the High " the lifetime of the Settlor if he so directs apply and appropriate Court of " any property including moneys belonging to the Trust for the " purposes of acquiring by purchase or exchange from the Settlor " or his executors any real or personal property valued for the " purposes of such purchase or exchange at a sum at least five per " cent. below the valuation of such real or personal property so " acquired as ascertained by some independent valuator appointed " by the Trustees other than the Settlor."

10 In addition to the original sums of money mentioned in these indentures the Settlor paid to the trustees of the settlement from time to time further sums of money totalling £51,807 as gifts to be held on the trusts of the settlement and the trustees used these sums in buying from the Settlor in all 50,000 shares in Gillespie Bros. Pty. Ltd. and 25,896 shares in seven other companies. All these moneys were paid to the trustees more than three years prior to the date of the death of the Settlor. On 30th June 1945, about a month before the Settlor's death, the trustees used £281 15s. 0d. of moneys the subject of the trusts in buying from the Settlor 725 shares in two companies. None of the shares bought by the trustees from the 20 Settlor was acquired in accordance with valuations made pursuant to clause 24 of the indenture. The Settlor was one of the trustees of the settlement from the date of its execution to that of his death.

Before referring to the relevant provisions of the Stamp Duties Act, it will be convenient to discuss the meaning of clauses 2, 3 and 24 of the settlement. There are three objects of the charitable trust, the trustees having a discretion to apply the trust funds both income and corpus for the advancement of these objects. The Settlor in his lifetime had a control over the manner in which the discretion of the trustees should be exercised to the extent that the exercise was subject to his direction and approval. 30 Trustees of a charity in the absence of a provision to the contrary in the trust instrument can act by a majority. In this case there is a provision to the contrary, and it may be that the word "direction" would have been sufficient to compel the other trustees to exercise their discretion as the Settlor directed, but the better opinion would appear to be that the effect of the provision was merely to give the Settlor a right of veto, so that the majority could not exercise their discretion in a manner of which the Settlor did not approve. But on either view it would not be correct to construe the settlement as containing two trusts (1) a trust during the

lifetime of the Settlor to distribute the trust funds amongst the charitable 40 objects in accordance with his direction and approval; and (2) a trust after his death to distribute the trust funds amongst such objects in the absolute discretion of the trustees. It is not a trust which can be divided into a trust, like that in *Waldo* v. *Caley*, 16 V. 206, limited to endure for the life of the Settlor with a further and different trust to take effect on his death. It is a single trust though different persons are to exercise the discretion as to the manner in which the trust funds should be distributed Court of Australia.

In the High amongst the charitable objects during the life of the Settlor and after his death. There is a general charitable intention to benefit the objects of the trust irrespective of the mode by which the gift is to be carried into effect from time to time, and in such a case equity will not allow the trust to fail by reason of the failure of the appointed mode. The trust would therefore have taken effect during the life of the Settlor although he had refused to act as a trustee or had retired or had become for some other reason unwilling or unable to exercise his discretion A.G. v. Gladstone 13 Sim.7; In re Willis 1921 1 Ch. 44 : Halsbury 2nd Edit. vol. 4, p. 192. The settlement contains one trust and one trust only and that is a charitable trust 10 which took effect immediately upon the Settlor handing the initial sum of money to the trustees of the settlement.

> The second question of construction relates to the proper meaning of Clause 24 of the settlement. The preceding Clause 23 authorises the trustees to apply so much of the income of the trust fund as they think fit for the purposes of the trust and capitalise the balance, and the succeeding clause 25 authorises the trustees to retain unrealised so long as they might think fit any of the properties or securities then assigned to them or which might thereafter be vested in them by gift, bequest, or devise, and to realise any of them which they might think fit and from time to time to invest any 20 moneys forming part of the trust funds available for investment in a wide range of investments. Clause 24 in the first limb authorises the trustees to apply and appropriate any property for any trust purposes and to use any moneys of the trust in purchasing any land or buildings or in erecting buildings or in altering or improving buildings to be used for the purposes of the trust. It then proceeds in the second limb to authorise the trustees during the life of the Settlor or afterwards to apply and appropriate any property including moneys belonging to the trust for the purposes of acquiring by purchase or exchange from the Settlor or his executors any real or personal property valued for the purposes of such purchase or 30 exchange at a sum at least five per cent. below the valuation of such real or personal property so acquired as ascertained by some independent valuator appointed by the trustees other than the Settlor. It provides that the trustees shall during the lifetime of the Settlor if he so directs apply and appropriate any property including moneys belonging to the trust in this manner. It is a rule of equity that a trustee must not place himself in a position where his interest and duty may conflict. He cannot therefore in the absence of a special dispensation in the trust instrument either sell his own property to the trust estate or purchase any property from the trust estate. The purpose of the second limb is to provide such a 40dispensation. It authorises the trustees to apply and appropriate trust funds for the purpose of acquiring by purchase or exchange any real or personal property of the Settlor in the manner therein mentioned. The valuations provided for are only valuations of the real and personal property of the Settlor. There is no express provision for valuing the trust assets. The second limb should not be read as meaning that the Settlor may direct the trustees to exchange some particular item of trust property

for some particular property of his own. The words "or exchange" In the High are only intended to authorize the trustees to acquire the real and Court of personal property of the Settlor not only by the purchase but Australia. also by the exchange of some of the trust property for some property of the Settlor. The second limb provides the necessary machinery Joint to enable the trustees of the settlement to acquire property from one of Reasons, themselves. It also enables the Settlor as one of the trustees to require the ^{18th} other trustees to make such an acquisition. But it does not enable the August, Settlor to require the other trustees to apply any particular part of the trust

10 property for this purpose, and it does not enable the Settlor to require the trustees to acquire his property by exchange and not by purchase. The discretion as to what part of the trust property shall be used to acquire the Settlor's property and as to whether the acquisition shall be for cash or by way of exchange is a matter for the trustees of the settlement as a whole and if there is a difference of opinion for the majority of those trustees. The words "pay and appropriate any property including moneys belonging " to the trust" are intended to remove any doubt that the authority of the trustees to use the trust funds for this purpose extends to the whole trust estate and not to any particular part of it. It would require very clear words 20 to empower the Settlor to compel the trustees to use some particular portion of the trust funds to acquire his property and in particular to exchange some trust asset selected by himself for an asset of his own.

The contrary view which was accepted by the Supreme Court would be that the clause authorised the Settlor at any time during his life to direct the trustees of the settlement to exchange any asset of the trust for an asset of his own. On this view the Settlor had a sort of floating right of selection exercisable against the assets of the trust which would crystallize against any particular asset upon its exercise. But if this was intended the settlement would have provided for an independent valuation

- 30 of the trust asset. Further the trust assets from time to time would presumably consist of moneys in the bank and tangible real and personal property. Clause 24 authorises the trustees to purchase land and buildings to be used or applied for the purposes of the trust, so that the tangible property might comprise a school and it could hardly have been intended that the Settlor should have the power to direct the trustees to exchange the school buildings and shut down the school for some shares which he desired to transfer to the trust. It was suggested during the argument that the clause might have been inserted to enable the Settlor to require a transfer of some or all the shares in Gillespie Bros. Ltd. if he desired to increase his
- 40 voting power in that company. But the Settlor could achieve this object by registering himself as the first joint holder of the trust shares. As a trustee he would have to exercise his vote for the benefit of the trust, but there is no reason to believe that the interests of the trust and his own personal interests would not coincide. The material words of Clause 24 of the settlement are not apt to create a covenant between the Settlor and himself and the other trustees which by virtue of Section 72 of the Conveyancing Act 1919 (N.S.W.) would be construed and capable of being

No. 6. Joint Reasons, 18th August, 1949 continued. enforced in like manner as though the covenant had been made between the Settlor and the other trustees. No particular form of words is necessary to create a covenant but the words must be sufficient to establish an agreement to do a thing: Norton on Deeds 2nd Edit. p. 532. The power to direct the other trustees conferred on the Settlor by Clause 24 is at most a power as a trustee to control the exercise of the discretion by the trustees as a body and it is a fiduciary power which must be exercised in the interests of the trust property. If the other trustees refuse to accede to his direction, the only remedy of the Settlor would be to sue them for breach of trust joining the Attorney General as a party to represent the charities. 10 He could not sue the other trustees for specific performance of a contract to exchange an asset of his own for an asset of the trust.

It will now be convenient to consider the relevant provisions of the Stamp Duties Act. There is first section 102(2) (a) which includes in the notional estate all property which the deceased has disposed of by way of settlement containing any trust in respect of that property to take effect after his death. In Rabett v. Commissioner of Stamp Duties 1929 A.C. 444 at p. 448, Lord Buckmaster, delivering the judgment of the Privy Council, included in the trusts that took effect after the death of the Settlor in that case a trust enabling his widow alone to sell and vary investments. But 20 it would appear that this machinery trust was included among such trusts per incuriam. It is at least clear that the paragraph does not refer to powers but to trusts. It is dealing with dispositions, that is with beneficial interests created in property, and therefore to the beneficial trusts and not to the administrative trusts and powers of a trust instrument. Even if the paragraph does include administrative trusts, there are in the settlement no administrative trusts but only powers. The settlement contains only the one trust, namely the charitable trust for educational purposes, the relief of poverty in Australia and the general benefit of the community in Australia not falling under these heads. This trust took effect in the life-30 time of the Settlor and did not in any sense take effect after and by reference to his death. Accordingly, as Owen J. held, the Respondent's claim so far as it is based on sec. 102(2) (a) of the Act, fails.

The next section is sec. 102(2) (c). This section provides that there shall be included in the dutiable estate of the deceased any property passing under any settlement, trust or other disposition of property made by the deceased (i) by which an interest in or benefit out of or connected with that property, or in the proceeds of the sale thereof, is reserved either expressly or by implication to the deceased for his life or for the life of any other person, or for any period determined by reference to the death of the **40** deceased or of any other person; or (ii) which is accompanied by the reservation or assurance of, or a contract for, any benefit to the deceased for the term of his life or of the life of any other person, or for any period determined by reference to the death of the deceased or of any other person; or (iii) by which the deceased has reserved to himself the right, by the exercise of any power, to restore to himself or to reclaim that property or the proceeds of the sale thereof. The first question that arises under the section relates

to the meaning of "any property passing under any settlement" or in In the High other words to the meaning of the words "that property" in the section. Court of It was contended for the Appellants that the property in question was the Australia. sums of money which were originally handed to the trustees of the settlement by the Settlor to be held on the trusts of the settlement and the Joint further sums of money which were subsequently handed to the trustees by Reasons, the Settlor to augment the trust funds. It was contended that paras. (i), 18th (ii) and (iii) could have no operation in respect of these sums of money and August, . the section was therefore inapplicable. On this point counsel for the 1949-

- 10 Appellants relied particularly on the judgment of Isaacs J. in Dent v. Commissioner of Stamp Duties, 9 C.L.R. 406. There the question arose as to the meaning of property passing under a voluntary settlement for the purposes of sec. 49(2) (e) of the Stamp Duties Act 1898 (N.S.W.). Isaacs J. was of opinion that the property did not include the natural increase in the stock on a station between the date of the settlement and the death of the Settlor. But no such question arises here. The only question is whether the words "that property" refer to the identical property originally settled or to the trust funds as they existed from time to time, and on that point there was no difference of opinion between Isaacs J. and the other 20 members of the Court. Griffith C.J. said at p. 416 that the property passing
- under the settlement means "all property the title to which is immediately "derived from the deed." Isaacs J. said at p. 422 that the property in question "must be the property which passed so far as it exists, and in whatever form it exists . . . I assume the words are sufficient to comprise the property assigned, into whatever shape it may have been transmuted. so long as it remains substantially the representative of the property actually transferred." There are remarks of His Honour to the same effect in Watts Case, 38 C.L.R. 12 at p. 35. The learned author of Green on Death Duties 2nd Edit. p. 86 says, in reference to the corresponding English
- 30 legislation, that the property passing under a settlement does not connote a passing on death but "broadly speaking, it means merely property "comprised in the settlement or subject to the trust." The remarks of Dixon J. in Vicars v. Commissioner of Stamp Duties 71 C.L.R. 309 at pp. 340 to 343, are to the same effect. The purpose of the Stamp Duties Act is to include in the notional estate of a Settlor for the purposes of death duty property which can be identified and valued at the date of death, and the words "that property" in the section mean the trust fund as it exists from time to time.

The power of discretion conferred on the Settlor is conferred for his 40 life so that the first question is whether this power is within the meaning of para. (i) an interest in or benefit out of or connected with the trust funds or in the proceeds of sale thereof. These are wide words, but they are not wide enough to apply to the right conferred on the Settlor by Clause 24 of the settlement. This right was at most a right to have his real or personal property purchased with trust moneys or exchanged for trust property on terms advantageous to the trust and only when the Settlor

In the High in the exercise of a fiduciary power thought it proper to direct the trustees to acquire his property on these terms. This is not an interest in or benefit out of or connected with the settled funds within the meaning of the paragraph. It is simply a power to alter the investment of the trust funds for the benefit of the trust. The power does not confer on the Settlor any beneficial interest in or the right to receive any payment out of or connected with the income or corpus of the trust as it exists from time to time. To fall within the paragraph such an interest in or benefit out of or connected with the trust fund must confer on the Settlor some legal or equitable right to obtain some benefit in money or moneys worth for his own advantage 10 out of or connected with the trust property. In A.G. v. Farrell 1931 1 K.B. 81, the Court of Appeal held, following A.G. v. Heywood 19 Q.B.D. 326, that the Settlor had an interest in the property passing under the settlement where he was one of the objects of a discretionary trust during his life. The judgments in A.G. v. Heywood and A.G. v. Farrell support the view that the kind of interest or benefit to which the section is intended to apply is an advantage of this kind. The interest or benefit must be such that the beneficiaries under the settlement would derive an advantage from the death of the Settlor or some other person. Further, since Clause 24 of the settlement does not create a covenant, it could not be said 20 that the disposition of property made by the Settlor was accompanied by the reservation or assurance of, or a contract for, any benefit to the Settlor for the term of his life within the meaning of para. (ii). There remains para. (iii). The words "restore to himself" and "reclaim" in this paragraph indicate that it is intended to apply to cases where the Settlor has the power to diminish the value of the trust property by freeing it or some part of it from the trusts and appropriating it to his own use without consideration or adequate consideration in money or moneys worth, and it would not therefore apply to an alteration in the investment of the trust assets from which the settlement and not the Settlor derived the 30 advantage. Accordingly the Respondent's claim, so far as it is based upon sec. 102(2) (c), also fails.

> The final section of the Act is sec. 102(2) (d). This section provides that there shall be included in the dutiable estate of the deceased "any property comprised in any gift made by the deceased at any time, " whether before or after the passing of this Act, of which bona fide possession "and enjoyment has not been assumed by the donee immediately upon "the gift and thenceforth retained to the entire exclusion of the deceased, " or of any benefit to him of whatsoever kind or in any way whatsoever " whether enforceable at law or in equity or not and whenever the deceased 40died." In Commissioner of Stamp Duties N.S.W. v. Perpetual Trustee Co. 1943 A.C. 425, where the Settlor had appointed himself one of the trustees, Lord Russell of Killowen, delivering the judgment of the Privy Council, said at p. 440 that "the trustees alone were not the donee. They were "in no sense the object of the Settlor's bounty. . . . The linking of " possession and enjoyment as a composite object which has to be assumed " by the donee indicates that the possession and enjoyment contemplated

In the present case the beneficial possession and enjoyment Court of of the donor's bounty was immediately and indefeasibly vested in the Australia. objects of the charitable trust. The income and corpus of the trust property could be applied for the benefit of those objects and for no other purposes. Joint The Settlor as donor was therefore entirely excluded ab initio from Reasons, possession and enjoyment of the settled property and had no enjoyment 18th and possession such as is contemplated by the section. Further it follows August, from what has already been said that the Settlor was excluded from any $\frac{1949}{continued}$.

10 benefit of whatsoever kind or in any way whatsoever whether enforceable at law or in equity because the benefit from the exercise of the power contained in Clause 24 was a benefit to the settlement and not to the Settlor. Accordingly the Respondent's claim, so far as it is based upon sec. 102(2) (d) also fails.

The appeal should be allowed with costs. The order of the Supreme Court should be set aside and in lieu thereof an order made answering the first question in the negative, the second question "£74,915 4s. 4d.," and the third question "by the Commissioner of Stamp Duties." There should be an order that the sum of £26,049 5s. 8d. and the sum paid in as security for

20 costs be repayed by the Respondent to the Appellant. The Respondent should pay the costs of the proceedings in the Supreme Court.
