

## EVIDENCE of RANTHENE MOLALA

P.W.7. RANTHENE MOLALA: (who is duly sworn by Interpreter):

EXAMINED BY MR. THOMPSON:

Ranthene do you remember the winter two years ago? Yes.

Where were you living at that time? At the time I lived at Mpunyetsane's.

Did you point out that village to Captain Shortt-Smith? Yes.

Do you remember a man Tieho Matsora? Yes. Were you related to him at all? Yes. What was the relationship? He was my

maternal uncle.

What happened to him? The deceased came to my place on Monday.

This man Tieho is he still alive? He is now dead.

Do you know how he came by his death? Yes. I want you to start from the beginning. Tell My Lord about the first person who spoke to you or the first person you knew about the events which led up to his death? This man Tieho came to my place on Monday, he was in the company of a young man called Motsoenkana.

The events you are just about to talk about did they take place on the day the deceased died? Yes.

Had you had any discussion with or had you spoken to anybody prior to that in connection with something that led up to the death of the deceased? I was working up to that point, I was going to explain.

I will let you tell your story in your own way but I prefer you to start at the beginning instead of going back from the middle but go on and explain the way you want to? One of the days which was a Saturday in the week before the deceased met his death a man came to me who was No. 4. accused. He said: "Look here Ranthene I've paid you a visit". He found me at my own house, I was not inside the house but outside. He asked if I would be good enough to go with him a little distance away from my house because he wanted to say something to me. I went with him and we stood aside and he then told me he had been sent to me. He said that he was sent to me by No. 1 accused but through No.5 accused. He said that I should listen carefully to what he was going to tell me. He said I should pay due respect to what he was going to tell me. He said that this was a matter which I should keep in my bosom and not disclose it to anybody else. No. 4 accused said that No. 5 accused trusted him very much. He said he also trusts me. He said that No. 5 accused had given instructions by No.1 accused that we should catch Tieho for him. He said that however, this was not the day for giving

out plans and that if we wanted to make sure we should go to No. 1 accused who would explain the thing. He said that if I said anything about the plan and told it to somebody else I would be killed myself because it would be known that it was I who had given out the secret. He said I should go to his place late on Monday because the matter would then be properly arranged.

You were to go to No. 4 accused's place? Yes. Anything else, did you agree? Yes, I agreed. And was that all of that conversation? Yes, that was all the conversation on that occasion.

What happened on the Saturday? Monday came. Before you go on is this the same Monday the deceased met his death or a different Monday? This was the Monday on which the deceased met his death.

What happened on that Monday? On the Monday deceased came to my place.

Just a moment please Ranthene. On the Saturday you say No. 4 accused had asked you to go and visit him on the Monday? Yes.

Did you or did you not comply with that request? Yes, I complied with that request.

Then you did go to No. 4 accused's home on the Monday? Yes.

Please tell My Lord what happened when you went to No. 4 accused's home, who spoke, who you saw and all about it? On that Monday as I went close to No. 4 accused's place I noticed that people had not yet arrived as had been previously arranged. I had a rest there and as time went on I saw some people arriving at his home. I then went down and reached his home; when I arrived at No. 4 accused's I found No. 1 accused and also No.5 accused. No. 2 accused, Nos. 4, 7, 3 accused then No. 4 accused said to No. 1 accused, "Chief the young men that I have been talking to you about have also arrived".

HIS LORDSHIP: Just a moment. Stand up accused Nos. 1, 2, 3, 4, 5 and 7. Those are the ones you saw are they? Yes. Then No. 4 accused said to No. 1 accused this is

the young man? Yes.

MR. THOMPSON: Yes? - Then No. 1 accused said it is all right if the young men have arrived. No. 1 accused then said to No. 4 accused: "I hope you have told them everything because if you have not told them they would not have come. Since thev have already had information from you No. 4 accused there is something short which I am going to speak to them about! 'No. 1 then said that the person he required was Tieho and that we should go for him. "I want you to catch him for me so that I can kill him to enable me to fill my medicine horn with the flesh". He said that after the plot had been carried out he would give us some reward. He further said that if anybody disobeyed the order and told other people who did not know anything about it, that person would be killed. That was all he said except that he said we should wait because others had not yet arrived and when they arrived everything would be arranged when all were there. Shortly afterwards other young men arrived.

Who were they? A young man arrived namely Rabolai. No. 6 accused.

Stand up No. 6 accused, is that the man? Yes.
Anybody else? If I haven't forgotten any
other person whom I may have left out I think that
is all that I saw of these people on that occasion.

Have you mentioned everybody who was there or do you mean there were others there whose names you don't remember now? I think I have given all the names however, as this thing happened some days ago I cannot say whether I have left out names of others who were present on that occasion.

Was there any more talking after other persons joined the party? He said: "It is all right young men that you have come together but you already know what orders I have issued".

This is No. 1 accused still speaking is it?
Yes. He said: "I have issued orders through Nos.
4 and 5 accused, and they will be responsible for making this matter known to the young men". He said the time was getting short and it would be a good thing to hurry the matter because people would

No.2 Ranthene Molala examination suspect what the meeting was about because there was not even beer to drink at that place. He said that we should listen carefully if we were given an order. "The person I am talking about saying I want him I shall make plans about him so that he can go away for some distance, where you will be able to catch hold of him when I give you the order to do so". He said the person who would be responsible for the carrying out of this plan would be No. 5 accused who would be assisted by No. 4 accused, and they would see to it that the plan was carried out according to instructions. Then No. 1 gave instructions that we should disperse and go to our homes. We then dispersed.

At the time you dispersed had you any idea when the plot was to be carried out? Yes, I had known when the plot would be carried out.

When was that? He said that the plot would be carried out on the Monday and that the people responsible for the arrangements would be accused Nos. 4 and 5.

This meeting took place on a Monday didn't it? Yes.

Was the plot to be carried out that same Monday, or the next Monday or two Monday's afterwards or which Monday? The plot was to be carried out on the following Monday.

Did anything happen between that Monday and the following Monday that has something to do with this case? Nothing happened except the orders.

I am coming now to the following Monday. What happened on the following Monday? On the Monday which was the last one No. 4 accused came to me and said: "Young man, it is true that No. 1 accused has made plans that the person about whom you are talking should go away and he has sent him out towards Mapoteng".

Where was this? I was at my own house. We were not actually in the house but standing outside.

You had been told the deceased had been sent to Mapoteng, is that correct? Yes, he said we should keep watch because the deceased might come on his return by the path a little higher up or by 10

the path a little lower down. We waited there and In the High whilst waiting the deceased came in the company of Motsoenkana.

Who do you mean by "we" when you say "we waited there"? After No.4 accused told me about this he went away and I waited there alone. I should have said I waited there not "we".

You waited alone? Yes.

And was nobody else present when No. 4 accused spoke these things to you? No one else was present.

What time of the day did this conversation take place, midday or in the afternoon? It was in the forenoon a little time before midday.

You say you personally alone remained there? Yes. What happened? Later in the afternoon the young man Motsoenkana came with the deceased.

From what direction? They came from the direction of Monyane's in the valley.

Monyane's is right across the valley is it? Yes, they were walking from Monyane's towards me.

And what happened? They were coming in the direction of my home and they eventually reached my home. As they arrived at my place I greeted them with pleasure and was very glad to meet them because there was an order given. I took them into my hut. When they actually arrived at my home it was in the evening.

Had the sun already set or not? towards sunset.

You invited these two people into your house? Yes. I gave them chairs on which they seated themselves and then I gave them some beer which they drank. They went on drinking until it became dark.

Were there just the three of you in the hut, yourself, the deceased and Motsoenkana? I believe that No. 4 accused came when the other two were already in the hut.

You say you believe that, do you mean you know it or think it or what do you mean? I remember that No. 4 accused arrived after the three of us were in the hut. No. 4 accused joined the three of you in the hut? Yes.

You told me the drinking continued until dusk?

Yes.

And then? No. 4 accused went outside and called Motsoenkana to him, he said he wanted to speak to him, and Motsoenkana left the hut and went to No. 4 accused. No. 4 accused asked Motsoenkana where the man was and Motsoenkana in reply said "Here he is, I have been coming with him". No. 4 accused said it was a good thing that he had already brought the man whom they were looking for. He said we should remain in the hut until it became dark.

No. 4 accused said that? Yes.

Who was to remain in the hut? That was Motsoenkana, Ranthene, the deceased and myself,

Those were the instructions of No. 4 accused? Yes. He said that as it became dark Motsoenkana should take the deceased with him so that he could meet them at Ntsang's.

Is that the name of a village? Yes. The time which he spoke about came.

20

What happened to No. 4 accused? Immediately after giving this order that deceased should be taken by Motsoenkana he went away to his own village.

Did he go away alone or in company with other people? He went away alone.

Leaving you three people at your own home? Yes and when the time came Motsoenkana and deceased left the hut, it was then already dusk.

They left leaving you behind them? Yes, immediately after they had left the hut I also left the hut and followed.

You followed the two men who had just left? Yes, I was a little distance behind them so that they could not see that I was following.

In which direction were you going? We were going in the direction of Ntsang's village. Then we went on until we approached Ntsang's village; as they neared Ntsang's village I took a short cut route and proceeded to No. 4 Accused's house.

No. 4 accused's house being in Ntsang's village? It is close to Ntsang's village.
You took a short cut to Ntsang's village. Go

on? As I approached No. 4 accused's house I saw people. I did not therefore go to the house of No. 4 accused but approached these people to find out whether they were the same people who had been detailed to do this work. As I came to them I found this party was that of the people who had been given the orders including No. 1 accused.

Was there anybody else besides No. 1 accused whom you remember? Nos. 8, 3 and 2 accused. I could see that there were some people a little below but while we were there we were hiding ourselves in order that we should way-lay the deceased.

Did anybody speak when you joined that group? I cannot remember. I do not know whether I may have just forgatten.

So you joined the group and that made five of you with some other persons some distance away? Yes.

Then what happened? The whole group was sitting down but were not sitting in a group, we were sitting separately and hiding. Shortly afterwards I saw people coming alone. There were some who were in line but there was a larger group following those who were in front and the first person who I recognised was No. 4 accused.

And the next person you recognised? The group that were following No. 4 accused caught up with him and they spoke to him. Others were walking a little slower and No. 4 accused walked towards us and found where we were. When he came No. 4 accused told No. 1 accused and us all that the young men were bringing the deceased with them. He said that we should get ready.

No. 1 accused or No. 4 accused said this?
No. 4 accused said that we should get ready. No. 1 accused also spoke after No. 4 accused and said we should get ready for this man. We then kept watch and did not reply. The group came up and when they came into the defile, just a little before they crossed the defile he spoke and said "Why are you waiting, take hold of him".

Who spoke? That was No. 1 accused. We rushed at him, all of us rushed at him. As we rushed at him the deceased Tieho tried to defend himself as it appeared that in defending himself deceased would be dangerous No. 5 accused said "This man will beat you", then he tied him with a riem round the neck.

Did the deceased say anything while all this was going on. The attack and the ultimate putting of the riem round his neck? The deceased spoke at the time that he was being attacked.

Did he speak words that could be understood? Yes, he spoke something which we understood,

What did he say? He cried out and said "Jooe, why are these people cruelly killing me".

Jace is a Sesuto expression of distress isn't it? - Yes.

No. 5 accused put the riem round his neck? Yes. he did so from behind the deceased.

And then? At the time the deceased could not have seen No. 5 accused because he was facing those who were attacking him. This is what caused the deceased to weaken, and at that time No. 2 accused hit the deceased on the head.

What with? He struck him with a battle-axe on the head.

How many times? Twice.

Can you describe that battle axe? Yes. What did it look like? It is a battle axe whose handle is not very long.

What about the blade? It was shaped like a sharp axe and has got a spike on the other hand.

Anything like this axe exhibit No.11 which I am now going to show you? Yes, it was an axe similar to the one before the Court.

Did you observe which portion of the axe came into contact with the deceased's head? I could not say what part of the axe struck the deceased.

What happened to the deceased after he had been struck these two blows on the head? The deceased fell to the ground, as he fell to the ground we were ordered to take off our blankets and

take away the clothing from the deceased.

Was that order obeyed? Yes, this order was obeyed and it was given by No. 1 accused.

Right. You removed your own blankets and unclothed the deceased, then what happened? After putting away our blankets I held one arm of the deceased.

Was anybody else holding the deceased? No. 8 accused held the other arm.

Was anybody else holding him? Others held the deceased by the legs,

Do you remember who they were? I cannot be definite about names but many of us were holding the deceased and we were ordered to do the work hurriedly in order that we would not be found by other people.

Are you definite about No. 1 accused giving the orders and No. 5 accused putting the riem round and No. 2 occused striking with the axe? Yes. I am quite certain.

You were holding one arm and others were also holding, then what happened? Then No. 1 accused gave an order to No. 2 accused that he should cut the deceased at the testicles with an axe. No. 2 accused obeyed the order and chopped the deceased. I saw him striking at the deceased and I believed it was with the battle axe.

Are you not certain about that? I am certain about that.

Did you observe which portion of the battleaxe came into contact with the portion near the deceased's testicles? I noticed that it was something which pierced the deceased.

What happened then? Then No. 1 accused came holding a billy can. and he collected the blood in the billy can which was brought to him.

Where was the blood coming from? The blood was coming from below the deceased.

Which portion of the body? Just below the testicles.

Was there any blood so far as you could observe coming from the two wounds on the head? There was.

No.2 Ranthene Molala examination Did anything particular happen to the blood from the head wounds? As the blood flowed from the wounds it was wiped off.

The blood was collected from the testicle wound then? Yes.

And after that what happened? What happened after that was that No. 1 accused gave an order that we should put on our clothes. Which we did.

You resumed your blankets and then? We put on our blankets although others did not put on theirs which were taken by No. 3 accused. No. 1 accused then ordered that we should take the deceased to No. 4 accused's place.

No. 1 accused you told us was there and his orders were carried out. No. 2 accused struck the blows? Yes.

No. 3 accused stand up please. You say No. 3 accused was in charge of some blankets, are you quite sure he was there? Yes.

Did you see him taking any other part apart from looking after the blankets? Yes.

What did he do besides hold the blankets? At one stage immediately after the deceased was caught No. 3 accused tried to run away.

Was he stopped from running away? Yes, he was stopped from running away because it was feared he would make a report.

Do you know who stopped him? I am not certain about that because there was confusion.

So, as far as No. 3 accused is concerned, he held blankets and he tried to run away is that all he did? Someone said there is a man running away.

You have told us about that. Stand up No. 4 accused please. This man No. 4 accused you have told us that he was there immediately before the deceased was seized. Can you say whether or not No. 4 accused was present there at the killing? Yes, he was there all the time.

Did he take any active part in the killing? Yes, he took part because he was with us there and an order was given that we should all take part in the killing.

You can't mention any specific thing that he

did, either holding or stabbing or anything like that? No. I didn't notice.

Stand up No. 5 accused. Was he present or was he not present at the killing? He was present at the killing.

What part did he play? He strangled the deceased with a riem.

No. 6 accused stand up. Was he present or not? He was present.

What part did he play if any? I did not see him striking any blows but he was there when the orders were given.

Do you know anything about No. 7 accused? He was present at the killing.

Did he play any particular part? I didn't see him do anything that would kill the deceased but he was there to help us.

No. 8 accused? He was at the killing.
Did he play any part? He did take part in
the killing but I did not see him use anything
that I can say killed the deceased.

Now when No. I accused gave instructions that the body of the deceased should be carried away, was it carried away? Yes, it was carried away.

What was used to carry the body? An ox skin was used which came from No. 4 accused.

No. 4 accused produced an ox skin and that was used. The body was placed on the skin is that right? Yes.

Do you remember who carried the skin? Although all of us were there with the exception of a few who remained behind, I can remember who carried.

Did you carry yourself? Yes I carried. Who else? Accused Nos. 4, 2, 7, 8 Motsoenkana, Ramatsepe and accused No. 6. I think that is about all.

Where did you carry the body to? We carried the body to No. 4 accused's house.

And the remaining people who were not carrying, what happened to them? The persons that I saw staying behind were No. 1 accused.

No need to go through the names again. You

No.2 Ranthene Molala examination mentioned the carrying party and the remainder of people stayed behind. You carried the body to No. 4 accused's hut, what happened when you got to No. 4 accused's hut? An order had been given by No. 1 accused before we started carrying the body to the effect that after we had placed the body in the hut we should all return to him.

Did you place the body in the hut? Yes, we

placed the body in the hut.

Whereabouts in the hut? In the square hut belonging to No. 4 accused.

But whereabouts on the chair, or bed or where? As we approached the hut No. 4 accused went ahead of us, entered the hut and lit up.

Whereabouts in the hut was the body placed?

We placed the body under the bed.

And after placing the body what did you carrying party do? We obeyed the order which was given by No. 1 accused and returned to him at the path.

What happened when you got back to the path? Then No. 1 accused took out a medicine.

Where did the medicine come from? The nedicine was contained in a billy can and there was also the brush from the tail of an ox.

Do you know what happened to the billy can in which the blood had been collected? No.

Was it the same billy can with the medicine or not? No, it was not the same billy can, it was different.

What was done with the brush from the tail of an ox? The brush was put into the billy can and then sprinkled the medicine on us.

All of you? Yes.

And then? After sprinkling the medicine on us he addressed us and said "All you young men who have come here obeying my order, you have carried out my order. I am now going to make arrangements, after everything has been finished with regard to killing this man, to reward you. I will give you a very big reward. Now I give you instructions that you should be here again, all of you, on Thursday".

Where were you to go on Thursday? He said we should meet at No. 4 accused's place. Then we dispersed.

What happened on the Thursday? The Thursday came, he had explained that on that Thursday the body would be thrown away.

Was that No. 1 accused? Yes, No. 1 accused. What did you do on the Thursday? On that Thursday I left my home and as I approached Sabilone's village it was dark then and I heard the footsteps of people who were walking some distance away. It appeared to me that they were the people who I was to join and had already left, being late. I followed this group. I walked very fast and caught up with them.

Who were in the group? The group consisted of accused Nos. 1, 5, 2, 3, 7, 8, 6, myself and No. 4 accused. That was all.

When you joined the group what happened? Someone asked "Is it you" and I said "Yes". I joined the group in carrying the body which was on an ox skin.

Was the group already carrying the body? Yes. Who was in the carrying party? All the persons whose names I have mentioned were carrying the body on the ox skin.

Where was it taken to? We went through Mosenekeng defile, until we came up on top of the

What was the name of that cliff, do you remember? - Mojapela.

And when you got to the top of Mojapela's cliff what happened? When we got to the top No. 1 accused said we should place the body on the ground. He said that many people should not be ordered to go to the bottom of the cliff but only a few selected people should go. Then No. 5 accused, Nos. 2, 8 and No. 3 went down and all the others remained at the top.

Did those who went down ultimately return? All those went down in the company of No. 1 accused.

Saying? "Now men we have done the work, but I have not arranged everything to complete this work. I am intending to complete the work". He said that as soon as he had finished the work we would know through either accused No. 4 or No. 5. He said particularly those who were living in far off villages. "I am going to give you a very

villages. "I am going to give you a very substantial reward, if any or you report this matter or speak about it to his wife, you will be killed".

Anything else? He said that it was a pity that some of the people he had required had not attended but he would let us know everything when everything was completed. He said "Let us now disperse".

And did you disperse? We then went back through the Mosenekeng's defile back to No. 4 accused's place carrying the ox skin.

And when you got to No. 4 accused's? However we did not reach No. 4 accused's house but as we approached he took his ox skin and we went our own way to our homes.

Now you have told My Lord what you know about the death of Tieho? Yes.

One last thing I want to know from you. Is No. 1 accused related to you? Yes.

What relationship? He is my maternal uncle.

Does he hold any position of authority in his area? Yes, he holds some position of authority, although it is not an important position.

What is it? He is the head of a village.
No. 2 accused. is he related to you? Yes.
What? He is my cousin.
Does he hold any position of authority? No.

No. 3 accused, is he related to you? Yes. What relationship? He is also a cousin. Any position of authority? No.

Did you point those places out correctly to the best of your knowledge ? - Yes, I claim that I pointed them out correctly.

I am rather interested in the deceased's dog. Do you remember on the Monday when he met his death deceased had his dog with him when he came along to your place on Monday afternoon? - I did not see the dog when he came to my village on that occasion.

Some witnesses will say that deceased's dog was seen hanging around No.4 accused's village after the deceased had been killed, do you know anything about that? - I only heard the dog barking at the time when the deceased was seized.

You heard dogs barking at that time ? Yes.

CROSS-RXANINED BY MR. LIEBETRAU: Cross-

How long have you known No.1 accused (HABOFANOL)

It is quite a long time.

Can you tell me the number of years? - No I cannot say exactly how many years it was.

Where did you first meet him? - I first met

him at the school at Sekhoeng.

And that was a short while before the death of Tieho? - I cannot quite remember because there was nothing significant about that but as far as I can remember he was a person who salled me to him and asked me if I knew him when we were at the school at Sekhoeng.

At any rate you have not known him since childhood? - No:

Can you explain to the Court how you only met your maternal uncle at such a late stage in your life, that you haven't known him since youth? - No, I cannot explain because I do not know the circumstances why it occurred.

The first time you learnt about this plot to kill Tieho was on a Saturday? - Yes, that was the first time that I was consulted about it.

You told us that this took place at your house I think ? - Yes.

Can you tell us what time of day it was? -I cannot be quite certain as to what time it was,

in any case it was during the day. I had no watch with me but in any case I cannot read a watch.

Can you say if it was before or after lunch? You mean the Saturday?

Yes? - I think it could have been before lunch but some time just before lunch.

Did No.4 accused find you in your house? - Yes, I was in my house when he arrived. He greeted me and I went out of the house.

Were you alone in the house? - No, I was with my children.

But he greeted you and then you went outside? Yes.

Would you be good enough, you have already told us but I would like you to repeat the persons you found in the square hut when you arrived? — I found there accused Nos. 1,5,2,7,4,3 and 8. The others had not yet arrived.

Let us talk about No.8 accused for a moment. When you gave your evidence in chief earlier this

So now you say that when you arrived at No.4 accused's place you found five people in the hut? - Yes.

You've told us that everybody had not yet arrived when you came? - Yes.

Will you tell us whether anybody did arrive after you? - Yes, accused No.6 arrived, that is the only person.

He is the only person who came after you? Yes, the only one.

So now we are quite certain therefore that Nos. 3 and 8 accused never attended that meeting on the Monday? - That is possible because we did now all come at the same time, those who had been invited.

Your house is not very far from his? - It is some distance away from his but not far. We are under the same Chief. Are you a frequent visitor at No.4 accused's 20 place? - No, I have visited his home but not frequently. Do you know that the house he occupied belonged to his grand-mother Paulina? - Yes, I know that is his parents! home. Paulina also lives in one of the houses in that little group? -Yes. On this Monday did you see Paulina? No, I did not. Did you see the wife of No.4 accused? -No. 30 You have told us that the date for the killing was fixed for the following Monday? - Yes. Was that date fixed in the meeting in No.4 accused s house? - Yes. Who fixed the date? - No.1 accused. What exactly did he say? - He said that he had made arrangements. Did he say it would happen on the following Monday ?- Yes, he explained that Was that after the arrival of No.6.

Accused? - He had previously said that to me

after I had arrived and also after No.6 accused had arrived.

I have been reading the evidence which you gave at the Preparatory Examination in regard to this meeting at No.4 accused s house. And in that evidence I can't find any reference whatsoever to the presence of No. 5. accused at that meeting? - I cannot say whether any reference was made to No. 6. accused but the day we arranged to meet there it was arranged that all of us should be there although some may not have come at the same time and may have come later on.

In any case you are sure now that No.o accused was present at this meeting? - Yes.

Are you certain that this meeting ever took place? - I am quite certain that this meeting took place at No.4 accused's place.

I put it to you that if such a meeting ever took place, No.1 accused was not present at it; that he was somewhere on the road between Teyateyaneng and Mapoteng? - No, we were together.

I put it to you the other names you have mentioned, they were all at their homes or busy in their lands? - According to my own knowledge I was with them.

I want you to carry on to the Monday on which Tieho was killed. On that Monday you had quite a party at your place? ~ Yes.

You did have a party ?- Yes, I had a party but it was not a feast.

Was that at your house? - Yes. Did you have any visitors ?- No.

Did you have a visitor, a man by the name of Mahlomola, (witness No.16 at the Preparatory My Lord). Do you know Mahlomola?— Yes I know a man called Mahlomola.

Mahlomola Masetla ?- Yes,

Was Mahlomola at your house on that Monday?-

Was Mahlomola there all day or only for part of the day? - Not the whole day, he was only there for part of the day.

Having delivered the body you all returned to the Red Path? Yes.

And there you were doctored? - Yes.

Was Motscenkana present amongst those people who were being doctored? Yes he was.

Was Motsoenkana present when that order was given?- Yes he was.

On the Thursday night did you in fact come back?- Yes.

Can you remember what the weather was like on that Monday when Tieho was killed. There are Crown witnesses who said at the Preparatory that it was snowing, I just want to know if you will confirm that (Mohapi, P.W. 12 spoke about snowing My Lord, there are several but he is one of them). What was the weather like on the day of the killing? — That is correct, there was rain on that night.

Do you still adhere to that? - Yes. MR. THOMPSON

Can you tell me on this day of the killing, at what stage you noticed the deceased was dead?—
The deceased died after he was struck on the head.

Do you mean to tell me that up to the time you left the body at the top, the body was still unclothed? - No, it was already reclothed.

Now Ramatsepe, two winters ago, where did you live? I lived in the village of Ntsang.

Are you related to any of the accused, Look at them. No.1 accused is he any relation of yours?No, I am not related to him.

No.2 accused? - According to our clan we are somewhat related.

Are any of them closely related to you? No.

Do you remember a man whoused to live not
far away from you by the name of Tieho Matsora? I did not know him during his lifetime.

You know that he is dead though? Yes. Do you know how he came by his death? Yes.

I want to start right at the beginning, from the first time you heard anything about his death, and tell My Lord what happened?— The beginning of the whole matter is that on one occasion I saw No.4 accused rounding up his sheep near my village.

Do you know the months of the year? No. All right. Go on? He called me, and I went to him. When I came to him he said: "My friend there is a certain person who has spoiled my name and the name of No2 accused" he went further and said that they had now decided to kill that person.

He and No.2 accused had decided? - Yes. Then he said whenever you see this person let me know. In reply I said "My friend I feel afraid, why are you so bold to kill a person". He then said: "If you agree to help me with regard to this person I will give you medicine which will make you a rich man." And you went to No.4 accused! s? Yes. What happened when you arrived? I found the following persons. Accused Nos. 1,2,3,4 and 5, Ranthene and accused No.6.

You found those people there?— As soon as I arrived No.4 accused spoke and said: This is another man who I have found who is going to help us get this man". No.1 accused asked whether I knew that person and in reply I said I did not know him. No.4 accused said, however, that he would show me this person. No.1 accused asked what was going to be done in order that this person should be found quickly. No.2 accused replied and said he would do something clever which would cause this man to be found. No.1 accused said that the matter that was being discussed there should not be

reported by anybody. We then dispersed.

Did any of those present whom you have named refuse to take part in this scheme or raise any objection to it?- No, no one.

What is the next thing that happened? - On

Was that all that happened on the Sunday?-Motsoenkana said that he would go.

What time of the day was this on the Sunday when discussion took place between the four of you, you two witnesses and accused Nos 4 and 6?-It was in the afternoon on Sunday.

Did anything else happen on that Sunday?-

No .

We come to the following day, the Monday. Where were you at sunset on that Monday?at home.

What happened that evening? - During that evening Motsoenkana came to me when I was in Mamojela's with Mankhoaba.

In the hut of a woman called Mamojela and Mankhoaba was present?- Yes, he then reported to me that he had come with that person. He said that he had already reported to accused Nos 4 and 6. I was talking to them outside the hut. He told me that I should follow the road leading to Mosenekeng. Motsoenkana told me saying that we would find the others ahead of us. I then left.

In which direction did you go? - In the direction of Mosenekeng.

Is that the krantz called the Red Path?-Yes, these are the krantzes leading to the red path.

What did you do when you saw them? I went towards that group thinking those were the members of the party who were referred to. When I got up to this group I identified the persons.

Who were they? - Accused Nos. 5,7,6,4,3 and another person who I did not identify.

Did you join these people ?- Yes.
What did you seven people do?- We went in the direction of the Red path.

What happened? - On reaching the Red Path I found the following persons, accused Nos.1,2,8 and Ranthene.

Were there any others in that group besides the ones you named? I omitted to mention accused No.? in whose company I had come.

Did he do that by himself or did he have assistance?— There were others assisting him but I could not say who because there was a lot of confusion.

His trousers were taken off and then? - He said to me and Motsoenkana "I can see you are afraid of handling this person, are you wanting to go and report?" I then held the left leg of the deceased and Motsoenkana held the right leg.

With the same receptable? - Yes. Then it appeared that No.3 accused was frightened and wanted to run away and No.2 accused said the thing to be done was to make him drink the blood, then No.1 accused made No.3 accused drink the blood. I don't want you to force your memory, if you can't remember say so. Only mention peoples names that you have a very clear recollection that they were carrying?— It was I, accused Nos.4, 2, Ranthene, and Motsoenkana.

Are those the only ones you remember, yourself and four other people? Yes.

When the body was placed in the hut of accused No.4 was there any light in the hut do you remember?— There was no light.

Where about in the hut was the body placed?-

An order was given that the body should be placed under the bed.

Did No.1 accused go down with the body or remain behind? - He remained behind.

After placing the body you say you returned to the path, what happened when you returned to the path?— Then No.1 accused said if anybody reported we had killed this person the person who made that report would also be killed in the same way as the deceased. I saw a billycan in his hand and also an ox tail brush. I saw him dip the brush into the billycan and then sprinkling that medicine on us.

Were you sprinkled?- Yes.

What was the object of this sprinkling do you know? - He said he was doing so in order that the Police should not worry us.

You say the medicine that he was sprinkling was taken from a billycan. Was that the same billy can in which the blood had been collected?— I did not see clearly but the medicine with which we were sprinkled didn't look like blood but like water.

After the sprinkling and the warning not to talk, what happened? - No. 1 accused said we should know that the body would be thrown away on Thursday. I then saw about six saddled horses near the rock.

You don't know whose horses they were?- I don't know. We then dispersed.

On Thursday did you return?— There is something which I have omitted to mention in regard to what happened at the path.

What was that? There was a certain group of people I saw when I was at the path some distance away from us, they were sitting down.

You have given the names of various people you found at that meeting?- Yes.

Motsoenkana two winters ago were you living at the village of Ntsang's? Yes, I was paying a visit there.

At the time you arrived there I think you had not yet met Tieho Matsora who is now dead? I did not meet him there as soon as I arrived but met him later.

Do you know how he came to meet his death? Yes.

What is the first thing that happened so far as you are concerned that led up to his death? There was a plot made.

When did you first hear of the plot? During the month of August two years ago.

What happened? I met a young man called Sabilone (Accused No. 4). I met him on his way to

During the same week on a Sunday he sent someone to me namely Ramatsepe asking me to go and see him with Ramatsepe. I went with Ramatsepe in the afternoon with him.

On the Sunday? Yes.

When I came to him No. 4 accused was with accused No. 6 on the hill.

The same hill near Ntsang's village, near the Red Path? Yes.

There was yourself Ramatsepe, accused Nos. 4 and 6, then what happened? Accused No. 4 asked me whether I still remembered the request he had made to me. I asked him what request. He said that he was referring to the request which he had made asking me to look for Tieho for him. I told him I was afraid to kill a person. He said "Look here man I will reward you with the sum of £60 and if you are not going to do so we are going to kill you because you already know of our plot". asked him where this man Ticho lived and he told me he lived at Majaheng. I asked him what this man Tieho had done and he said it was because Tieho had said that he, No. 4 accused and No. 2 accused were thieves. I then agreed. He said that on the Monday I should go to Mapoteng and I would find him there.

You were to go to Mapoteng on the following day? Yes. He said I would find Tieho either at the Police Post or the National Treasury Court. He told me he was an elderly man, dark brown. I left on Monday for Mapoteng.

Did you go alone or in company? I ought to have gone with Ramatsepe but he did not go on account of ill health.

So you went alone? Yes, I left in the direction of Totoshe then crossed the Qubetu. I returned at Makhapela's because it was late in the evening.

In which direction did you go? I went to the kraal and kraaled up the animals. After kraaling up the animals I left with Tieho.

Where did you and Tieho go? We went to a beer drink at Ranthene's.

When you got to Ranthene's was there anybody but the three of you? I found people there.

Did you recognise any of them? I recognised accused Nos. 4, 6, Ranthene, Mahlomola and Rantsepe and others.

What happened at Ranthene's when you and the deceased arrived there? We entered the hut, then Ranthene, accused Nos. 4 and 6 left the hut. Then No. 6 accused called me, he didn't shout, he just beckoned to me and I then left the hut. I found him and others outside.

What person? The deceased. He asked where he was and I told him he was at his mother's place. I told him to go ahead and I would rollow. I then left and went to the hut where I was staying. After that I went to sleep with my wife Mamojele. However, I left Mamojele in the hut and went away.

By that time it was quite dark? Yes, it was dark.

Where did you go to? I went to the Red Path.
Did you arrive at the Red Path? Yes, I
arrived at the Red Path and found many people, many
more than I had been with.

Could you recognise any of those people? Yes I recognised Ramatsepe, accused Nos. 4, 6, Ranthene and I was the fifth.

Anybody else that you recognised? No. What were these people doing? These people were killing the deceased Tieho.

So you recognised the deceased as well as those you named? Yes, I recognised him.

In what position was the deceased when you arrived there? I found the deceased had all his clothing removed from him.

In what posture was he? He was lying on the ground.

What else did you see? I found that the deceased had a wound on the head but he was still alive. After I arrived accused Nos. 4 and 6 told me to hold the deceased by the legs. I held the legs of the deceased with some other person who I did not know. I held the right leg while Ramatsepe held the left. Another person who I did not know chopped the deceased underneath the testicles with a battle axe.

Do you not know who that person was? At the time I did not know him.

Do you know him now? Yes, I recognised that person when we took the deceased into the hut.

Who was it? Accused No. 2.

What sort of a weapon did he use? It was something like a battle axe.

Can you describe it? Yes.

Please describe it to My Lord? It was something with a sharp blade like an axe and at the rear of the blade it had a point.

Anything like Exhibit 11? Yes, something like that. After that the deceased died. When he was dead we took the body on an ox skin.

Did anything else happen before the body was taken on the ox skin? Yes.

What was that? There was a man carrying a billy-can and a bottle. This person collected blood in a billy-can after the deceased was chopped underneath the testicles and at the time I arrived the same man was collecting blood from the head wounds.

Did you notice anything else before the carrying? I do not know who that person was but that person ran away.

Did he run away completely? He was stopped from running away and made to daink the blood.

Where was the body carried to? The body was taken to accused No. 4's house.

Was it? Yes.

The delay in bringing this case to trial is solely due to the fact that the Medical Officer who performed the post mortem examination on the body of the deceased left Basutoland and settled permanently in the United States of America before the Preparatory Examination opened. Hence a commission had to be sent to America and his evidence was taken there on interrogatories by both the Crown and the This commission was not completed in the United States until the end of February 1953. As soon as it was received here this trial was listed for the next Criminal Sessions.

The body of the deceased was found on Friday the 24th August 1951 at the foot of a vertical rocky cliff, about sixty feet high, at the spot marked N on the plan Exhibits A and C. There were the following injuries -

- .. Two lacerated wounds on left side of scalp, with multiple fractures of the skull.
- 2. A small penetrating wound on the left side of scrotum.
- 3. A fracture of the breast bone.
- 4. A small abrasion half an inch in diameter of skin on surface of tips of right forefinger and middle finger.

In addition to these injuries there was bloodstained fluid in the mouth, gullet, and upper breathing passages of the deceased.

The dead body was identified by P.W.1 and 2. The Medical Officer who conducted the post mortem examination stated that, when he did so, putrefaction of the body had set in but he was able to give his opinion that death was due to

the fracture of the skull. When giving evidence on commission he said that there was not sufficient evidence to say that the deceased had met his death by falling over the cliff because the only bones broken were in the skull and the breast bone and he pointed out that the wound in the scrotum could only have been made by a sharp instrument.

In my view the deceased could not have met his death by falling over a cliff about sixty feet high. The medical evidence discloses that only the skull and breast bone were fractured. P.W.6. Captain Shortt-Smith the Police Officer in charge of this case, stated that the cliff in question is vertical, absolutely sheer, and at the base the ground is solid rock. If the deceased had fallen over it he would have sustained many more fractures particularly of the arms and legs.

Further, we have the evidence of the policeman Trooper Moferefere, P.W.5. who was present when the body was found at the foot of the cliff, He stated that the body was then clothed in undermants and trousers and that there was no hole in either of these garments corresponding to the wound in the scrotum which was caused by a sharp instrument, This evidence is corrobated by P.W.16 brother of the deceased, who was also present when the body was found. Therefore these garments must have been placed on the deceased after that wound was inflicted, and this is what the accomplices say was done.

Hence any suggestion that the accused fell over the cliff is untenable and I am satisfied beyond doubt that he was murdered.

The main evidence for the Crown rests on the evidence of Ranthene, P.W.7. Ramatsepe, P.N.8. and Motsoenkana, P.W.25, all accomplices.

The Crown case is that accused 1 required the deceased to be killed because he, accused 1, wanted medicine. Therefore this is a medicine murder.

On the Monday prior to the 20th August 1951, there was a meeting at the hut of accused 4 at

No.13 Extracts from Judgment 15th July 1953 which the plot was hatched to kill the deceased on the following Monday, the 20th August 1951.

On that 20th August 1951, the deceased was returning from a place called Mapoteng, shown on the plan. Exhibit A. where he had been to search for some sheep of his which were lost. and the accomplice Motsoenkana (P.W.25) arrived together at the hut of the accomplice Ranthene. about sunset. So there were then present at that hut the deceased, Motsoenkana and Ranthene. were joined by accused 4 and 6 a little later. After accused 4 and Motsoenkana had had a private talk outside that hut accused 4 and 6 went away. Shortly afterwards deceased and Motsoenkana left and went in the direction of the village of Ntsangs, which is very close to Red Path. Ranthene followed them and taking a short out arrived at the hut of accused 4 before them - that hut is near the village of Ntsangs. It was completely dark by this time - it was winter time. At the Red Path Ranthene saw several groups of persons waiting there. Immediately the deceased and Motsoenkana arrived, the deceased, on the orders of accused 1, was seized and accused 5 threw a riem round his neck. Deceased screamed. accused 2 hit the deceased twice on the head with an axe. An axe, Exhibit 11, which is a fireman's axe with a short handle and a blade on one side and a pick at the other side was put in evidence. It was identified by P.W. 24 as belonging to her and all that can be said about this Exhibit 11 is that it was in the village in which accused 2 lived at the time of this murder. But there is no evidence that this was the weapon used - all the accomplices can say is that the axe used was like Exhibit 11.

After being hit with the axe by accused 2
the deceased fell to the ground and was stripped
of his clothing on the orders of accused 1.
Accused 2 again hit the deceased with the axe close
to the testicles - we know from the medical evidence
that this wound in the scrotum was caused by a sharp penetrating instrument. Accused 1 collected blood in a

billycan from both the head and scrotum wounds. The deceased died on the spot at Red Path.

According to the Crown evidence the principal actors in the actual killing of the deceased are accused 1, 2 and 5.

The body of the deceased was then carried to the square hut of accused 4 - marked L on the plan Judgment Exhibit B - and there placed under a bed. It was carried on the ox skin - Exhibit 1, which was eventually found by the Police in the hut of accused 5.

The body was reft in accused 4's hut until the following Thursday night. That night, on the orders of accused 1, it was taken to the spot N on the plans Exhibits A and C and there deposited at the foot of the cliff, where it was eventually found by the Police.

That is the Crown case and I now deal with the salient evidence against each accused in chronological order.

#### Accused 3.

- The case against this accused is as follows:  $(z_i)$ The two accomplices, P.W.7 and 8 state that accused 3 was present at the meeting on the 13th August 1951, when the plot was hatched to kill the deceased.
- (b) The same two accomplices state that accused 3 was present at Red Path when the deceased was killed. They both say he tried to run away but was called back by accused 1. The third accomplice, P.W. 25, stated that there was one man there who tried to run away. This is corroborated by independent witness P.W.II.

The defence of this accused is an alibi supported by his wife,

Counsel for the defence suggested in his closing address that if this accused was found to be

In the High Court

No.13 Extracts from Judgment 15th July 1953 present at the Red Path when deceased was killed he would, on the Crown evidence that he tried to run away, be entitled to rely on the defence that he acted under compulsion.

In my view such a suggestion is untenable because, first, this accused did not rely on it in his evidence - he said he was not at the killing, and secondly, there is not sufficient evidence that he took part in the killing because he was in fear of his life or of serious bodily injury. Further, there is the evidence for the Crown that he attended the meeting when the plot was hatched to kill the deceased; if he wished to withdraw he could have done so after that meeting and never gone to the Red Path on the night of the 20th August 1951.

Therefore against accuseds 1 to 6, both inclusive, we have both accomplice and independent evidence. Against accused 7 there is accomplice evidence and the bloodstained sack. He has given no explanation regarding the sack.

In addition, we have the medical evidence of the wounds, which corroborates the account given by all three accomplices.

The law in this Territory with regard to accomplice evidence was laid down by the Judicial Committee of the Privy Council in the case of Gideon Nkambula v. Rex (1950) A.C. 379; that is a Swaziland case but the law in Basutoland on accomplice evidence is identical with the law in Swaziland. That case laid down that the evidence of two accomplices, unsupported by any other testimony, is sufficient, if believed and if the warning of the danger of accepting it is present in the mind of the Judge and his Assessors, to warrant the conviction of those accused of a crime.

There are discrepancies in the evidence led by the Crown but none of them go to the root of the case. In a fast moving drama such as this it is only to be expected that there would be discrepancies.

In this case the defence could not produce any evidence of motive as to why these accomplices should lie. All three accomplices, in my view, and I have warned myself and my Assessors of the danger of accepting accomplice evidence, are witnesses to truth. Further, there is ample independent evidence, which I have set out earlier, corroborating their evidence. I believe the evidence of those independent witnesses.

In the face of this overwhelming evidence brought by the Crown I reject the alibi defences brought by the defence.

Clearly from the Crown evidence - the meeting of the 13th August 1951, when the plot to kill the deceased was hatched, the actual killing on the 20th August 1951 and the disposal of the body on the 23rd August 1951 - all this evidence establishes common purpose.

I have no hesitation in convicting accuseds 1, 2, 3, 4, 5, 6 and 7 of this murder.

I give accused 8 the benefit of the doubt only because there are discrepancies in the accomplice evidence, the only evidence against him - evidence which is much weaker than the evidence against the other seven accused. I acquit him.

All four Assessors agree with my findings in respect of accuseds 1, 2, 3, 4, 5, 6 and 8. As regards accused 7 three of the Assessors agree with my finding.
