- 1.—The Plaintiffs are an association established for the following purposes, namely:—
 - (a) The protection and promotion of Trade and Commerce in 20 Nigeria.
 - (b) The collection and dissemination of Statistical and other information relating to Trade, Commerce, Shipping, Industry and Manufactures:
 - (c) The promoting, supporting or opposing legislative or other measures affecting the aforesaid interests and
 - (d) The doing of all such other things as may be conducive to the extension of Trade, Commerce, Shipping, Industry or Manufactures, or incidental to the attainment of the above objects.
- 2:—Membership of the Plaintiffs' association is open to any person, 30 firm or company established in trade, commerce, shipping, industry or manufactures in the Western Provinces of Nigeria and the Colony of Lagos and consists of African as well as European and Syrian individuals, firms and companies.
- 3.—The Plaintiffs were originally established in the year 1888 under the name of the Lagos Chamber of Commerce.
- 4.—The Plaintiffs were incorporated under the Provisions of the Companies Ordinance in June, 1950, under the name of "The Lagos Chamber of Commerce (Incorporated)."

5.—Since its formation in 1888 the Plaintiffs have been commonly In the known and addressed as "The Chamber of Commerce Lagos" and a large Supreme proportion of the correspondence received by it particularly from abroad Nigeria. is so addressed.

6.—The Plaintiffs are not aware of the precise objects of the second Defendants but believe them to be substantially the same as those of the of Claim. Plaintiffs.

- 7.—On 26th June, 1950, the Plaintiffs' solicitors received notification 1950from the first Defendant that an application had been made to him by the continued. 10 second Defendants for the registration of their Association under a different name i.e. "African Chamber of Commerce" and a request that the first Defendant be informed whether or not the Plaintiffs had any objections to the proposed registration.
 - 8.—On the same date the Plaintiffs informed the first Defendant that they objected to the registration, but the first Defendant refused to entertain the objection.
- 9.—The Plaintiffs object to the registration of the second Defendants under the name of "African Chamber of Commerce" on the ground that the name containing the words "Chamber" and "Commerce" so nearly 20 resemble that of the Plaintiffs as to be calculated to deceive and that its use by the second Defendants in the Western Provinces of Nigeria and the Colony of Lagos would lead to confusion greatly to the detriment and embarrassment of the Plaintiffs.
 - 10.—The Plaintiffs therefore claim that they are entitled to an injunction to restrain the first Defendant from registering the proposed new name of the second Defendants.

I have been engaged in business for a long time; I am a permanent citizen. Born and bred and live always here. I have always known about the Plaintiffs—since I am a school boy—say 1910. August 3, 1898—"Lagos Standard "-I see here at bottom of Column 2 on page 2 a reference to the Lagos Chamber of Commerce. I have had the paper in my custody and I produce it. Exhibit "A."

FRANK GUSTAV FROST: Sworn, about 60 years. Head, locally, of Gottschalk and Company—I am General Manager. Our Company is a member of the Lagos Chamber of Commerce. I am Vice President of the Chamber. Messrs. Gottschalk has belonged to the Chamber for over 30 years. I saw three Certificates of Incorporation of the Plaintiff. 23.6.50incorporated under the Company's Act. Exhibit "B." The Chamber was in existence before the incorporation, since 1888. I see that Nigerian

Handbook page 55—It mentions the 4 Chambers of Commerce in Nigeria and the dates when each began. The Lagos Chamber of Commerce is shown as opening in 1888. The other 3 are at Port Harcourt, Calabar, and Kano. I see that list. It is a list of the members of the Plaintiff. Exhibit "D." Most of the big companies in Nigeria are our members. The Companies are of many different nationalities. They handle every type of trade known in Nigeria. I have heard now of the Association of Merchants and Industrialists (No. 2 Defendant). I had not heard of them before this case. I do not know at all who are their members.

Cross-examined by No. 1. Nil.

Cross-examined by No. 2. I have been a member personally myself since 1929—my firm has been a member for more than 30 years. Chamber was in constant correspondence with the Government throughout. I do not know if it was registered 30 years ago or if there were facilities for registration then. We got the Chamber incorporated in 1950 so as to give members some protection if any one else tried to take the name. I do not think our claim to the name is founded on 9 months existence. I think the whole time we have been operating, i.e. 30 years entitles us to some consideration. If the name "African Chamber of Commerce" is registered I think confusion for the public would arise—especially from letters addressed carelessly—often they are addressed Chamber of Commerce, Lagos—or Lagos Chamber of Commerce—very many different ways. Our name is "Lagos Chamber of Commerce." When we write letters we give our proper address. Correspondents usually write back correctly but we receive many letters unsolicited—People hastening to make contact just write "Chamber of Commerce—Lagos." We oppose the registration of "African Chamber of Commerce "because it will lead to confusion. Chambers of Commerce are established all over the world and business people wanting to make contacts write to "Chamber of Commerce"—If such a letter is sent to Lagos then we have now to receive it and not for it to go to any other body. We do 30 not want there only to be one Chamber of Commerce in Lagos. We do not want a Monopoly of Service. If a letter was addressed "Chamber of Commerce Lagos" and it was registered I do not know if we could claim it. We probably would I think and deal with it. I do not know.

ROBERT CHRISTOPHER IRVING, Sworn: 11, Tinubu Street, Lagos. Company Director. I am Director of Apex, Ltd., Lagos Building 40 Society, Ltd., African Lands, Ltd. Apex, Ltd., are Secretaries and Treasurer of Chamber of Commerce. I am actively engaged with Plaintiff myself on

the administrative side. I myself do the work of Secretary. That is the in the Memo. and Articles of Association of the Plaintiff. Exhibit "H." I see Supreme Court of that list of members Exhibit "D." Members belong to all nationalities— I see here—British, French, Belgian, Swiss, Greek, African. There are 19 wholly owned or managed and directed by Africans. Membership of the Chamber is open to anyone of any nationality interested in Commerce and Trade in Nigeria. The Lagos Chamber is affiliated to the London, Liverpool, Manchester Chambers of Commerce—also to Calabar, Kano and Port Harcourt, Kumasi, Cape Coast, Sierra-Leone and Council of Chamber of Examina-10 Mines, Jos. I see most of the correspondence addressed to Plaintiffs—when tion-I was in Lagos I see it all. Letters come from all over the world. I see that continued. bundle of envelopes. We accepted the letters and dealt with them. They were all meant for us although differently addressed Exhibit "F." That is a further pile of envelopes with different addresses—all meant for Plaintiffs Exhibit "G." We, Apex, Ltd., dealt with them all as Secretaries. I know No. 2 Defendants have applied for registration as "African Chamber of Commerce." The Plaintiffs have objected. In spite of our objection No. 1 Defendant wrote that letter dated 2.8.50 saying he intended to proceed with the registration so then it was necessary to come to Court.

CROSS-EXAMINED by No. 1 by SAGOE: I am Director of African Lands, Cross-exam-20 Ltd. I think "Lands" could be considered descriptive. It gives a clue ination to what the Company is. If someone wanted to register "Lagos Lands, Ltd." by 1st I should object on the ground that it might cause confusion. The words "Lands" would bring the confusion. I would object to "Nigerian Chamber of Commerce." Port Harcourt Chamber of Commerce is in existence. I do not think it is registered with you. If it is registered I would not object. I object to "Africa or African Chamber of Commerce." The real objection is "Lagos." Anything addressed to Lagos and Chamber of Commerce should come to us.

CROSS-EXAMINED by No. 2: I am Director of Apex, Ltd., Apex, Ltd., Cross-exam-30 are valuers Estate Agents, Company Secretaries things like that. We do not ination object to rivals. "Chamber of Commerce" is descriptive. Every part of by 2nd Defendant. the world knows what is meant by Chamber of Commerce. I know the Union Trading Company U.T.C., also Ikorodu Trading Company. They operate side by side in Lagos. I do not think there could be any confusion in the words "Trading Company." I did not know there was "Lagos "Trading Company." If I am a Director of U.T.C. I would not object to registration of "Lagos Trading Company." There is no similarity between Trading Company and Chamber of Commerce. Only our (sic one) Chamber of 40 Commerce can exist in each centre. It does not matter how many Trading Companies. I see that envelope (part of Exhibit "F"). Address "Nigerian Chamber of Commerce & Industries, Lagos." It is addressed to Lagos. This one: Secretary, Chamber of Commerce, Nigeria, West Africa. "Kano" Chamber could have claimed it if it had been delivered there. Trading companies are in competition. A Chamber of Commerce is not. We say people throughout the world are entitled to write and for the letter to come

to us for us to deal with. We do not want to create monopoly of Service. I should say, without the record that at least 60 per cent. of our correspondence comes addressed "Secretary, Chamber of Commerce, Lagos." We have done nothing to correct such errors. We are the only registered Chamber of Commerce in Lagos.

In this action the Plaintiffs "The Lagos Chamber of Commerce (Incorporated) " seek an injunction against No. 1 Defendant, the Registrar of Companies, to restrain him from proceeding with the registration, on an application by No. 2 Defendant, who at present call themselves "The Association of Merchants and Industrialists," for a change of that name to "The African Chamber of Commerce."

The Plaintiffs gave evidence but neither of the Defendants elected to 30 do so, with the result that the Court is in a position to know something about the Lagos Chamber of Commerce, its membership and activities but it knows nothing about the Association of Merchants and Industrialists-I gather from Exhibit "H," a letter from the Registrar of Companies to the Plaintiffs, where he says "I am proceeding with the registration of

"the change of name of the 'Association of Merchants and Industrialists' In the "to 'African Chamber of Commerce,'" that the Association has already Supreme satisfied the Registrar under Section 21 of Cap. 38 that it is not an Court of Association for Profit and is registered accordingly, and now it wants to register a change of name. The Court also knows, from paragraph 5 of the Statement of Defence, that the Association's operations cover the whole Judgment. of Nigeria and are limited to Africans only; but whether that means that 8th May membership is restricted to Africans or whether it means that the 1951-Association is not interested in Commerce and Trade between Africans and 10 Europeans or Overseas enquiries, is not clear.

More is known about the Lagos Chamber of Commerce. It was established in 1888 (only 7 years after the London Chamber—the Liverpool Chamber was founded in 1884 and since then has been the leading voice in all commercial matters in England relating to West Africa—This information is to be found in the Encyclopædia Britannica under the heading "Trade Organisation") although it was only incorporated in June, 1950— Its membership is open to any person, firm or company established in trade . . . in the Western Provinces of Nigeria and the Colony of Lagos— See Exhibit "E" the Memo and Articles of Association. Presently it has 20 89 members comprising all the big firms and including 19 African firms and others from France, Belgium, Switzerland, Greece, India and America— See Exhibit "D." It is affiliated to the Chambers of London, Liverpool, Manchester and also to the Chambers in Calabar, Kano, Port Harcourt, Kumasi, Cape Coast and Sierra Leone. It is a serious and authoritative body of responsible business men joined together for the protection and promotion of Trade and Commerce in Nigeria.

The Plaintiffs object under Section 9 (1) of Cap. 38 to the registration of the Association under the name "African Chamber of Commerce" on the ground that such a name so nearly resembles that of the Plaintiffs as to 30 be calculated to deceive and that its use in the Western Provinces and the Colony of Lagos would lead to confusion. To substantiate that 2 bundles of addressed envelopes (Exhibits "F and G") may be about 200 of them from all over the world were put in. Very very few were correctly addressed, the big majority were addressed "The Chamber of Commerce, Lagos" which address is also favoured by the Government Printer. argument runs that most of those letters from foreign correspondents contained serious enquiries about the chances and statistics of establishing trade in Nigeria and that they were intended for the old established Chamber which had been founded in 1888. If the Association is permitted to be 40 registered with an address in Lagos then there is no reason why the letters should not all go to them to the detriment and embarrassment of the Plaintiffs, and also, I think, possibly to the detriment of the foreign enquirers if the Association is only confining itself to trade amongst Africans, because the letters might never get answered. If that happened, it could be injurious to trade in Nigeria generally.

The ordinary practice is to have a Chamber of Commerce for each Centre which is known by the name of the town or city or locality where it is situated, and then there is an Association of Chambers of Commerce

Judgment. 8th May 1951 continued. which meets about once a year and to which the local Chambers send delegates, but it is contrary to all commercial practice for one locality to have more than one Chamber—good sense forbids it: good sense decrees that all reputable merchants in one locality should join together in one Chamber.

But if good sense is not going to prevail is there any legal objection to the 2nd Defendants being registered as the "African Chamber of Commerce "with an address in Lagos and thus almost certainly receiving a number of letters addressed "Chamber of Commerce-Lagos"? I think not-The words "Chamber of Commerce" are descriptive-It describes 10 what the company is and there could be no objection to each locality having one so long as the name of the locality is only taken by one. Chambers of Commerce are differentiated, from the point of view of Registration, by the name of the Chamber—I think the Registrar is right when he says that his duty is to ignore the words "Chamber of Commerce" and to see whether "African" so nearly resembles "Lagos" as to be calculated to deceive. If letters are correctly addressed, they will arrive at their respective addresses without confusion—Confusion will arise in fact because foreign correspondents, knowing the proper and ordinary practice of Chambers of Commerce i.e. one for each place, would not expect 20 a choice of addresses if they sent their letters to "Chamber of Commerce They would expect their letters to find their way to the Lagos Chamber of Commerce, but I do not think that because the 2nd Defendants choose to break away from common form that it can be said in the legal sense to be calculated to deceive. There could be no difficulty at all if their address was not in Lagos. But the Registrar, and the Court, is only concerned with the name, not the address.

Various authorities were cited but there is nothing directly on the point, and I do not think it necessary to examine them in detail—I will however record them. Mr. Teesdale for the Plaintiffs cited Braham v. 30 Beachim (1878) 7 Ch. D. 848. Lloyd's and Dawson v. Lloyd's Southampton (Ltd.) (1912) 28, T.L.R. 338. Merchant Banking Co. of London v. Merchant's Joint Stock Bank (1878) 9 Ch. D. 560.

Mr. Sagoe for the 1st Defendant cited Aerators Ltd. v. Tollitt (1902) 2 Ch. 319. British Vacuum Cleaner Co. v. New Vacuum Cleaner Co. (1907) 2 Ch. 312.

Mr. Adesanya for 2nd Defendant cited *Turton* v. *Turton* (1889) 42 Ch. D. 128. I hold that the Plaintiffs are not entitled to the injunction sought and the case must be dismissed.

In the Court below the Registrar of Companies contended that the Coussey, words "Chamber of Commerce" constitute a generic designation for J.A.). particular associations or bodies of persons and therefore cannot be 17th exclusively claimed by one association or body of persons. He argued, 30 therefore, that if the 2nd Respondent company satisfied the requirements of Section 21 (1) of the Companies Ordinance, Cap. 38, as in his view it had, it was entitled to registration under the new name, and he drew attention to the provisions of Section 9 (1) (b) of the Ordinance which provides that no company shall be registered by a name which contains the words "Chamber of Commerce" unless the company is a company which is to be registered under a licence granted in pursuance of Section 21 (1) of the Ordinance without the addition of the word "Limited" to its name. Finally, he submitted that it was his duty to ignore the words "Chamber of Commerce" and determine whether the word "African" so nearly 40 resembles the word "Lagos" as to be calculated to deceive, which he submitted was not the case.

Foster Sutton, P. (concurred in by Verity, C.J. and Coussey, J.A.). 17th November 1952 continued. Appellants' Counsel argued that the new name under which the Association of Merchants and Industrialists sought to be registered does so nearly resemble the name of the Appellant organisation as to be calculated to deceive, that Section 9 (1) (a) of the Companies Ordinance, which prohibits registration in such circumstances, applies, and that registration should, therefore, be refused. He further argued that the word "African" is only distinctive when separated from the words "Chamber of Commerce," that in considering the tendency of the new name to deceive regard must be had to the place where it is to be used, that is to say Lagos, that "African" and "Lagos" are both words of the same nature, Lagos being in Africa, 10 and that the use of the word "African" in conjunction with the words "Chamber of Commerce" is calculated to deceive the numerous firms abroad who from time to time make trade enquiries through the Appellants.

The learned Trial Judge accepted the contentions put forward by the

Registrar of Companies and declined to grant the injunction prayed.

I do not consider myself that if a company chooses to incorporate into its own name words descriptive of, and universally used to describe an organisation formed for promoting commerce, it can fairly claim a monopoly of the use of those words. The words "Chamber of Commerce" are clearly descriptive and it seems to me that the addition of the word "African" ought to be sufficient to distinguish the two organisations. It certainly would be if reasonable care is used. In my view it would not be right to deprive the Appellants of the use of a descriptive name like "Chamber of Commerce" merely because mistakes may arise through lack of knowledge or carelessness on the part of persons making enquiries from abroad.

It follows that, in my opinion, the decision appealed against was right, and ought to be affirmed. I would, therefore, dismiss this appeal with costs.

During the course of his judgment the learned trial Judge embarked upon a dissertation regarding the undesirability of having more than one 30 Chamber of Commerce in the same locality and asserted that it is the ordinary practice and good sense not to do so. The observations were not necessary for the decision in this case and I only refer to them lest it be thought that in agreeing with his decision I also agree with the observations I have referred to, because such is not the case.
