IN THE MATTER of the objection by THOMAS LLOYD FORSTER RUTLEDGE, THE HONOURABLE WILLIAM MCCULLOCH GOLLAN and MAURICE VICTORIAN POINT to the valuation by the VALUER GENERAL of certain lands situated in the Municipality of Randwick.

AND IN THE MATTER of the objection by THE RANDWICK MUNICIPAL COUNCIL to the said valuation.

AND IN THE MATTER of the Valuation of Land Act 1916-1951

CASE STATED BY THE LAND AND VALUATION COURT FOR THE DECISION OF THE SUPREME COURT THEREON IN PURSUANCE OF SECTION 17 OF THE LAND AND VALUATION COURT ACT, 1921-1955.

I DO OF MY OWN MOTION state the following case for the decision of the Supreme Court on the questions of law hereinafter set forth: In the Land and Valuation Court

- 1. By Deed of Grant bearing date the 15th day of June 1863 Her Majesty Queen Victoria granted unto the Honourable Edward Deas Thomson. C.B. Richard Jones and William Bede Dalley their heirs and assigns certain lands in the Parish of Alexandria to be held on the trusts and with the powers and subject to the conditions and provisos therein appearing.
- 2. Hereunto annexed and marked with the letter "A" is a true copy of the said Deed.
- By Deed of Grant bearing date the 11th day of 3. February 1935 His Majesty King George V granted adjoining lands to the persons then holding the land referred to in paragraph 1 hereof and annexed hereto and marked with the letter "B" is a true copy of such additional grant.
- By a Private Act of the Legislature of New South Wales entitled the Australian Jockey Club Act, 1873, after reciting the trust provisions of the Deed referred to in paragraph 1 hereof it was provided that the trustees for the time being of the lands referred to in paragraph 1 hereof were authorised by writing under their hands to grant upon such terms and conditions as to them should seem expedient to the Australian Jockey Club or to any other club or association then formed or which might thereafter be formed for the purpose of horse racing or for the purpose of promoting or engaging in any other public amusement or purpose for which it was intended the said lands should or might be used the exclusive right to use and occupy the said lands or any part or parts thereof for any number of years not exceeding twenty one years and for the trustees for the time being of the said lands from time to time to renew any such lease for any further term not exceeding twenty one A true copy of the said Private Act is hereunto annexed and marked with the letter "C".
- The trustees from time to time have since 1873 5. leased the said lands to The Chairman of the Australian Jockey Club which is an unincorporated Club and a "non-proprietary Association" within the meaning of The Gaming and Betting Act, 1912, as amended, for successive terms. now current is for a term of twenty one years

expiring in 1968. The said lands have at all material times been used, and are still used, by the said Australian Jockey Club as a race course, and erected thereon are the usual improvements appropriate for that purpose.

6. There has not in terms of the grants referred to in paragraphs 1 and 3 hereof been any cesser of the said trusts and the said lands have not been forfeited nor have they reverted to the Crown nor has there been any declaration of any public amusement or purpose for which the said lands may be used other than those specified in the said grants.

- The lands referred to in paragraphs 1 and 3 7. hereof were, with the exception of a small part which has been resumed for public purposes, at the date of the objections hereinafter referred to and still remain vested in the above-named objectors Thomas Lloyd Forster Rutledge, the 20 Honourable William McCulloch Gollan and Maurice Victorian Point, the trustees for the time being of the trusts of the said grants, upon the trusts and for the purposes and with the powers and subject to the conditions and pro-The said visos in the said grants set forth. lands now comprise an area of approximately 198 acres 2 roods and 35½ perches and are the lands comprised in Certificate of Title under the provisions of the Real Property Act 1900, 30 registered Volume 2579 Folio 66 and Crown Grant registered Volume 4673 Folio 38. said lands constitute a licensed racecourse under the provisions of The Gaming and Betting Act, 1912, as amended.
 - 8. The said lands are within the area for rating purposes of the abovenamed objector, the Randwick Municipal Council.
- 9. Prior to the notification hereinafter referred to the said lands were coloured dark green on the Scheme Map referred to in the County of Cumberland Planning Scheme Ordinance which is set forth in the Scheaule to the Local Government (Amendment) Act, 1951.
 - 10. On 24th of October 1952 the Minister for Local Government acting in pursuance of Section 342Y

14th December 1956 continued. of the Local Government Act 1919 as amended duly notified the suspension in relation to the said lands of the provisions of the prescribed scheme embodied in the said Ordinance, and the provisions of Division 7 of Part XIIA of the said Act and of Ordinance 105 made under the said Act thereupon applied and still apply to the said lands.

- 11. The said lands were on the 23rd of September 1954 valued by the Valuer General under the provisions of the Valuation of Land Act, 1916-1951 as being of the unimproved value of £385,400 and as being of the improved value of £1,250,000 and as having the assessed annual value of £62,500. The Municipal Rates payable by the objectors Thomas Lloyd Forster Rutledge, the Honourable William McCulloch Gollan and Maurice Victorian Point unto the objector the Randwick Municipal Council assessed upon the said unimproved value of £385,400 were, in the year 1955, £8,631.7.1.
- 12. The Valuer General pursuant to the provisions of the said Act duly gave notice of the said valuation to the said Thomas Lloyd Forster Rutledge, The Honourable William McCulloch Gollan and Maurice Victorian Point and also pursuant to the said Act duly furnished to the said Council a valuation list containing the said valuation.
- 13. The said Thomas Lloyd Forster Rutledge, the Honourable William McCulloch Gollan and Maurice Victorian Point on the third day of August 1955, and pursuant to the provisions of the said Act, made objection to the said valuation and in its notice of objection contended that the values assigned were too high and should in each case be reduced to nil or to a nominal figure.
- 14. On the 12th day of December 1955, and pursuant to the provisions of the said Act, the said Randwick Municipal Council duly made objection to the said valuation and in its notice of objection the Council claimed that the values should be: Unimproved Value £574,246.0.0. Improved Value £1,250,000.0.0. and Assessed Annual Value £93,027.0.0.
- 15. The Valuer General upon receipt of such objec-

tions did not in pursuance of the said Act see fit to alter the valuation referred to in paragraph 11 hereof and forwarded a list showing particulars of the said objections to the Registrar of the Land and Valuation Court for the hearing and determination by the Court of such objections as appeared therein.

16. The said objections came on for hearing before the Court and a direction was given by the Court that they should be heard together.

- 17. Upon the objections coming on for hearing Mr. Saunders of Counsel for the Valuer General informed the Court that in making the said valuation the Valuer General had taken into consideration the said trusts, restrictions, conditions and provisos appearing in the said grants by assuming a sale of the fee simple of the said lands to a purchaser who would take and hold the said lands subject thereto. He also informed the Court that the said valuation was not affected in any way by the provisions of Division 7 of Part XIIA of the Local Government Act 1919 as amended and Ordinance 105 made under the said Act.
- 18. Mr. Wallace of Queen's Counsel for the objectors the said Thomas Lloyd Forster Rutledge, The Honourable William McCulloch Gollan and Maurice Victorian Point submitted that as a matter of law the unimproved value, the improved value and the assessed annual value of the said lands should be determined on the footing that the said lands were subject to all the trusts, restrictions, conditions and provisos appearing in the said grants and were respectively only nominal amounts; that the decision in Royal Sydney Golf Club v. Federal Commissioner of Taxation (91 C.L.R. 610) insofar as it held the contrary was wrong; that in the event the present case was distinguishable from that case; and that the recent decision of this Court in Council of the City of Sydney v. Valuer General (13th September, 1956 as yet unreported) was Mr. Wallace also submitted that the wrong. submission by Mr. Bower of Queen's Counsel regarding the correctness and applicability of the decision in Council of the City of Sydney v. Valuer General was wrong; Mr. Wallace also

submitted that whether or not the trusts, restrictions, conditions and provisos aforesaid were to be taken into consideration, the provisions of the said Division 7 and of the said Ordinance were to be taken into account and that in this regard the decision of this Court in Thistlethwayte v. The Minister (19 L.G.R. 87) was wrong and he also made the submission, alternatively to his submission that as a matter of law the said values were respectively only nominal amounts, that the basis of valuation on which the Valuer General had proceeded was correct although he disputed the correctness of the values assessed by the Valuer General on that basis.

19. Mr. Bowen of Queen's Council for the objector The Randwick Municipal Council submitted that the unimproved value of the said lands should be determined on the footing laid down in the said recent decision of this court in Council of the City of Sydney v. Valuer General, namely that the said trusts, restrictions, conditions and provisos be ignored in determining such unimproved value. Mr. Bowen also submitted that the submissions by Mr. Wallace hereinbefore stated were wrong.

20

20. Mr. Saunders of Counsel then informed the Court that the Valuer General was not concerned to debate the questions of principle referred to by Mr. Wallace and Mr. Bowen but is content to abide by the decision thereon which might be given by this Court or by any Court on appeal therefrom. Mr. Saunders informed the Court that, if the correct basis for valuation of the said lands was in accordance with the submissions of Mr. Bowen, the value determined by the Valuer General would have been in excess of £385,400 for the unimproved value of such lands.

21. No ground or reason appeared for distinguishing in the present case the decision in Council of the City of Sydney v. Valuer General or why this Court should depart therefrom in the present case, and Mr. Wallace having informed the Court that his clients desire to test its correctness on appeal and would, for that purpose, appeal from a determination of this Court founded thereon, I decided that before proceeding to a

lengthy and costly enquiry into values, which might prove abortive, I should of my own motion state this case for the opinion of the Supreme Court.

The questions of law stated as aforesaid for the decision of the Supreme Court are:-

1. Whether, in valuing the said lands under Sections 5 and 6 of the Valuation of Land Act, 1916-1951, the trusts, restrictions, conditions and provisos contained in the said grants and in the said Act of 1873, or any of them, should be taken into consideration, and if so in what manner and to what extent.

- 2. Whether, in valuing the said lands as aforesaid, the restrictions arising from the said notification by the Minister for Local Government under Section 342Y of the Local Government Act should be taken into consideration, and if so in what manner and to what extent.
- Whether the valuation required by Sections 5 and 6 of the said Valuation of Land Act to be made by the Valuer General is:-
 - (a) On the basis that such lands were held by the objectors for an estate in fee simple which could be alienated but only under circumstances in which the alienee would then hold such lands on the trusts and for the purposes and subject to the restrictions, conditions and provisos set forth in the said grants and in the said Act of 1873; or
 - (b) on the basis that such lands were held by an owner for an estate in fee simple free from any such trusts, restrictions, conditions or provisos and could accordingly be alienated to an alienee who would hold such lands free from any such trusts, restrictions, conditions and provisos; or
 - (c) on some other, and if so what, basis.

An Act to extend the period for which the Trustees of the Randwick Racecourse are enabled to grant leases thereof and to enable the Members of the "Australian Jockey Club" to sue and be sued in the name of the Chairman for the time being of the Committee of the said Club and for other purposes.

WHEREAS by deed poll or grant from the Crown bearing date the fifteenth day of June in the year of Our Lord one thousand eight hundred and sixty-three under the hand of His Excellency Sir John Young then Governor-in-Chief of the colony of New South Wales and under the seal of the said colony ALL that piece or parcel of land in the said colony containing by admeasurement two hundred and two acres be the same more or less situate in the county of Cumberland parish of Alexandria at Randwick commencing at a point on the southern side of the road leading from the old Botany Road to the village of Coogee bearing east one degree north and distant forty-five chains and south twenty-two chains and seventeen links from the north-eastern corner of S. Terry's five hundred and seventy acres and bounded thence on the east by a line bearing south-west one degree east twentyeight chains and twelve links on the south by a line bearing west one degree south forty-two chains and sixty links to the eastern side of the old Botany Road on the west by that road north-westerly to its intersection with the east boundary of S. occupy the said lands or any part or parts thereof as the said Trustees should in their discretion think fit for any number of years not exceeding seven years commencing from the time of the signing in writing by which the right of using the said lands should be granted to any such club or association as aforesaid provided always and it was thereby declared that when and so often as the said Edward Deas Thomson Richard Jones and William Bede Dalley or any Trustee or Trustees to be appointed by virtue hereof should die resign cease to reside in the colony of New South Wales or become incapable of acting in the Trusts thereby created it should be lawful for the Governor for the time being of the said colony with the advice of the Executive Council thereof from time to time by writing under his hand to name and appoint a new Trustee or Trustees in the place and stead of any Trustees or Trustee so dying resigning ceasing to reside in the said colony of New South Wales or becoming incapable of acting in the said Trusts and thereupon the said lands should be conveyed and assured by the surviving continuing Trustees or Trustee or by the heirs of the last surviving Trustee their or his heirs or assigns upon the trusts and for the intents and purposes thereinbefore created and declared of and concerning the said land and whereas the said Richard Jones having resigned his said office of Trustee Alfred Cheeke of Sydney aforesaid Esquire was duly appointed a Trustee in his place and stead and Whereas the said Trustees have for some years past permitted the Members of the Australian Jockey Club to have the use and enjoyment of the said land for the purpose of horse racing and the said Australian Jockey Club have expended large sums of money in making forming and improving a course for horses to race on and a tan gallop for horses to train on and in erecting fences stands and other buildings on the said land in connection with horse racing and whereas the said Australian Jockey Club are desirous of erecting a new Grand Stand on the said land and of forming a training gallop inside the course so formed as aforesaid and of erecting other permanent improvements on the said land and whereas in order to enable them to raise money for such improvements they have applied to the said Trustees for a lease of the said land which the said Trustees are willing to grant AND WHEREAS the term of Seven years for which the said Trustees have power to grant such lease being insufficient to enable the said Club to obtain the

money for such improvements it is desirable that power should be given to the said Trustees to grant a longer lease in manner hereinafter mentioned AND WHEREAS the Members of the said Club are desirous of obtaining authority to borrow money for the purpose of improving the said lands and of obtaining the power and privileges hereinafter granted BE it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in this present Parliament assembled and by the authority of the same as follows:-

- 1. This Act may be cited for all purposes as the "Australian Jockey Club Act 1873".
- 2. In this Act

The term "Club" means the Australian Jockey Club.

The term "Committee" means the Committee for the time being of the Club.

The term "Chairman" means the person who is the Chairman for the time being of the Committee.

The term "Justice" means a Justice of the Peace acting in and for the Colony of New South Wales.

The term "Building" means any house out-house stand booth stable shed tent fence or other building edifice or erection of any description whatsoever for the time being standing or being upon any land for the time being vested under or by virtue of this Act in the Chairman.

3. It shall and may be lawful for the said Honorable Edward Deas Thomson Alfred Cheeke and William Bede Dalley as such Trustees or other the Trustees for the time being of the said Grant of the fifteenth day of June one thousand eight hundred and sixtythree and they are hereby authorised by writing under their hands to grant upon such terms and conditions as to them shall seem expedient to the said Australian Jockey Club or to any other club or association now formed or which may hereafter be formed for the purposes of horse-racing or for the

purpose of promoting or engaging in any other public amusement or purpose for which it is intended the said land should or might be used as aforesaid the exclusive right to use and occupy the said lands or any part or parts thereof as the said Trustees should in their discretion think fit for any number of years not exceeding twenty-one years commencing from the time of signing the writing by which the said lands shall be granted with power also for the said Trustees or the Trustees for the time being of the said Grant from time to time to renew any such lease for any further term not exceeding twenty-one years from the granting thereof and with power also in any such lease or any renewal thereof to make such stipulations with reference to any buildings to be erected on said land as they may think proper.

All actions suits and proceedings at law or in equity for any cause matter or thing happening after this act to be commenced instituted prosecuted or carried on by or on behalf of the said Club or wherein the said Club is or shall be in any way concerned against any person or persons body or bodies politic or corporate whether a member or members of the Club or otherwise and may be lawfully commenced instituted and prosecuted or carried on in the name of the Chairman at the time any such action suit or proceedings shall be commenced or instituted as the nominal plaintiff complainant or petitioner for and on behalf of the Club and all actions suits and proceedings as aforesaid to be commenced instituted and prosecuted against the Club or any of the members thereof as such shall be commenced instituted and prosecuted against the Chairman as the nominal defendant for and on behalf of the Club or members and in all indictments and informations it shall be lawful to state the property of the Club to be the property of such Chairman and any offence committed with intent to injure or defraud the Club shall and lawfully may in any prosecution for the same be stated or laid to have been committed with intent to injure or defraud the said Chairman and any offender or offenders may thereupon be lawfully convicted of any such offence in all other allegations or indictments informations or other proceedings it shall and may be lawful and sufficient to state the name of such Chairman and the death resignation or removal or other act of such Chairman shall not abate any such action suit or prosecution but the same may be continued where it left off and prosecuted and

concluded in the name of any person who may be or may become Chairman.

A memorial of the names of the Chairman and of cach of the members of the Committee respectively in the form or to the effect set forth in the Schedule to this Act signed by such Chairman and by a majority of the Committee shall be recorded upon oath in the Supreme Court of the Colony of New South Wales within one calendar month after the passing of this Act and when and so often as any Chairman or member of Committee shall be newly elected a memorial of the name of such newly elected Chairman or member in the same form and to the same effect as the above mentioned memorial signed by such newly elected Chairman or member and by a majority of the Committee at the time of such election shall in like manner be recorded upon oath in the said Supreme Court within one calendar month next after every such Chairman or member shall be elected and for all purposes whatsoever the production of the memorial recorded as by this Act directed or of any office or examined copy thereof shall be received as sufficient and conclusive evidence in all courts of justice or before any person having by law or by consent of parties authority to receive evidence of all the matters contained or set forth in such memorial and that the members of Committee who sign such memorial formed a majority of the Committee at the respective times aforesaid nor shall any proof be required of the authority of the person before whom the oath verifying the said memorial shall appear to have been sworn to administer such oath.

- 6. Until such memorial as hereinbefore first mentioned shall be recorded in the manner herein directed no action suit or other proceeding shall be brought by the Club or any of the members thereof in the name of the Chairman of the Committee of the Club under the authority of this Act.
- 40 7. Every judgment and every decree or order which shall be at any time after the passing of this Act obtained against the Chairman on behalf of the Club shall and may take effect and be enforced and execution thereon be issued against the property and effects of the Club.
 - 8. It shall be lawful for such Chairman and his

successors in office from time to time to purchase any lands on behalf of the said Club or to accept a lease of and to hold by demise from the said Trustees for the purposes of this Act the said lands so granted as aforesaid or from any other persons any other lands it may be thought desirable to lease.

- All lands tenements and hereditaments real and personal and all personal chattels and effects which are now vested in or held by any person or persons whomsoever in trust for or for the benefit of the Club or the members thereof shall immediately upon the passing of this act become and be vested in and be held by the Chairman and his successors in such office in trust for the Club and in the like manner as if such Chairman and his respective successors in such office were in law a corporation sole and as if the personalty were real estate and all lands tenements and hereditaments real and personal and all personal chattels and effects which may hereafter be contracted for or be acquired by or belong to the Club or the members thereof collectively may be conveyed assigned and assured to and shall therefrom become vested in the Chairman and his successors in such office in trust for the Club and in the like manner as if such Chairman and his respective successors in such office were in law a corporation sole and as if the personalty were real estate.
- 10. The lands by this Act authorised to be demised to the Chairman shall be held by the Chairman and his successors in office only for the purpose of being maintained and used for a public racecourse or for one or other of the purposes in the said Deed of Grant mentioned under and subject to the provisions of this Act and any by-laws to be made under and by virtue hereof.
- 11. The Committee may maintain any building now standing and being upon the said land so to be vested in the Chairman or any part thereof and may also from time to time build or erect upon the said land or any other land for the time being vested in the Chairman either in addition to or substitution for the buildings now standing thereon all such other buildings as may in the opinion of the Committee be necessary or expedient for or in connection with the use of the said land as a public racecourse.
- 12. The Committee or an absolute majority in number

of such Committee present at any meeting duly summoned for that purpose may from time to time subject to the special provisions of this Act make such by-laws as they may think fit for regulating all matters concerning or connected with any lands authorised by this Act to be leased to the said Chairman on behalf of the Club or any lands which may hereafter be vested in the Chairman of the said Committee and the admission thereto and expulsion therefrom of members of the Club or any persons respectively and the rates or charges to be paid for such admission and for the general management of the said racecourse and may from time to time by any other by-laws alter or repeal any such by-laws. Provided that no such by-laws be repugnant to the laws for the time being in force in New South Wales and every by-law shall be reduced into writing and shall be signed by the Chairman.

- Every by-law shall forthwith on the expiration of one month after the same shall have been sent as aforesaid if not disallowed within that time be published in the Government Gazette together with a notice stating that when such by-law was sent to the Chief Secretary and that such by-law has not been disallowed and such by-law shall come into operation upon such publication.
 - The production of a copy of the Government Gazette containing any such by-law and notice as aforesaid shall be conclusive evidence that such by-law was duly made and not disallowed.
 - The Governor in Council may at any time by Order in Council declare that from a time to be named in such order and not less than six months from the date of the publication of such order in the Government Gazette any by-law made under this Act shall be repealed and from and after the times

named in such order such by-law shall unless previously repealed under the provisions herein contained be absolutely repealed and of no effect. - 21. Any member officer or servant of the Committee and all persons called by him to his assistance may seize and detain any person who shall have committed any offence against the provisions of this Act or of the by-laws made under this Act and whose name and residence shall not be given to such member officer or servant upon his requiring the same to be given and give such offender in charge to a police constable who shall convey him with all convenient despatch before some justice without any warrant or other authority than this Act and such justice shall proceed with all convenient despatch to the hearing of the complaint against the offender.

: The Valuer-General acting under the provisions of the Valuation of Land Act, 1916-1951, valued certain lands situated in the Municipality of Randwick as at 23rd September 1954, assigning to them an unimproved, improved and assessed annual value. The lands in question comprise, and are generally referred to as, the Randwick Race-course.

Objections against the valuations were duly lodged by the persons in whom the fee simple of the subject lands are vested (hereinafter referred to as the Trustees) their objection being upon the ground that the values assigned were too high, and also by the council of the Municipality of Randwick, its objection being upon the ground that the values assigned were too low. The Valuer-General, upon receiving the objections and not seeing fit to alter his valuations, duly forwarded them to the Land and Valuation Court pursuant to section 37 of the Valuation of Land Act for determination. the objections coming on for hearing before the Court, it was directed that they should be heard together; in course of that hearing certain preliminary questions arose and were argued on behalf of the parties as to the proper bases in law for making the valuations, in particular of the unimproved and improved values. 25th October 1957 continued. adopted an attitude of neutrality or submission to the Court's order as to the proper legal bases for these valuations, and the questions were debated upon the rival contentions for the Trustees on the one hand and the Council on the other.

The questions raised involve, amongst other things, a consideration of the recent decision of the Land and Valuation Court, in the case of The City of Sydney v. The Valuer-General, 1956 L.G.R., 229, the correctness of which was disputed by counsel for the Trustees; rather than enter upon "a lengthy and costly inquiry as to values which might prove abortive" the Judge of that Court, of his own motion, stated this case for the opinion of this Court under the power conferred upon him by s.17 of the Land and Valuation Court Act, 1916-1955.

The first question in the case is "whether in valuing the said lands under ss. 5 and 6 of the Valuation of Land Act, 1916-1951, the trusts, restrictions, conditions and provisos contained in the said grants and in the said Act of 1873 or any of them should be taken into consideration.

The lands in question are held by the Trustees as successors in title to the grantees under two Crown Grants made respectively on 15th June, 1863 and on 11th February, 1935. The earlier grant, which comprises the whole of the subject lands except an area of less than one acre, was made to the grantees upon certain trusts and contains certain restrictions as to the user of the land and certain powers and obligations on the part of the grantees and certain reservations in favour of the One of the powers expressly conferred upon the Trustees under the terms of the grant is a power to grant leases to, inter alia, an association called the Australian Jockey Club for a term not exceeding seven years.

In 1873 a private Act of Parliament called the Australian Jockey Club Act 1873 was passed. It is entitled "an Act to extend the period for which the Trustees of the Randwick Race-course are enabled to grant leases thereof and to enable the members of the Australian Jockey Club to sue and be sued in the name of the Chairman for the time being of the Committee of the said Club and for other purposes." In this Act the Crown Grant of 15th June 1863 is

recited in full, but the enacting provisions follow closely the long title which we have quoted and only alter the terms of the Crown Grant by extending from 7 years to 21 years the period for which leases might be granted to the particular body or bodies mentioned in the Crown Grant. The Crown Grant of 11th February 1935, which dealt with a small area of less than one acrea, was in the same terms as those contained in the earlier Crown Grant, except that the Trustees were authorised to grant a lease for a term of years not exceeding twentyone years, i.e. for the period authorised by the earlier Crown Grant as varied by the Act of 1873.

If considerations arising from the enactment and terms of the 1873 Act are omitted, the first question in the case raises one short point, namely, whether the recently expressed view of the High Court as to the proper construction of the expression "the fee simple of the land", where it is used in the Land Tax Assessment Act 1910-1950 in the definitions of "improved" and "unimproved" value, should be applied also in the construction of those words, where used in ss. 5 and 6 of the Valuation The opinion in question is expressed of Land Act. "The interpretation of the Act which as follows: seems best to accord with the policy appearing from its provisions and also to flow from its language is that in assessing the unimproved value an estate in fee simple must be taken as the hypothesis unencumbered and subject to no condition restricting the use or enjoyment of the land" (Royal Sydney Golf Club v. Federal Commissioner of Taxation, 91 C.L.R., 610 at 623). The question whether this interpretation should be applied to the provisions of ss. 5 and 6 of the Valuation of Land Act was examined in detail by Sugerman J. in his decision in Sydney City Council v. The Valuer-General he held that it should be applied and (supra); that consequently what had to be valued in ascertaining the improved or unimproved value of land under the Valuation of Land Act was a hypothetical fee simple freed from conditions and restrictions upon the use or enjoyment of the land as well as from encumbrances. We agree with the conclusion arrived at by Sugerman J. in that case and with the reasons advanced by him in favour of it, and think it unnecessary to traverse the same ground as he did (Cf. Commissioner for Railways v. Andreas

55 S.R. 323 at 327 & 332). The first question should then, so far as it relates to the Crown Grants, be answered in the negative.

An alternative argument has been submitted on behalf of the Trustees to the effect that the first question should be answered in the affirmative by reason of the provisions of the Australian Jockey Club Act, 1873. It is claimed that as that Act recites all the provisions of the Crown Grant of the 15th June, 1863, and in particular, those imposing restrictions on the use of the subject lands and on their alienation, those restrictions form part of the general statutory law of the state, and accordingly should be taken into account in determining value under ss. 5 and 6 of the Valuation of Land As already stated, the Act is a private one, its main provisions are summarised in the short title quoted earlier, and it only varies the Crown Grant in one respect, i.e. by enlarging the power of the Trustees to grant leases.

We see nothing in the Act to justify the conclusion that the restrictions on the Trustees' power of using and alienating the subject lands flow from "a Public law affecting the enjoyment of land" rather than "a restriction of title". Crown Grant creates the "restriction of title". The Act of 1873 does not create the restriction; all it does, by recitals, is to recognise the restriction already created, which must, having regard to the decision in Royal Sydney Golf Club v. Federal Commissioner of Taxation (supra at 624) be ignored because the provisions of the Valuation of and Act require the assumption to be made of "a hypothetical fee simple unencumbered and subject to no condition restricting enjoyment or use", other than restrictive conditions imposed by "a public law of the State affecting the enjoyment of land". contrary to the view we have taken, the restrictions should, as from the date of the enactment of the Act of 1873, be treated as created by that Statute, the source, being a private Act of Parliament, would not be "a public law" and the result would thus be the same.

For the reasons indicated above the submissions made on behalf of the Trustees on the first question in the case stated must be rejected, and the question answered in the negative.

The second question submitted in the stated case is, "Whether in valuing the said land as aforesaid the restrictions arising from the said notification by the Minister for Local Government under s.342Y of the Local Government Act should be taken into consideration.

It appears from the stated case that the subject lands were colored dark green on the scheme map referred to in the County of Cumberland Planning Scheme Ordinance; in other words, they were for a period subject to the provisions of Part II of the Ordinance, being reserved as "parks and recreation areas" and thus subject to the same restrictions on user under the Ordinance as were at the respective material dates applicable to the Golf Course dealt with by the High Court in the Royal Sydney Golf Club case (supra), and to Trumper Park, the land considered by the Land and Valuation Court in Sydney City Council v. Valuer-General (supra). It also appears from the stated case that on 24th October 1952, the Minister for Local Government notified, pursuant to s.342Y of the Act, the suspension in relation to the subject lands of the provisions of the prescribed scheme embodied in the Ordinance, and that thereupon the provisions of Division 7 of Part XIIA of the Act and of Ordinance 105 applied and still apply to the said Under Division 7 of Part XIIA "developlands. ment", as defined in s.342T, was forbidden except to the extent to which it was permitted by Ordinance or by a decision of the Council under the authority of an Ordinance (Sect. 342U). relevant Ordinance, namely Ordinance 105, permitted specified types of development to take place in c certain special cases, but in general required the consent of the Council to any change of user. terms of the notification of suspension under Sect. 342Y of the Local Government Act affecting the subject lands is not set out in the stated case; however, a copy was tendered in these proceedings and the parties have invited the Court to look at its provisions, notwithstanding the fact that it was not incorporated in the case. schedule to the notification identified the lands to which it applied as "the lands shown edged blue" on a number of maps stated to have been "prepared by the Cumberland County Council" and referred to by distinguishing serial numbers. schedule also contained a short general description

of the lands, as well as stating the municipality or shire in which they were situated. The subject land was described as "Randwick Race-course" and the description of the other lands, some forty-eight parcels in all, indicates that they are in the main Golf Courses, Race-courses, Sports Grounds, and the like.

The relevant statutory provisions applicable to the subject lands from and after the date of the notification under S. 342Y of the Local Government Act, like those applicable whilst they were subject to the provisions of Part II of the Ordinance, prohibited the lands from being used for any purpose other than that for which they had previously been used, unless with the consent of the appropriate Whilst the provisions of Part II of authority. the Ordinance applied, the Cumberland County Council was the authority with power to grant such a consent, with a right of appeal to the Land and Valuation Court against any refusal to grant it. After the land reverted to interim development control, i.e. by reason of the notification, the authority having power to grant consent to a change of user was the local Council, with a right of appeal to the Minister.

The issue for determination on this branch of the case is whether the restrictions on user of the subject lands are imposed by "a public law affecting the enjoyment of land", or, in other words, by "a law operating over an area of country within the State, which, though not large, is chosen independently of all questions of title or ownership and controlling the use to which owners in fee simple or for any less estate or interest may put the land"; or whether they arise from a "restriction of title", or, in other words, "an encumbrance or condition or restrictive obligation affecting the titles to specific parcels of land." (See Royal Sydney Golf Club case, supra at 624).

The subject land was taken out of the operation 40 of the Town Planning Ordinance of 1951 and made subject to the provisions of Division 7 of Part XIIA of the Local Government Act by a Ministerial decision and not by legislation. However, the fact that a Ministerial act brought about that change in the statutory planning provisions applicable to the subject land does not alter the fact

that the restrictions affecting the land at the relevant date were imposed by "a public law affecting the enjoyment of land" and not by "a restric-The Ministerial decision embodied tion of title". in the notification under s. 342Y was not, in any relevant sense, the source of the restrictions. It was merely the event upon the happening of which the restrictions on use and enjoyment of land contained in the relevant provisions of Division 7 of Part XIIA of the Local Government Act became applicable to the subject land. It has not been suggested, nor in our view could it be seriously contended, that the interim or temporary nature of the restrictions imposed by Division 7 of Part XIIA of the Act has any material bearing on the question of principle involved in this point.

As we are of opinion that the restrictions upon user imposed by the provisions of Division 7 of Part XIIA of the Local Government Act should be taken into consideration in the valuation of the subject lands under the Valuation of Land Act, we answer Question 2 as follows: Yes, the restrictions being those contained in Division 7 of Part XIIA of the Local Government Act.

The question as appearing in the stated case proceeds to ask, "and if so, in what manner and to what extent?" Neither party has addressed any argument to the Court on this branch of the question and accordingly we do not propose to deal with it except to the limited extent indicated by the answer set out above.

Paragraph 18 of the stated case summarises the submissions of counsel for the Trustees on the point raised by the second question in the case, from which it appears that one of the contentions on behalf of the Trustees before the Land and Valuation Court was that the decision of that Court in Thistlethwayte v. The Minister (19 L.G.R.87) was wrong. That contention was not developed, nor even put in this Court; accordingly we need not advert further to it.
