


A. H. M. ISMAIL :---Advocate, Barrister-at-law.

Law graduate of both Cambridge and London-in practice since 1929.

I am a nephew of the late Mr. N. D. H. Abdul Caffoor, the settlor of the Trust. I am one of the original trustees appointed under the Trust Deed. I still hold the office of Trustee and have been appointed Secre-20 tary by the Trustees. I have been Secretary from the inception of the Trust.

I produce copies of the minutes of the meetings of the Trustees from 20-1-1949-80-12-53-P 8.

I also produce copies of the minutes of the Board of the Abdul Caffoor Trust from June 1949-24, December, 1954-P4.

These minutes (both sets) show the disbursements made from the Trust Fund during the period covered by the minutes.

The decision to make any payment is in the first instance made by Trustees subject to confirmation by the Board. This is the practice. The ³⁰ reason for this is that it is difficult for the Board to meet frequently and on every occasion that a request is made for contribution from the Fund.

> Mr. Abdul Caffoor died on 1-11-48. In the minutes of a meeting of the Trustees (P3) held on 20-1-49, there is reference to a scholarship given to Dr. M. H. M. Hanza. He was sent to U. K. for post-graduate work and returned with high degrees. He was no relative or connection of the settlor.

Members of the settlor's family has been sent to England by their 10 parents e.g. Mrs. M. A. M. Hussain was the eldest daughter of the late Mr. Gaffoor. Her eldest son, Mr. Mahdi Hussain, entered Exeter College, Oxford in 1945 where he graduated and was later called to the Bar. He is reading in Chambers in London. All expenses of his studies were borne by his parents.

The 2nd son of Mrs. Hussain—Aly Fizal was sent to the Royal Grammar School, High Wycombe, Bucks, England in 1949.

From there he won a Scholarship to Oxford where he is studying medicine. All his expenses are borne by his parents.

The children of Mrs. Ghouse (2nd daughter) were educated in Ceylon 20 and all expenses borne by her.

Mr. Falil Gaffoor is a son of the settlor and his two sons. Alavi Navaz and Falil Fizal were educated in England, cost being borne by the Fund in the first instance. The reason was that the Estate of Late Mr. Gaffoor had not been fully administered and no distribution had been made to the heirs. Mr. Falil Gaffoor therefore applied to the Fund for Scholarship and he had undertaken to refund to the Trust the monies spent for the education of his two sons (vide P3-minutes of 29-9-43).

As regards second son I draw attention to P3—minutes of meeting held on 19-1-51.

Mr. N. H. M. Abdul Cader was a brother of the settlor. He had a number of children who were educated abroad. The Trust made no contribution towards their education.

From time to time the Trust has granted loans to the Estate of the deceased settlor. These were given from the building reserve that is being built up.

It is contrary to Islamic Law and religion for a Muslim to lend No. 1 Proceedings money on interest. The money which was collected in the Building Fund before the could not be used for any investment because it had to be regularly $\stackrel{\text{Commission-}}{\text{available so that the Trustees thought it advisable to loan the money free Tax of interest to the Administrator of the settlor's Estate so that it could be <math>\stackrel{\text{Marked X 1}}{\text{15-2-56}}$ readily available when required.

Similarly I have given loans to the Firm of N. D. H. Abdul Gaffoor The late Mr. Gaffoor carried on the business of a jeweller and dealer Ltd. in gems and textiles from about the year 1895. This business was the 10 source from which the capital of the present Trust Fund came into existence.

The business was floated into a Limited Liability Company by the late Mr. Gaffoor himself in 1945. The Trustees on occasions lent money free of interest from the Building Reserve to the firm. This money is also available when called for.

The Trustees have drawn out a scheme for constructing a third floor on the Gaffoor's building which is situated in the Fort and belongs to the Trust. The monies which have been given to the Administrator and the firm will have to be recalled shortly.

20 The minutes (P3 and P4) show large contributions made from time to time to educational institutions and also monies given as dowries and other assistance to members of the Islamic faith.

XXed.

The final authority is the Board. During the life time of Mr. Gaffoor he made the distributions with the prior approval of the Board—at the first meeting the Board decided that Mr. Gaffoor could make the distributions and only if there was any particular difficulty the Board need be consulted. The minutes books of the Board will be made available to the Assistant Commissioner.

80 Mrs. Ekanayake refers to item 6 of minutes of 20-1-49 (P3). There is no rule or provision for the granting of loans. The Trustees did it on their own responsibility.

We could not make investments giving interest. The money was lying idle. The giving of loans without interest is a type of charity.

In the same minutes there is a reference to a loan of Rs. 2,500/- to Mr. Mohideen A. Gaffoor. He is a son of the settlor.

The loan is not given on any security. The loan was given on 1-1-49. It has only been partly returned. He has taken further loans 1950, 1951, 1952 and thereafter.

The balance due from him on 31-12-54 was Rs. 7,649/19.

At 31-12-54 Mr. Falil Gaffoor owes no money.

At 31-12-53 he owed Rs. 39,350/-.

Meeting on 31-3-49 (P3)—We have money in our Reserve Fund which are prevented from investing and earning interest. When we find that there is a genuine case where a loan will be helpful and we are certain that the loan will be returned we make the loan as a charitable act.—Loan of Rs. 6,000/- must have been paid back. 10

Dowries referred to in this minute were given under 2 (d) and 2 (g).

Mr. Wahab is a consanguine brother of the settlor. He stays in Dematagoda Road. He has no income. He married the late Lady Macan Markar's younger sister. He received dowry, property worth Rs. 75,000/- in 1920. He did business between 1920—1926, incurred a debt of about Rs. 30,000/-. His wife sold her property to pay his debt. He is a pauper today. During the last 15 years he and his wife own no property. Mrs. Wahab is being helped by her sisters and nieces, Mr. Wahab is being helped by his relations.

Mr. and Mrs. Naina Marikar—Mr. Naina Marikar owns no property.²⁰ Mrs. Naina Marikar owns properties—she has seven children. Her income is about Rs. 300/- to Rs. 400/- a month.

90% of the donations given were to other than members of the settlor's family. The members of the family are not in need, but they were in difficulties pending administration of the Estate—Rs. 2,000,000/- has been paid in Estate Duty, during the last eight years and a further claim of Rs. 2,000,000/- additional duty has been made. Property to the value of Rs. 2,000,000/- had to be sold to pay duty.

Charity begins at home. As far as Mr. Gaffoor's heirs are concerned they were helped by loans to overcome temporary loans pending ad-³⁰ ministration.

The Trust property which was transferred is valued at Rs. 2,050,000/-.

Mr. Gaffoor earned all his money from his business. He did not inherit any money.

Mr. Usoof A. Gaffoor had a loan of Rs. 3,500/-. He is a son of $\frac{Marked X1}{15-2-56}$ Mr. Gaffoor. -continued.

Loans are given to outsiders also-vide loan to Mrs. Naina Marikar for wedding expenses.

Item 5 (c) donation to Mr. H. H. M. Mohideen towards a dowry to his daughter-he is a very poor man.

Mr. Falil Gaffoor has not repaid monies spent on the education of his sons, as he has not yet received his share of the Estate.

Rs. 1,000/- to Mr. M. S. M. Haddad on behalf of his sister. His sister is a daughter of the late Mr. H. M. Saly who was employed under Settlor 20 for 20 years, as an Assistant Salesman. A. H. M. ISMAIL

On the last occasion I testified to the amounts payable as Estate Duty by the estate of the deceased settlor.

I since got the details :---

The estate was valued at Rs. 10,001,842/-. The duty payable @ 30% is Rs. 3,001,842/-. The interest @ 4% from 2-11-49 to 1-11-55 is about 2 lakhs.

About 29 lakhs have been paid already. We have not yet been able to close the Estate and make a final distribution of assets although Mr. Gaffoor died on 1-11-48. 30

The daughters of the settlor had been dowried at the time of their marriage and hence they were able to look after the education of their children without any assistance from the Estate. They were married before the Trust was created. The education of the children of the sons could not be postponed till $\frac{No.2}{Proceedings}$ the distribution of the Estate and the Trust Funds came to their before the assistance but on the understanding that there would be a refund on the Commissioner of Income Tax Marked X 1

The sons and the widow have received assistance from the Trust $\frac{3\cdot3\cdot56}{--continued}$. Fund.

The widow has to get about Rs. 65,000/- from the Estate being a debt due to her. That too has not been paid. The amount advanced to Mrs. Gaffoor will be refunded when the administration is complete.

¹⁰ As regards the money due from the Company; this was advanced from money which constituted the Building Reserve and is available on call to any time.

This matter came up in appeal before. The assessee was represented by Senior Counsel both before the Commissioner and the Board and we incurred considerable expenditure in connection with the appeals. These minutes and accounts were available even then.

The appeal was heard by the Board on 23-11-54. It was with regard to the year of assessment 1949/50. It was heard by the Commissioner on the 23rd and 29th June, 1954.

Facts: On the 24th day of December, 1942, Mr. N. L. H. Abdul Gaffoor who was the owner of the buildings known as the Gaffoor Build-40 ings by Deed No. 1832 (produced and marked R1) attested by Mr. C. M. G. de Saram, Notary Public, transferred the said property to four trus-

tees to be held by them in accordance with the terms set out in Decd No. 3 No. 1833 (produced and marked P1). The four trustees had to manage tion of the the property, collect the rents, pay rates and attend to repairs and Commissioner of Income maintenance, and to apply the balance income for all or any of the seven Tax and purposes set out in Clauses (a) to (g) of paragraph 2 of the Deed as Reasons decided by a Board consisting of the trustees and seven others at its Section 71(2) absolute and uncontrolled discretion.

Ordinance The Grantor retained the right during his life time to direct the Marked N 2 trustees to apply the funds in whatever manner he liked. The Grantor <u>--continued</u>. 10 died on the 1st November, 1948.

The question whether the Trust Deed No. 1833 of 24-12-42 (P1) creates a Charitable Trust the income of which is exempt from taxation in terms of Section 7 (1) (c) of the Income Tax Ordinance came up for consideration in the appeal for the year of assessment 1949/50. I decided that in view of Clause (b) of paragraph 2 of the Deed the Trust was not one of a public character established solely for charitable purposes and that the income was therefore liable to tax under our Ordinance. The Trustees appealed to the Board of Review which took the view that I was wrong and that the Trust was one of a public charactor established 20 solely for charitable purposes. That appeal went no further.

The question has come up again in connection with appeals against assessments made on the Trustees for the years of assessment 1950/51, 1951/52, 1952/53, 1953/54 and 1954/55. The appeals were argued more fully, one of the Trustees gave evidence and was questioned on the administration of the Trust Funds and the accounts covering the period 1st January, 1948 to 31st December, 1953 were produced and examined. Copies of the Minutes of the Meetings of the Trustees and of the Board are also in evidence.

The current annual income of the Trust is Rs. 194,000/-. Out of this ³⁰ a sum of Rs. 45,578/- is paid as taxes. The deed requires or authorises the following expenditure per annum :---

 - for the relief of poverty distress or sickness amongst members (4) of the Islamic Faith in Ceylon.

P5 which was produced and relied on by Counsel for Appellant gives a summary of income and expenditure over the years 1948-1953. From this it appears that the expenditure over the six years was more than the income and that the reserves have been reduced by about Rs. 22,000/-.

It may be noted however that even after excluding taxes the expenditure on buildings and administration over the six years is about Rs. 273,000/- although the amounts allowed by the Trust Deed is 20 Rs. 144,000/-.

The analysis produced by the Assistant Commissioner clearly shows that there is considerable expenditure on the buildings and administration beyond what is allowed under the Trust Deed. This analysis also shows that at 31-12-53 a sum of Rs. 266,662/- had been given out as interest free loans. Out of this sum Rs. 223,960/- had been given out as a loans to the Donor's business, the Donor's widow and the Donor's sons as follows:-

Determination :

The appeals are dismissed.

Reasons :

1. It was urged at the out set of this appeal that the decision of the 30 Board of Review (P2) in connection with the Trustees' appeal against the 1949/50 assessment must be regarded as *res judicata* and binding on the Assessor in all subsequent years.

2. This was not argued in detail before me and I do not think that the principal of *res judicata* applies to decisions of either myself or the Board of Review. It is of course usual that the Department follows the decisions of the Board of Review but it may be recalled that the Incorporated Law Society of Ceylon, although the Board of Review held against the assessments for 1948/49 and 1949/50, took up the same point in an appeal against the assessment for 1950/51, and took this appeal to 40 the Supreme Court.

5. The material proportion of Section 7(1) (c) reads as follows:—

"There shall be exempt from the tax the income of any......trust 10 of a public character established solely for charitable purposes".

6. The trust property is known as "Gaffoor building" and the application of the income thereof is provided for in paragraph 2 of the said deed. Paragraph 2 (a) provides for the remuneration of the trustees and the expenses incurred by them in the administration of the trust. The purposes of the trust are set out in sub-paragraphs (b) to (g) of paragraph 2.

7. The question whether the income of this trust is exempt from the tax is entirely a matter of construction of the terms of the trust deed. In Keren Kayemeth Le Jisroel Ltd. vs. the Commissioners of Inland Revenue, reported in 17 Tax cases, Lawrence L. J. states at page 43 ".... 20 the court is not concerned with the motives or ultimate aims of the founders...... as to the true character of the objects of the company, but it is solely concerned with the meaning and effect of the language Again in the case of Tennent Plays Ltd. vs. the employed....." Commissioners of Inland Revenue (30T.C. 107) even though it was found on the evidence that the company had confined its activities to objects which were charitable nevertheless in view of the fact that the memorandum contained objects which were not charitable The court of appeal held that the company was not "established for charitable purposes only".

8. Proceeding now to consider the purposes set out in the memo-30 randum the following words of Lawrence, L. J., in the case already referred to and reported in 17 T.C. at page 40 must be borne in mind.

"It is not enough that the purposes described in the memorandum should include charitable purposes the memorandum must be confined to those purposes so that any application by the company of its funds to non-charitable purposes would be ultra vires ". At this stage it might also be useful to quote the words of Lord Eldon in the case of Morrice vs. the Bishop of Durham (10 Vesey 522).

9 Now coming to a consideration of the provision of paragraph 2(b) of this deed the question which I have to answer is not whether under this sub-paragraph the trustees could have applied income from the trust property to purposes charitable, but whether they could have applied such income solely to charitable purposes so that if income could have been lawfully applied to purposes which were not charitable then the income from this trust would not come within the exemption provided 20 for in Section 7(1)(c). Paragraph 2 (b) reads as follows :—

"A sum not exceeding in all one thousand rupees (Rs. 1000/-) a month for the education, instruction or training in England or elsewhere abroad of deserving youths of the Islamic Faith in such professions, vocations, occupations, industries, arts or crafts trades employments subjects line or any other departments of learning or human activity whatsoever as the Board may in its aforesaid discretion decide in the case of each such deserving youth with a like discretion in the Board from time to time to change, modify or alter or completely discontinue in the case of each such youth either the object or objects of instruction, education or ³⁰ training selected for him by the Board (from among the objects enumerated above) or the place or places or countries whereat such education training or instruction is being given from time to time the Board may under a like discretion partially or wholly discontinue any assistance it may have given or may be giving in the case of any of such youths. Now this paragraph is very widely framed. The question is whether it is possible for the trustees to have utilised any part of the income from the trust property for non-charitable purposes. "Charitable purpose" is defined in Section 2 of the Income Tax Ordinance as follows :—

"Charitable purpose" includes relief of the poor, education and medical relief. It will be noted that the definition though referring specifically to the relief of poverty, education and medical relief is not an exculsive definition and further exemption from tax in the case of religious bodies or institutions is provided for in paragraph 7(d). It could be contended that the purposes set out herein are charitable purposes 20 coming within the category of Education, but in my view the paragraph is so widely framed as to make it possible for the trust income to be applied for purposes not strictly educational but which come only within the term education used in a very loose sense, for it is to be noted that under this sub-paragraph the income could have been utilised to give "instruction or training" in "any departments of learning or human activity". In this connection, though not exactly in point, it would be useful to refer to the case of Baddeley and others vs. the Commissioners of Inland Revenue (35 Tax cases pg.661). In this case properties were conveyed to trustees on trust "for the promotion of the religious, social 30 and physical well-being of persons resident in the Country Broughs of West Ham and Leyton.....by the provision of facilities for religious services and instruction and for the social and physical training and recreation of such aforementioned persons who.....are.....members or likely to become members of the Methodist Church and of insufficient means otherwise to enjoy the advantages provided.....and by promoting and encouraging all forms of such activities as are calculated to contribute to the health and well-being of such persons". It was argued before the House of Lords that the validity of the trust could be sustained on the ground that, regarded as a whole it was an educational charity.40 Viscount Simonds (at pg. 696) states as follows:----

"The short answer appears to me to be that, regarded as a whole the sum of the activities permissible under the deed can only be regarded as educational in the sort of loose sense in which all experience may be said to be educative and that if such activities are examined one by one, No. 3 it would be impossible to regard many of them as in even the loosest tion of the sense educational". In my view paragraph 2 (b) is so framed as to make Commissionit possible for the trustees to apply trust income for non-charitable Tax and purposes. I, therefore, hold that this is not a trust "established solely Reasons for charitable purposes".

of the

10. I now come to a consideration of sub-paragraph 2(f) of the Income Tax trust deed which reads as follows :---

"A sum not exceeding one thousand rupees (Rs. 1000/-) a month to 10 be accumulated from month to month and distributed for charity once a year during the month of Ramalhan".

The distinction between "charity" in the popular and legal sense is well-known. Charity in the popular sense would include not merely charity in the legal sense but also benevolence, and in my view, in this paragraph the word "charity" is used in its popular sense and I, therefore, hold that the provisions of this paragraph, 2(f), make it possible for the trustees to utilise trust income for non-charitable purposes. On this ground too, I hold that the income of this trust is not exempt from tax under the provisions of Section 7(1) (c).

20 11. There is a more fundamental objection to the granting of exemption to the income of this trust in view of the proviso to paragraph 2 which reads as follows :---

"PROVIDED however that during the life time of the Grantor the Trustees shall apply the nett rents profits dividends and Income of the trust property for such purposes and in such manner as the Grantor in his absolute discretion whether such purposes shall fall within the objects specified in any provision above or not may through the Board direct."

This proviso gave the author of the Trust power to deal with the income of the trust property in his absolute discretion even to the extent of 30 appropriating it for his own use. In this connection, I would refer to the case of Rex vs. the special Commissioners of Income Tax (Ex Parte Rank's Trustees)-8 T.C. 236.

In this case Mr. Joseph Rank by an indenture executed in March, 1917, had settled upon trustees' certain funds to be held, together with the income thereof, upon trust "for the benefit of such persons institutions or purposes as the said Joseph Rank shall by any writing under his hand or by Will appoint". In default of any such appointment the deed provided that the trust funds and income were to be held by the trustees upon trust for the benefit of the Wesleyan Methodist Church.

40 The trustees applied for repayment of tax deducted at source claiming exemption under Section 37(1) (b), of the Income Tax Act, 1918, which is as follows:—

You gave evidence earlier on this matter before the Commissioner? Q.

- You are a Muslim? Q.
- Yes. A.
- Q٠ You refer to the distribution of certain sums of money in paragraph 2(f) of P.1 for charity for one year during the month of Ramalhan? (Shown paragraph 2(f) of P.1)

Yes. Α.

The month is the 9th month? Q.

- A. 9th month of the Arabic year. The month is called in Arabic Evidence of "Ramalhan", but in English it is always referred to as "Rama-Ismail Exzan" for this reason. When the British went to India the Indians were not able to pronounce the word. They pronounced 'IL as 'z'. So Ramalhan was always pronounced as Ramazan.
- Q. What exactly is the significance of this month to the Muslims?
- A. That is the month in which the Muslims fast during the whole of the month, 29 or 30 days.
- Q. Every Muslim is obliged to fast?
- 10 A. Yes. It is one of the five pillars of Islam.
 - Q. Is it correct to say that there is a custom to distribute money as charity during this month?
 - A. Yes. They distribute alms to the poor.
 - Q. Why do they distribute? Can you give the reason?
 - A. It is one of the injunctions of the religion of the Islamic Religion — to distribute charity during the month of Ramazan.
 - Q. What is meant by Charity food, clothing and money?
 - A. Yes. Or money to purchase food and clothing given to the poor.
 - Q. Are people expected to work during this period?
- ²⁰A. No. they cannot work during this period.
 - Q. Especially the labourers, when they fast, they cannot work?
 - A. Yes.
 - **Q.** The rich compensate them?
 - A. Yes.
 - **Q.** Charity is given only to the poor?
 - A. Yes.

Cross Examination

- Q. What exactly is meant by fasting?
- A. Fasting is observed between sun rise and sun set and no morsel of food or any drink is partaken by the person fasting. It is a rigorous fast of 14 to $14\frac{1}{2}$ hours a day.
 - Q. And between sun-set and dawn?
 - A. It is not sun-rise actually. It is one hour and 35 minutes before sun-rise. Between sun-set and dawn you can take any food.

- Èvidence of Q. A. H. M. Ismail Examination
 - . How exactly is this distribution done. You said you distribute alms or charity?
- *continued.* A. This could be seen even in the Pettah. People who are known to be poor come to the door and they would be given alms. Also poor people who cannot come, or ladies, widows and orphans, alms would be taken to them. To some money is sent.
 - Q. How much would you give them?
 - A. It all depends. Rs. 1/-, Rs. 2/-, Rs. 5/-, Rs. 10/- or Rs. 15/-. There are different categories of persons. A widow of 50 or 60 might get about Rs. 25/-. It is given according to their needs. 10
 - Q. In this particular case what was done under the terms of this Deed?
 - A. We followed the practice of Mr. Caffoor. During his time he used to distribute charity and we followed it. He has distributed something like Rs. 15,000/- to Rs. 18,000/-.
 - Q. Were you aware of this?
 - A. Yes. It is to my knowledge?
 - Q. You knew it in the sense that you knew it of your own personal knowledge?
 - A. I knew it by having access to the account books.
 - **Q.** You know what exactly happened?
 - A. Yes. From 1924. I was attending to his business from 1924 onwards, excepting for the four years that I was in England.
 - Q. Giving charity is mentioned in the Koran. Can you state what the words of the Koran are in this respect?

 - Q. You have seen Mr. Caffoor distribute alms?
 - A. Yes.
 - Q. Under the terms of the trust you distributed the money?
 - A. Yes. A number of people attended to take alms during the month.

- Q. Are all those who came for alms only Muslims?

Q. What is the reference to the distribution of alms?

I will quote — Chapter 2 verse 267 :—

"O you who believe, spend of the good things that you earn and of that which we bring forth for you out of the earth, and aim not at the bad to spend thereof, while you would not take it yourselves unless you connive at it. And know that Allah is self-sufficient, praiseworthy".

Verse 270:---

"And whatever alms you give or (whatever) vow you vow, Allah surely knows it. And the wrong-doers shall have have no helpers" 10

Verse 271 :---

"If you manifest charity, how excellent it is? And if you hide it and give it to the poor, it is good for you. And it will do away with some of your evil deeds; and Allah is aware of what you do".

Verse 272 :---

"Their guidance is not thy duty, but Allah guides whom he pleases. And whatever good thing you spend, it is to your good. And you spend not but to seek Allah's pleasure. And whatever good thing you spend, it will be paid back to you in full, and 20 you will not be wronged".

Verse 273 :---

"(Charity) is for the poor who are confined in the way of Allah, they cannot go about in the land; the ignorant man thinks them to be rich on account of (their) abstaining (from begging). Thou canst recognize them by their mark—they beg not of men importunately. And whatever good thing you spend surely Allah is knower of it".

Q. Yesterday, you referred to to page 483 of the book "The Religion of Islam by Maulana Muhammed 'Ali, i.e. this quotation:—

"But the appearance of the moon of Ramadzan is a signal for a mass movement towards equality which is not limited to one vicinity or even one country but affects the whole Muslim world. The rich and the poor may stand shoulder to shoulder in one row in the mosque, but in their homes they live in different environments. The rich sit down on tables laden with dainties and with these they load their stomachs four, or even six, times daily; while the poor cannot find sufficient with which to satisfy their hunger even twice a day. The latter often feel the pangs of hunger to which the former are utter strangers; how can the one feel for the other and sympathize with him? A great social barrier thus exists between the two classes in their homes, and this barrier is removed only when the rich are made to feel the pangs of hunger like their poorer brethren and go without food

Re-examination ---continued. for a day, and this experience has to be gone through, not for a day or two, but for a whole month. The rich and the poor are thus, throughout the Muslim world, brought on the same level in that they are both allowed only two meals a day, and though these meals may not be exactly the same, the rich have perforce to shorten their menu and to adopt a simpler fare and thus come closer to their poorer brethren. This course undoubtedly awakens sympathy for the poor in the hearts of the rich, and it is for this reason that the helping of the poor is especially enjoined in the month of Ramadzan."

- A. Yes.
- Q. You also draw attention to page 502 of the same book when you quote:---

"The moral value of the fasting discipline is further enhanced by laying stress on the doing of good to humanity in the month of Ramadzan. The example of the Holy Prophet, is quoted in this connection in a hadith: 'The Holy Prophet, may peace and the blessings of Allah be upon him, was the most bountiful of all people, and he exceeded his own bounty in the month of Ramadzan.' In another hadith it is stated that the Holy 20 Prophet used, on the arrival of Ramadzan, to free every captive and to give alms to every beggar. A third describes the month of Ramadzan as a month in which the sufferings of the poor and the hungry must be attended to'."

- Q. What is a Hadith?
- A. The sayings and acts of the Prophet which is also the second source from which I can gather the tenents of my religion.
- Q. During this 14-hour period of fasting, you are not even allowed to drink water?
- A. No, not allowed.
- Q. It is so rigorous that I believe you are not even allowed to swallow saliva?
- A. Yes.

(The passages which I quoted from the Koran yesterday are from the 1951 Edition of Maulana Muhammad 'Ali's *The Religion* of *Islam*, which I have also cited today.)

- Q. You said that when someone comes to the doorstep for alms it is easy to say whether he is a beggar or not. Is it customary to make inquiries from such persons as to their means before you give alms?
 - A. No.

1. The facts relating to these appeals are stated in the determination of the Commissioner. They are not in dispute. The Commissioner has held that Deed. 1833 of 24th December 1942(P1) did not establish a Trust solely for charitable purposes and has therefore dismissed the appeal against the assessment made by the Assessor, We shall first deal with the points made by the Commissioner on which he has based his determination.

2. There was a previous appeal to the Board of Review against the 30 assessment of Income Tax in respect of the income from this Trust for the year of assessment 1949/50. The Board of Review which heard that appeal held that the Trust was of a public character established solely for charitable purposes and that the income was exempt from Income Tax. A copy of the Judgment of that Board of Review has been put in evidence, marked P2. There was no appeal from that decision to the Supreme Court. The Commissioner has held that the principle of 'res judicata' does not apply to decisions either of himself or of the Board of Review. In the argument before us, Counsel for the appellant did not abandon this ground of appeal although he argued the appeals on their No. 5 merits. We are of opinion that the previous decision of the Board of Decision of Review which relates to an assessment for a year previous to the years Review of assessment which are now before us is not binding on us. —continued.

3. We are in agreement with the Commissioner's statements in paragraphs 7 and 8 of his determination as to the manner in which this question now before us should be determined, namely, that the question whether the income of the Trust is exempt from Income Tax or not must be determined entirely on a construction of the terms of the trust deed and not by the manner in which the Trustees had acted in the administration of the Trust; nor are we concerned with the motives or ultimate 10 aims of the author of the Trust except in so far as they are given expression to in the deed. We also wish to state that we are mindful of the fact that the burden of proving that the income of this trust is exempt from income tax lies on the appellant.

4. In paragraph 9, the Commissioner proceeds to deal with the provisions of paragraph 2 (b) of the Deed and finds that the terms of this paragraph do not provide solely for a charitable purpose in view of the fact that the paragraph is so widely framed as to make it possible for the Trust income to be applied for purposes not strictly educational but which would come within the term "education" only when used in a 20 very loose sense. He relied on the case of Baddeley & Others v, the Commissioners of Inland Revenue (35 T. C., p. 661). We are of opinion that the terms used in Baddeley's case are very much wider than the terms used in the Deed now under consideration and that case has therefore no application to the present case. We have had the benefit of the arguments adduced by Counsel on both sides with regard to this paragraph and also have considered the authorities cited by them. The Judgment in the English Case-Re Shaw's Will Trusts. The National Provincial Bank Limited v. The National City Bank Limited and others (1952-1 A.E.R., p 49) is, in our opinion, more in point. The words in 30 the Deed under consideration to which emphasis was given by the Counsel for the Commissioner are the following : "Education, instruction or training in subjects, lines or any other departments of learning or human activity whatsoever". He argued that these words were so wide as to empower the Trustees to expend the funds for purposes other than strictly educational. The words used in the Will considered in Shaw's Will Trusts case specifying one of the objects of the trust were as follows :----

"The teaching, promotion and encouragement in Ireland of selfcontrol, elocution, oratory, deportment, the arts of personal 40 contact, of social intercourse and the other arts of public, private, professional and business life ".

It was held that although these wide terms were used, the trust in

question was for an educational purpose and therefore was a valid No 5 charitable trust.

the Board of Review marked X4 —continued.

Paragraph 2 (b) of the Deed (P1) may be split up as follows :---

- 1. Education, instruction or training
- 2. in England or elsewhere abroad

10

- 8. of deserving youths of the Islamic faith
- 4. in such professions vocations occupations industries arts or crafts trades employments subjects lines or any other departments of learning or human activity whatsoever as the Board may in its aforesaid discretion decide in the case of each such deserving youth.

It will be seen that the purpose of this trust is governed by what is stated in 1 above—"education, instruction or training". The use of the words "subjects, lines or any other departments of learning or human activity whatsoever" in 4 must be read in conjunction with what is stated in 1. Crown Counsel argued that the use of the word "training" with the words quoted above from 4 would take the object out of the scope of education. We do not agree with that construction. We are of opinion that the word "training" must be construed ejusdem generis with 20 education and instruction; and also that the words "subjects, lines or any other departments......or human activity whatsoever" must also be construed ejusdem generis with professions, vocations, occupations, etc., referred to in 4.

We therefore hold that all the objects contained in paragraph 2 (b) are solely educational.

5. With regard to the provision in the latter part of paragraph 2 (b) that in selecting from the primary class of deserving youths of the Islamic faith preference should be given in the first instance to the male descendents of the grantor or of his brothers and sisters, we do not think so that that provision would in any way take this trust out of the field of a charity of a public character.

We agree with the decision of the previous Board of Review on this matter which was based on the decision of the English Courts in the case of Re Koettgen (deceased)—Westminster Bank Limited and Another v. National Welfare Association Trustees Limited and others (1954—1 A.E.R., p. 581).

6. In paragraph 10 of this determination, the Commissioner holds that sub-paragraph 2 (f) of the deed makes it possible for the Trustees to

No. 5 utilize the income of the Trust for non-charitable purposes as the word the Board of " charity " in this paragraph is used in its popular sense and may include Review marked X_4 benevolence. This sub-paragraph requires the Trustees to spend a sum -continued, not exceeding Rs. 1,000/- a month, "to be accumulated from month to month and distributed for charity once a year during the month of Ramalhan". We have allowed Counsel for the appellants to lead the evidence of Mr. Ismail, one of the Trustees, as to the meaning of the words" the month of Ramalhan" and also as to the practice among the Muslims of the distribution of alms during this month. Ramalhan is what is usually known as Ramazan in India and Ceylon, during which 10 period Muslims fast from dawn to sunset and alms are distributed to the poor people, mainly of the Muslim community. We are of the opinion that the use of the word "charity" in this sub-paragraph does not include the idea of mere benevolence, but denotes the relief of the poor and that the purpose therefore is a charitable purpose within the legal sense.

> 7. In paragraph 11 of his determination, the Commissioner says that there is a more fundamental objection to the granting of exemption in view of the proviso to paragraph 2 of the deed, which gave the author of the trust the power to deal with the income of the Trust property in 20 his absolute discretion even to the extent of appropriating it for his own use. He relies on the case of Rex v. The Special Commissioners of Income Tax (ex parte Rank's Trustees) (8 T.C., p. 286) where there was a similar provision in the Deed considered in that case. We are of opinion that this case has no application to the Deed now under consideration because the author of the Trust viz., Joseph Rank was living at the time when the Deed came up for consideration, whereas in the present case Mr. Abdul Caffoor died on 1st November, 1948 and the present appeals deal with the years of assessment after his death.

> Crown Counsel urged that this Deed must be construed as at the 30 date when it was executed, for the Trust was established at that date and the words in Clause 7 (1) (c) of the Income Tax Ordinance are "established solely for charitable purposes". His argument was that the "establish" means create or set up and that a Trust could only be set up once. If the Crown Counsel's contention is correct then this Trust is not one established solely for charitable purposes because the proviso enabled the grantor to direct that the Trust funds should be applied for any purposes whatsoever, whether such purposes fall within the objects specified in Clause 2 or not. We are unable to agree with the interpretation of the words "solely established" in Section 7 (1) (c) as stated by 40 Crown Counsel. We are of the view that the terms of the trust deed must be construed in accordance with the facts as they exist at the time it becomes necessary to construe it for Income Tax purposes. At the relevant time this part of the proviso had ceased to be operative, the grantor being dead, and the trustees were bound to administer the trust only in accordance with paragraphs (a) to (g) of this clause. We are of

opinion that with regard to the periods of assessment now under con- $\frac{No. 5}{Decision of}$ sideration the trust deed is one solely established for charitable purposes, the Board of Review

8. Crown Counsel also argued that paragraph 2 of the deed gives <u>marked X 4</u> the trustees an absolute and uncontrolled discretion in the expenditure of trust funds, and that even if they spend them for non-charitable purposes, neither a Court nor anybody else could question their decisions in view of the terms of the second part of the proviso to this paragraph. He also pointed to the fact that according to the accounts produced in evidence and the minutes of the meetings of trustees, funds have been 10 expended on matters which do not come within the purview of subparagraphs (b) to (g), such as loans to Abdul Gaffoor Limited, Falil Gaffoor and others, and donations to the Board of Control of Cevlon Cricket, Ceylon Police Fund, Gulam Mohamed Reception Fund, Batticaloa Muslim Election Fund, etc. Counsel for the appellant while conceding that some of these payments were outside the provisions of the trust deed stated that a Court could interfere under the Trusts Ordinance and order the trustees to re-imburse expenditure not covered by the terms of the deed. He further argued that the discretion given in this paragraph did not enable the trustees to act outside the purposes stated 20 in sub-paragraphs (b) to (g), but they could exercise their discretion only if they acted intra vires of these provisions.

9. We are of the view that the manner in which the trustees acted in the instances quoted would not make the Trust a non-charitable trust as the question whether the trust is solely one for charitable purposes or not has to be determined by the terms of the deed. We are of the opinion that the "absolute and uncontrolled discretion" vested in the trustees does not enable them to act outside the objects given in clause 2 (b) to (g), and that their discretion is limited to matters like the course of instruction to be followed, the place of instruction abroad, the choice of **30** beneficiaries from among eligible applicants, etc. That it is the discretion that cannot be questioned, but if they act outside the purview of clause 2 (b) to (g) a Court can question the exercise of their discretion. The cases cited by Crown Counsel on this point, viz., Keren's Case (17 Tax Cases-page 27) and Associated Artists Limited v. Inland Revenue Commissioners (1956-2 A.E.R. 583) do not apply as, according to the powers vested in the companies in those cases, they were given the absolute discretion to decide what was and what was not conducive to the attainment of the primary object. Their exercise of discretion was subjective and not objective as in the present case.

10. Crown Counsel also drew attention to the use of the words 40 " in furtherance of all or any one or more of the various objects of the trust" used in sub-paragraph (g) which relates to the expenditure of surplus funds and argued that this enabled the Trustees to spend these funds on whatever object they decided was in furtherance of the Trust. Counsel for the appellant urged that the expression " in furtherance of "

No. 5 means "for" or " on " and that the words " conducive to " which is the Decision of Decision of the Board of expression used in the cases relied upon by Crown Counsel are much Review wider than the words "in furtherance of". We are of the opinion that marked X_4 the use of these words "in furtherance of" does not enable the Trustees to spend any of the surplus funds on objects other than those specified in this clause, the discretion allowed to them being limited to a choice among the objects specified therein. We therefore hold that the vesting of a discretion in the Trustees by this clause does not take away the charitable character of the trust deed.

> 11. In the result we are of the opinion on a construction of the 10 terms of the deed P 2, omitting the first sentence of the proviso to clause 2 which is inoperative, that the trust established is one of a public character and solely for charitable purposes.

We therefore hold that the income from this trust is exempt from Income Tax under Section 7 (1) (c) of the Income Tax Ordinance and allow the appeals.

The Facts are as follows :---

1. Mr. N. D. H. Abdul Gaffoor, owner of buildings known as the so Gaffoor Buildings, by deed No. 1832 marked R 1 transferred the said property to trustees to be held by them in accordance with the terms of the Trust Decd No. 1883 of 24th December 1942, marked P1. The grantor retained the right during his life time to direct the trustees to

apply the funds in whatever manner he liked. The grantor died on 1st November 1948. The Trustees had to manage the property; collect the -continued. rents, pay rates, attend to repairs and maintenance and to apply the balance income for all or any of the seven purposes set out in sub-paragraphs (a) to (g) of paragraph 2 of the Trust Deed P1 as decided by a Board consisting of the trustees and seven others in their absolute and uncontrolled discretion.

> 2. From the accounts produced in evidence and the minutes of the meetings of trustees it was found that during the period 1st January 1948 to 31st December 1953 (a) the trustees had incurred considerable 10 expenditure on the buildings and the administration beyond what is allowed under the Trust Deed (b) that they had given out various sums of money from the funds on interest free loans to Abdul Gaffoor Ltd. (the Grantor's business) and to the Grantor's sons and widow, and (c) the trustees had given donations to several institutions which do not come within the purview of sub-paragraphs 2 (b) to 2 (g) of the Deed.

> The question whether the Trust Deed No. 1833 (P1) created a 3. Charitable Trust, the income of which is exempt from tax in terms of Section 7 (1) (c) of the Income Tax Ordinance, came up for consideration in an appeal to the Commissioner of Income Tax for the year of assess-20 ment 1949/50. He decided that in view of sub-paragraph (b) of paragraph 2 of the Trust Deed, the trust was not one of a public character established solely for charitable purposes and that the income was therefore liable to tax. The matter was taken up in appeal to the Board of Review which reversed the order of the Commissioner and held that the Trust was one of a public character established solely for charitable purposes. There was no appeal to the Supreme Court.

> 4. The present appeal was in connection with the assessments made on the Trustees for the years of assessment 1950/51, 1951/52, 1952/53, 1953/54, 1954/55. The Assessor made assessments on the footing that 30 the Trust was not of a public character established solely for charitable purposes.

5. The assessees appealed to the Commissioner of Income Tax against the assessments on the ground that the income of the Trust was exempt under Section 7 (1) (c) of the Income Tax Ordinance.

The Commissioner of Income Tax heard the appeal and recorded 6. the evidence of witnesses marked X1. He gave his decision confirming the assessments. The Determination and Reasons of the Commissioner are attached hereto as part of the case marked X 2.

- (1) The Commissioner's determination is contrary to law and against the weight of evidence in the case.
- (2) It having been decided earlier by the Board-of-Review that the trust under consideration was a public character established solely for charitable purposes and that its income was exempt from Income Tax the matter could not be reagitated by the Assessor.
- (3) The Assistant Commissioner's analysis and summary were not accepted as correct by the appellants and has influenced the Commissioner's view of the appellants' case adversely.
- (4) In law, in any event after the death of the author of the trust, the trust created by deed under consideration is a trust of a public character established solely for charitable purposes and the income of the trust is exempt from income tax.
- (5) In arriving at his decision the Commissioner failed to appreciate the difference between the Law of England and the Law of Ceylon.
- (6) The Appellants are not in any event liable to be assessed.
- (7) It is submitted that the Commissioner has misconstrued the several provisions of the Trust Deed and the objects and purposes of the trust and as a result has misdirected himself in determining the question before him.
- (8) It is submitted that on a correct interpretation of the Trust Deed and section 7 (1) c of the Income Tax Ordinance no other conclusion can be come to except that the Assessee— Appellants are exempt from taxation.
- 30 8. Counsel for the appellant at the hearing of the appeal led the further evidence of Mr. A. H. M. Ismail (record of which is marked X 3) and contended inter alia as follows :---
 - (a) The principal of *res judicata* applied to the previous decision of the Board of Review;
 - (b) Since the author of the Trust died on 1st November, 1948 the proviso to paragraph 2 of the Trust Deed has become inoperative and therefore the trustees are bound to admi-

No. 7 Case Stated 6-7-57 —continued. nister the trust in accordance with the provisions of subparagraphs 2 (a) to 2 (g) and that therefore the trust is one established solely for charitable purposes;

- (c) The provisions of sub-paragraph 2 (b) are not so wide as to take the trust out of the character of charitable purposes;
- (d) That the words "in furtherance of" appearing in sub-paragraph 2 (g) means "for" or "on" and is narrower than the words "conducive to" appearing in the deeds relating to the cases quoted by Crown Counsel;
- (e) That Section 35 of the Trusts Ordinance gives power to the 10 Trustees to bring the building up to date and thereby to increase the income and that therefore the sums expended on the buildings are not outside the purview of the trust;
- (f) That if the trustees did in point of fact act outside the provisions of the Trust Deed, the Court could interfere under the Trusts Ordinance and order the Trustees to reimburse the Trust funds to the extent of the expenditure not covered by the deed;
- (g) That uncontrolled discretion given to the Trustees did not enable the Trustees to act outside the purposes set out in 20 sub-paragraphs (b) to (g) of paragraph 2 of the deed;
- (h) That therefore, the income from this Trust is exempt from Income Tax under Section 7 (1) (c) of the Income Tax Ordinance.

9. Crown Counsel on behalf of the Assessor contended inter alia as follows :---

- (a) That the principle of "res judicata" did not apply to the previous decision of the Board of Review;
- (b) That Section 7 (1) (c) of the Income Tax Ordinance as it stands to-day does not include "religious purposes "; 80
- (c) That the word "established" in Section 7 (1) (c) means "set up" or "created" and that a trust could be "established" only once and not several times and that this trust was established during the lifetime of the Grantor once and for all and that at the time of its establishment it did not come under Section 7 (1) (c) and that subsequent events could not bring it under the operation of Section 7 (1) (c);

- (d) That the language of sub-paragraph 2 (b) of P1 is extremely $\frac{No.7}{Case Stated}$ wide and covers instruction or training in any department 6-7-57 -continued. of human activity whatsoever as the Board may in its absolute and uncontrolled discretion decide, and thereby permits expenditure from Trust funds for non-charitable purposes;
- That sub-paragraph 2 (b) read with sub-paragraph 2 (g) (e) empowered the trustees to expend the trust funds entirely for the benefit of the Grantor's relations and that therefore the trust created by P1 was not a trust of a public character established solely for charitable purposes;
- (f)That sub-paragraph 2 (f) of P1 makes provision for the distribution of "doles" which is not a charitable purpose or alternatively that distribution of charity once a year during the month of Ramalhan is a religious purpose and therefore not caught up by Section 7 (1) (c) of the Income Tax Ordinance:
- That the words "in furtherance of "in sub-paragraph 2 (g) (g) had the same meaning as " conducive to " and that this subparagraph gave a wide discretion to the Board and empowered them to expend trust funds on purposes which the Board in its absolute uncontrolled discretion thought was in furtherance of all or any one or more of the various objects of the trust specified in P1 and thereby the Board was empowered to lawfully spend trust funds on noncharitable purposes;
- (h) That the facts show considerable expenditure of Trust funds on non-charitable purposes which expenditure can be justified under the terms of P1 as the proviso to paragraph 2 of P1 provides that "The Board shall not be nor be liable to be questioned regarding or asked the grounds or

- (i) That if the provisions of the Trust Deed P1 are such as to permit any portion of the trust funds however small being 10 used for non-charitable purposes, then the exemption granted by Section 7 (1) (c) of the Income Tax Ordinance becomes inapplicable and the entire trust income is subject to tax;
- (j) That the onus of bringing the case within the exemption granted by Section 7 (1) (c) of the Income Tax Ordinance is on the Trustees.

10. The Board of Review allowed the appeal of the appellant. A copy of the decision of the Board is attached hereto as part of the case marked X 4.

11. Dissatisfied with the decision of the Board of Review, the Commissioner of Income Tax has by his letter dated 20th March, 1957 marked X 5 applied to the Board to have a case stated for the opinion of the Hon'ble the Supreme Court on the following questions of law : (1) Was a trust of a public character, established solely for charitable purposes, created by N. D. H. Abdul Caffoor by deeds Nos. 1832 and 1833 of 24th December, 1942, attested by C. M. G. de Saram, N. P.? (2) Is the income of the said Trust exempt from tax for the years of assessment 1950/51 to 1954/55 under the provisions of Section 7 (1) (c) of the Income Tax Ordinance (Cap. 188)?

12. In the view of the Board an important point of law in this

case that needs consideration of the Supreme Court is the following :- No. 7 Case Stated 0-7-57 - continued.

"The creator of the trust, N. D. H. Abdul Caffoor, having died on 1st November, 1948, can the terms of the trust deed Nos. 1833 of 24th December, 1942, be construed in accordance with the facts as they exist at the time it becomes necessary to construe it for Income Tax purposes, or must it be construed for such purposes only in accordance with the facts existing at the date it was executed?".

By a conveyance No. 1832 of 24th December, 1942, one N. D. H. Abdul Gaffoor conveyed certain immovable property to four persons, referred to in the document and in this judgment as "the Trustees," upon certain trusts declared in an instrument No. 1833 of the same date. It is necessary for the purposes of considering the question arising upon this Case stated to set out in *extenso* some of the provisions of this ins-30 trument :—

2. "The Trustees shall stand possessed of the trust property with the power to let lease and manage the same or any part or portion thereof and shall apply the nett rents, profits, dividends and income thereof (after payment thereout of all the rates, taxes and other outgoings and after reserving a sum of One Thousand Rupees (Rs. 1000/-) a month for the proper upkeep, repair and maintenance of the trust property) for all No. 8 or any of the purposes following as the Board in its absolute and uncon-of the trolled discretion may decide that is to say :--

- (a) A sum not exceeding one thousand rupees (Rs. 1000/-) a -continued. month for the remuneration of the Trustees and the expenses incurred by them in connection with the administration of the trust......
- A sum not exceeding in all one thousand rupces (Rs. 1000/-) (b)a month for the education instruction or training in England or elsewhere abroad of deserving youths of the Islamic Faith in such professions vocations, occupations, industries, arts or crafts trades employments subjects lines or any other departments of learning or human activity whatsoever as the Board may in its aforesaid discretion decide in the case of each such deserving youth with a like discretion in the Board from time to time to change modify or alter of completely discontinue in the case of each such youth either the object or objects of instruction, education or training selected for him by the Board (from among the objects enumerated above) or the place or places or countries where at such education, training or instruction is being given from time to time. The Board may under a like discretion partially or wholly discontinue any assistance it may have given or may be giving in the case of any of such youths. If shall be lawful for the Board out of the said sum to pay for or provide the whole or any part of the cost of any such youth going abroad from or in returning to Ceylon once or oftener as the Board may under such discretion aforesaid from time to time decide. The recipients of the benefits provided for in this clause shall be selected by the Board from the following classes of persons and in the following order :---
- (i) Male descendants along either the male or female line of the Grantor or of any of his brothers or sisters failing whom.

- (g) Any surplus or any sums not expended on any of the above objects shall be credited to a reserve fund to be used in such proportions to such extents at such time or times and from time to time and in such manner as the Board may in its absolute and uncontrolled discretion decide (1) for the purpose of meeting any unforseen expenditure or contingency in connection with the trust property (2) in furtherance of all or any one or more of the various objects of the trust (3) for educating in a secondary school or secondary schools in Ceylon poor deserving boys of the Islamic Faith born of 20 Muslim parents permanently resident in Ceylon (wherever such boys may have been or be resident from time to time) and (4) for the relief of poverty distress or sickness amongst members of Islamic Faith in Ceylon PROVIDED however that during the lifetime of the Grantor the Trustees shall apply the nett rents, profits, dividends and income of the trust property for such purposes and in such manner as the Grantor in his absolute discretion whether such purposes shall fall within the objects specified in any provision above or not may through the Board direct. The Board shall not 30 be nor be liable to be questioned regarding or asked the grounds or reasons for and decision of the Board in regard to any of the matters provided for in sub clauses (b), (c), (d), (e), (f) and (g) of this clause it being the aim, intention and object of These Presents that the Board and every member thereof shall at no time be liable to have their decisions or their grounds or reasons in regard to such matter revised discussed gone into challenged modified or altered in any manner howsoever by any person body authority or Court ". 40

In connection with the assessment of the income of the Trustees to tax under the Income Tax Ordinance for the year of assessment 1949/50, the Board of Review constituted under the Income Tax Ordinance (Cap No. 8 Judgment 188) held, on 22nd December, 1954, upon an appeal preferred by the of the Trustees, that the income was income of a "Trust of a public character $\frac{\text{Supreme}}{\text{Court}}$ established solely for charitable purposes" and was therefore exempt 26-11-58 from tax in terms of Section 7 (1) (c) of the Ordinance. On that occasion —continued, no application was made to the Board by the Commissioner to state a case on any question of law for the opinion of this Court.

In respect, however, of the years, 1950/51, 51/52, 52/53, 53/54, 54/55, the Assessor again made assessments on the basis that the income of the 10 Trustees was not exempt from the tax and these assessments were upheld by the Commissioner. The Trustees appealed against these assessments to the Board of Review which made Order dated 19th February, 1957, again holding that the income of the Trustees is exempt under Section 7 (1) (c) of Ordinance. The Board as now, upon the application of the Commissioner, stated a case for the opinion of this Court in the following terms :—

"The creator of the trust, N. D. H. Abdul Gaffoor, having died on 1st November, 1948, can the terms of the trust deed No. 1833 of 24th December, 1942, be construed in accordance with the facts as they exist 20 at the time it becomes necessary to construe it for Income Tax purposes, or must it be construed for such purposes only in accordance with the facts existing at the date it was executed ?".

Having regard to the matters which have been argued before us, I am of opinion that the questions arising for our determination would be better formulated thus :---(1) Does the decision dated 22nd December, 1954, of the Board of Review constituted under the Income Tax Ordinance, on appeal against the assessment made on the Trustees for the year of assessment 1949/50, operate as *res judicata* in respect of subsequent years upon the question whether the income of the Trustees is 80 income of a "trust of a public character established solely for charitable purposes" within the meaning of Section 7 (1) (c) of the Income Tax Ordinance?.

(2) Is the income derived from the property described in the schedule to the instrument No. 1833 of 24th December, 1942, exempt from tax for the years of assessment 1950/51, 51/52, 52/53, 53/54, 54/55, under Section 7 (1) (c) of the Income Tax Ordinance as being the income of trust of a public character establised solely for charitable purposes ?.

With regard to the first of the two questions we have to decide, the Solicitor-General relies on the decision of this Court in *The Attorney-General Vs. Vallyamma Atchie* (1) The question which there arose was 40 whether a decision of the Board of Review of Income Tax, to the effect that the estate of a certain deceased person was not joint property of a Hindu undivided family, operated as res judicata in subsequent proceedings where the point for determination was whether the same property was the joint property of the family for the purposes of Section 73

of the Estate Duty Ordinance. Howard C. J. (with whom Wijewardena J. agreed) held that "the decision of the Board of Review can be regarded as final and conclusive as between the Crown and the assessee as to the latter's income in regard to the particular year, but not as to future -continued. years ".

> It is contended for the Trustees that that decision should not be followed, or alternatively that its true ratio decidendi was that the question which subsequently arose in the Estate Duty case. There would seem to be some ground for the alternative argument, for Howard C.J. refers to the circumstance that the decision which was relied on as creat-10 ing an estoppel by means of res judicata had been given in a matter arising under the Income Tax Ordinance and not in a matter arising under the Estate Duty Ordinance. In the present case, the question we are now asked to decide is whether the trust is one of the description specified in Section 7 (1) (c) of the Income Ordinance, and since it is clear that that very question had been answered by the Board in favour of the Trustees, the decision in Valliamma Atchie's case may be distinguishable.

For this reason it is desirable that we consider the matter afresh without regarding Valliamma Atchie's (1) case as having already decided it.

An assessment to income tax is in the first instance made by an 20 assessor under Section 64 of the Ordinance and the assessment is scrutinized, amended, and then signed (Section 66) by an Assistant Commissioner, who thereafter gives notice of the assessment to the person chargeable. Against this assessment the assesse can appeal to the Commissioner of Income Tax who is empowered (Section 69) "to confirm, reduce, increase, or annul the assessment". The right of appeal to the Board of Review from the Commissioner's determination is conferred by Section 71; after certain preliminaries, the appellant gives notice of appeal to the Board against the Commissioner's determination. At such an appeal, the assessee may be heard in person or by an authorised re-so presentative and the assessor or some other person authorised by the Commissioner attends in support of the assessment. After hearing the appeal, the Board "shall confirm, reduce, increase, or annul the assessment" as determined by the Commissioner on appeal, or as referred by him under Section 72, as the case may be, or may remit the case to the Commissioner with the opinion of the Board thereon ". Where a case is so remitted by the Board the Commissioner shall revise the assessment as the opinion of the Board shall require.

Section 74 provides that the decision of the Board shall be final, but enables the appellant or to Commissioner to apply to the Board to state 40 a case on a question of law for the opinion of the Supreme Court. So far as a determination of the Board of Review is concerned, the effect of Section 75 is that an assessment as regards the assessable income assessed thereby, as determined by the Board on appeal, is final and

conclusive for all purposes of this Ordinance as regards the amount of ^{No. 8} such assessable income, if such assessment is not subsequently altered or of the has not to be altered by or in consequence of the ultimate decision of the ^{Supreme} Supreme Court or of the Privy Council upon a case stated on a question ²⁶⁻¹¹⁻⁵⁸ of law.

The main point for determination is whether the Board of Review performs judicial and not merely administrative functions, for, if the Board's decision on appeal is merely administrative, it would not operate to create an estoppel by means of res judicata. Having regard to those 10 provisions of the Ordinance to which I have referred above, the functions of the Board of Review are properly comparable with those of the Board established under the Australian Income Tax Assessment Act, and which were considered in the Privy Council case of Shell Company of Australia Vs. The Federal Commissioner of Taxation. (2) In the Australian Act as well as in the Ceylon Ordinance the provisions for the making of assessments and for the making of appeals therefrom, including appeals to the Board of Review, would seem to be no more than expeditious administrative machinery for determining each year the assessable income upon which tax to be levied for that year. No doubt the Board of Review is 20 expected to act in a judicial manner, and an appeal might well raise, as it did in the present case, questions of law for determination by the Board; but as was pointed out in the Shell Company case (2) " an administrative tribunal may act judicially but still remains an administrative tribunal as distinct from a Court, strictly so called ". Their Lordships of the Privy Council held in that case that the Board under the Australian Act was not exercising the "judicial power" of the Commonwealth. Can it be said, nevertheless, that such a Board is a "Court of competent jurisdiction " for the purposes of the principles of res judicata?

The decision of the English Court of Appeal in the case of The Com-30 missioners of Inland Revenue Vs. Sneath (3) is directly of assistance. Under the English Income Tax Act of 1918 there was a right of appeal to the Special Commissioners after preliminaries not substantially different from the steps prescribed by the Cevlon Ordinance. But it was held that what the Special Commissioners had to determine was the amount of the assessment which should be made upon the facts of the case before them. Lord Hanworth M. R. thought it difficult to attribute to such a determination of an assessment in amount, the decision of a *lis inter partes.* The reasons which underly this view of the functions of a statutory authority set up for taxation purposes were stated by Greer. 40 L. J. as follows :--- "I think the estimating authorities, even an appeal is made to them, are not acting as judges deciding litigation between the subject and the Crown. They are merely in the position of valuers. whose proceedings are regulated by statute to enable them to make an estimate of the income of the taxpayer for the particular year in question. The nature of the legislation for the imposition of taxes

making it necessary that the statute should provide for some machinery whereby the taxable income is ascertained, that machinery is set going seperately for each year of tax and, though the figure determined in one year is final for that year, it is not final for any other purpose. It is -continued. final not as a judgment inter partes, but as the final estimate of the statutory estimating body. No *lis* comes into existence until there has been a final estimate of the income which determines the tax payable. There can be no *lis* until the rights and duties are ascertained and thereafter questioned by litigation. It would be unfortunate if we were compelled to arrive at any other result, because it might well be in one year 10 the taxpayer might not think it worthwhile to challenge the decision of the Commissioners for that particular year, though it might in later years prove to be worth his while to contest their view. On the other hand, it is equally likely that there may be many cases in which the Crown would be quite prepared to make concessions in one year, whereas they might rightly conclude in subsequent years that it would not be in the interests of the taxpayers generally that they should make such a concession ".

I would with respect adopt these observations. Section 75 of our Ordinance gives finality to a determination of the Board as regards the 20 assessable income assessed thereby, that is to say, as regards the amount of the income for the year to which the determination relates, and not as regards income for subsequent years. Moreover, there is the provision in Section 72 whereby the Board of Review may even take the place of the Commissioner and hear an appeal preferred to that officer, and the provision in Section 73 that the Board's hearings shall be in camera. These features of the statutory provisions weight considerably against the view that the Board was intended to function as a Court to decide litigation between the subject and the Crown.

Counsel for the Trustees relied on a statement in Spencer-Bower 30 (4) in which "Income Tax Commissioners and authorities" are included in a class of Civil tribunals whose decisions are stated to operate as res judicata. I find however that none of the cases cited by the learned author were concerned with the question whether decisions of such Commissioners would so operate. The cases of Hoysted Vs. The Commissioner of Taxation (5) also does not assist the Trustees, for the decision which was there held to operate as res judicata, was one of High Court of Australia and not of any statutory Board of Commissioners.

I would for the reasons stated answer in the negative the first question which we are called upon to decide. The second question which 40 this Court has to answer is the substantial question in the case—is the income of the trust exempt from income tax?

I was at first impressed by the argument for the Trustees that the No. 8 answer is to be ascertained only from a consideration of paragraph (c) of or the of Section 7 (1) of the Income Tax Ordinance, that is to say, by deciding Supreme Court whether or not the trust firstly is of a public character and secondly is one 26-11-58 established solely for "charitable purposes' as defined in the interpreta--continued. tion section (Section 2). Whether the last mentioned definition should be regarded as being exhaustive, or whether (because of the use of the word "includes") other purposes generally considered charitable are also included within its scope, the objects of the present trust are prima facie 10 within the definition, for each of them is either for education or for the relief of poverty. There is nothing, it is said, in paragraph (c) of Section 7 (1) or in the definition of "charitable purposes", indicative of an intention that a purpose must be "legally" charitable, which is the chareteristic required by the law of England in similar cases.

Having regard to the terms of paragraph (c) of Section 7 (1) of our Ordinance it is urged that these observations would apply equally in 30 cases where the interpretation of the paragraph is involved.

The Solicitor-General argues, however, that the expressions "public character" and "charitable purposes" are not the only expressions which we have to construe. We have first to consider whether there is in this case a "trust". The term "trust" cannot be understood in any loose or colloquial sense, and can denote only such a trust as is contemplated in the Trusts Ordinance; although the disposition in this case may apparently fall within the scope of the definition of "trust" in Section 2 of that Ordinanee, the matter does not end there; having regard to Section 110 of the Trusts Ordinance the trust now under con-40 sideration will be void as offending the rule against perpetuities, unless it is a "charitable trust" (Section 110 (5)). Accordingly, the preliminary question we must decide is whether the "trust" is a "charitable trust" as defined in Section 99 of the Trusts Ordinance; and for that purpose we do have to construe that definition.

The argument of the Solicitor-General is in my opinion perfectly sound, and I need not make but one further comment; the Legislature could surely not have contemplated the grant of tax exemptions for "trusts" which have no legal validity or existence under the special -continued. law relating to trusts which had earlier been enacted in the Trusts Ordinance. I shall now set out a summary of the principal reasons relied on for the argument that the trust in question is not a "charitable trust" as defined in Section 99.

Paragraph 2 of the instrument confers on the Board (constituted by paragraph 9) an absolute and uncontrolled discretion to make 10 decisions concerning the utilisation and application of the income of the trust property for all or any of the purposes enumerated in the various clauses of that paragraph. This discretion is reinforced (if reinforcement were needed) in the Proviso at the end of paragraph 2, whereby the Grantor declares his intention and object that any such decision of the Board must not be revised or challenged. Although then, clause (b) purports to direct or authorise the application of sums not exceeding Rs. 1000/- per month for the education instruction or training aboard of deserving youths of the Islamic faith-a designation which might well denote an intention on the part of the Grantor to benefit a section of 20 the public—the construction that the object is to benefit the public must be rejected upon a consideration of the aforementioned discretionary power and of the directions of the Grantor contained in clause (b). The argument is that, upon construction of the whole clause, the Board is directed to give preference to deserving descendants of the Grantor's family, and further that, since there is no obligation cast on the Board to apply moneys in each and every year for the purposes specified in the clause, the Board can in its discretion refrain from utilising the specified monthly sums except for the purposes of the education of such descen-dants. The Solicitor-General sought to underline his argument by 80 reference to clause (g) of paragraph 2. The Board, he said, would not be acting in breach of the trust if surpluses, accumulated either after application of income annually for the several purposes mentioned in clauses (b) to (f) or even by the expedient of remaining "inactive" with respect to the purposes specified in clauses (c) to (f), are kept in the reserve fund and applied solely or mainly for the education of family descendants. He pointed to the provisions in sub-clause (2) of clause (g) whereby the reserve fund can be used, in "absolute and uncontrolled discretion", "in furtherance of all or any one or more of the various objects of the trust ", which he said would render unquestionable the right of the Board to apply the 40 reserve fund only for the object specified in clause (b), and in so doing to prefer family descendants exclusively. His submission in brief was that no benefit under clause (b) if assured to deserving youths of the Islamic faith as such, and that in effect, if not also in intention, the benefit is or can properly be restricted to family descendants. At the least, having regard to the imperative direction for the selection of "deserving male descendants", the provision that, failing them, beneficiaries of the "public class" would be eligible is of

remote and indirect nature, so that the element of "public benefit" No. 8 required by Section 99 is not present. Hence, assuming that the gift in $_{0 \text{ fthe}}^{\text{Judgment}}$ clause (b) is for a purpose mentioned in the definition of "charitable $_{\text{Supreme}}^{\text{Supreme}}$ trust" namely "the advancement of education", the trust fails to $_{20-11-58}^{\text{Court}}$ satisfy the requirement in the definition that it must be for the benefit of —continued. the public or a section of the public.

The expressions "public", "public benefit", and "benefit of the public ", occurring in statutory provisions, have often to be construed by the Courts. It seems to me that the first step in the process of inter-10 pretation is to ascertain the ordinary grammatical meaning of the expression. In its ordinary meaning, "public" would mean "of, concerning, the people as a whole" and also "open to, shared by the people". In addition the term carries with it a connotation opposed to "private", which ordinarily means "not open to the public" or "one's own, individual or personal". If then it can be said that the contemplated benefit is of a "private" nature, it may lack the characteristic of being public even though it may in certain events be available to the public. I note also at this stage that the definition in Section 99 of the Trusts Ordinance does not require a trust to be solely for the 20 public benefit, so that a trust which a essentially or substantially for the public benefit may reasonably be considered to fall within the definition, Let me take the case of the landlord of a block of flats who maintains a playing field, the use of which is regulated by some document which entitles the children of the tenants to play there on all such days as their parents may freely decide, and provides further that children of members of the public may use the field on other days. The man in the street or a city official might well come in time to regard the playing field as "public", if in practice it has habitually been used by the "privileged" children only on a specified days each week and been available for 30 public use on other days. But if the matter is considered in limine, at a time when it is not clear that other children can ever enjoy a benefit, the rights of these others are merely theoretical and uncertain. A right to use a playing field would not be theoretical, and uncertain, if the only restriction as to user is that a child must firstly satisfy some authority that he is proficient at cricket or football, for then the designated section of the public would consist of all children who satisfy the test of proficiency at cricket or football. But in the example I have taken, there is a right of preference dependant on a qualification which cannot be fulfilled by any child of a member of the public, as such, and there is no certainty 40 or assurance that children of members of the public can benefit.

It is in this ordinary and reasonable sense that I would in the first instance construe the expressson "for the benefit of the public or a section of the public"—so that the test is whether, although a class or section of the public is designated in the instrument, members of that class or section can, as such, qualify for the benefit. Applying this test to the terms of the present instrument it would seem at the least doubtful

whether the test is satisfied. The answer to the question whether deserving youths of the Islamic faith are as such qualified to receive educational assistance under clause (b), can only be "Yes, but if only moneys remain available from the specified sum of Rs. 1000/- per month or from -continued. apportionments from the reserve fund after providing for the education of such deserving family descendants as the Board may decide to assist, and furthermore only if the Board in its absolute discretion desires to educate Islamic youths who are not family descendants". If that be the correct anwer, then clause (b) does not contain the element of public benefit which should characterise a charitable trust. I also seriously 10 doubt whether, having regard to the uncertainty of the rights of the general class of youths, the clause can even be regarded as being essentially or substantially for the benefit of a section of the public.

I have referred already to the dictum of Lord Wright in the Indian Spinners Association case (6) which generally speaking must be born in mind by Judges in Ceylon when concerned with the interpretation of language in enactments of the Ceylon Legislature. Nevertheless, the expression "for the benefit of the public or a section of the public" had been employed so frequently in judgments in England dealing with charitable trust, that it is difficult to resist the impression that the e_{x-20} pression was used in our Ordinance to denote the same concept as in English Trust Law.

The following passage from Tudor on Charities has often been cited with approval:---" In the first place it may be laid down as a universal rule that the law recognises no purpose as charitable unless it be for a public character. That is to say, a purpose must, in order to be charitable, be directed to the benefit of the community or a section of the community ".

In the Judgment of the Privy Council in Verge Vs. Somerville (7) Lord Wrenbury said :..."..... to ascertain whether a gift constitutes a 80 valid charitable trust so as to escape being void on the ground of perpetuity, a first inquiry must be whether it is public, whether it is for the benefit of the community or for an appreciably important class of the community". In his observations in the case of Oppenheim Vs. Tobacco Trust Co: (8) Viscount Simonds lays down the same test in similar language :----" It is a clearly established principle of the law of charity that a trust is not charitable unless it is directed to the public benefit. This is sometimes stated in the proposition that it *must benefit community* or a section of the community. Negatively it is said that a trust is not charitable if it confers only private benefits ". 40

Since the language of the Ceylon Trusts Ordinance so nearly corresponds with the language in which the test invariably applied in England is phrased, it is legitimate, if not necessary, to consult these authorities in England in which the test has been applied in cases similar to that No. 8 under consideration. Trusts which can benefit relatives or decendants of of the a settlor came in for exhaustive examination by Lord Greene in Re^{Supreme} Compton (9) and the views and conclusions there expressed by the Master 26-11-58 of the Rolls were approved by the House of Lords in Oppenheim's base. —continued. (8) subject only to the dissenting opinion of Lord MacDermott. It would seem to be settled law in England that a trust for the relief of poverty would be regarded as charitable even if the benefit is restricted to kin of the settlor; but the validity of such trusts has recently been 10 doubted and it is clear that the cases are regarded as anomalous and will have no bearing except upon trusts for the relief of poverty. Clause (b) of the present instrument is in any event not of this class, its object being education, and not the relief of poverty.

There are then the so-called "founder's kin" cases, in which the English Court had for long recognised trusts for the endowment of educational insitutions as being charitable notwithstanding the reservation of benefits to descendants or relatives of the settlor. Lord Greene in Compton's case, (9) after examination of the earlier authorities, doubted the correctness of the proposition in Tudor (at page 30) that "bequests 20 for the education of the donor's descendants and kinsmen at schools and colleges are valid bequests ". With respect, it seems to me that the authorities only support the view that the trust in such a case would be construed as being one to some particular college or foundation upon trust to educate descendants there. The instrument I am now considering cannot be so construed, there being no specified educational institution designated for the purpose of the trust. The trust is *Re Compton* (9) itself was for the education of Compton and Powell and Montague children and was held not to charitable on the ground that "a gift for the education of descendants of named persons must be regarded as a 30 family trust and not as one for the benefit of a section of the community, on any fair view of what that phrase may mean ". Lord Greene thought that "a gift under which the beneficiaries are defined by reference to a purely personal relationship to a named propositus cannot on principle be a valid charitable gift " (at page 131).

The only earlier case on comparable facts was that of *Re Rayner*, (1) a decision of Eve J. which was disapproved by the Court of Appeal and subsequently doubted by Viscount Simonds and Lord Normand in *Oppenheim's* case. (8)

Before referring to a subsequent decision upon which Mr. Perera 40 very strongly relied and which the Board of Review has applied, it would be useful to summarise his arguments.

The proper mode of interpretation of clause (b) it is said, would be to ascertain the primary object of the disposition. The primary object here No. 8 Judgment of the Supreme Court 26-11-58 —continued.

is "the education instruction and training of deserving youths of the Islamic faith born of muslim parents of the Ceylon Moorish community permanently resident in Ceylon ". (I should mention that the limitation to the Ceylon Moorish community is derived from references to that community in sub-clauses II and III of clause (b). Mr. Perera concedes that having regard to these limiting references the class intended to be benefited is not the wider class "deserving youth of the Islamic faith" simpliciter but rather the narrower class I have just described). This class I will assume for the purpose of discussion to be "a section of the public", The further argument is that the 10 "order of selection" set down in the latter part of the clause (b) merely conferes a right of preferance on such deserving youths of the Islamic faith as are also descendants of the family of the Grantor. A descendant who does not belong to the primary class would not be eligible for the benefit and even a descendant who does so belong may only be selected if he is deserving; preference for him on the ground of his being a descendant is contemplated, but only if he is in other respects as deserving of the benefit as other youths of the primary class. Such a right of preference does not, it is said, detract from the public character of the primary object of clause (b). 20

The counter to the Solicitor-General's argument as to the combined effect of clauses (b) and (g) was that the right of preference for family descendants will be available only in respect of the sum not exceeding Rs. 1000/- per month specified in clause (b) and not in the event of surpluses or accumulations in the reserve fund being utilised for the purposes mentioned in clause (b). The ground of this distinction is that the reference in clause (g) to the "various objects of the trust" would denote in this context, not the whole "scheme" set out in clause (b), but only the primary object of the disposition in that clause. This distinction, it is argued, is apparent in clause (b) itself, for the order of selection is pres-so cribed only for "the recipients of the benefits provided for in this clause". that is to say, the monthly one thousand rupees benefit, and would not apply when surpluses are used for the education abroad of Muslim youths. Moreover, the exclusion of the order of selection is also implicit in clause (g) itself where the language "in such mannar as the Board may in its absolute and uncontrolled discretion decide" enables the Board to disregard the manner of selection contemplated in clause (b). It is urged also that the discretion conferred on the Board is of a fiduciary character and that the intention therefore is that the Board will not so act as to defeat or unduly diminish the benefits intended to be conferred 40 on the primary class of beneficiaries. The English decision in support of these arguments is that of *Re Koettgen* (11) decided by Upjohn, J. which needs very close consideration. The objects of the trust set up in that fund shall be persons of either sex who are British born subjects and who are desirous of educating themselves or obtaining tuition for a higher commercial career but whose means are insufficient or will not allow of their obtaining such education or tuition at their own expense; in selecting beneficiaries it is my wish that the charity trustees shall give a pre-^{No. 8} ference to any employees of John Batt & Co, (London), Ltd., or any of the members of the families of such employees; failing a sufficient number of ^{Supreme} beneficiaries under such description then the persons eligible shall be any 20-11-58 persons of British birth as the charity trustees may select. Provided —continued. that the total income to be available for benefiting the preferred beneficiaries shall not in any one year be more that seventy-five per cent of the total available income for such year ".

It was conceded that the trust was for a charitable purpose, namely 10 the advancement of education and was as to twenty-five per cent of the income a valid charitable trust. But the validity of the trust as to seventy-five per cent of the income was challenged on the ground that the provisions for the application of the income did not have the requisite degree of public benefit. Upjohn J. was of opinion that the desire of the testatrix to prefer the members of the families of the named firm must be read in an imperative sense. But he did not attach much significance to the possible practical effect of the perference clause;-"In some years there might be sufficient members of that limited class to fill the seventy-five per cent available for them, and in other years 20 there might not be. The evidence, as I have said, is inconclusive on this point. The time may come when John Batt & Co. (London), Ltd., ceases to carry on business, and in that event the income of the whole trust fund be applied for the benefit of the primary class which fulfils qualifications contained in sub-clause (d) ".

That view of the "facts" probably explains why the learned Judge rejected the construction (against a trust) that the public could only benefit when the preferred class of beneficiaries failed. He was satisfied that the first sentence in paragraph (d) of the instrument specified the primary class of beneficiaries and that the primary trust was not invaliso dated by the provisions for the selection from a narrower group although that provision was imperative.

I must assume the correctness of the view taken on the facts, though it was formed apparently without strict regard to the dictum of Viscount Simonds in Oppenheim's case, (8) "it must not I think be forgotten that charitable institution enjoy rare privileges and that the claim to come within that privileged class should be clearly established". But I have great respect to disagree with the view that the recital in the forefront of paragraph (d) of a desire to benefit a section of the public, taken together with the probability that benefits will accure to that section, 40 will constitute the section as the primary class, irrespective of the limitation of the element of public benefit, which the subsequent imperative requirement of preference for a special group imposes. If the order in which a settlor's wishes are set down can properly be regarded as significant for the purpose of ascertaining his primary object, then would the Koettgen disposition have been construed differently had the designation No. 8 Judgment of the Supreme Court 26-11-58 —continued.

of British born subjects occurred only after the preference clause?

Whatever the form or arrangement of a disposition, its primary object can be ascertained only after examination of all its provisions, and if the primary object as so ascertained is the benefit of the public, then any subsequent inquiry as to whether the object is invalidated by any particular provision is idle, for account would already have been taken of the significance of all such provisions. Why then did Upjohn J. make such a subsequent inquiry? The reason, I think with much respect, is that he had not taken the provision for selection into account before deciding which was the primary class of beneficiaries. The same error is 10 inherent in the mode of construction suggested on behalf of the Trustees in this case.

In the Koettgen (11) case the following summary of the earlier law from the judgment of Jenkins L. J. in *Re Scarisbrick's Will Trusts* (12) was cited :---

- (i) "It is a general rule that a trust or gift in order to be charitable in the legal sense must be for the benefit of the public or some section of the public;
- (ii) An aggregate of individuals ascertained by reference to some personal tie (eg; of blood or contract) such as the 20 relations of a particular individual, the members of a particular family, the employees of a particular firm, the members of a particular association, does not amount to the public or a section thereof for the purposes of the general rule;
- (iii) It follows that according to the general rule above stated a trust or gift under which the beneficiaries or potential beneficiaries are confined (that is an important word) to some aggregate of individuals ascertained as above is not legally charitable even though its purposes so are such that it would have been legally charitable if the range of potential beneficiaries had extended to the public at large or a section thereof (eg; an educational trust confined as in *Re Compton* to the lawful descendants of three named persons, or, as in *Oppenheim Vs. Tobacco Securities Trust Co., Ltd.* to the children of employees or former employees of a particular company); ".

(iv) "There is, however, an exception to the general rule in that trusts or gifts for the relief of poverty have been held to be charitable even though they are limited No. 8 in their application to some aggregate of individuals of the ascertained as above, and are, therefore, not trusts or Supreme gifts for the benefit of the public or a section thereof, 26-11-58 This exception operates whether the personal tie is one -continued. of blood (as in the numerous so-called "poor relations" cases, to some of which I will presently refer) or of contract".

To judge from the comment of Upjohn J. that "confined" in the 10 third paragraph of the summary is an important word, it wood seem that the paragraph was assumed to be authority for the proposition that the element of public benefit is negatived only when the potential beneficiaries are *confined* to some aggregate of individuals, and not when some such aggregate is to preferred to other members of the public. But the decision in Scarisbrick's (12) case was not concerned with any such distinction; the only question it decided was that the line of authorities recognising the validity of "poverty" trusts for poor relatives applied not only to "permanent" trusts, but also to trusts for immediate distribution. Neither the facts nor the law under consideration in that case 20 rendered it necessary for the Court to make any observation relevant to the problem which subsequently arose in Re Koettgen. In stating his proposition (iii), Jenkins L. J. recorded the principle of earlier decisions (Re Compton), merely for the purpose of pointing thereafter (in his proposition (iv)) to the exception to that principle, which was an exception directly relevant to the case he had to decide. In such a context, there was no need for the learned Lord Justice, either expressly or by implication, to approve or disapprove a disposition, the beneficiaries under which are a group of individuals, together with, but having preference before, a section of the public. I would not, therefore, attach any so special significance to his use of the word " confined ". Indeed, if " confinement" of the benefit is to be regarded as a proper test, a disposition for the education of ten British born subjects, nine of whom must at all times be relatives of the settlor, would have to be construed to be a valid charitable trust. That example, to my mind, reduces such a test to an absurdity. The converse example, namely where one out of ten beneficiaries must always be a family descendant, will of course present difficulty, though such a trust might properly be regarded as being essentially or substantially for the benefit of the public and therefore valid, in application perhaps of the maxim de minimis non curat lex. Before leav-40 ing the *Koettgen* case I would observe that there has been an inclination on the part of some Judges (Lord Mac Dermott in Oppenheim's case was one of them) to look with some degree of favour on trusts for the benefit of employees of particular organisations, presumably because there might be some justification for the view that modern business organisations are so large and employ such numerous personnel that the employees of such organisations can fairly be regarded as a section of the public. If that were the view which moved Upjohn J. to regard as unimportant the pre-

ference clause in *Koettgen's* case, I would not for present purposes need to disagree with it. But that consideration apart, an examination of the decisions which have been brought to our notice satisfies me that Koettgen's case was one of the first instance and that the decision cannot -continued. be justified as being based on precedent. For reasons already stated I do not propose to follow it, but at the least it can properly be distinguished on the ground that a preference clause in favour of family descendants was not there involved. The English cases do not therefore lead me to a conclusion in any way different from that reached on first impression upon consideration of the ordinary meaning of the expression "for the 10 benefit of the public or a section of the public". I would hold therefore that the purpose mentioned in clause (b) of paragraph 2 of the Trust instrument before me is not one which satisfies the requirement of " public benefit", prescribed in Section 99 of the Trusts Ordinance, and that the instrument does not create a valid trust.

Counsel for the Trustees did not argue that the income intended by the settlor to be utilised under clause (c) to (f) of the instrument can be regarded as being income of a separate trust and therefore entitled to exemption from tax. Indeed having regard to the powers exercisable by the Board under paragraph (g), and the uncontrolled discretion to restrict 20 the use of the income and of the reserve fund for the purposes mentioned in paragraph (b), one can well understand why no question of separation was raised in these proceedings. I am not called upon therefore to make any further observations with regard to it.

I have considered the Trust instrument on the basis that the trust does not qualify for the tax exemption unless it comes within the scope of the definition in Section 99 of the Trusts Ordinance. But even if that is an erroneous basis, I would hold that the income of the trust is not exempt from tax because the Trust fails to attain the qualification of "public character" required by paragraph (c) of Section 7 (1) of the 80 Income Tax Ordinance. The argument for the Trustees that this requirement was satisfied was founded upon the decision in Re Koettgen, (11) or at least upon corresponding reasoning. In my opinion, "public character" means much the same thing as "for the benefit of the public or a section of the public ". The " private nature " of the benefit conferred by paragraph (b), and by paragraph (g) read in conjunction therewith, takes the trust out of the class denoted by the expression "trust of a public character". Even if (contrary to the view I hold) it be proper to regard the trust in this case as a valid charitable trust on the analogy of the "poor relations" or "founder's kin" cases in 40 England, the tax exemption provision cannot apply in the absence of the element of "public character" required by that provision.

Among other matters raised by the Solicitor-General there are two upon which some expression of opinion would perhaps be desirable, One argument was that the trust does not fall within the description of No. 8 a "trust *established* solely for charitable purposes "; in fact the question of the as formulated by the Board of Review in the Case Stated was the same ^{Supreme} as that raised in this argument of the Solicitor-General. Briefly stated, 20-11-58 the point argued is that the exemption only applies to a trust which is —*continued*. created or set up solely for charitable purposes and which contemplates the application of the income only for such purposes right from the inception of the trust. In the present case the purposes were not always charitable for the reason that the Proviso at the end of clause 2 requires 10 the Trustees, during the lifetime of the Grantor, to apply the income for such purposes as the Grantor may direct.

I cannot agree that such a significance should be given to the word "established". In the first place it would seem that for grammatical purposes it is necessary to use *some* verb in conjunction with the word "trust", for else the expression "trust solely for charitable purposes" *simpliciter* might have been ungrammatical. Secondly, I agree with the argument for the Trustees that the language in Section 7 (1) (c) is only intended to denote a trust having for the time being legal effect or operation, its purposes being solely charitable. Any other view of the 20 matter would have anomalous and even absurd results.

Another objection taken by the Solicitor-General was that the purpose specified in clause (f) is not for the benefit of the public. He relied in this connection on decisions, such as that in the Australian case of Dunne Vs. Byrne (13) decided by the Privy Council, which have held that dispositions generally "for religous purposes" or "for charitable purposes" to be determined in the direction of a trustee are not charitable trusts because the trustee would be entitled to apply money for purposes commonly, though not legally, regarded as charitable. In the present case, however, although the Board enjoys a discretion, the pur-**80** pose specified is "charity once a year during the month of Ramalham". The Board of Review recorded evidence as to the significance to Muslims of the month of Ramalham and to the practice of the distribution of alms during that month enjoined by the religion of Islam. The Board of Review was I think entitled on that evidence to decide as it did, that " charity " in clause (f) means only the relief of the poor. The Trustees would not therefore be entitled to utilise money under clause (f) except for purposes properly charitable within the meaning of Section 99 of the Trusts Ordinance and the definition in Section 2 of the Income Tax Ordinance.

40 The Solicitor-General relied also on some observations of Viscount Simonds in *Inland Revenue Commisioners Vs. Baddeley* (14) in which he doubted whether "a trust can qualify as a charity within the fourth clause in *Pemsel's* case (15) if the beneficiaries are a class of persons, not only confined to a particular area, but selected from within it by reference

to a particular creed". The present trust is distinguishable on the ground that the dispositions here are not of the fourth class but clearly for education and the relief of poverty, and the observations of the learned Lord Chancellor are probably not applicable in this case. It is -continued. to be noted also that the learned Lords who concurred in the decision ultimately given disisted from expressing any opinion on the point made by the Lord Chancellor. In any event the judgment of the Privy Council in the Indian Spinners Association Case (6) would be sufficient authority for the Courts in Cevlon to interpret the intention of the Cevlon Legislature by reference to the particular circumstances and conditions of life in 10 this country. I think that there can be no question, having regard to such circumstances and conditions that the members of the Moorish community in Colombo or in Ceylon, being of the Islamic faith, would constitute a section of the public for the purposes of the relevant law and that a trust for their benefit would be one of a public character.

Apart then from the arguments based upon the true construction of paragraph (b) of the instrument, and of paragraph (g) read in relation to paragraph (b), there are in my opinion no other grounds for holding that the income of the trust is not entitled to exemption from income tax.

In the result, I answer in the negative the second question which we 20 are invited to decide. The Respondents must pay the costs of these proceedings which I would fix at Rs. 2,100/-.

Surplus Revenue for the year: In terms of clause 2 (g) of the Trust Deed, the surplus for the year after allowing for payments under clause 2 30 (a), (c), (d), (e) and (f), a summary of which appear on the accompanying Income and Expenditure Account, has been credited to the Reserve Fund.

BALANCE SHEET.

Property: The value of the Trust property is the same as the value accorded to it in the Trust Deed.

Abdul Ghafoor Trust: Deposit: We have seen a certificate in support of the deposit with the Director of Government Electrical Undertakings.

Cash: We have seen a certificate in support of the balance lying to the credit of the Chartered Bank of India, Australia and China, Colombo. The Cash in Hand is supported by a certificate from Mr. M. Falil A. Caffoor, one of the Trustees.

Building Depreciation Reserve : Rupees Seventy five thousand (Rs. 75,000/-) has been transferred from Reserve Fund Account.

Reserve for Upkeep of Building: In accordance with the provision of the Trust Deed, Rs. 12,000/- has been credited to this account out of the income for 1948. After charging the Expenditure amounting to Rs. 29,268/51 incurred during the year, the credit balance on this account 10 is Rs. 10,701/01 as at 31st December, 1948.

Reserve Fund Account: The credit balance on this account as at **31st December**, 1948 is Rs. 55,974/05 compared with a balance of Rs. 162,999/34 at the commencement of the year under review. This reduction is mainly due to the fact that the following items have been charged during the year 1948 :---

- 11. On the proposal of A. H. M. Ismail seconded by Hon. Mr. T. B. Jayah, Sir P. J. Parsons was unanimously elected Chairman of the Board of Abdul Ghaffoor Trust for the year 1949.

(a) A sum of Rs. 250/- a month as a donation under clause 2 (c), $\frac{1}{Trust}$.

(b) A sum of Rs. 500/- (five hundred rupees) a month as a donation under clause 2 (g) of the Trust Deed.

- 18. Dr. A. R. M. Waffarn proposed and Hon. Mr. T. B. Jayah seconded that a donation of Rs. 750/- (Seven Hundred and fifty rupees) a month be made to the Ghafooriyah Arabic College, Maharagama and the provisions clauses 2 (e) and 2 (g) of the Trust Deed Rs. 250/- and Rs. 500-/ respectively beginning from 1st 1949. Dr. Halepota had intimated to him that he will be willing to come to Ceylon immediately and help in the study of Arabic of Ceylon Muslims on a reasonable remuneration. Mr. Hussein and Dr. A. C. M. Sulaiman who is at present in England on a tour strongly recommended the services of Dr. Halepota and suggest that the Trust should encourage the study of Arabic among Ceylon Muslims and that if a man of Dr. Halepotas calibre is made available Ceylon Muslim youths who pursue their studies in Muslim theology in Arabic will greatly benefit by his teaching, guidance and leadership.

The meeting after due consideration decided subject to the approval of the Board of Abdul Ghafoor Trust to secure the services of Dr. A. J. Halepota on the following terms :---

- (i) The period of service and employment shall be for a term of three years beginning from January 1950;
- (ii) Payment of cost of Sea-passage from Oxford to London to Colombo.
- (iii) Payment of a monthly remuneration of Rs. 500/- (Five Hundred Rupees) for the first year of service.
- (iv) The monthly remuneration during the second year shall be Rs. 550/- and for the third year Rs. 600/-
- (v) Dr. Halepota shall have the option of continuing in our service for two years more at the end of the third year at a monthly remuneration of Rs. 650/-.

Caffoor informed the meeting that as regards the scholarship awarded to his son Mohamed Alavi Navaz Caffoor he would be requiring a sum of Rs. 670/- a month, the equivalent of \pounds 50/- Sterling, for the educational expenses of his son in England. Decision of the Board :

This is an appeal by the Trustees of the Gaffoor Building Trust against the determination of the Commissioner of the Income Tax in respect of the assessment made on them for the year of assessment 1949/50.

The point at issue in this case is whether Trust Deed No. 1833 20 dated 24th December, 1942 creates a Charitable Trust the income of which is exempt from taxation in terms of Section 7 (1) (c) of the Income Tax Ordinance which exempts income from trusts of a "public character established solely for charitable purposes."

The difficulty in this case is created by clause (b) of Para 2 of the Trust Deed which after directing the trustees to apply "a sum not exceeding Rs. 1000/- a month for the education, instruction or training in England or elsewhere abroad of deserving youths of the Islamic Faith in such professions, vocations, occupations, industries, arts, crafts, trades, employments, subjects, lines or any other departments of learning or 30 human activity whatsoever as the Board may in its aforesaid discretion decide in the ease of each such deserving youth......" contains the following additional provisions to wit :-- P 2 "The recipients of the benefits provided for in this clause shall Income Tax appeal to the be selected by the Board from the following classes of persons in the Board of following order :— Review

22-12-54 ----continued.

- (1) Male descendants along either the male or female line of the Grantor or any of his brothers or sisters failing whom
- (2) Youths of the Islamic Faith not being male descendants as aforesaid of the Grantor or of his brothers or sisters born of Muslim parents of the Ceylon Moorish community permanently resident in the City of Colombo (wherever such youth may have been or be resident from time to time) failing whom 10
- (3) Youths of the Islamic Faith not being male descendants as aforesaid of the Grantor or of his brothers or sisters born of Muslim parents of the Ceylon Moorish Community permanently resident anywhere else in the said Island of Ceylon other than in Colombo (wherever such youths may have been or be resident from time to time)."

It has been held by the Commissioner that but for this clause the trust would be treated as a trust of a public character establised solely for charitable purposes. The Commissioner held that the decision in the case of Re Compton, Powell vs. Compton reported in All England Law 20 Reports 1945 Vol. 1, page 198, applied to this case and decided that the trust is not exempt from taxation under Section 7 (1) (c).

We disagree from this view of the matter. In the Re Compton Case, the trust was an educational trust *confined to* certain families namely the descendants of three named persons. In this case the trust is not *confined* to the descendants of the Grantor or of his brothers or sisters. The trust is extended to the section of the public although preference was to be given in the selection of the recipients of the award to decendants of the Grantor or of his bothers or sisters; that too only if the Board considers them "deserving youths of Islamic faith." The Board is therefore not 30 bound to select any descendant of the Grantor etc. Therefore we do not think that the decision of "in Re Compton" applies to this case.

We are supported in this decision by the judgment of the Chancery Division in Re Koetigen's Wills Trusts. Westminster Bank Ltd. Vs. Family Welfare Association Trustees Ltd. and others reported in All England Reports (1954) at page 581. In this case too, the testatrix provided that in selecting the beneficiaries preference shall be given to any employees of John Batt & Co. or any members of the families of such employees, failing that to any persons of British birth. In this case Upjohn J. after reviewing a number of authorities including the in Re 40 Compton Case referred to above says thus :----"In my judgment it is at the stage when the primary class of eligible persons is ascertained that P² Theome Tax the question of the public nature of the trust arises and falls to be decided, appeal to the and it seems to me that the Will satisfies that requirement, and that the Board of Review trust is of sufficiently public nature. If when selecting from that 22-12-54 primary class the trustees are directed to give a preference to the *-continued*. employees of the Company and members of their families, that cannot affect the validity of the primary trust......this is not primarily a trust for persons connected with John Batt & Co. and the class of person to benefit is not "confined" to them, and in my judgment the trust contained 10 in clause 7 and 8 of the Will of the testatrix is a valid charitable trust."

We hold that the same reasoning applies to the present case and that it is a trust of a public character established solely for charitable purposes. It was contended by the Assessor that the inclusion of the word "solely" in Section 7 (1) (c) makes a difference. We do not think so. If the trust though of a public character contained charitable purposes along with non-charitable purposes which could not be severed from each other, then the trust is not established solely for charitable purposes. In this case all the purposes were charitable purposes.

We therefore allow the appeal and hold that the trust is not liable to 20 Income Tax.

The Trustees informed the meeting that on 31-3-53 the Assessor of Income Tax assessed the income of the Abdul Ghafoor Trust for the Income Tax year ending 31-3-50 at Rs. 75,000/- and called upon the Trustees of the Trust to pay the sum of Rs. 15,000/as Income Tax reckoned at 20%. The Assessor was of opinion that in new clause 2 (b) of the Trust Deed No. 1833 dated 24-12-1942 the Trust cannot be treated either as one of a public character or established solely for charitable purposes. The

Trustees objected to the assessment and the objection was heard P_4 by the Commissioner of Income Tax on June 23, 1954. On the meeting June 29, 1954 the Commissioner made his order dismissing the of the appeal of the Trustees. In dismissing the appeal the Com-Abdul missioner increased the Assessable Income of the Trustees of Abdul and Abdulmissioner increased the Assessable Income of the Trustees to pay a 24-12-54 higher sum as Income Tax based on the increased assessment. —*continued*. The Trustees thereupon appealed to the Board of Review. The Board of Review after hearing Counsel for the Trustees and the Assessor on November 23, 1954, allowed the appeal. The Board held on the authority of In re Koetgiv's Will (1954) 1 All England Reports 581, that the Trust Deed No. 1838 dated 24-12-1942 created a Charitable Trust and the income of which was exempt from taxation in terms of Section 7 (1) (c) of the Income Tax Ordinance, which exempts income from trusts of a public character established solely for charitable purposes.

The Trustees also informed the meeting that in view of the change over of the supply of electric current from direct current to alternative current in the Fort Area from the end of the year 1954 it becomes necessary to change the forty year old lifts now working in the Gaffoor Building and replace them with new The Gaffoor Building itself requires reconditioning in lifts. respect of the roofs, basement walls and H-iron supports; verandah batches, lavatory accommodation and stair cases arrangements etc. They also recommended that in view of the general demand for office accommodation in the Fort it will be worth while if at the time of the general reconditioning of the building and the erection of the new lifts the work of electing an additional floor (a third floor) on the present building is also undertaken. It was decided that in view of anticipated capital expenditure in the near future on the purchase of new lifts, maintenance upkeep of, and new erections to the trust property -Gaffoor Building----donations and other expenditure should be curtailed.

10. The meeting ended at about 5-30 p.m. with a vote of thanks to the Chair and recital of Fathiha and Dua.


