

The plaint of the plaintiffs abovenamed appearing by D. A. S. Ranaweera, their Proctor states as follows:—

- 1. The defendants reside at the respective places aforesaid and the 10 cause of action hereinafter set out arose and the land which is the subject matter of this action is situated within the jurisdiction of this court.
- 2. Singappulige Rana Fernando was by long and prescriptive possession the lawful owner of the premises morefully described in the schedule hereto situate within the jurisdiction of this Court and of the value of Rs. 15,000/-.
- 3. By deed No. 406 dated 11th September, 1941 the said Rana Fernando sold and transferred the said premises to Dr. M. G. Perera the 3rd defendant abovenamed who entered into possession thereof.
- 4. The said Dr. M. G. Perera by deed No. 3098 dated 5th May 1953²⁰ sold and transferred the said premises to the plaintiffs abovenamed who entered into possession thereof and made improvements to the value of Rs. 10,000/-.
- 5. The plaintiffs and their predecessors in title have been in the undisturbed and uninterrupted possession of the said premises by a title adverse to and independent to all others and have acquired a prescriptive title thereto.
- 6. The 1st and 2nd defendants who have no manner of right or title to the said premises on or about 22nd November, 1953 wrongfully and unlawfully entered the said premises and continue to be in wrongful 30 possession of the same disputing the Plaintiff's title to the Plaintiffs' loss and damage of Rs. 5,000/- and continuing damages at Rs. 1,000/- a month.
- 7. The 2nd plaintiff prosecuted the 1st and 2nd defendants in M. C. Kurunegala case No. 6128 on the 26th November, 1953 and the 2nd plaintiff was directed to file a Civil action on the 1st and 2nd defendants depositing a sum of Rs. 2,000/- as security in the case. The said security was deposited on the 27th February, 1954.
- 8. A cause of action has accrued to the Plaintiffs to sue the 1st and 2nd defendants for a declaration of title ejectment and damages.

9. The 3rd defendant is made a party necessary to give him notice of this action to enable him to appear and warrant and defend the title conveyed by him to the plaintiffs and no other relief is claimed against him in this action.



The answer of the 2nd defendant abovenamed appearing by Aloysius Eric Oswald de Silva, his Proctor states as follows:—

- 1. This defendant admits the averments in paras 1 and 7 of the plaint and denies the rest which are not consistent with this answer.
- 2. Further answering this defendant states that the land described in the schedule to the plaint was waste land situated in the Kandyan Pro²⁰ vinces and as such was land at the disposal of the Crown.
 - 3. The Crown by its Order under Waste Lands Ordinances of 1897, 1899, 1900 and 1903 published in *Government Gazette* No. 6927 of 1st March, 1918 declared Henry Fernando and Albert Cyril Fernando the owners of the said land.
 - 4. The said Henry Fernando being seized and possessed of a half share died leaving as his heirs his five children Albert Cyril, Henry Lionel, Clouda, Stella and Olga.
 - 5. The said Albert Cyril Fernando being seized and possessed of 6/10 share died leaving as his heirs his children Leila Godvia and Bede.
- 6. Henry Lionel, Clauda, Stella, Olga, Leila Godvia and Bede being seised and possessed of the said land by deed No. 35 dated 7th October, 1953 sold the same to this defendant.
 - 7. This defendant by deed No. 4498 of 3-11-1953 sold 1/10th share to the 1st defendant who by deed No. 4701 of 8-2-1954 resold the same to this defendant.

The plaintiff seeks to have a declaration of title to two allotments of land called Elabodahenyaya and Medakumburahenyaya marked L114A and O114 appearing in P. P. 4516.

According to the plaintiff the 3rd defendant Dr. M. G. Perera purchased this property on deed P1 of 11th September, 1941 from one Rana Fernando. The transferor on P1 states that she is entitled to this land by right of inheritance from her son and grandson Singapullige Henry Fernando and Singapulige Albert Cyril Fernando. Thereafter Dr. M. G. Perera planted this land. With the deed are attached—, a copy of the Final Order No. 1991 of 1st March, 1918 showing that Henry Fernando and Albert Cyril Fernando purchased the land from the Government; a plan dated 15th May, 1953, an exract from the Ceylon Government Gazette No. 6927 of 10 1st March, 1918. Thereafter the 2 plaintiffs purchased the land on deed P2 of 5th May, 1953.

According to the story of the 1st plaintiff, he was in possession of this land and he and the 2nd plaintiff put up a house and the 2nd plaintiff occupied that house. On 11-8-53 the 2nd plaintiff left the land as he had fallen ill. In November, 1953 the watcher he had placed was ousted by the defendants and he made a complaint to the D. R. O., to the police and to the headman. Later he found that the coconut plants which were there when he purchased the land had been removed by the defendants. According to him there were 9 or 10 coconut trees of about 9 years of age which had 20 been removed.

Wickremasinghe, the Assistant Superintendent of Clovasana Estate, belonging to Dr. M. G. Perera gave evidence. He said that on the date of the purchase by Dr. Perera he planted this land till the sale in 1953. Evidently the crops and the coconut plants planted by him failed because of the drought. He frankly admitted that he was not a cultivator of coconut but he merely carried out the instructions of the visiting agent, and that the plantation was more or less a failure because only a few trees were planted. He said that he put up a house for him to stay and that his watcher stayed there. The 1st plaintiff who gave evidence contradicted this by saying that there was no house when he went there. Mr. Wickremasinghe said that there was a house in a dilapidated condition more or less. Mr. Wickremasinghe too stated that he was aware that the government had made an allocation of a portion of this land to some person and he was aware of the fact that the Government Agent wrote to that person to leave the land as it was private property.

The defence called Mr. Claude Stanley Fernando an advocate practising at Colombo. His father was one Henry Fernando and his brother was Dr. Albert Cyril Fernando. These two names tally with the names of the purchasers from the crown in 1917. But Mr. Claude Fernando definitely states that he was not aware of this land. I therefore do not know whether it is really his father and his brother who were the purchasers. There may have been 2 other persons by the name of Henry Fernando and Albert Cyril Fernando who may have purchased this. These names are fairly common in Ceylon. Claude Fernando became aware of this land only when one Pathirana told him about the existence of these lands.

Claude Fernando and Chandra Bede signed deed No. 35 of 1953 (marked 2D1) in favour of the 2nd defendant, and very advisedly Mr. Claude

Fernando had got it inserted that he would not warrant and defend title as he was not aware of the existence of the land.

The other heirs of Henry Fernando and Dr. Albert Cyril Fernando had given powers of attorney to Mr. Claude Fernando to transfer the land. Thereafter the defendants had taken possession of this land from the plaintiffs.

None of the defendants gave evidence. They merely called one Kulatunga to whom the Government had given permit in 1945 to possess this land. Thereafter that permit was withdrawn from him as it was proved to be private land. It is clear that this withdrawal of the permit 10 was not at the instance of Mr. Claude Fernando or the other heirs of Henry Fernando and Dr. Cyril Fernando alleged by the defence. If it had been at their instance Claude Fernando would have been aware of the existance of the land. His lack of knowledge shows that it was not at their instance but Wickremasinghe the Superintendent under Dr. M. G. Perera speaks about this. Hence it is clear that it is at their instance that this had been done or on some complaint made to the Government Agent on their behalf.

Kulatunga admitted in evidence that the boundaries were given to him by the 2nd defendant Robo Singho. I do not know how he would otherwise have got the boundaries. During his possession he was not 20 aware of Wickremasinghe being in occupation. This witness did not impress me as a truthful witness. He appears to be very partial to the defence and I do not accept his evidence as true.

The other witness called by the defence was the village headman. How this village headman came to remember the number of the plan and its extent I do not know. In his official capacity he would have looked into a number of plans, and he had seen this plan somewhere in 1953, at the latest, and I do not know how he would have kept this information in mind. inquired from him whether he refreshed his mind after that and he answered in the negative. This clearly shows how partial he is to the defence. I 30 am sure he must have been given this information by the 2nd defendant. He said that on a reference by the D. R. O. he went to the land and according to the information given by the D. R. O. one Jayawardena, that is the 1st plaintiff, had purchased the land and that the 2nd defendant was trying to get possession of it. He also said that when he went there he found the 2nd defendant and several others there and that he also saw several young coconut plants. According to him they were 1 year to 6 months old, most probably plants planted by Jayawardena or immediately before Jayawardena purchased it, because Jayawardena was ousted 5 months after his purchase. That was when he went to the land on 11th November, 1953 for the 40 first time. When he visited this land for the 2nd time on 24th November he did not find a single coconut plant. This clearly shows that the 2nd defendant had tried to eradicate that someone had been in possession of this land, merely to avoid prescriptive title. If it has been jungle land then prescription would not take place. The removal of such evidence clearly shows that the defendant was aware that the land was in possession of someone and he wanted to remove it. As I said, the headman being a partial

witness, he does not want to say whether any plants were removed. But he definitely stated that there were no trees of 10 years of age. I do not accept this evidence.

Further Mr. Claude Fernando stated that Rana Fernando is no relation of theirs. If Henry Fernando and Cyril Fernando did not belong to the relationship of Rana Fernando and that the true purchasers were the ancestors, or her brother — Claude Fernando were the true owners, Dr. M. G. Perera would have prescribed to the land from the date that he came into possession I see no reason not to accept the evidence of Wickremasinghe.

Hence it is clear that this had been in the possession of Dr. M. G. Perera since 1941 and that the ouster was only in 1953. Thus the plaintiffs have prescribed to the title even if title was in the defendants.

On the evidence there is nothing to hold that Rana Fernando too had a son and grandson and their names were Henry Fernando and Cyril Fernando and who had obtained a transfer from the crown. The Crown Grant unfortunately had not been produced. But whatever the paper title of the parties were the plaintiffs have prescribed to this land.

Therefore it must be taken into account that Mr. Claude Fernando, being an advocate, a member of the legal profession, would have known if 20 this land belonged to them and would not wait for information to be given by others about this land and only for the sake of the transfer.

I therefore hold that it is more probable that the deed in favour of Dr. Perera were made by the real owners of the land.

I therefore answer the issues as follows:—

- 1. Yes.

- 3. Damages agreed upon.
- 4. Plaintiffs have prescribed to the land.
- 5. No.
- 80 6. No.
 - 7. Does not arise and was not proved.

I therefore give judgment to the plaintiff as prayed for but restrict the damages to the amount agreed upon, and costs.

HIS LORDSHIP THE CHIEF JUSTICE AND OTHER JUDGES OF THE SUPREME COURT OF THE ISLAND OF CEYLON.

On this 19th day of May, 1958.

The petition of appeal of the 2nd defendant-appellant abovenamed appearing by A. E. O. de Silva, his proctor states as follows:—

- 1. The plaintiffs filed this action against the 3 defendants above-20 named for a declaration of title to a land 50 acres and 27 perches in extent described in the schedule to the plaint.
- 2. The 2nd defendant-appellant filed answer setting out his title and pointed out that the plaintiffs had no title whatsoever. The 1st defendant did not file answer and took no part in the action.
- 3. The 3rd defendant Dr. M. G. Perera was made a party to enable him to appear and warrant and defend his title which passed to the plaintiffs.
- 4. The case went to trial on the 30th day of April, 1958 and the learned District Judge by his order dated 16th May, 1958 gave judgment 30 for the plaintiffs and damages as agreed upon.
- 5. Being aggrieved and dissatisfied with the said judgment the 2nd defendant-appellant begs to appeal therefrom to Your Lordships' Court on the following among other grounds that may be urged by Counsel at the hearing of this appeal.

- (a) The said judgment is contrary to law and against the weight of evidence adduced in the case.
- (b) On the question of title the learned District Judge has misdirected himself in holding that he does not know, "whether it is really Claude Fernando's father and his brother who were the purchasers" from the Crown. The learned Judge further holds that "there may have been two other persons by the name of Henry Fernando and Albert Cyril Fernando." The identity of these two persons and the land purchased by them from the Crown is conclusively established by the Schedule to the plaint which admits 10 the Crown Grant and the title set out by the Appellant reinforced the evidence of Advocate Claude Fernando.
 - (c) Rana Fernando from whom Dr. M. G. Perera traces his title could not have inherited this land from Henry Fernando and Albert Cyril Fernando, her son and grandson, as they both died leaving as heirs several children who sold their rights to the 2nd defendant-appellant.
- (d) The learned District Judge further holds that the plaintiffs and Dr. M. G. Perera have acquired prescriptive title to the land in dispute. It is respectfully submitted that evidence of prescriptive possession adduced in this case is inadequate and insufficient inasmuch as Dr. M. G. Perera ²⁰ failed to give evidence although he was present in Court and the plaintiffs have had only 5 months possession, and Kiribanda, the Watcher was not called.
- (e) The only evidence in support of prescriptive possession was that of Wickremasinghe, the Private Secretary of Dr. M. G. Perera who is supposed to have possessed this land as the Agent of Dr. M. G. Perera from 1941 to 1953 without interruption and obstruction. His evidence should not have been accepted in view of the very material contradiction of his evidence of the plaintiffs regarding the existence of a house in the land at the time of the purchase by the plaintiffs from Dr. M. G. Perera. If Wickremasinghe 30 really visited this land at the time of the purchase he would have discovered that there was no house.
 - (f) Wickremasinghe's evidence of continued possession should not be accepted in view of the evidence given by Kulatunga that he cultivated 15 acres of this land from 1945 till 1949. This evidence is supported by the evidence of the Village Headman.
 - (g) The learned District Judge states that Kulatunga did not impress him as a truthful witness but does not give any reason for rejecting his evidence. Kulatunga's evidence is supported by documents written to him by the Government Agent of North Western Province, Kurunegala.
- (h) The Village Headman's evidence is rejected because he remembered the number of the Plan relating to this land and holds, "this clearly shows how partial he is to the Defence. I am sure he must have been given this information by the 2nd Defendant". Fortunately for the Village Headman he has failed to remember correctly the number of the Plan. He mentions

the number as 1849 whereas in fact the correct number is 1848. If the information was given by the 2nd defendant he would have received the correct number.

- (i) It is respectfully submitted that there were no coconut trees in bearing in the jungle of 50 acres and there is no evidence that the 2nd defendant destroyed any plantations or took forcible possession from the plaintiffs and therefore no damages should have been awarded.
- (j) Although the plaintiffs claim Rs. 10,000/- as damages there was no proof of any improvements made to the land.
- (k) In view of the established title of the 2nd defendant and the absence 10 of satisfactory proof of prescriptive possession by the plaintiffs or their predecessor Dr. M. G. Perera it is submitted that the plaintiffs' action should have been dismissed.

Wherefore the 2nd defendant-appellant prays that the judgment and order of the learned District Judge be set aside, that judgment be entered in favour of the 2nd defendant-appellant, for costs and for such other and further relief as to Your Lordships' Court may seem meet.


