

<u>AN AGREEMENT</u> made on the Seventeenth day of February One thousand nine hundred and Sixty <u>BETWEEN</u> <u>HIRE</u> <u>FINANCE LIMITED</u> of 9-13 Bligh Street, Sydney (hereinafter referred to as the Company) <u>AND</u> The undersigned (hereinafter referred to as the Agent) <u>WHEREAS</u> the company at the request of the agent has agreed to permit the agent to acquire motor vehicles on behalf of the company and to sell such vehicles on behalf of the company upon the following terms :-

1. The agent is authorised to purchase such types of motor vehicles and cycles and in such quantity as the company may from time to time in writing authorise. Such authority may be revoked at any time but shall not affect any vehicles or cycles purchased in pursuance of such authority prior to its revocation. All such motor vehicles and cycles are referred to hereinafter as goods.

- 2. All new goods shall be purchased by the agent from the distributor in the name of the company and shall be paid for by the company. Any used goods may be purchased by the agent in the name of the company or in the name of the agent without disclosing the agency. Purchase in this regard shall include a trade-in to the agent in the ordinary course of his business.
- 3. The company will pay to the agent 90% of the 10 purchase price or trade-in allowance of any used goods but prior to so doing reserves to itself the right to assess by independent valuation or otherwise the fair wholesale value of any such goods and such assessment shall be binding on the agent and shall be substituted for the purchase price or tradein allowance.
- 4. The agent agrees to keep all goods purchased in pursuance hereof in as good order and 20 condition as when acquired on behalf of the Company and will indemnify the company from and against all loss or damage thereto from any cause whatscever arising while in the possession of the agent and in particular will indemnify the company from and against all actions proceedings claims and demands arising out of any defect in the title thereto.
- 5. The agent agrees that as from the date of 30 acquisition any goods purchased in pursuance hereof shall be on hire and the possession of the agent shall be as bailee only. Nevertheless the agent may sell such goods on behalf of the Company. If a sale is made by the agent for cash or on hire purchase not arranged through the company the agent will account to the company immediately thereafter (and irrespective of the sale price) for:
  - (a) in the case of new goods the purchase 40 price paid by the company
  - (b) in the case of used goods the 90% of the purchase price or trade-in allowance or assessment paid by the company to the agent.

If a sale is on hire purchase arranged Exhibit "W" through and accepted by the company (at its discretion) the agent will immediately there-after:-

- (a) in the case of new goods account to the company for the deposit received less the difference between the sale price and the purchase price paid by the company
- (b) in the case of used goods account to company for the deposit received less the difference between the sale price and the 90% paid by the company to the dealer

<u>AND</u> in all cases exclusive of the hiring or rental charges referred to in Clause 7 hereof <u>BUT</u> the agent shall be entitled to retain any surplus over and above the above amounts as and by way of his commission.

- 6. <u>DURATION OF AGREEMENT</u>. The agent or the company may at any time respectively return or require the return of any goods and the agent will on demand forthwith deliver up possession of any goods the subject hereof and in default the company may at any time by its authorised agent take possession of any goods without notice and may enter any premises of or controlled by the agent by force if necessary and as the act of the agent may enter any premises of any other person in the name of the agent.
  - 7. RENTAL OR HIRING. The agent shall pay to the company on demand during the bailment of any goods a rental calculated from the date of acquisition by the company until the date of return to the company or in the case of a sale until the day of accounting by the agent of Thirty pounds per centum per annum on a daily basis on the price paid by the company under clause 2 or 3 hereof as the case may be provided nevertheless that the company will accept in lieu thereof in all cases where the agent shall observe the terms and conditions hereof and in respect of all goods sold on hire shall submit an offer to hire Exhibit "W"

below motor vehicles and such other goods as may be agreed on from time to time which Griffiths Bros. Credits will let on hire to the Dealer for display on the Dealer's showroom floor HEREBY AGREES as follows: -

1. To purchase on Griffiths Bros. Credits behalf and as its agent, within the limits and subject to the conditions set out below, display 30 units as defined in Clause 2 suitable for display on the Dealer's showroom floor.

- A DISPLAY unit may consist of :-2.
  - (a) a new vehicle - that is to say, a new motor car or goods or passengercarrying vehicle, to be acquired from the manufacturer or distributor (either of whom are comprised in the term "distributor" used hereunder).
  - (b) a used vehicle - that is to say, a used motor car or goods-carrying vehicle not being a trade-in as defined in subclause (c).

- (c) a "trade-in" that is to say, a motor car or goods or passenger-carrying vehicle taken over by the Dealer on the disposal of a new motor vehicle as defined in-Clause 2 sub-clause (b) or on a trade-in as defined in this subclase (whether the new vehicle or used vehicle or trade-in as the case may be, is itself a display unit or is part of the Dealer's general stock).
- 3. THE Dealer's authority to purchase display units hereunder shall be limited by such directions as Griffith Bros. Credits may give the Dealer from time to time as to the make price type or model of display units to be purchased and as to the limit of expenditure and in particular Griffiths Bros.Credits may limit the Dealer to any one or more of the classes and sub-classes of display unit defined in Clause 2 and may at any time wholly revoke or suspend his authority.
- 4. (a) Every new vehicle purchased as a display unit shall be purchased from the distributor in Griffiths Bros. Credits name and shall be paid for by Griffiths Bros. Credits direct to the distributor on or before delivery of the vehicle to the Dealer.
  - (b) Every used vehicle purchased as a display unit shall be purchased by the Dealer 30 from the owner thereof as Griffiths Bros. Credits' agent (but without his necessarily disclosing the fact of agency) and shall be paid for in the first instance by the Dealer as Griffiths Bros. Credits' agent, but Griffiths Bros. Credits shall reimburse the Dealer as provided in clause 5.
  - (c) Every trade-in as defined in Clause 2 (c) taken over by the Dealer shall if covered by the limits of his authority hereunder 40 existing at the time the trade-in is taken over be deemed to have been purchased by him as Griffiths Bros. Credits' agent whether he discloses to the other party the fact of agency or not, and he shall be deemed to have paid to the other party, as Griffiths Bros. Credits' agent, an amount equal to the trade-in allowance on the Exhibit "7"

trade-in, Griffiths Bros. Credits shall reimburse the Dealer for such expenditure as provided by Clause 5.

- (d) The Dealer shall have no right or interest in any display unit acquired hereunder which shall be solely the property of Griffiths Bros. Credits.
- 5. GRIFFITHS BROS. CREDITS shall indemnify and reimburse the Dealer in respect of the expenditure incurred by him as Griffiths Bros. Credits' Agent under Clause 4 (thereinafter called "the purchase money") as follows:-

In the case of a used vehicle or tradein as defined in Clause 2 sub-clauses (b) and (c) Griffiths Bros. Credits shall reimburse the Dealer one hundred (100) per cent, of the purchase money or of the fair wholesale value as assessed under Clause 6 (whichever is the less) when he has complied with Clause 6 and the balance shall be reimbursed (subject to Clause 10) when such display unit is disposed of.

6. BEFORE acquiring any used vehicle or trade-in the Dealer will satisfy himself as to the title. He will supply Griffiths Bros. Credits with such details as Griffiths Bros. Credits requires concerning the vehicle and will hand Griffiths Bros. Credits the owner's certificate (if any). Further the Dealer warrants that he will not acquire any trade-in or used vehicle at a sum higher than the fair wholesale value. Griffiths Bros, Credits may at any time assess the fair wholesale value of any trade-in or used vehicle purchased by the Dealer for Griffiths Bros. Credits and such assessment made by Griffiths Bros. Credits shall be strictly conclusive and binding between the parties. If Griffiths Bros. Credits: assessment is less than the purchase price paid by the Dealer and Griffiths Bros. Credits has reimbursed the Dealer on the basis of the purchase price, the dealer will on demand repay Griffiths Bros. Credits the amount paid by it in excess of 100 per cent. of the assessed fair wholesale value.

- 7. THE Dealer indemnifies Griffiths Bros. Credits against any loss arising by reason of the title to any display unit purchased by him on Griffiths Bros. Credits' behalf proving to be defective.
- 8. THE Dealer will carry out at his expense all repairs to used vehicles and trade-ins as defined in Clause 2 sub-clauses (b) and (c) necessary to put the units in reasonable order.
- 9. To take every display unit on to the Dealer's floor immediately after its acquisition and to be personally liable for and pay all freight and delivery charges on the unit. The Dealer shall be deemed for the purposes of this agreement to have taken delivery on the date of acquisition of the unit.
- 10. To take on hire every display unit provided hereunder and keep the same in the Dealer's 20 own possession as bailee for Griffiths Bros. Credits for display purposes only on his showroom floor and not to allow the same to be driven or operated for demonstration or trading purposes but on the contrary to keep the same in at least as good a condition as when purchased for Griffiths Bros. Credits and to indemnify Griffiths Bros. Credits against any loss or damage to the unit (whether before or after it reaches the 30 Dealer's floor) arising from the act or default of anyone but Griffiths Bros.Credits and against any expenses incurred by Griffiths Bros. Credits in making good any default by Further the Dealer hereby the Dealer. warrants that on the sale or other disposal of the display unit (wherever occurring) Griffiths Bros. Credits will receive a price or sum (exclusive of hire charges) at least equivalent to the distributor's net price in respect of a new display unit or the purchase 40 money referred to in Clause 5 in the case of display units as defined in Clause 2 subclauses (b) and (c).
- 11. SUBJECT to the limitations in Clause 10 the Dealer may sell the display unit on Griffiths Bros. Credits' behalf or receive on its behalf offers to take it on hire purchase from

Griffiths Bros. Credits and he shall account to Griffiths Bros. Credits for all moneys received by him from the customer. If the unit is disposed of under hire purchase his authority to receive moneys on Griffiths Griffiths Bros. Credits' behalf shall be limited to the initial payment and he shall not have or hold himself out as having any authority to collect rentals on Griffiths Bros. Credits' behalf.

- 12. NOTHING contained in Clause 11 shall relieve the Dealer of any obligations to Griffiths Bros. Credits in respect of a display unit insofar as the sums available in accordance with Clause 11 prove insufficient to discharge such obligations.
- 13. (a) If during the bailment a display unit is sold or let by Griffiths Bros. Credits on hire purchase to a customer the Dealer shall subject to sub-clauses (b) and (c) be entitled by way of commission to a sum equal to
  - (1)In the case of a new vehicle the difference between the distributor's net price to Griffiths Bros. Credits for the unit and the retail cash list price:
  - (2)in the case of a used car or trade-in the difference between the purchase money or the assessed fair wholesale value (whichever is less) and the cash list price to the customer.
  - (Ъ) If there is no "difference" as aforesaid, no commission shall be payable by Griffiths Bros. Credits.
  - (c) Griffiths Bros. Credits will however be entitled to deduct from the commission referred to in sub-clause (a) -
    - (1)any freight and delivery or other charges on the display unit

- (2) rent calculated over the whole of such display period involved at the rate of Five Pounds (£5.0.0.) for the first month and 1% simple per month thereafter on the distributor's net price to Griffiths Bros. Credits or the proportion of purchase money 10 provided by Griffiths Bros. Credits under Clause 5 as the case may be, but such rent to be subject to adjustment in accordance with Griffiths Bros. Credits' rebating system in operation from time to time.
- 14. THE bailment of a display unit shall continue until the happening of whichever of the following events shall first happen :
  - (a) the expiration of four months in the 20 case of a new display unit or two months in the case of a used vehicle or tradein calculated from the date of delivery to the Dealer (which periods are in this agreement called "display periods") :
  - (b) the Dealer's delivering up the unit to Griffiths Bros. Credits;
  - (c) Griffiths Bros. Credits' taking or demanding possession of it;
  - (d) the disposal of it.

PROVIDED that if within 7 days after the expiry of a display period the Dealer does not return the unit to Griffiths Bros. Credits he shall be deemed to have re-hired it from Griffiths Bros. Credits as from the day after such expiry on the same terms as if it had been delivered to him as a display unit hereunder on that day.

15. THE Dealer may deliver up a display unit to Griffiths Bros. Credits at any time. Griffiths 40 Bros. Credits or its authorised agent may at any time take possession of any unit without notice and for that purpose or in search of

premises of any other person. Griffiths Bros. Credits or its authorised agent may check inspect or test any unit at any time and make for any such purpose the like entries as above. The Dealer indemnifies Griffiths Bros. Credits against responsibility for anything lawfully done in purported performance of this clause.

- 16. (a) The Dealer shall be liable to pay Griffiths Bros. Credits on demand rent during the bailment calaculated at onetenth of one per centum per day on the distributor's net price to Griffiths Bros. Credits or the proportion of the purchase money provided by Griffiths Bros. Credits under Clause 5 as the case may be PROVIDED HOWEVER that if the unit is sold or let on hire purchase during the bailment (whether original or renewed under the proviso to Clause 14) the total rent in respect of each display period shall be reduced to the rent stated in Clause 13 (c) (2).
  - (b) If the Dealer fails or refuses to deliver a display unit to Griffiths Bros. Credits on demand by Griffiths Bros. Credits he shall be liable to pay Griffiths Bros. Credits as liquidated damages for detention an amount equal to one-tenth of one per centum per day calculated on the distributor's net price to Griffiths Bros. Credits or on the proportion of the purchase money provided by Griffiths Bros. Credits under Clause 5 as the case may be watil Griffiths Bros. Credits obtains possession. This liability shall be without prejudice to any other legal obligation to Griffiths Bros. Credits on the Dealer's part in relation to the unit.
- 17. ANY trade-in taken by the Dealer on a display unit otherwise than in accordance with his then current authority to accept trade-ins as display units shall be deemed

to have been taken over by him entirely on his own account and he shall be bound to provide to Griffiths Bros. Credits cash equal to the amount all-owed on the tradein (if the same be traded in on a display unit).

- 18. TO deposit with Griffiths Bros. Credits an amount equivalent to ten per centum of the limit value for display units under this plan from time to time fixed by Griffiths Bros. Credits and to augment this amount to maintain this ratio if the limit value is increased. Griffiths Bros. Credits shall refund to the Dealer on request any amount required to maintain this ratio if the limit value is reduced.
- 19. GRIFFITHS BROS. CREDITS may at any time in its discretion use all or any part of the deposit moneys to discharge any of the Dealer's obligations to Griffiths Bros. Credits whether 20 arising under this agreement or otherwise or in Griffiths Bros. Credits discretion to pay any sum owing by the Dealer to any distributor from whom a display unit or units have been purchased hereunder. On the termination of this agreement Griffiths Bros. Credits shall re-pay to the Dealer any of the deposit remaining subject to his no longer being indebted to Griffiths Bros. Credits or to any such Distributor as aforesaid. 30
- 20. THE Dealer may not assign his rights hereunder. He will indemnify Griffiths Bros. Credits against any loss suffered by Griffiths Bros. Credits by reason or arising out of any failure by him to observe or perform his obligations hereunder. Griffiths Bros.Credits may pay any moneys payable by the Dealer to a third party in respect of a display unit and the sum paid shall be deemed a debt due by the Dealer to Griffiths Bros. Credits. Griffiths 40 Bros. Credits shall have power to appropriate any moneys paid by the Dealer or any sum due by Griffiths Bros. Credits to the Dealer towards any debt or liability owing by him. 




