#### STATEMENT OF CLAIM

Jacob Williamson Sawyerr late of Accra in Ghana (formerly the Gold Coast Colony) was seised in fee simple absolute of hereditaments and premises with buildings thereon situated at Fourah Bay Road, Malta Street, Lucas and Farm Land at Fourah Bay Road all in Freetown in the Western Area of Sierra Leone (formerly the Colony of Sierra Leone).

2. The said Jacob Williamson Sawyerr died on the 15th day of August 1916 having made and

duly executed his last Will and Testament dated the 30th day of May, 1908 probate whereof was on the 14th day of October 1918 committed and granted at Accra in the Gold Coast Colony aforesaid to Ransolina Patience Cromanty the then sole surviving executrix and trustee under the Will of the said Jacob Williamson Sawyerr (deceased).

3. In the said Will the said Jacob Williamson Sawyerr inter alia made the following devise:-

"I device and bequeath my freehold lands with the buildings therein situate at Fourah Bay Road Malta Street, Lucas Street and Farm land at Fourah Bay Road, all in Freetown Sierra Leone to my brothers Richard William James Beresford and my sister Ransolina Patience Cromanty, and to my daughters Georgiana Lucretia and Jane Alice all in equal share and it is express desire that these lands be not sold but that they must descend from children to children".

- 4. Richard William and James Beresford referred to in the aforesaid devise predeceased the testator Jacob Williamson Sawyerr.
- 5. Jane Alice referred to in the said devise was married to a certain Emmanuel Onesimus Smith and became known as Jane Alice Smith.

6. The said Jane Alice Smith died on the 24th day of December 1957 having made and duly executed her last Will and Testament dated the 11th day of December, 1957, probate whereof was on the 27th day of February, 1958 committed and granted by the Supreme Court to the executors and trustees therein named.

7. By her said Will the said Jane Alice Smith inter alia made the following devises:-

para. 12 "I devise my share of arrears of rent due me during my lifetime in the property situate at Fourah Bay Road in Freetown aforesaid now being used as Saint Philips Church Parsonage to all my male children mentioned in this will".

10 para. 13 "I give devise and bequeath the rest and residue of my estate (real and personal) not herein devised by this my Will to all my male children share and share alike and I direct that any benefit which under this my Will may become vested in any female herein or hereafter to be born married or to become married shall be for her sole and separate 20 estate free from the debts control engagements interference or liabilities of any husband."

- 8. The property referred to in paragraph 12 of the Will of the said Jane Alice Smith is the freehold land with the buildings thereon situate at Fourah Bay Road, referred to in the devise of the Will of the said Jacob Williamson Sawyerr (deceased).
- 9. Georgiana Lucretia was married to a certain Rose and became known as Georgiana Lucretia Rose.
  - 10. The said Georgiana Lucretia Rose died on the 16th day of April, 1963 a widow and intestate without any lawful issue.
  - 11. Ransolina Patience Cromanty aforesaid registered the will and probate thereof of the testator Jacob Williamson Sawyer deceased obtained at Accra aforesaid on the 11th day of July 1918 and thereafter intermeddled in the

Defendants herein were not defendants in those 30 two actions - defendants in those two actions were Executors of the Estate R.P. Cromanty deceased.

Relationship between defendants and Estate of R.P.Cromanty deceased is that defendants

derived title to No. 98 Fourah Bay Road from a Deed of Gift where the Donor was R.P. Cromanty Position is that R.P. Cromanty deceased. deceased could not give any better title than she herself had - plaintiff herein is one of the plaintiffs in those two actions where it was decided that the plaintiffs are beneficially interested in 98 Fourah Bay Road and that R.P. Cromanty had intermeddled as Executor de bon tort in the estate - plaintiff would 10 therefore have to litigate all over again.

Mr. Luke opens case - Action in which Plaintiff seeks to set aside a Deed of Gift dated 6.10.53 made between one Ransolina Patience Cromanty now deceased late of No. 14 Crook Street, Freetown and Executrix of Will of Jacob Williamson Sawyerr and the defendants registered at Page 15 15 Vol. 39 Register of Voluntary Conveyances - Grounds set out in the Statement of Claim - basically that Donor was 20 not the owner in fee simple or otherwise of 98 Fourah Bay Road - She was in fact an executrix de bon tort of the estate of Jacob Williamson Sawyerr late of Accra in Ghana which estate comprised 98 Fourah Bay Road and other properties - Reads Statement of Claim.

Note - 14th day of October 1918 in line 4 of Statement of Claim should read "14th October, 1916".

Ransolina Cromanty did not take probate in Sierra Leone nor did she reseal the probate obtained in Accra in Sierra Leone.

Ransolina Cromanty had a share in No. 98 Fourah Bay Road as a tenant in common.

Reads defence - Ransolina Patience Cromanty was well possessed of and entitled to the property in question - defendants rely on the Limitation Act. No Reply filed.

Mr. Luke - At this stage I ask for an adjournment on the ground that we could not go very far with the evidence - Only evidence of Plaintiff available - This could not take the Court very far - It would be preferable if all the evidence be taken together.

Mr. McCormack - I will not oppose the application but I ask for costs for today to be assessed at Le.4.20 cents.

Mr. Luke - I undertake to pay today's costs assessed at Le.4.20 cents.

Adjourned to 27.10.65 for hearing Costs for today assessed at Le.4.20 cents to defendants! Solicitor to be paid by the Plaintiff.

No Probate of that Will was taken out of this Court - in Sierra Leone - One was taken out in Ghana - Probate granted to Ransolina Patience Cromanty - only surviving Executor at the death of the Testator - The Deed of Gift in question relates to property No. 98 Fourah Bay Road, Freetown. Fourah Bay Road to all her male children - I am one - not specifically named - I am a lawful child - Probate of the Will of Jacob Williamson Sawyerr was not resealed in Sierra Leone - Will was registered in Sierra Leone -Mrs. Cromanty went into possession of No. 98 Fourah Bay Road by her tenants - She went into possession of No. 98 Fourah Bay Road in her capacity as executrix and trustee - There are documents in my possession in support of this namely -

By a Deed of Conveyance dated 16th day of November, 1932 made between Ransolina Patience Cromanty as executor and trustee of Jacob Williamson Sawyerr to Joseph Christopher Metzger registered at Vol. 130 page 106 of the Register of Conveyances at the office of the Registrar—General relating to portion of No. 98 Fourah Bay Road.

At this stage Mr. McCormack objects to this bit of the evidence on the ground that the evidence is of no relevance to the issue - It has not been pleaded. Court - Objection upheld.

Ransolina Cromanty also rented property to St. Philips Church.

She made a deed of Gift in 1953 relating to the property - 98 Fourah Bay Road another part of that property - Ransolina Cromanty continued after 1953 to receive the rents and profits of No. 98 Fourah Bay Road - No. 98 Fourah Bay Road has been the subject matter of proceedings before the Supreme Court between myself as one of the plaintiffs and the executors of Ransolina Cromanty No. C.C.85B/5 1958 S.No.10 - There was an appeal against the judgment in that case to the Sierra Leone Court of Appeal - S.L.App. 14/61 - Appeal was dismissed with costs. This property in question was one of the properties affected in those proceedings.

Xxd. by McCormack - Jacob Williamson Sawyerr in his Will specifically referred to No. 98 Fourah Bay Road - He described it as "my property at Fourah Bay Road" that meant No.98 Fourah Bay Road - Jacob Williamson Sawyerr had documents to show he owned No. 98 Fourah Bay Road - I refer to a Mortgage Deed dated 14.5.1895 made between James Beresford Sawyerr and Jacob Williamson Sawyerr registered at Vol.14 page 205 Register of Mortgages Registrar-General's Office - Freetown - Jacob Williamson Sawyerr did not refer to any mortgaged property in his will - don't know any person named James Beresford Sawyer - I understand he was grand uncle - It is true that Jacob Williamson Sawyerr left Sierra Leone in 1872 - He died in 1918 - He came in 1906 - I was not yet born - There is no foreclosure proceedings to the mortgage to which I have referred - I don't know when

Cross-Examination James Beresford Sawyerr died - I am not sure whether my mother had any portion of rent of 98 Fourah Bay Road during her lifetime - I am not sure whether she brought any action relating to No. 98, Fourah Bay Road.

- Q. Why do you say that Ransolina Cromanty went into possession of 98 Fourah Bay Road as Executrix and Trustee.
- A. She said so. She also stated so in the document I have already referred to.

James Beresford Sawyerr, I think, died first before Jacob Williamson Sawyerr.

C.J.:- In this action the Plaintiff claims that the Deed of Gift dated the 6th day of October, 1953, and made between Ransolina Patience Cromanty now deceased, late of 14, Crook Street, Freetown and Executrix of the Will of Jacob Williamson Sawyerr And the Defendants registered at page 15 in Volume 39 of the Books of Voluntary Conveyances be set aside with all proper consequential directions, costs and such further or other relief as is just.

The Plaintiff's case is this. On the

6th day of October, 1953 Ransolina Patience Cromanty (now deceased) conveyed to the Defendants in fee simple under a registered deed of gift Exhibit 'E' bearing that date premises commonly known as No. 98 Fourah Bay Road, Freetown.

"bounded on the North by Fourah Bay Road 53' (fifty three feet) on the South by property now or formerly in the possession or occupation of Jos Metzger 67' (sixty—seven feet) on the East by property now or formerly in the possession or occupation of Austin Bowen deceased 78' (seventy—eight feet) and on the West by Mercer Street 66' (sixty—six feet)".

I shall hereafter in this judgment refer to those premises as "No. 98 Fourah Bay Road". In the recital portion of Exhibit M Ransolina Patience Cromanty's title to No. 98 Fourah Bay Road is described in the following words:-

"Whereas the Donor is seised of and otherwise well and sufficiently entitled to the property hereby conveyed for an estate in fee simple in possession free from incumbrances having been in sole continuous and undisturbed possession of the said property for a period of over 36 years".

It might perhaps be convenient at this stage to trace the history of this property No. 98 Fourah Bay Road as far as the evidence in this case goes. No. 98 Fourah Bay Road originally formed part of certain premises at Fourah Bay Road Freetown which was acquired by purchase by James Beresford Sawyerr from one William Smith under registered Deed of Conveyance dated the 6th July, 1887. This Deed of Conveyance is Exhibit N.

On the 16th May, 1895, James Beresford Sawyerr by Deed of Mortgage dated the 16th May, 1895, Exhibit J, mortgage the whole of

the premises contained in Exhibit N which included No. 98 Fourah Bay Road to Jacob Williamson Sawyerr, a Merchant then residing at Accra in the then Gold Coast now The mortgage was redeemable on the 8th February, 1897. This mortgage was registered as No. 259/201510/65 at This mortgage page 205 of Volume 14 of the Record Book of Mortgages at the Registrar-General's Office in Freetown, Sierra Leone. 10 should be noted that on the date of the mortgage the mortgagor James Beresford Sawyerr was residing in Sierra Leone and according to paragraph 4 of the Defence James Beresford Sawyerr died in Freetown in the year 1909. There is no evidence that James Beresford Sawyerr or any one on his behalf redeemed the mortgage or obtained reconveyeance of the mortgage premises. In the circumstances I find that the mortgage 20 in question was never redeemed. That being the case I also find that the right of redemption on the part of James Beresford Sawyerr of the premises mortgaged has been lost by lapse of time.

Jacob Williamson Sawyerr died on the 15th August, 1915, at Accra Gold Coast now Ghana leaving his last Will and Testament dated the 30th day of May, 1908. I am satisfied on the evidence that on the date of his death the mortgaged premises at Fourah Bay Road belonged to and formed part of the estate of Jacob Williamson Sawyerr. In that Will part of Exhibit K, Jacob Williamson Sawyerr devised his real properties in Sierra Leone in these words:-

"I devise and bequeath my freehold lands with the buildings therein situate at Fourah Bay Road, Malta Street, Lucas Street and Farm land at Fourah Bay Road all in Freetown Sierra Leone to my brothers Richard William, James Beresford, my Sister Ransolina Patience Cromanty and

to my daughters Georgiana Lucretia and Jane Alice all in equal shares and it is my express desire that these lands be not sold but that they must descend from children to children".

On the 14th October, 1916, probate of the said Will dated 30th May, 1908 of Jacob Williamson Sawyerr was granted by the Supreme Court of the then Gold Coast Colony now Ghana to Ransolina Patience Cromanty according to the evidence, the only surviving of the three Executors named in the said Will. Exhibit K refers. Exhibit K was not resealed in Sierra Leone as it should have been done under Order-in-Council applying the provisions of the English Statute The Colonial Probates Act 1892 to both the Gold Coast and Sierra Leone. The effect of such resealing would have been that the probate Exhibit K would have been of like force and effect and would have had the same operation in Sierra Leone as if Exhibit K had been granted by the Supreme Court of Sierra Leone.

According to the evidence only the Will, part of Exhibit K, was registered in Sierra Leone on the 11th July, 1918. The result is that though No. 98, Fourah Bay Road formed part of the estate of Jacob Williamson Sawyerr at the time of his death it did not pass under the Probate Exhibit K. No probate or Letters of Administration with the Will annexed was taken in Sierra Leone.

There is no evidence as to when Ransolina Patience Cromanty came to Sierra Leone but the evidence is that as far back as 1910 only six years before she took probate she had been dealing with No. 98 Fourah Bay Road renting it and collecting the rents and profits. After she took out probate and with full knowledge of the contents of the Will she continued to collect the rents of No. 98 Fourah Bay Road. She also in 1932 sold part of premises adjacent

She collected the rents and profits, paid the rates and taxes for No. 98 Fourah Bay Road up to the 6th October, 1953 when she conveyed the property to the Defendants by Exhibit M and in spite of that Conveyance she continued according to the evidence to collect the rents of No. 98 Fourah Bay Road up to her death in 1957. This is the title on which she relies when she conveyed No. 98, Fourah Bay Road to the Defendants by virtue of Exhibit M.

It would appear from the Defence and the evidence led that the Defendants rely on these facts as their title to No. 98 Fourah Bay Road and they therefore plead the Limitation Act.

Two questions therefore arise, namely,

- (i) What was the effect in law of the dealings and disposal by Ransolina Patience Cromanty 20 of the property No. 98 Fourah Bay Road?
- (ii) Does the Statute of Limitations apply to such a case?

With regard to the first question I am satisfied on the evidence as a whole that her dealings with the estate of Jacob Williamson Sawyerr (deceased) in Sierra Leone of which No. 98 Fourah Bay Road forms a part constitute her in law an executor de son tort of that part of the estate of Jacob Williamson Sawyerr in Sierra Leone. In view of my findings on the first question I hold that in law the Limitation Act does not apply. This disposes of the second In these circumstances it is my view that the deed of gift Exhibit M cannot stand.

The question now arises whether I can properly set aside the deed of gift Exhibit Mr. McCormack, Learned Counsel for the Defendants, in his final address submitted. inter alia, that since the Plaintiff has sued alone and not in a representative capacity the action should be dismissed. The evidence is that Plaintiff is one of the lawful sons of Jane Alice Smith (nee Sawyerr). Plaintiff deposed as follows on this point -

She was a beneficiary under that will at least as regards No. 98 Fourah Bay Road the subject matter of this Under her will the plaintiff is one action. of those also beneficially interested in No. 98, Fourah Bay Road. In my view, where a trustee has committed a breach of trust fraudulent or otherwise any beneficiary can bring an action to question the validity of the acts of such a trustee. As I have already found Ransolina Patience Cromanty was not only an executor de son tort of the estate of Jacob Williamson Sawyerr as regards that part of his estate in Sierra Leone but she was also a trustee who in the manner in which she disposed of No. 98, Fourah Bay Road committed a fraudulent breach of her trust. SIR SAMUEL BANKOLE JONES, P.: The claim in the court below was for an order to set aside a registered deed of gift dated the 6th day of October 1953 made between Ransolina Patience Cromanty deceased, the donor of the one part and the defendants, the donees, now the appellants of the other part. from delineating the boundaries of the property, the deed was silent as to its number (municipal). Both parties were however agreed that the number was 98 Fourah The learned judge in his judgment ordered that the deed of gift be set aside and that the property "be dealt with in the manner laid down in the will of Jacob Williamson Sawyerr (deceased)". It is against this decision that the defendants have appealed to this Court.

Now, 98 Fourah Bay Road was owned by James Beresford Sawyerr and mortgaged by him on the 16th May 1895 to his brother the abovenamed Jacob Williamson Sawyerr. On the date of the execution of the mortgage deed which was subsequently registered in Freetown, and at all material times, the mortgagor resided in Freetown, Sierra Leone, and the mortgagee in Accra, Gold Coast, now Ghana. mortgage was redeemable on the 8th February The learned judge found, and, I think 1897. rightly so on the evidence, that up to the date of the death of the mortgagor which took place on the 17th May 1909 in Freetown, a period of just over twelve years, it had not been redeemed. The mortgagee died on the 15th August 1916 in Accra without having exercised his right of foreclosure or sale under the mortgage deed, and left a will dated 30th May 1908 which was probated in

Accra by the only surviving executor named in the Will namely, Ransolina Patience Cromanty on the 14th October, 1916. It should be noted in passing that the probate was not re-sealed in Only the will was registered. Sierra Leone. For the purposes of this judgment, this is not important. In the will however, Jacob Williamson Sawyerr devised among other properties his "freehold lands with the buildings thereon situate at Fourah Bay Road . . . . and farm land at Fourah Bay Road all in Freetown" to his two brothers, his sistertthe said Ransolina Patience Cromanty and his two "98 Fourah Bay daughters in equal share. Road" was not specifically mentioned in the will but the parties were also all agreed that that property formed part of the "freehold lands with the buildings thereon situate at Fourah Bay Road . . . and Farm land at Fourah Bay Road all in Freetown" devised in the said Will.

After the death of James Beresford Sawyerr in 1909 the evidence, as well as the admissions of the parties, disclosed that Ransolina Patience Cromanty entered into possession of 98 Fourah Bay Road and continued in uninterrupted possession from 1909 up to her death in 1957. The judge's note on this latter point is as follows:

- Note "Both sides agree that for the period 1909 up to death of Mrs. Cromanty in 1957 the rates in respect of No. 98 Fourah Bay Road Freetown were paid by Mrs. Ransolina Cromanty. Ghana leaving his last Will and Testament dated the 30th day of May, 1908. I am satisfied on the evidence that on the date of his death the mortgaged premises at Fourah Bay Road belonged to and formed part of the estate of Jacob Williamson Sawyerr."

This finding supports the contention of the Respondent in this Court and in the Court below. The appellants on the other hand have always contended that 98 Fourah Bay Road did not form part of the estate of Jacob Williamson Sawyerr (deceased) and also that the disposal of this property in his Will was wrong in law. They have always contended that Ransolina Patience Cromanty acquired title to this property by virtue of the Statute of Limitation and that was why, according to them, she was entitled to convey it by deed of gift to them.

There are four grounds of appeal but I think only two need be considered namely:-

1. "The learned trial Judge was wrong in law and in fact by his finding that at the date of death of Jacob Williamson Sawyerr, the mortgaged premises No. 98 Fourah Bay Road belonged to him and passed under the devise in his will".

2. "The learned trial Judge misapplied the law of mortgages to the facts herein when he held that the right of redemption on the part of James Beresford Sawyerr (the mortgagor) of the premises mortgaged had been lost by lapse of time".

These grounds raise two questions of law for the determination of this court. Firstly, did the property in question form part of the estate of Jacob Williamson Sawyerr on the date 40 of his death in 1916 and secondly did Ransolina Patience Cromanty possess the legal right to

convey it by deed of gift as she did to the appellants?

Now as to the first question. James Beresford Sawyerr the mortgagor, as has been stated above, failed to redeem the property at the time and in the manner covenanted by him in the mortgage deed - Exh. J.1, and accordingly it seems to me to be the law that Jacob Williamson Sawyerr's right as a mortgagee to foreclosure or sale was extinguished after the period of twelve years had run out as from the 8th February 1897 to 17th May 1909 and the effect of this was to bar his title and in the circumstances vest the legal estate in the mortgagor. See Kibble v. Fairthorne 1895, K.B.D. 219 see also Sec. 16 of our Limitation Act, No. 51 of 1961 which reads as follows :-

"16. Subject to the provisions of Sec. 8 of this Act at the expiration of the period prescribed by this Act for any person to bring an action to recover land (including a redemption action) the title of that person to the land shall be extinguished".

Section 8 relates to settled land and land held on trust, which is not the case here. The period prescribed by the Act for the purpose stated in the above section is twelve years.

On the evidence it was quite clear that the mortgagee was never in possession of the property and it is a reasonable and fair inference from all the surrounding circumstances that from the date of execution of the mortgage deed, the mortgagor was in possession and was so in possession up to the date of his death. It follows then in my opinion, that the answer to the first question is, that the property, with respect to the learned judge did not in law form part of the estate of Jacob Williamson Sawyerr (deceased) and he therefore had no right to have devised it in his will as he did.

Now as to the second question. As has been stated also, Ransolina Patience Cromanty entered into possession of the property, it seems, immediately after the death of the mortgagor in 1909 and continued to be in undisturbed possession until her death in 1957, a period of forty-eight years. on the other hand, she was the lawful sister of the mortgagor, and together with other 10 relations acquired an interest in the property on his death intestate. law then stood, the property became vested in the then Curator of Intestate Estates Ordinance 1887. There is no evidence whatever that the Curator took possession within the required statutory period for the purposes of administration. He appeared to have allowed time to run out against him and in favour of Ransolina Patience Cromanty. 20 was in no better position than an ordinary administrator against whom the twelve year period under the Statute of Limitation applied, and consequently his right over the property became barred by lapse of time. In the matter of the Estate of Josiah Pratt (deceased) Vol. 2 The Sierra Leone Recorder p.9 at p.11 and In the matter of certain lands at and about the Grass Fields, Wellington in the Colony of Sierra Leone and C. Walton Jackson 30 Vol. 2 The Sierra Leone Law Recorder p. 12. The answer therefore to the second question is, that Ransolina Patience Cromanty having acquired and indefeasible possessory title to this property, she consequently and unquestionably possessed the legal right to part with it by whatever means she chose and to whomsoever she pleased. She parted with it by means of a deed of gift and to the appellants who were no strangers in blood to her. It follows 40 therefore that the appellants must be considered the lawful owners of the property 98 Fourah Bay Road in accordance with the provisions of the deed of gift of the 6th October 1953. The appeal is accordingly allowed and the order of the Supreme Court is set aside.
