TAKE NOTICE that the Defendants/Appellants being dissatisfied with that part of the decision more particularly stated in paragraph 2 hereof of the High Court contained in the judgment of the Honourable Mr. Justice Renwick dated the 17th day of July 1972 doth hereby appeal to the Court of Appeal upon the grounds set out in paragraph 3 and will at the hearing of the appeal seek the relief set out in paragraph 4.

And the Appellants further state that the names and addresses including their own of the persons directly affected by the appeal are those set out in paragraph 5.

## 2. Parts of the Decision referred to:

"In Civil Appeal No. 3 of 1970, it was held that Christianie Burke had a life interest only in the Mero Estate. It follows therefore that George James Christian, although he may well have intended to dispose of his entire interest in Mero Estate, the beneficial interest in fee simple always remained in him and so he was the reversionary owner of the equitable fee simple. The legal estate he had successfully vested in the trustees. It seems to me therefore that it does not matter whether Christianie Burke fulfilled all or any of the conditions set out in the trust instrument, the sole interest which she received under the trust instrument is a life interest.

In the Court of Appeal, P. Cecil Lewis J.A., said:-

'It is not disputed that the Appellant is a lawful son of Clara Gordon (nee Christian) one of the persons mentioned in paragraphs 5-7 of the settlement. She died in 1964 leaving lawful issue, but as her death took place before she obtained a vested interest in the hereditaments there was nothing to pass to her heirs by way of succession. Accordingly the Appellant could have no claim to the hereditaments as one of her heirs. In the circumstances the Court raised the question of his locus standi in the matter'.

I would normally have been bound by this specific ruling by the Court of Appeal. Unfortunately all the facts were not placed before the Court of Appeal. In particular an attempt by the Plaintiff to have the will of George James Christian put in evidence at the proceedings which gave rise to Civil Appeal No. 2 of 1970 was successfully opposed with the result that the Court of Appeal did not have that will before it. In these circumstances I feel justified in arriving at my own decision and to treat the ruling of the Court of Appeal as persuasive authority and that I am not completely bound thereby.

The position in these cases as I see it is as follows: George James Christian settled Mero Estate in various trusts. Whatever may have been his intention by the failure to use the technical expression "heirs" he created only life interests and as a result he was the reversionary owner of the equitable fee simple. Such an interest is a vested interest and not a future interest properly so called.

The will of George James Christian contains two residuary clauses. To my mind there is no necessity at this stage to determine which of these clauses is applicable because in each clause Clara Gordon, the mother of the Plaintiff, is a beneficiary. Clara Gordon died in 1964 approximately four years after the death of George James Christian so at the date of his death she had a vested interest. The Plaintiff is the legal personal representative and a beneficiary of his mother's estate and consequently his interest is also a vested interest."

## 3. Grounds of Appeal.

- (1) The learned Judge misdirected himself in holding that the will of George James Christian deceased was relevant to the ruling of the Court of Appeal in Civil Appeal No. 3 of 1970 on the issue of Locus standi.
- (2) The learned Judge misdirected himself as to the distinction between "reversions" and "remainders" having regard to the declaration sought by the Plaintiff/Respondent as set forth in the judgment of the learned judge "that the Plaintiff is one of the beneficial owners or remaindermen of the fee simple absolute of the aforesaid Mero Estate...."
  - (3) The learned Judge was wrong in law in holding that a claim to share in the residue of the Estate of George James Christian deceased conferred a vested interest in the hereditaments having regard to the Real Representative Ordinance (Cap 213 of the Laws of Dominica) section 2 the Plaintiff/Respondent not being or claiming to be a Personal Representative of George James Christian deceased.

- 4. Relief Sought.
- (1) That the decision of the learned Judge be set aside.
- (2) That the case be remitted to the Court below with such directions for the disposition thereof as to the Court may seem fit.

#### JUDGMENT

17th Renwick, J.

July 1972

Suits No. 70 of 1969 and No. 188 of 1971 were by order made on the 7th day of December, 1971 consolidated and the hearing into the locus standi of the plaintiff as regards Castaways Developments Limited and Castaways Hotel Limited be commenced on 7th January 1972 whether or not the other issues in the suits were ready for trial.

The plaintiff has claimed against the 10 defendants jointly and severally, in respect of the Mero Estate now known as Castaways situate in the parish of Saint Joseph in the State of Dominica, in each and every instance on the grounds of breach of trust, actual and constructive, misrepresentation and fraud, for relief under eight heads, the sixth of which is "A declaration that the Plaintiff is one of the beneficial owners or remaindermen of the fee simple absolute of the aforesaid Mero Estate by virtue of the operation of the Indenture of Trusts dated March 1913 recorded in Book of Deeds E No. 7 20 folio 689, the last Will and Testament of George James Christian, deceased dated 22nd January, 1936 proved the 14th day of June, 1946, and the last Will and Testament of Clara Marguerite Gordon, deceased, duly proved and re-sealed in the State of Dominica on the 6th April, 1971 and recorded in Book of Probates "P" Folios 277-289.

In Civil Appeal No. 3 of 1970 between
Hakim E. F. Gordon - Plaintiff/Appellant and 30
Christianie Burke Defendant/Respondent, the Court of
Appeal raised the question of the locus standi of the
Plaintiff/Appellant who is the Plaintiff in these
proceedings he having sued herein both his personal
and representative capacities. For the purpose of
that appeal only counsel for the Defendant/Respondent
conceded that the Plaintiff/Appellant (to quote
Lewis, J. A.) "had the right to move the Court for
the determination of the question whether or not the
respondent had the right to convey the fee simple in 40
the Mero Estate as she purported to do."

The Plaintiff must show a sufficient interest in order to be permitted to maintain these proceedings. The Defendant it is conceded is entitled to have the question of the locus standi of the Plaintiff decided in limine. Indeed, not only was the question of the locus standi of the Plaintiff posed by the Court of Appeal, but having been

specifically pleaded, arises directly on the pleadings themselves.

Counsel for the Defendant referred to Daniell's Chancery Practice 7th Edition Vol. 1 at page 349 where the following words are to be found:

"The Plaintiff must not only show an interest in the subject matter, but it must be on actual existing interest; a mere possibility, of a future title will not be sufficient to sustain the action ...."

He relied on a statement to like effect per Lord Eldon in Allan v Allan 15 Vesey 130 at page 135.

In other words, the Plaintiff must establish that he is as he claims, a reversionary owner or a remainderman and having done so, that that is interest sufficient to enable him to maintain these proceedings.

The facts here are really not in dispute and are as follows: By an Indenture made the 15th day of October, 1894 between Francis Thomas Burke and George James Christian, Mero Estate was mortgaged to George James Christian. Francis Thomas Burke was unable to redeem the mortgage debt and so by Indenture of Trust made the 18th day of March, 1913 George James Christian created a trust in which he named the following persons as likely beneficiaries: Francis Thomas Burke, his two children Margery and Christianie Burke and their lawful children, and Peter Charles Christian, Clara Christian, Maud Christian and their lawful children.

Under the Indenture of Trust the legal estate in the Mero Estate and the Cassada Estate was conveyed to Thomas Howard Shillingford as trustee, his heirs or executors to the uses following:-

1. The Trustee, his heirs, or executors shall remain in possession of the said lands, hereditaments, and premises during the life-time of Francis Thomas Burke, or until the said Margery Burke and Christianie Burke shall attain their majority (or marry) or whichever event, the death of the said Francis Thomas Burke, or the majority or marriage of the said Margery Burke and Christianie Burke shall happen later.

Judgment 17 July 1972

- The said Trustee shall manage, superintend the management, or lease the said Estate or Plantation, whichever he may deem expedient and shall in no case be liable for impeachment for waste.
- From the rent or net profits of the said hereditaments, the said Trustee shall pay and satisfy the amount which by Bond he the said George James Christian and the said Trustee have bound themselves to pay to the said Francis Thomas Burke, and from any balance which may remain, shall at his discretion pay the whole or such part thereof for the maintenence and personal support or benefit of Margery Burke and Christianie Burke until they shall attain the age of 21 years (twentyone) or marry

- Should either the said Margery Burke or Christianie Burke die under the age of 21 years or without having married and leaving lawful issue, the whole of the lands, hereditaments, and premises shall be held in trust for the survivor.
  - Should the said Margery Burke and 5。 Christianie Burke die without attain-30 ing the age 21 years(twenty-one) or without having married and without having left lawful issue, then the said Trustee shall hold the said lands, hereditaments, and premises in trust for Peter Charles Christin, Clara Christian, and Maud Christian until they shall attain the age of 40 21 (twenty-one) years or, being girls, attain that age or marry, with power at his discretion to pay any part of the rents and profits of the said hereditaments and premises for the maintenance and personal support and benefit of the said Peter Charles Christian, Clara Christian, and Maud Christian.

6. Should either the said Peter Charles Judgment Christian, Clara Christian, or Maud Christian die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the said lands, hereditaments, and premises shall be held in trust for the survivor or survivors of them.

17 July 1972

Should the said Peter Charles 10 7. Christian, Clara Christian, and Maud Christian all die without attaining the age of 21 (twentyone) years or marrying and leaving lawful issue, then the whole of the lands, hereditaments, and premises shall be held by the Trustee, his heirs, or executors in trust for the said George James Christian 20 or as he shall, by Deed or Will appoint."

By his last Will and Testament dated the 30th November, 1938 George James Christian made the following bequests -

> "I give and bequeath all my interests in Syers Estate and Placeawill Estate, in the Parish of St. Joseph, Dominica, British West Indies, aforesaid, and houses and my other real or personal property or interest therein to Peter Charles Christian and Clara Gordon in equal shares absolutely as tenants in common. Mero Estate and Cassada Garden Estate I have already settled on Chrissie Burke and her lawful children (if any); but if she dies without lawful issue, then the said estates to follow the terms of the Deed of Settlement."

40 I give and bequeath all my property, not hereby other disposed of, unto my trustees in trust to convert same into money by sale, or otherwise, and to divide the proceeds, after paying my funeral and testamentary expenses and debts and the legacies hereby bequeathed, in equal shares among Peter Charles Christian, Clara Gordon, Chrissie Burke, Sarah Christian, Joseph Christian, Josephine Martha Christian, Howard Christian, and Amba or Angela Christian,

all of whom are now of age, and the following who are now infants; namely Matilda Christian, Ferdinand Christian, and Edward Clifford Christian, who being sons attain the age of twenty-one years, or being daughter attains that age or marries, their respective shares, vesting on my death, and to raise any part not exceeding one moiety of any such infant's share and apply the same for the advancement or benefits of such infants. And I also empower my said trustees to postpone the sale and conversion of any part of my estate for so long as they shall think fit; and the income of unconverted property shall, from the time of my death, go in the same manner as the income of the proceeds thereof would have been applicable if 20 the same has been converted, provided always that if any of the said beneficiaries; namely, Peter Charles Christian, Clara Gordon, Chrissie Burke, Sarah Christian, Joseph Christian, Josephine Martha Christian, Howard Christian, Matilda Christian, Ferdinand Christian, Amba or Angela Christian, and Edward Clifford Christian, shall die in my lifetime leaving a child or 30 children who shall survive me, and being a son or sons shall attain the age of twenty-one years, or being a daughter or daughters shall attain that age or marry under that age; then in every such case, the last-mentioned child or children shall take (and if more than one equally between them) the share which lies, or their parent would have taken of; and in the res-40 iduary trust funds if such parent had survived me and attained the age of twenty-one years and if any of the said beneficiaries shall die during my lifetime without leaving a child or children who shall survive me, then such beneficiary's shall fall into residue and be equally divided among the remaining beneficiaries."

By an Indenture dated the 29th May, 1952 Christianie Burke as beneficial owner conveyed the Mero Estate containing approximately 179 acres and 1 rood to Lionel Edwin Pinard for £1,200.

By an Indenture dated 30th July, 1960 and recorded in Book of Deeds A No. 8 folio 218 Edwin Lionel Pinard conveyed 4.58 acres of Mero Estate to Daphne Taylor.

By an Indenture dated 29th May, 1964 and recorded in Book of Deeds C No. 8 folios. 314-318 Edwin Lionel Pinard conveyed part of Mero Estate to Castaways Developments Limited.

Some of the arguments so ably and candidly put forward by Counsel for the defendants to my mind are substantive defences and should not be decided on the narrow issue of the plaintiff's locus standi which is before me at this stage. One such matter is the instrument of further assurance referred to in the defence of Christianie Burke.

No arguments were adduced before me on the probable effect of the counterclaim filed by the defendant Castaways Development Limited. On this counterclaim the plaintiff could and indeed would raise the issue which he seeks to do in his actions.

In my view in all the circumstances the interest of justice will best be served only if all the many and complex issues raised on the pleadings be fully ventilated and determined.

I hold therefore that the plaintiff has shown a sufficient interest to maintain these proceedings. Costs to be costs in the cause.

- (i) The area of the Trusts Property in dispute measuring some 365.38 acres.
- (ii) On 29th May, 1952 Christianie Burke conveyed the said property to Edwin Lionel Pinard for £1,200.0. or \$5,760. On 28th May, 1964, Edwin Lionel Pinard conveyed the same to Castaways Developments limited for \$80,000. a percentage increase in the region of 1,330% in 12 years, or 110% per annum.

- (iii) Castaways Developments Limited have currently been disposing of the said lands at the rate of about \$20,000 per acre. For the total area, this represents a current capital value of some \$7,300,000 excluding the value of Castaways Hotel Limited, its shares and revenues; and a capital gain of nearly 100 times the purchase price of \$80,000.
  - (iv) Assuming a return of 10% per annum 10 for 20 years, the loss to the Plaint-iff, in interest only, is in excess of \$5,000,000. The Plaintiff, accordingly, claims \$5,000,000 damages.

1. The Defendant Castaways Hotel Limited is the bona fide purchaser of the legal estate in respect of 4.58 acres of the Mero Estate without notice of any breach of trust affecting the same, by virtue of an Indenture dated the 13th day of June 1967 recorded in Book of Deeds L No. 8 folios 269 to 272 from Daphne Taylor to Castaways Hotel Limited.

2. The particulars of the Defendant's title are as follows:

(a) Indenture dated the 15th day of October, 1894 between Francis Thomas Burke of Mero, of the one part, and George James Christian also of Mero of the other part, recorded in Book of Deeds Y No. 6 folios 421 to 422 reciting in consideration of the sum of £120.0s.0d paid to the said Francis Thomas Burke by the said George James Christian the said Francis Thomas Burke convenanted to pay the said George James Christian on the 30th day of June 1899 next the sum of £120.0s0d. with interest thereon in the meantime at the rate of five (5) per centum per annum from the 15th day of October, 1894, and also so long after that day as any principal money remained due, interest at the same rate by equal yearly instalments on the 30th day of June in each year. In consideration whereof the said Francis Thomas Burke "as Beneficial owner hereby conveys unto the said George James Christian all that estate or plantation known as Mero estate"..... etcetera..."To Hold the same unto and to the use of the said George James Christian in fee simple. Provided always": here follows the proviso for redemption and the power of entry and sale.

(b) Indenture dated the 18th day of March 1913 between Francis Thomas Burke of Mero, George James Christian of Roseau and Thomas Howard Shillingford of Hobbs Hole reciting that Francis Thomas Burke is well seised and entitled to the Mero Estate; that on the 15th day of October 1894 the said Francis Thomas 10 Burke executed a Mortgage in favour of the said George James Christian of the said Mero Estate for the sum of £120.0s0d, with interest, which the said principal sum and interest are still unpaid. Whereas Francis Thomas Burke hath agreed with the said George James Christian for the sale to him of the hereditaments intended to be hereby granted, and the inheritance 20 thereof in fee simple in possession free from incumbrances at the price of £584.0s0d. and it has been agreed that the said mortgage debt of £120.0s.0d. and interest shall be retained by the said George James Christian out of the said purchase money and also in consideration of the payment by the said George 30 James Christian of the mortgage debt and interest when it becomes due to the said Alexander Davis Riviere under the mortgage security above mentioned, and also in consideration of an annuity of £25.0s.0d. to be paid to the said Francis Thomas Burke during his life and to be secured by the bond of the said George James Christian and Thomas 40 Howard Shillingford. And Whereas in consideration of the love and affection which the said George James Christian bears to Margery Burke and Christianie Burke, Peter Charles Christian, Clara Christian and Maude Christian, the said George James Christian is desirous of settling the said estates in the manner here-And the said inafter expressed. 50 Thomas Howard Shillingford (hereinafter called the trustee) hath at his request agreed to accept the conveyance to himself of the abovementioned hereditaments and to be the trustee of the said intended settlement. Now This Indenture Witnesseth that in pursuance of the said agreement"...etcetra ... "The said Francis Thomas Burke at the request of the said George James Christian doth hereby grant to the said Thomas Howard Shillingford his heirs and Executors All That estate of plantation"...etcetera."To Hold the same unto the use of the said trustees his heirs or Executors to the uses following" Then follow the uses recited in the said Deed to which the Defendant will seek to refer fully during the trial.

Defence of Castaways Hotel LTD.

(c) Indenture dated the 29th day of May 1952 between Christianie Burke of Roseau and Edwin Lionel Pinard of Roseau whereby "the Vendor as Beneficial Owner hereby conveys unto the Purchaser all that estate and plantation known as Mero Estate situate in the parish of Saint Joseph in the said Colony of Dominica...To Have and to Hold the same unto and to the use of the Purchaser and his heirs in fee simple forever.

"And it is hereby agreed and declared that the usual qualified covenants on the part of the Vendor for right to convey for quiet enjoyment for freedom from incumbrances and for further assurance are intended to be implied from the use of the expression "Beneficial Owner" in these presents as if Section 76 of the Law of Property Act (15 Geo.V.C.20) now in force in England reenacting the Conveyancing Act 1881 (44 & 45 Vict.C41) were in force and applicable to conveyance made in or relating to land situate in Dominica."

(d) Indenture dated 30th day of July 1960 between Edwin Lionel Pinard aforesaid and Daphne Taylor recorded in Book of Deeds A Number 8 folio 218 conveying to the said Daphne Taylor and her heirs all the fee simple estate in 4.58 acres part of the said Mero Estate.

Defence of Castaways Hotel Ltd.

- (e) Indenture dated the 13th day of June 1967 between Daphne Taylor aforesaid and the Defendants Castaways Hotel Limited recorded in Book of Deeds L Number 8 folios 267 to 272 conveying to the said Castaways Hotel Limited the fee simple interest in the said 4.58 acres.
- (f) Indenture made the 19th day of June
  1971 by Christianie Burke as tenant
  10
  for life under the Settled Estates Act
  and in pursuance of her covenant for
  further assurance further assuring
  unto the said Edwin Lionel Pinard and
  his heirs the fee simple estate in the
  said land.
- By the Indenture of 1913 it was provided 3. inter alia in paragraph 5 of the Trust provisions as follows: "Should the said 20 Margery Burke and Christianie Burke die without attaining the age of 21 years or without having married, and without having left lawful issue, then the said trustee shall hold the said lands, hereditaments and premises in trust for Peter Charles Christian, Clara Christian and Maude Christian until they attain the age of 21 years or being girls attain that age or marry with power at his discretion to pay any part of the rents and profits of the 30 said hereditaments and premises for the maintenance and personal support and benefit of the said Peter Charles Christian, Clara Christian and Maude Christian."

The contingencies or contingency giving effect to a gift over have not occured.

4. The residuary devise of the Will of the said George James Christian dated the 22nd day of February 1936 reads as follows: "I give and bequeath all my property not hereby otherwise 40 disposed of unto my trustees in trust to convert same into money by sale or otherwise, and to divide the proceeds after paying any funeral and testamentary expenses and debts and the legacies hereby bequeathed in equal shares among Peter Charles Christian, Clara Gordon, Chrissie Burke, Sarah Christian, Joseph Christian, Josephine Martha Christian, Howard Christian, and Amba or Angela Christian,

all of whom are now of age, and the following who are now infants, namely Matilda Christian, Ferdinand Christian and Edward Clifford Christian, who being sons attains the age of 21 years, or being daughter attains that age or marries, their respective shares vesting on my death." etcetera.

Defence of Castaways Hotel Ltd.

- 5. The said George James Christian has by his said Will made no appointment of the corpus of the Trust.
  - 6. Christianie Burke on the 19th day of June 1971, as tenant for life of the said settlement under the Settled Estates Ordinance with intent to fulfil the covenant contained in the said Indenture dated the 29th day of May 1952 and recorded in Book of Deeds V number 7 folios 154 to 156, executed an instrument of further assurance in favour of the said Edwin Lionel Pinard and caused the same to be left with the said Edwin Lionel Pinard.

7. The Defendant does not admit paragraph 2 and paragraph 3 of the plaintiff's Statement of claim.

- 8. The Defendant denies paragraphs 4 to 7 of the Plaintiff's Statement of Claim, and states that Clara Marguerite Gordon died without having obtained any vested interest in the hereditaments and accordingly there was nothing to pass to her heirs by way of succession.
- 9. Accordingly the plaintiff can have no claim to the hereditaments as an heir and has no interest or sufficient interest to maintain the present suit.
- 10. The plaintiff can have no claim to the reversion of the fee simple of the corpus of the Trust, and has failed to show any or any sufficient interest therein.
- 11. In the alternative, there is no privity of contract or estate between the plaintiff and the Defendant.
  - 12. If as alleged by the plaintiff in paragraphs 8, 10 and 11 of the Statement of Claim (but not admitted by the Defendant) the first-named

Defendant Christianie Burke executed a conveyance on the 29th May 1952 thereby forfeiting her life tenancy at the very moment of the execution by her of the said conveyance and that from then a right of entry accrued to Clara Marguerite Gordon who died on 27th September 1964 any pretended right of action by the said Clara Marguerite Gordon or her successors is barred by reason of the Real 10 Property Limitation Act.

Save as hereinabove expressly admitted the Defendant denies each and every allegation affecting it as if the same were fully set out and denied seriatim, and in particular denies that its dealings with the hereditaments have been in any way tortious

The rest of the issues are not yet determined and are incorporated in 188/1971 as well as 70/1969. It is true that 188/1971 is new and Def No. 2 has been served for the first itme. He has appeared but not filed a defence. iculars were requested yesterday. Appearance was entered on 15th December, 1971.

Mr. Alleyne: Suit No. 70/1969 as regards (2) is ready to be heard. There is a preliminary objection in limine.

- (2) If he has such an interest has it been infringed
- (3) What damage has he suffered

Pl. is elder son and is beneficiary and residuary legatee of her
will. Probate resealed in this 10
Court. Pl's claim right to bring
suit mortem as (1) reversionary
owner of the corpus of trust
property known as Mero now called
Castaways Developments Ltd.

A reversion is something which has not gone away. A reversion is always vested. Megarry & Wade 1947 Edition. P.174; P 175 para. 2.

George James Christian made a 20 trust in 1913 out of which he created certain life interests. The Plaintiff says his mother is one of the beneficiaries of his Grandfather's trust deed. The will and deed make reference to each other.

In his will Christian left all his property in Dominica that he had not disposed of to Clara Marguerite Gordon, Peter (In his 30 Will) Christian. The will cannot change the terms of the Deed of Settlement. (Indenture of Trust) -- the root of title.

The Plaintiff's mother is only one who performed all conditions set out in Deed of Settlement.

Last Will and Testament of Clara Gordon.

In Conveyance dated 18/5/52 the Indenture of Trust is recited only 40 to 4 uses. 5, 6, and 7 were not recited, these were the paras in which name of Clara Gordon was mentioned. This Conveyance and Deed of Settlement are both cited

in Abstract of Title for the Certificate of Title to Casta-ways Developments Ltd. The moment Certificate of Title was granted Conveyance 18/5/52 died-see chaps. 222 - section 5. By section 20 no way to transfer land under T by R than by procedure under Cap. 222. In 1971 a deed was executed using the conveyance of 18/5/53. The person who signed died in June 1971, Christianie Burke purports to re-

Christian had intended to benefit Burke first. Clara Gordon is residuary legatee of Christian.

Megarry & Wade P. 197 "Tortious conveyance". The application for the Certificate of Title is not based on long possession. The Statute of Limitations does not apply here.

Certificate of Title.

Christianie Burke was one of the beneficiary of George James Christian. She swore in instant suit dated 20th Jan, 1920 an affidavit. Transactions are in 1913, 1940 death of Christian, 1952, 1964 - 40 years search 12 years long possession.

Adj. at 11 - 11.15 a.m. 11.15 a.m. Court resumed.

By the conveyance of 1952 Christianie forfeited her life interest by the tortious conveyance. Right of entry to Marguerite accrued in 1952; time runs from time fraud is discovered.

Section 12 of Cap. 222. Grounds for application of 1st. Cert. of Title.

Judge's Notes Castaways got title under (a) Can title be now claimed as long possession? Christianie Burke deceived Pinard by the Conveyance in 1952. Clara Marguerite Gordon left Dominica in 1926. Until Clara heard of death of Christianie Burke there was nothing to excite her. The Trustees did nothing. Plaintiff returned in 1968.

Under Settled Land Act, Cap. 221 a tenant for life has a statutory right of sale. The tenant for life must sell under the statutory powers, and the consequences of the statutes must be observed. proceeds of the sale must be held upon the same trusts. Section 3(2). In this case there was a 3(4). settlement created with trustee. 20 Section 11, the Court is given power to authorise sale of whole or part of Settled Estates. Section 17 states what consents are necessary. Section 19 requires notice to be given. Section 22 provides for the disposition of the purchase monies. Section 35 provides for the investment of the proceeds of sale. Section 50 requires that the tenant for life to 30 give notice. Section 54 is made a trustee for other beneficiaries. Section 61, Section 29 applies where there are no trustees. Court calls attention to section 29.

Fraud in equity does not have same meaning as at common law it can be negligence, carelessness, etc. Directors of Deft. had knowledge of Trust, and so Shillingford v A. G. 40 of Dominica: 12 Part 1, W. 1. R.82, 83, 1968 12 W.I.R. 57. by "wilful representation" used in section 19(2)

"Indefeasible" definition "fraud" used in Schedule.

All subsequent purchasers should have had notice of the trust.

Mr. Alleyne:

The plaintiff must establish a title to sue or locus standi or he must show a sufficient interest. P.14 of the decision of the Court of Appeal. Daniell's Chancery Practice 7th Edition Vol. 1 p.349. There must be a right of Pl. to move the Court. Page 4-5 of pleadings. In particular he is relying on the capability of inheriting part of his mother's estate.

In his indorsement of claim (vi) Plaintiff is described as beneficial reversionary owner and remainderman.

In Cheshire's Modern Law of Real Property 5th Edition P. 433 P.434 Future interests. The Deed of Settlement 1913. There is a Mortgage. Thomas Francis Burke the father of Christianie Burke to Christian.

Legal reversion was in Trustees of 1913 Deed of Settlement. If the trusts all failed, the Trustees hold reversion for Christian. He only has a life interest himself. Dyer (1788)2 Cox 92.

Boys v Carritt (1884) L. R. 26 Ch. D. 531 Resulting trust.

The settlement itself could have resulted in a complete disposition of the fee simple. If the tenant for life under exercise of powers as contained in Settled Estates Act Cap. 221 had disposed of the fee simple. Sec. 29,34. Section 50(5). This section disproves submission that Cap. 221 must be strictly followed.

Plaintiff's title through George Christian reversion is too remote. By Cap 213 section 2 The Real Estate vested in P. R. of George Christian. Adj. at 1 p.m. to 2.30 p.m. Mr. Alleyne contd.

Judge's Notes

The supposed rights of Pl. under will of George James Christian. submission that Pl. is entitled as residuary legatee depends on a misreading of the will of G. J. Christian. George James Christian can hardly have intended to give Mero Estate or any reversion of Mero Estate by virtue of the clause read. 10 There was reserved to him him Deed of 1913 a power of appointment by Deed or will he can hardly have intended to exercise that power in this casual way. If he had an undisposed of reversion it would go under his general residual clause. I give etc., (Marked B) This residuary clause establishes a Trust for Sale. death the property is converted into 20 personalty.

The third objection is based on Settled Estates Act. The tenant for life has the power of alienation Gordon at P.10, Lewis at p.16) Allen v Allen (1808) 15 V. Reports 130. As to interest and locus standi of trustee comes before other interest. The tenant for life had power of sale. If the case goes beyond preliminary 30 stage I will argue the tenant for life has sold under Settled Estates Act and has brought money into Court.

Conditions for gift over were that they both should be under 21 unmarried without lawful issue. There could never be a remainder to Clara Gordon under the provisions of this deed. No vested interest until conditions other than death of life tenant had ful— 40 filled. Clara Gordon could only possibly have a life interest. Since she died before the possibility of that interest being vested it did not go to her heirs.

Mr. Degazon:

The Will and trust refer to one another. The formal words of limitation are not required in a will.

The legal estate is vested in trustees. Norton Deeds 1928, P. 410. Reference to Will: "Therein" means Christianie Burke has Dominica. forfeited her life interest.

Judge's Notes

Beneficiary under a will is not too remote to bring action. Adj: to Monday 12th January 1972 at 10 a.m.

the C, of A. in more than one place. I make this statement because my learned friend had hinted that the settler was Thomas Burke. I say as a matter of fact on reading the judg. of Court of Appeal that the settler

was George James Christian. When the will of George James Christian is put in evidence it will be seen that he exercised the power of appointment given to him by the Settlement which was signed by

Thomas Burke himself and Thomas Howard Shillingford. It will be seen

furthermore from this will that their exercise of that Power of Appointment was a testamentary disposition of the land and that the exercise of this Power of Appointment created a chain of succession in the settled land in the construction of which chain of succession technical words of limitation were not ncessary on account of the testamentary character of the exercise of the power. The Court of Appeal did not reach this far because the will which will now be in issue formed no part of the case either in fact or law from either side - Appellant or Respondent on which that Higher Court adjudicated and handed down its judgment.

The respondent instituted two suits in the High Court of Dominica. The first was Suit No. 70 of 1969 in which Christianie Burke, Castaways Developments Ltd., and Castaways Hotel Ltd. were the defendants. The second was suit No. 188 of 1971 in which Christianie Burke, Edwin Lionel Pinard, Daphne Taylor, Castaways Developments Ltd. and Castaways Hotel Ltd. were the defendants. These suits were consolidated by an order of Renwick, J. dated December 7, 1971.

In the first suit the respondent sued in his personal capacity and in the second as a personal representative of his mother Clara Marguerite Gordon. His claims for relief in the two suits overlap somewhat. He alleges in his statement of claim in each suit that he is one of the reversionary owners of the fee simple of an area of land known as Mero Estate, and among his 20 claims for relief is a claim for a declaration to this effect. He also claims that Christianie Burke who is a defendant in both actions made a "tortious conveyance of the said Mero Estate to the defendant Edwin Lionel Pinard" who in turn disposed of 4.58 acres thereof to Daphne Taylor and another portion to the appellant Castaways Developments Ltd. In addition to his claim for the declaration referred to above the respondent asked for further relief including the cancell-30 ation of various indentures listed in the statement of claim in the second suit, recovery of possession of Mero Estate, an order that accounts be rendered by the several defendants in the two suits in respect of this estate, an injunction to restrain them from dealing with the said estate, the appointment of a trustee and receiver of the estate and damages in the sum of \$5m.

The "tortious conveyance" to Edwin Lionel
Pinard referred to above, is a conveyance made
on May 29, 1952 by Christianie Burke to Edwin
Lionel Pinard of the Mero Estate for £1200 in
which she claimed to convey as beneficial owner.

In Suit No. 70 of 1969 the appellant Castaways Developments Ltd. pleaded that an objection in limine would be taken that the respondent "has not sufficient interest to maintain the suit", and in suit No. 188 of 1971 a similar plea was

put forward in its defence. This preliminary Judgissue was argued before the trial judge who made ment an order that the respondent "has sufficient interest and has a locus standi to pursue his claim".

The relevant facts which give rise to this appeal are as follows: Francis Thomas Burke was indebted to George James Christian in the sum of £120 and in 1894 he executed a mortgage in his favour, on the Mero Estate and the Cassada Garden Estate as security for the said loan. In 1913 this with interest thereon was still unpaid. Burke had borrowed the sum of £100 from one A. D. Riviere in 1909 and executed a second mortgage in his favour on the Cassada Garden Estate as secur-This sum and the interest ity for this loan. thereon were still unpaid in 1913 and it was agreed between Burke and Christian that Burke would sell the Mero Estate to Christian for £584 out of which Christian would repay the loan due to himself and also the mortgage debt due to A. G. Riviere. It was further agreed that an annuity of £25 would be paid to Burke and this was secured by a bond entered into by Christian and one Thomas Howard Shillingford

In consideration of the aforesaid premises and in further consideration of the love and affection which the said George James Christian bore to Margery Burke and Christianie Burke, Peter Charles Christian, Clara Christian and Maude Christian, Francis Thomas Burke at the request of George James Christian conveyed Mero Estate to Thomas Howard Shillingford in fee simple on March 18, 1913 to hold the same as trustee "to the uses following":

- "1. The Trustee, his heirs, or executors shall remain in possession of the said lands, hereditaments, and premises during the lifetime of Francis Thomas Burke, or until the said Margery Burke and Christianie Burke shall attain their majority (or marry) or whichever event, the death of the said Francis Thomas Burke, or the majority or marriage of the said Margery Burke and Christianie Burke shall happen later.
  - 2. The said Trustee shall manage, superintend the management, or lease the said Estates or Plantation, whichever he may deem expedient and shall in no case be liable for

impeachment for waste.

- 3. From the rent or net profits of the said hereditaments, the said Trustee shall pay and satisfy the amount which by Bond he the said George James Christian and the said Trustee have bound themselves to pay to the said Francis Thomas Burke; and from any balance which may remain, shall at his discretion pay the whole or such part thereof for the maintenance and 10 personal support or benefit of Margery Burke and Christianie Burke until they shall attain the age of 21 years (twenty-one) or marry.
- 4. Should either the said Margery Burke or Christianie Burke die under the age of 21 years or without having married and leaving lawful issue, the whole of the lands, hereditaments, and premises shall be held in trust for the survivor.
- 5. Should the said Margery Burke and Christianie Burke die without attaining the age of 21 years (twenty-one) or without having married and without having left lawful issue, then the said Trustee shall hold the said lands, hereditaments, and premises in trust for Peter Charles Christian, Clara Christian, and Maud Christian until they shall attain the age of 21 (twentyone) years or, being girls, attain that age 30 or marry with power at his discretion to pay any part of the rents and profits of the said hereditements and premises for the maintenance and personal support and benefit of the said Peter Charles Christian, Clara Christian and Maud Christian.
- 6. Should either the said Peter Charles
  Christian, Clara Christian, or Maud Christian die without attaining the age of 21
  (twenty-one) years or marrying and leaving lawful issue then the whole of the said lands, hereditaments, and premises shall be held in trust for the survivor or survivors of them.
- 7. Should the said Peter Charles Christian, Clara Christian, and Maud Christian all die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the lands,

hereditaments, and premises shall be Judg-held by the Trustee, his heirs, or execut-ment ors in trust for the said George James Christian or as he shall, by Deed or Will appoint."

It is common ground that Christianie Burke who is still alive and who was the survivor under paragraph (4) of the limitations in the trust, holds only a life interest in Mero Estate. It was so held in Gordon v. Burke (1970) 16 W.I.R. 204, when on an application by the respondent in suit No. 70/1969 to determine whether Christianie Burke was empowered to sell the fee simple in Mero Estate as beneficial owner, this Court, reversing the decision of the High Court, held that she was not so empowered as she took only a life interest under the settlement.

Under the settlement the settler George James Christian created only life interests and did not dispose of the beneficial interest in the Mero Estate. As held in Gordon v Burke (Supra) Christianie Burke accordingly became entitled only to a life interest in the said estate, and by virtue of this decision under paragraph (6) of the settlement the survivor or survivors of the persons mentioned therein would similarly take a life interest or life interests as the case may The result is that George James Christian having not effectively disposed of the equitable interest in the Mero Estate there was a resulting trust to him on the very date on which he executed the trust instrument on March 18, 1913 so that, on that date the equitable fee simple became vested in him,

George James Christian made a will in 1936 in the residuary clause of which he bequeathed all his property not otherwise disposed of unto his trustees to convert the same into money by sale or otherwise and to divide the proceeds in equal shares among eleven named persons who included Christianie Burke and Clara Gordon the respondent's mother. Under this clause the respondent's mother who died in 1964 became entitled to a share in the equitable interest in Mero Estate which had resulted to her father under the settlement because she was alive in 1940 when he died.

Judgment

The respondent is a beneficiary under his mother's will and also her personal representative and trustee.

The question which arises in this appeal is whether the respondent is entitled to maintain an action in respect of the Mero Estate in his representative capacity and also in his personal capacity.

Counsel for the appellant contended that the relevant representation is the estate of George James Christian, the reversioner under the settlement and not that of Clara Gordon, a beneficiary under the will of George James Christian. further contended that a residuary legatee has no interest in any particular part of the assets of an estate where administration is not complete. There was admittedly no vesting assent by the personal representative in respect of the Mero Estate to Clara Gordon and therefore she had no interest and could not sue. Her personal rep-20 resentative, the respondent, therefore could not sue. He supported his contention by citing the case of Corbett v Commissioners of Inland Revenue (1938) 1 K.B.567. In that case it was held that the legatee of a share in residue has no interest in any property of the testator until the residue has been ascertained, and that this proposition is applicable to all cases of residue which is being ascertained and which cannot be ascertained until administration is complete. It appears to me that the answer to this submission is that the residue in the present case is ascertained. It is the Mero Estate containing approximately 179 acres.

In my opinion the respondent has an equitable interest under the will of George James Christian but is only entitled to sue if the person in whom the legal estate is vested are made parties to the action.

Rule 2 (2) and rule 3 (1) of Order 63 R.S.C. 1907 are applicable to the circumstances of this 40 case. The relevant portions of these are as follows--

"2(2) Without prejudice to the generality of paragraph (1), an action may be brought for the determination of any of the following questions:-

(c) any question as to the rights or interests of a person claiming to be a creditor of the estate of a deceased person or to be entitled under a will or on the intestacy of a deceased person or to be beneficially entitled under a trust."

Judgment

"3-(1) All the executors or administrators of the estate or turstees of the trust, as the case may be, to which an administration action or such an action as is referred to in rule 2 relates must be parties to the action, and where the action is brought by executors, administrators or trustees, any of them who does not consent to being joined as a plaintiff must be made a defendant."

The terms of the above rules, in my view, reflect "the general rule" referred to by Viscount Findlay in Performing Right Society Ltd. v London Theatre of Varieties Ltd. (1924) A.C.1 at page 18 where he stated the position as follows:-

"It follows that when Messrs Chappell and Messrs, Keith, Prowse & Co respectively acquired the copyright in these songs, the equitable interest in the performing rights in respect of them vested in the society as assignees from them. The society became entitled to sue in respect of the interests so acquired, but their right to sue is subject to the general rule that the owner of the legal estate should be joined as a party. It is true the owner of a merely equitable estate may in certain cases sue alone, as where there are special circumstances which make it inconvenient that the owner of the legal estate should sue, or where his conduct with reference to the estate But there is no case in is in question. which it has been held that the presence of the legal owner in an action against a third party can be dispensed with on such grounds as those which are alleged in the present case ..... Except under very special circumstances the ordinary rule should be observed, that the legal owner should be a party to the proceedings."

In the present case there are no special circumstances which show the respondent is entitled to sue without joining the persons in

Judgment whom the legal estate is vested.

The respondent's actions are only maintainable if he joins as co-plaintiffs the persons in whom the legal estate in the trust property is vested. The respondent will therefore be given the opportunity of amending the writs, pleadings and other documents in his actions on payment by him in any event of all costs thrown away. If the respondent elects within thrity days to amend on these terms, the actions can proceed, but if he does not so elect the actions will be dismissed with costs. The trial judge's order will therefore be set aside and the appeal allowed with costs here and in the court below.

- 1. The Writ of Summons in this cause was issued Claim on the 15th day of November, 1971.
- 2. The Plaintiff is the Personal Representative of the Estate Clara Marguerite Gordon who died in the Islands of Bermuda on the 27th day of September, 1964.
- 3. The Plaintiff is the elder son of the aforesaid deceased, and is one of the beneficiaries and residuary legatee under her last Will and Testament.
- 4. Before her death, and since the year 1952, Clara Marguerite Gordon was the reversionary owner of, with right of entry upon, the Mero Estate, now known as Castaways, in the Parish of Saint Joseph.
- 5. The Plaintiff has succeeded to that status by virtue of the following:-
  - (i) Deed of Settlement by George James Christian and Thomas Francis Burke, deceased, dated 18th March, 1913, and registered in Book of Deeds E, No. 7, Folio 689;
  - (ii) Last Will and Testament of the aforesaid George James Christian deceased, dated 22nd January, 1936, proved the 14th June, 1946, and recorded in Book of Probates E, Folios 133 to 144;
  - (iii) Judgment of the Court of Appeal in Suit No. 3 of 1970, dated 30th November, 1970;
    - (iv) Last Will and Testament of Clara Marguerite Gordon, nee Christian, deceased, duly proved and re-sealed in Dominica on 6th April, 1971, and recorded in Book of Probates P, Folios 277 to 289.
- The deceased, Clara Marguerite Gordon, is the only descendant of George James Christian, deceased, who fulfilled the conditions for becoming sole-cestui-que-trust under the Deed of Settlement of 1913, in that she attained the age of 21, married and died, leaving lawful issue her surviving.
- The said Clara Marguerite Gordon, as a residuary devisee, on the demise of George James Christian, her father, in 1940, also inherited inter alia a vested equitable interest as a reversionary owner of the Mero Estate now known as Castaways.

At paragraph 10 of that Indenture, reference is, yet again, made to the Indenture of 1913 and specifically to the 30 fact that it created certain Trusts. Again, it must be assumed that the intending purchaser had duly investigated the purported Vendor's Title. Paragraphs 11 and 12 of the Indenture of 1964 purported to repeat that Christianie Burke became seized of the lands in question for her sole use and benefit as subsequently did Edwin Lionel Pinard.
- Notwithstanding, Castaways Developments
  Limited on 10th April, 1968, procured the 40
  issue of a First Certificate of Title No.
  139, 1968, Register Book W 1, Folio 122, for
  the said lands, although the Indenture of

## JUDGMENT

# GORDON, J, A

At the hearing of an application by summons in Chamber by the plaintiff/appellant for a declaration that he is one of the reversionary owners of the fee simple absolute of certain lands included in an Indenture of Trust, it was agreed by the parties that the issue be confined to the question of whether the respondent had a right to convey as beneficial owner, property which was the subject-matter of a trust. The learned trial judge having decided that the respondent was entitled to do so, the appellant now appeals from that decision.

The notice of appeal was served on the solicitor for two other persons, namely - (i) Castaways Developments Limited, and (ii) Castaways Hotel Limited, but counsel at the Bar agreed that the only real respondent to this appeal is Christianie Burke.

The facts revealed by the affidavit evidence in the matter are as follows:-

By an Indenture of Trust (hereinafter referred to as "the trust instrument") executed on the 18th March, 1913, George James Christian, a Barrister-at-Law, created a trust in which he named the following persons as likely beneficiaries:

Francis Thomas Burke, his two children Margery and Christianie Burke and their lawful children, and Peter Charles Christian, Clara Christian, Maud Christian and their lawful children.

Under the trust instrument the legal estate in the Mero Estate and the Cassada Estate was conveyed to Thomas Howard Shillingford as Trustee, his heirs or executors to the uses following:-

- "1. The Trustee, his heirs, or executors shall remain in possession of the said lands, hereditaments, and premises during the life-time of Francis Thomas Burke, or until the said Margery Burke and Christianie Burke shall attain their majority (or marry) or whichever event, the death of the said Francis Thomas Burke, or the majority or marriage of the said Margery Burke and Christianie Burke shall happen later.
- 2. The said Trustee shall manage, superintend the management, or lease the
  said Estate or Plantation, whichever
  he may deem expedient and shall in no
  case be liable for impeachment for
  waste.
- From the rent or net profits of the said hereditaments, the said Trustee shall pay and satisfy the amount which by Bond he the said George James Christian and the said Trustee have bound themselves to pay to the said Francis Thomas Burke; and from any balance which may remain, shall at his discretion pay the whole or such part thereof for the maintenance and personal support or benefit of Margery Burke and Christianie Burke until they shall attain the age of 21 years (twenty-one) or marry.

4. Should either the said Margery Burke or Christianie Burke die under the age of 21 years or without having married and leaving lawful issue, the whole of the lands, hereditaments, and premises shall be held in trust for the survivor.

- 5。 Should the said Margery Burke and Christianie Burke die without attaining the age of 21 years (twenty-one) or without having married and without having left lawful issue, then the said Trustee shall hold the said lands, hereditaments, and premises in trust for Peter Charles Christian, Clara Christian, and Maud Christian until they shall attain the age of 21 (twentyone) years or, being girls, attain that age or marry, with power at his discretion to pay any part of the rents and profits of the said hereditaments and premises for the maintenance and personal support and benefit of the said Peter Charles Christian, Clara Christian, and Maud Christian.
  - 6. Should either the said Peter Charles Christian, Clara Christian, or Maud Christian die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the said lands, hereditaments, and premises shall be held in trust for the survivor or survivors of them.
  - 7. Should the said Peter Charles Christian, Clara Christian, and Maud Christian all die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the lands, hereditaments, and premises shall be held by the Trustee, his heirs, or executors in trust for the said George James Christian or as he shall, by Deed or Will appoint."

The following facts relating to persons named in the instrument were excepted by the court below:

Francis Thomas Burke died on the 17th June, 1913. Margery Burke who was born on 24th February 1902 died in 1919 without lawful issue.

Christianie Burke - the respondent in this case - was born on the 19th January 1906. She is unmarried and had been in possession of the trust property since she became 21 years.

Thomas Howard Shillingford died in 1917 (according to a statement by counsel) without having named anyone as his successor to administer the trust. The record does not disclose who his executors were.

Maud Christian and Peter Christian both died without issue.

Clara Gordon, nee Christian, died in 1964

Clara Gordon, nee Christian, died in 1964 leaving lawful issue of whom the appellant is one.

By a conveyance dated the 29th May, 1952, the respondent as beneficial owner in fee simple sold approximately 179 acres of the Mero Estate to Lionel Edwin Pinard for £1,200.

In the course of his judgment dismissing the application the learned judge stated thus:

"In my view, the two conditions set out in Clause 4 of the trust deed of attaining majority and of marriage and leaving lawful issue, are in the alternative; and Margery Burke, having died without having attained her majority, unmarried and without issue, the right to possession of the Trustee lapsed when the survivor, Christianie Burke, attained her majority in 1927.

I am further of the view that Christianie
Burke then became the sole cestui-que trust
with full beneficial interest and was entitled to have the hereditaments conveyed
to her and, in turn, entitled to dispose
of the same."

By leave of the Court the grounds of appeal filed by the appellant were amended and the appeal was argued on the following grounds:

"(a) the decision of the learned trial judge be set aside; and that it be declared that:-

(b) the learned trial judge erred and was wrong in law in holding that merely by the attainment of her majority in 1927....
'Christianie Burke then became the sole cestui-que-trust with full beneficial interest and was entitled to have the hereditaments conveyed to her and, in turn, entitled to dispose of the same', notwithstanding the conditions as to marriage and issue in paragraphs 4,5,6 and 7 of the said Trusts.

Judgment of Court of Appeal

It was conceded by counsel for the respondent for purposes of this appeal only that the appellant has a right to move the Court.

Counsel for the appellant urged on this Court, firstly that the absence of technical words of limitation from the trust instrument precluded the respondent from taking the fee simple in the trust property on her having attained the age of 21 years, as was contended 20 by her when she purported as beneficial owner to sell the Mero Estate to Edwin Lion Pinard for £1,200 (see conveyance by Christianie Burke to Edwin Lionel Pinard of 29th May 1952); secondly, that on a proper interpretation of paragraph 4 as modified by paragraph 5 and subsequent paragraphs of the trust instrument, the respondent on attaining her 21st birthday without marrying and having lawful issue, took either an estate in tail or a life interest; 30 thirdly, that by virtue of the conveyance the respondent was estopped from denying that she sold as beneficial owner and consequently could not at this stage avail herself of the terms of the Settled Estates Ordinance, (Cap. 221) Laws of Dominica.

Counsel for the respondent urged that because -

- (a) the attitude of the courts was to presume in favour of divesting, particularly in a case such as this where the clear intention of the settlor was to convey the legal estate to the respondent on her attaining the age of 21 years; and
  - (b) the provision whereby the respondent was entitledon attaining her majority to call upon the trustee to convey the legal estate to her, rendered the trust an

executory one and such as to fall within the category of cases to which the courts were inclined to lend a liberal interpretation in order to give effect to the intention of the settlor.

The peculiar circumstances of the instant case, he submitted, rendered it a fitting one for the Court to read "and" for the word "or" in paragraph 4 of the trust instrument.

In inviting the Court to adopt such a course, counsel further urged that by doing so absurdities in the trust instrument (e.g. no legal estate in the trust property could vest in anyone,) would be avoided, and the trust brought to a satisfactory end.

Because of the Real Property Ordinance (Cap. 219) Laws of Dominica which came into force in 1873 and the fact that the Dominica Legislature never adopted the Conveyancing Act (U.K.) 1881, the operative law in relation to conveyances by deed in Dominica is to be found in (a) the Real Property Ordinance (Cap. 219) Laws of Dominica, and (b) in the common Law of England as it was prior to 1881 when the Conveyancing Act (U.K.) 1881 came into force there.

The requirements for creating certain legal estates are indicated by section 16 of the Real Property Act (Cap. 219) Laws of Dominica which reads as follows:

"No estate of fee tail shall be created, after the passing of this Ordinance, by any deed, or by any will or other instrument, otherwise than by an express limitation to a person and the heirs of his body, or the heirs, male or female, of his body, as the case may be."

as also by the following excerpt from Megarry and Wade, 3rd Edition, p. 51 -

"The rule at common law was that a free-hold estate of inheritance could be created in a conveyance inter vivos (i.e. a transfer of land between living persons) only by a phrase which included the word "heirs". In no other way could

a fee simple or fee tail be created."

It is also noteworthy that by section 29 of the Wills Ordinance (Cap. 215) Laws of Dominica (in force since 1872) which reads -

Judgment of Court of Appeal

"Where any real estate shall be devised to any person without any words of limitation, such devise shall be construed to pass the fee simple, or other the whole estate or interest which the testator had power to dispose of by will in such real estate, unless a contrary intention shall appear by the will."

adequate provision is there made whereby a devise of a fee simple estate may pass such an estate without the use of words of limitation.

From the fact that this provision has been specially created in respect of wills only, it therefore follows that in order to effectively pass the legal estate in real property by a deed, technical words of limitation must necessarily be used.

It is settled law that the fundamental rule of interpretation of deeds as instruments is that:- to interpret a deed the expressed intention of the parties must be discovered, and in support of this contention the following among other excerpts are cited in Norton on Deeds, 2nd Edition at p. 53:

"I adopt the observation of Alexander C.B, in Colmore v. Tyndall 1828 Younge & J 605 at p. 622 that this Court deals with a deed according to the clear intention of the parties appearing in the four corners of the deed itself. If the court sees an intention clearly and distinctly established by it, it has no difficulty in carrying that into effect; subject of course to any rules of law that may be applicable to it, but only qualified to that extent."

Sir J. Romilly M.R. in Beaumont v. Marquis of Salisbury (1854) Beav. 196 at p. 206 - and

".....in construing instructions you must have regard, not for the presumed intention of the parties, but for the meaning of the words which they have used."

per Brett L.J. Ex p. Chick Re Meredith (1879) ch. D. 731 at p. 739.

The effect of the above dicta as I see it, is that while the Courts wherever possible will give full effect to the intention of a donor or settlor as indicated in the deed, that intention must be qualified by the legal effect and meaning of the words actually used in the document.

Adverting to the trust instrument it is there clearly indicated that in consideration of the love and affection which George James Christian had for Margery Burke, Christianie Burke, Peter Charles Christian, Clara Christian and Maud Christian he settled the hereditaments on them in turn on the conditions set out in paragraphs 1 - 7 of the trust instrument (supra).

Paragraph 4 provides that in the event of either one or other of the two sisters not attaining the age of 21 or not marrying and having lawful issue, the whole of the hereditaments and premises shall be held in trust for the survivor. Margery Burke having died under the age of 21 years and being unmarried, it followed that the property continued to be held in trust for the survivor Christianie, and by virtue of paragraph 1 the trustee was to remain in possession until Christianie attained the age of 21 years.

The question then arises as to what interest did Christianie Burke acquire on her becoming 21 years. Counsel for the respondent contends that she acquired the fee simple and was entitled to have it conveyed to her, while counsel for the appellant contends that she could only acquire an estate in tail or a life interest.

An examination of the instrument reveals that while paragraph 4 provides what should happen in the event of either Margery or Christianie dying under 21, unmarried and without lawful

issue, paragraph 5 goes on to provide what should happen in the event of both Margery and Christianie dying under 21 years or without having married and without having left lawful issue, in which case the trust property is to be held in trust for Peter, Clara and Maud Christian until they in turn attain the age of 21 years or marry.

Judgment of Court of Appeal

Having regard to the provisions of paragraph 5, it would appear that the intention 10 behind paragraph 4 is that in the event of one of the two Burkes dying, as in fact occurred, then the hereditaments would be held by the trustee in trust for the survivor of the two sisters, in this case Christianie. It follows on this that the most that Christianie could have had on her attaining the age of 21 years was a life interest, and the fact that she entered into possession of the trust property ever since she was 21 years and that the trust-20 ee in whom the legal estate was vested had died without having conveyed the legal estate to any other person as trustee, made no difference to the interest which the respondent held. her death, should she not have married and had lawful issue, then in accordance with paragraph 5, the hereditaments which comprise the turst must remain in trust for Peter Charles Christian Clara Christian and Maud Christian until they attain the age of 21 years, or until the girls 30 marry and have lawful issue.

Paragraph 6, like paragraph 4, then provides what should happen in the event of the death of either of those beneficiaries there named, and paragraph 7 what should happen if all should die

It is to be observed that in paragraphs 4 and 6 whenever the word "survivor" appears it is not followed by any technical words of limitation, and that in paragraph 7 which provides for the final reversion of the fee simple in the trust property to the settlor, while there is a similar absence of words of limitation, provision is there made for the settlor to further appoint by deed or will.

In Re Bostock's Settlement (1921) 2 Ch. D. 469, by an indenture dated 1886, W. Bostock conveyed the equitable interest in freehold lands to trustees "in trust for the child or

In the instant case the fact that the terms of the trust have been finally declared by the settlor in such a complete manner that no instrument is required to define the limitation to which he intends to subject his property. in my view makes the instrument an executed trust and therefore not subject to the arguments urged by counsel for the respondent as being applicable to executory trusts. In this connection support for this view is to be found in the following statement of Sargant J, in Re Monckton's Settlement (1913) 2 Ch. D. at  $p_16\overline{42}$ , cited with approval by Warrington L.J. in Re Bostock's Settlement (supra) at p.135:

"In the case of an executed document as

distinguished from an executory document the rule is fairly well settled that the same words of limitation are necessary to convey an equitable estate in fee simple as would have been necessary if the conveyance had been one of a legal estate in fee simple. Equity follows the law in that respect."

Paragraph 5 of the trust instrument clearly indicates that it was not the intention of the settlor that the respondent should take a fee simple if she did not marry and have lawful issue. The dictum of Jessel M.R. in Smith v. Lucas (1881) 18 Ch. D. 531 at p.542 - "One must consider the meaning of the words used, not 30 what one may guess to be the intention of the parties:" is in point, and in my view defeats the argument of counsel for the respondent in relation to the intention of the settlor in the instant case.

The argument of counsel for the appellant that the respondent would be entitled to a fee tail is also defeated by the absence of any words of limitation as called for by section 16 of the Real Property Ordinance (Cap. 219) 40 Laws of Dominica, following on the word 'survivor' in paragraph 4 of the trust instrument,

The fact that the amending effect of the Conveyancing Act (U.K.) 1881 and the Real Property Act (U.K.) 1925 on the real property law in the United Kingdom, does not apply in Dominica, coupled with the provisions of the Real Property Ordinance (Cap. 219) of the Laws of Dominica, lead

me to the conclusion that in the instant case the effect of the absence of words of limitation which included the word "heirs", after the word "survivor" in paragraph 4 of the trust instrument, is that only a life interest passed to the respondent on her attaining the age of 21 years.

In the light of the above I am of the view that the appellant never had a beneficial interest amounting to a fee simple estate, to sell, as she purported to do.

10

It is however to be noted that in the Settled Estates Ordinance (Cap. 221), Laws of Dominica, provision is there made for the holder of a life interest to sell the settled land and the conditions under which such a sale can properly be effected. As the relief sought in the amended grounds of appeal does not involve this question, and as all parties who ought to be joined for the determination of the question of the disputed conveyance, including the purchaser therein, are not before the Court, I would not give any opinion on this question.

20

I would therefore declare -

- (1) that Christianie Burke was entitled under the Indenture of 18th March, 1913, to an estate for life only in the hereditaments therein settled, and
- (2) that the said Christianie Burke at the date of the said Indenture of Conveyance by herself to Edwin Lionel Pinard was seized as cestui-que-trust of an estate for life in the said hereditaments and not of an estate in fee simple and was accordingly not entitled to sell the said hereditaments as absolute owner thereof in fee simple.

For the above reasons I would allow the appeal with costs here and in the court below.

# CECIL LEWIS, J.A.

An indenture made the 18th day of March, 1913 between Francis Thomas Burke of the first part, George James Christian of the second part and Thomas Howard Shillingford of the third part had a two-fold purpose. It gave effect to an agreement between Francis Thomas Burke and George James Christian, a barristerat-law, for the sale by Burke to Christian of certain hereditaments and it also contained a settlement by the said George James Christian of the said hereditaments on certain trusts (to be hereinafter mentioned) with Thomas Howard Shillingford as the trustee of the settlement.

The hereditaments in question were the Mero Estate and the Cassada Garden Estate in Dominica (hereinafter referred to as "the hereditaments".)

The indenture having recited that "in 20 consideration of the love and affection which the said George James Christian bears for Margery Burke and Christianie Burke, Peter Charles Christian, Clara Christian and Maud Christian, the said George James Christian is desirous of settling the said estates in the manner hereinafter expressed, and the said Thomas Howard Shillingford (hereinafter called the Trustee) hath at his request agreed to accept the conveyances to himself of the above-30 mentioned hereditaments and to be the Trustee of the said intended settlement" went on to record that in pursuance of the said agreement between Francis Thomas Burke and George James Christian and for the consideration therein mentioned, "the said Francis Thomas Bruke at the request of the said George James Christian doth hereby grant to the said Thomas Howard Shillingford his heirs or executors all that estate or plantation known as the Mero Estate 40 ....and also all that estate known as Cassada Garden Estate .... " to hold the messuage land and hereditaments and all other premises hereby granted unto the said Trustee, his heirs or executors to the uses following:-

1 The trustee, his heirs, or executors shall remain in possession of the said lands, hereditaments, and premises during the lifetime of Francis Thomas Burke,

or until the said Margery Burke and Christianie Burke shall attain their majority (or marry) or whichever event, the death of the said Francis Thomas Burke, or the majority or marriage of the said Margery Burke and Christianie Burke shall happen later.

2. The said Trustee shall manage, superintend the management, or lease the said Estates or Plantation, whichever he may deem expedient and shall in no case be liable for impeachment for waste.

- 3. From the rent or net profits of the said hereditaments, the said Trustee shall pay and satisfy the amount which by Bond he the said George James Christian and the said Trustee have bound themselves to pay to the said Francis Thomas Burke; and from any balance which may remain, shall at his discretion pay the whole or such part thereof for the maintenance and personal support or benefit of Margery Burke and Christianie Burke until they shall attain the age of 21 years (twenty-one) or marry.
- 4. Should either the said Margery Burke or Christianie Burke die under the age of 21 years or without having married and leaving lawful issue, the whole of the lands, hereditaments, and premises shall be held in trust for the survivor.
- 5. Should the said Margery Burke and Christianie Burke die without attaining the age of 21 years (twenty-one) or without having married and without having left lawful issue, then the said Trustee shall hold the said lands, hereditaments, and premises in trust for Peter Charles Christian, Clara Christian, and Maud Christian until they shall attain the age 40 of 21 (twenty-one) years or, being girls, attain that age or marry, with power at his discretion to pay any part of the rents and profits of the said hereditaments and premises for the maintenance and personal support and benefit of the said Peter Charles Christian, Clara Christian, and Maud Christian.

6. Should either the said Peter Charles Christian, Clara Christian, or Maud Christian die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the said lands, hereditaments, and premises shall be held in trust for the survivor or survivors of them.

7. Should the said Peter Charles Christian, Clara Christian, and Maud Christian all die without attaining the age of 21 (twenty-one) years or marrying and leaving lawful issue, then the whole of the lands, hereditaments, and premises shall be held by the Trustee, his heirs, or executors in trust for the said George James Christian or as he shall, by Deed or Will, appoint."

In Megarry & Wade's The Law of Real Property,
3rd Edition, the following statement dealing with
the requirements of the common law for the use of
words of limitation in order to create a fee simple
occurs at page 51:

"The rule at common law was that a freehold estate of inheritance could be created in a conveyance inter vivos (i.e. a transfer of land between living persons) only by a phrase which included the word "heirs". In no other way could a fee simple or fee tail be created. Any attempted grant of a freehold estate in other terms (as "to A"or"to A in fee simple") gave A merely a life estate... It is important to note that no other word would do in place of "heirs": "relatives", "issue", "descendants", "assigns", "for ever", "in fee simple", "in tail" and so on were all ineffective. "Heirs" was the sacred word of limitation, and had a magic which no other word possessed".

In this case it will be observed that the settlor used the appropriate word necessary at common law for creating a fee simple estate which estate was vested in the trustee upon the trusts here-inbefore mentioned. Strict conveyancing language with a definite legal meaning having been used in this instance, it must be assumed that the language in the other parts of the indenture was intended to bear a similarly strict legal meaning.

In regard to the first paragraph of the settlement the following facts are agreed:

(a) Francis Thomas Burke died on June 17, 1913; (b) Margery Burke who was born on February 24, 1902, died in 1919. She thus did not attain her majority. She was unmarried at her death and left no lawful issue; (c) Christianie Burke who was born on January 19, 1906, is still alive but is unmarried and without lawful issue. It is also common ground that when Christianie Burke attained her majority in 1927 she was, under the terms of this paragraph, entitled to physical possession of the hereditaments as against the trustee.

10

By paragraph 4 of the settlement it is provided that if "either the said Margery Burke or Christianie Burke die under the age of 21 years or without having married and leaving lawful issue, the whole of the lands, hereditaments and premises shall be held in trust for the survivor." In the events which have happened, Christianie Burke, the respondent herein, was the survivor and the hereditaments were accordingly held in trust for her. The important question which arises in this appeal is what estate did the respondent take?

20

The respondent by an indenture dated May 29, 1952, purported as beneficial owner to sell the fee simple in the Mero Estate to Edwin Lionel Pinard for £1,200.

30

The appellant issued a summons dated April 10, 1969, in which he asked for certain relief including, inter alia, a declaration that he is one of the reversionary owners of the fee simple absolute of the hereditaments, thereby indirectly questioning the respondent's right to sell the fee simple in the Mero Estate as she purported to do as aforesaid. At the hearing of the summons the sole issue on which the Court's ruling was desired was agreed between the parties and the trial judge recorded this agreement in his judgment as follows:

"it was accepted that the entire issue revolved around the question as to whether the "respondent "had the right to convey the land in question on 29th May, 1952, by conveyance recorded in Book

of Deeds V, No. 7, Folios 154-156 to Edwin Lionel Pinard."

It is not disputed that the appellant is the Appeal lawful son of Clara Gordon (nee Christian) one of the persons mentioned in paragraphs 5-7 of the settlement. She died in 1964 leaving lawful issue, but as her death took place before she obtained a vested interest in the hereditaments there was nothing to pass to her heirs by way of succession. Accordingly, the appellant could have no claim to the hereditaments as one of her heirs. In the circumstances, the Court raised the question as to his locus standi in this matter. Counsel for the respondent conceded that for the purposes of this appeal only, the appellant had the right to move the Court for the determination of the question whether or not the respondent had the right to convey the fee simple in the Mero Estate as she purported to do.

The trial judge decided this question in the respondent's favour. He said:

In my view, the two conditions set out in Clause 4 of the trust deed of attaining majority and of marriage and leaving lawful issue, are in the alternative; and Margery Burke, having died without having attained her majority unmarried and without issue the right to possession of the trustee lapsed when the survivor, Christianie Burke, attained her majority in 1927.

I am further of the view that Christianie Burke then became the sole cestui-que trust with full beneficial interest and was entitled to have the hereditaments conveyed to her and, in turn, entitled to dispose of the same."

Counsel for the appellant before this Court submitted that the fee simple did not pass to the
respondent under paragraph 4 of the settlement
but that only a life interest, or an estate
rail passed to her. He said he preferred to
contend that an estate tail passed because it
is a greater estate than a life estate and if
she had had children then her children could
have succeeded thereto. The alternative submission that an estate tail passed to the

respondent is untenable by reason of the provisions of section 16 of the Real Property Ordinance, Cap. 219 (Dominica) which Ordinance came into force on August 4, 1873. This section reads as follows:

"No estate of fee tail shall be created, after the passing of this Ordinance, by any deed, or by any will or other instrument, otherwise than by an express limitation to a person and the heirs of his body, or the heirs, male or female, of his body, as the case may be."

10

It will be seen that there is no express limitation to the heirs of the body of the survivor under paragraph 4 of the trust instrument and accordingly an estate of fee tail was not created under this paragraph. Counsel for the appellant will therefore have to rely on his first submission that a life interest only passed to the respondent and he said that this was so because of the absence of the words of limitation "and her heirs" after the word "survivor" at the end of the fourth paragraph of the settlement which were the words required at common law to create a fee simple estate. This common law rule is still in effect in Dominica.

20

A statement of Warrington L.J. in <u>In Re</u>
<u>Bostock's Settlement</u> (1921) 2 Ch. 469 is here
<u>directly in point</u>. He said at p. 484 (ibid):

30

"According to technical rules a limitation to A and his heirs to the use of or in trust for B confers on B a legal estate for life only."

This is exactly the situation here. There has been a limitation to the trustee and his heirs (and in the events which have happened) to the use of or in trust for the respondent under paragraph 4 of the settlement. Thus, the respondent would take an estate for life only.

40

counsel for the respondent however challenged this conclusion on the ground that the trusts in this case are executory, and therefore, he said, the duty of the Court is to construe the settlement in order to ascertain the intention of the settlor; in which case the absence of words of limitation is irrelevant. He submitted that the trust under paragraph 4 was executory because on the assumption that the respondent was entitled on attaining her majority to call upon the trustee to convey the legal fee simple to her, this meant that there was something left to be done by the trustee to perfect the trust. Even if the respondent were entitled to a conveyance of the fee simple on attaining her majority (which in my view was not so) the necessity for such a conveyance by the trustee would not by itself be a sufficient ground for regarding the trust as executory. The reason why this is so is fully explained in a passage from Lord St. Leonard's judgment in Egerton v. Earl Brownlow & ors. (1843-1860) All E.R. Reprint 970. In this passage the learned judge in differentiating between executed and executory trusts said at pp. 1000 and 1001 (ibid):

Judgment of Court of Appeal

".....all trusts are in a sense executory, because a trust cannot be executed except by conveyance, and therefore there is something always to be done. But that is not the sense which a court of equity puts upon the term "executory trust". A court of equity considers an executory trust, as distinguished from a trust executing itself, and distinguishes the two in this manner: Has the testator been what is called, and very properly called, his own conveyancer? Has he left it to the court tp make out from general expressions what his intention is, or has he so defined that intention, that you have nothing to do but to take that which he has given to you, and to convert them into legal estates."

If one applies this test to the circumstances of this case, it will readily be seen that the trust under paragraph 4 of the settlement is an executed one. The nature of the trust is such that the respondent becomes entitled to her interest in the hereditaments merely by fulfilling the conditons of the trust. Her entitlements arises by operation of law and is so to speak an automatic process requiring no action by anyone to make it effective. Neither the assistance of the Court nor of the trustee is

necessary to complete the limitation to the respondent in this case for the trust is expressed in terms which are in themselves final, and in such circumstances all that the Court can do is to construe it according to the import of the words used. I therefore reject the submission that the trust under paragraph 4 is executory and hold that it is, in the language of Lord St. Leonard's "a trust executing itself".

10

For the reasons given above, I am of the opinion that the appellant's contention that the respondent took a life interest only is correct. She therefore could not sell the fee simple in the Mero Estate as she purported to do under the deed of indenture dated May 29, 1952.

The respondent was however a tenant for life of the settlement under the Settled Estates Ordinance, Cap. 221 (Dominica) and in this capacity she could have sold the hereditaments pursuant to the power of sale conferred on a tenant for life by this Ordinance, but she did not purport to sell in this capacity. The question of the validity of the sale by the respondent does not arise in this appeal and therefore I express no opinion thereon.

20

I agree with the order proposed by Mr. Justice Gordon and would accordingly allow the appeal with costs here and in the court below.
