## **ROAD TRAFFIC**

## The A1(M) Motorway (Junction 48 to Junction 49) (Temporary Restriction and Prohibition of Traffic) Order 2011

Made - - - - 24th August 2011

Coming into force - - 4th September 2011

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway and connecting roads, in the District of Harrogate in the County of North Yorkshire, is satisfied that traffic on that motorway and some of those connecting roads should be restricted and prohibited because carriageway resurfacing and general maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

**1.** This Order may be cited as the A1(M) Motorway (Junction 48 to Junction 49) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 4th September 2011.

## 2. In this Order; -

"the A1(M)" means the A1(M) Motorway;

"the northbound carriageway" means the A1(M) northbound carriageway from the nose of the northbound exit slip road at Junction 48 (Boroughbridge) to the nose of the northbound entry slip road at Junction 49 (Dishforth), a distance of 9000 metres;

"the southbound carriageway" means the A1(M) southbound carriageway from the nose of the southbound exit slip road at Junction 49 to the nose of the southbound entry slip road at Junction 48, a distance of 9000 metres;

"a slip road" means any of the following A1(M) slip roads at Junction 48:

- (i) the northbound entry and exit slip roads; and
- (ii) the southbound entry and exit slip roads;
- "a link road" means any of the following link roads at Junction 49:
- (i) the link road connecting the A1(M) northbound carriageway with the A168 Trunk Road northbound carriageway, and
- (ii) the link road connecting the A168 Trunk Road southbound carriageway with the A1(M) southbound carriageway;

"the works period" means a period of 12 hours starting at 20:00 hours on Monday 5th September 2011 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour in the northbound carriageway or the southbound carriageway.
- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the northbound carriageway, the southbound carriageway, a slip road or a link road.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs. Nothing in article 4 shall apply to:
  - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
  - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
  - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to a vehicle being used for the purpose specified in paragraph (a) of this article.

- **6.** No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
- **7.** The provisions of regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulations 1982(**b**) are suspended in relation to the hard shoulders adjacent to the northbound carriageway or the southbound carriageway as described in article 2 at such times and to such extent as may, from time to time, be indicated by traffic signs; and in this article "hard shoulder" has the meaning given in regulation 3(1)(e) of those Regulations.
