The A449 and A40 Trunk Roads (Travellers Rest Roundabout to Over Ross Roundabout, Herefordshire) (Temporary 10 Miles Per Hour and 40 Miles Per Hour Speed Limit) Order 2011

WHEREAS the Secretary of State for Transport, being the traffic authority for the A449 Trunk Road ("the A449") and the A40 Trunk Road ("the A40"), is satisfied that traffic on lengths of those roads near Ross on Wye in the District of the County of Herefordshire should be restricted because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling him in that behalf, hereby makes the following Order:-

1. This Order may be cited as the A449 and A40 Trunk Roads (Travellers Rest Roundabout to Over Ross Roundabout, Herefordshire) (Temporary 10 Miles Per Hour and 40 Miles Per Hour Speed Limit) Order 2011 and shall come into force on 11th March 2011.

2. In this Order –

"Travellers Rest Roundabout"	means the A449/B4221/M50 Junction 4 roundabout junction;
"Over Ross Roundabout"	means the A449/A40/B4234 roundabout junction;
"the trunk road"	 means – (i) the A449 from its junction with Travellers Rest Roundabout to its junction with Over Ross Roundabout; and (ii) the A40 from its junction with Over Ross Roundabout to points 100 metres west and south of that roundabout, including the circulatory carriageway of that roundabout;

"the works period"	means the period starting at 20.00 hours on Monday 14th
	February 2010 and ending when the said works have been
	completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the trunk road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to be driven at a speed exceeding 10 miles per hour on lengths of the trunk road whilst traffic signs of a character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating "convoy working" on those lengths of road are displayed.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to any vehicle -

- (i) being used for police, fire brigade or ambulance purposes; or
- (ii) proceeding at the direction of, or with the permission of, a police constable.
