## **ROAD TRAFFIC**

## The A49 and A465 Trunk Roads (South of Hereford) (Temporary Prohibition of Traffic) Order 2013

 Made
 28th May 2013

 Coming into force
 4th June 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A49 Trunk Road ("the A49") and A465 Trunk Road ("A465"), is satisfied that traffic on lengths of those roads south of Hereford in the County of Herefordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the A49 and A465 Trunk Roads (South of Hereford) (Temporary Prohibition of Traffic) Order 2013 and shall come into force on 4th June 2013.

## **2.** In this Order:

"the roundabout"

means the circulatory carriageway of the roundabout junction of the A49 and the A465 Belmont Road;

"the trunk road"

means -

- i) the southbound carriageway of the A49 from its junction with St Martin's Street to its junction with Hinton Road;
- ii) the northern section of the roundabout between the northbound carriageway of the A49 and the southbound carriageway of the A49;
- between the slip road leading to the A49 Ross Road and the slip road leading from the A465 Belmont Road;
- iv) the southbound carriageway of the A465 from its junction with the

roundabout to is junction with Belmont Avenue; and

v) the northbound carriageway of the A465 from its junction with Belmont Avenue to its junction with roundabout;

"the works period"

means the period starting at 08:00 hours on Monday 10th June 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road.
- **4.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to enter or leave the access roads leading to and from the ASDA store at their junctions with the roundabout.
- **5.** Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle to turn right from the northbound carriageway of the A49 into St Martin's Street.
- **6.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
  - 7. The provisions of articles 3, 4 and 5 shall not apply to any vehicle
    - (i) being used for police, fire brigade or ambulance purposes;
    - (ii) proceeding at the direction of, or with the permission of, a police constable; or
    - (iii) being used in connection with the said works.
