The A38 Trunk Road (Drumbridges Junction, Devon) (Temporary Restriction and Prohibition of Traffic) Order 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A38 Trunk Road ("the A38"), is satisfied that traffic on lengths of that road near Newton Abbot in the District of Teignbridge in the County of Devon should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act $1984(\mathbf{a})$, hereby makes the following Order:-

1. This Order may be cited as the A38 Trunk Road (Drumbridges Junction, Devon) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 23rd February 2013.

2. In this Order –

"the first length of the A38" means both carriageways of the A38 near Newton Abbot from a point 3000 metres west of the centre of the Drumbridges Junction to a point 2500 metres east of the centre of that junction;

"the second length of the A38" means (a) the eastbound carriageway of the A38 near Newton Abbot from the tip of the nosing of the eastbound exit slip road at the Drumbridges Junction to the tip of the nosing of the eastbound entry slip road at the same junction; and (b) the westbound carriageway of the A38 near Newton Abbot from the tip of the nosing of the westbound exit slip road at the Drumbridges Junction to the tip of the nosing of the westbound entry slip road at the same junction;

"the slip roads" mean the eastbound and westbound exit and entry slip roads at the A38 Drumbridges junction;

"layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(**b**); and in this definition "carriageway" means any way (other than a cycle track) comprised in the trunk road over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"overall width" has the meaning given in regulation 3(2) of the Road Vehicles (Construction and Use) Regulations 1986(**a**);

"tip of the nosing" means the first point where an entry slip road joins the carriageway of a trunk road or the last point where an exit slip road leaves the carriageway of a trunk road;

"the works" mean drainage upgrade works;

"the works period" means the period starting at 00.01 hours on Monday 25th February 2013 and ending when the said works have been completed;

"a works period" means a period of 11¹/₂ hours starting at 19.00 hours on Monday 25th February 2013 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 6, 7 and 8, no person shall, during the works period:

- (a) drive any motor vehicle at a speed exceeding 50 miles per hour in the first length of the A38;
- (b) cause or permit any vehicle to enter, proceed or remain in the layby adjacent to the eastbound carriageway of the A38 situated 900 metres west of the centre of the Drumbridges Junction;
- (c) cause or permit any vehicle to enter, proceed or remain in the layby adjacent to the westbound carriageway of the A38 situated 900 metres west of the centre of the Drumbridges Junction.

4. Subject as mentioned in articles 6 and 7, no person shall, during a works period, cause or permit any vehicle to enter or proceed in the second length of the A38 and the slip roads.

5. Subject as mentioned in articles 6 and 7, no person shall, during the works period, cause or permit any vehicle with an overall width in excess of 2 metres to enter or proceed in any lane other than the left hand or nearside lane of the first length of the A38.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, fire and rescue authority or ambulance purposes;

(b) anything done at the direction of, or with the permission of, a constable.

7. The provisions of articles 3(b), 3(c), 4 and 5 shall not apply to a vehicle being used in connection with the said works or for traffic officer purposes.

8. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
