ROAD TRAFFIC

The A1(M) Motorway (Junction 37 to Junction 38) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 23rd January 2014

Coming into force - - 2nd February 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway, the A638 Trunk Road and connecting roads, in the District of Doncaster, in the County of South Yorkshire, is satisfied that traffic on that motorway and some of those connecting roads should be prohibited because safety barrier renewal works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A1(M) Motorway (Junction 37 to Junction 38) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 2nd February 2014.
- **2.** Subject as mentioned in article 3 of this Order, no person shall, during a period of 10 hours starting at 20:00 hours on Monday 3rd February 2014 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the:
 - (i) A1(M) Motorway northbound carriageway from the nose of the exit slip road at Junction 37 to the nose of the entry slip road at Junction 38, a distance of 4520 metres;
 - (ii) A1(M) Motorway southbound carriageway from the nose of the exit slip road at Junction 38 to the nose of the entry slip road at Junction 37, a distance of 4820 metres;
 - (iii) A1(M) Motorway northbound entry and southbound exit slip roads at Junction 37;
 - (iv) A1(M) Motorway northbound exit and southbound entry slip road at Junction 38; or
 - (v) A638 Trunk Road northbound carriageway from its junction with the A638 roundabout at Redhouse Interchange to the A1 (M) Motorway southbound entry slip road at Junction 38.
- **3.** The provisions of article 2 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 2 of this Order shall apply to any vehicle or person proceeding in the A1(M) or A638 Trunk Road to or from premises and property which is accessible for that vehicle or person from, and only from, those roads.
