ROAD TRAFFIC

The A63 Trunk Road (South Cave Interchange to Brighton Street Interchange) (Temporary Prohibition of Traffic) Order 2014

Made - - - - 7th August 2014

Coming into force - - 20th August 2014

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A63 Trunk Road, in the East Riding of Yorkshire, is satisfied that traffic on that trunk road and some of those connecting roads should be prohibited because carriageway resurfacing, road markings, road studs, traffic loop installation and routine maintenance works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

1. This Order may be cited as the A63 Trunk Road (South Cave Interchange to Brighton Street Interchange) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on 20th August 2014.

2. In this Order:-

"the A63" means the A63 Trunk Road;

"the westbound carriageway" means the A63 westbound carriageway from the nose of the westbound exit slip road at Brighton Street Interchange to the nose of the westbound entry slip road at South Cave Interchange, a distance of 17000 metres;

"the eastbound carriageway" means the A63 eastbound carriageway from the nose of the eastbound exit slip road at South Cave Interchange to the nose of the eastbound entry slip road at Western Interchange, a distance of 10180 metres;

"a slip road" means any of the following A63 slip roads:

- (i) westbound entry slip road at Brighton Street Interchange;
- (ii) westbound exit and entry slip road at Priory Way Interchange;
- (iii) westbound exit and entry and eastbound exit slip roads at Western Interchange;
- (iv) westbound and eastbound entry and exit slip roads a Melton Interchange;
- (v) westbound and eastbound entry and exit slip roads at Welton Interchange; or
- (vi) westbound exit and eastbound entry slip roads at South Cave Interchange;

"a layby" means an area of carriageway intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002(a); and in this definition "carriageway" means any way (other than a cycle track) comprised in the A63 over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

"the works period" means a period of 10 hours starting at 20:00 hours on Thursday 21st August 2014 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the westbound carriageway, the eastbound carriageway or a slip road.
- **4.** Subject as mentioned in article 5 no person shall, during the works period, cause or permit any vehicle to enter or wait in the layby situated adjacent to the A63:
 - (i) westbound carriageway 465 metres west of the entry slip road at Brighton Street Interchange;
 - (ii) westbound carriageway 665 metres west and 1500 metres west of the entry slip road at Priory Way Interchange;
 - (iii) eastbound carriageway 740 metres east and 1300 metres east of the entry slip road at Melton Interchange; or
 - (iv) eastbound carriageway 768 metres west of the eastbound exit slip road at Brighton Street Interchange.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for traffic officer or winter maintenance purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle or person proceeding in the A63 to or from premises and property which is accessible for that vehicle or person, from, and only from, that road.
