ROAD TRAFFIC

The A45 Trunk Road (Wootton to Weston Favell, Northampton) (Temporary Prohibition of Traffic) Order 2014

Made		-	-	3rd October 2014
Coming	into force	-	-	10th October 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A45 Trunk Road ("the A45") and connecting roads, is satisfied that traffic on some of those connecting roads, between Wootton and Weston Favell near Northampton, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A45 Trunk Road (Wootton to Weston Favell, Northampton) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Friday 10th October 2014.

2. In this Order:

"Barnes Meadow Interchange"	means the roundabout junction of the A428, the A5095 and the slip roads leading to and from the A45;
"Brackmills Interchange"	means the roundabout junction of Eagle Drive, Caswell Road and the slip roads leading to and from the A45;
"the link road"	means the link road, adjacent to the westbound carriageway of the A45, from the roundabout junction with Barnes Meadow Interchange to the roundabout junction with Brackmills Interchange;
"the connecting road"	means that length of road which leads to the westbound carriageway of the A45 from the link road;

"a slip road"

means -

i)

- the slip road leading to the northbound carriageway of the A45 from the roundabout junction with Rowtree Road, Wooldale Road, and London Road;
- ii) the slip road leading from the northbound carriageway of the A45 to the roundabout junction with the A508, A5076, B526 Newport Pagnell Road, Hardingstone Lane and the slip roads leading to and from the A45, known as Queen Eleanor Interchange;
- iii) the slip road leading to the eastbound carriageway of the A45 from the roundabout junction with Brackmills Interchange;
- iv) the slip roads leading to the eastbound and westbound carriageways of the A45 from the roundabout junction with the A43 Lumbertubs Way, Ferris Row and the slip roads leading to and from the A45;
- v) the slip roads leading from the eastbound and westbound carriageways of the A45 to Barnes Meadow Interchange;
- vi) the slip roads leading to and from the westbound carriageway of the A45 from and to Brackmills Interchange;

"the works period"

means the period starting at 20.00 hours on Monday 13th October 2014 and ending when the said works have been completed,

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in articles 4 and 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in a slip road, the link road or the connecting road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

5. The provisions of article 3 shall not apply to any vehicle -

- (i) being used for police, fire brigade or ambulance purposes; or
- (ii) proceeding at the direction of, or with the permission of, a police constable;
- (iii) being used in connection with the said works.
