ROAD TRAFFIC

The A40 Trunk Road (Glewstone, Herefordshire) (Temporary Restriction and Prohibition of Traffic) Order 2014

Made - - - - 24th February 2014

Coming into force - - 3rd March 2014

WHEREAS the Secretary of State for Transport, being the traffic authority for the A40 Trunk Road ("the A40"), is satisfied that traffic on a length of that road, at Glewstone in the County of Herefordshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14 (1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A40 Trunk Road (Glewstone, Herefordshire) (Temporary Restriction and Prohibition of Traffic) Order 2014 and shall come into force Monday 3rd March 2014

2. In this Order –

"the trunk road" means the eastbound carriageway of the A40 between a

point 410 metres south and a point 1058 metres north of

the junction with Boat Lane;

"the central reservation" means that part of the trunk road which separates its

carriageways for the safety and guidance of vehicular

traffic using that road;

"the works period" means the period starting at 00:01 hours on Monday

10th March 2014 and ending when the said works have

been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the trunk road.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed through the gap in the central reservation of the A40 situated—

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

- i) opposite its junction with Boat Lane;
- ii) approximately 110 metres north of Boat Lane;
- iii) approximately 500 metres north of Boat Lane;
- iv) approximately 820 metres north of Boat Lane.
- **5.** The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.
 - **6.** The provisions of
 - a) article 3 shall not apply to any vehicle being used for special forces purposes;
 - b) articles 3 and 4 shall not apply to any vehicle
 - (i) being used for police, fire brigade or ambulance purposes; or
 - (ii) proceeding at the direction of, or with the permission of, a police constable; and
 - c) article 4 shall not apply to any vehicle being used in connection with the said works.
