ROAD TRAFFIC

The A5036 Trunk Road (Princess Way/Church Road Roundabout) (Prohibition of Left and Right Turns and One Way Traffic) Order 2015

Made 25th March 2015

Coming into force 31st March 2015

The Secretary of State for Transport in exercise of the powers conferred by sections 1(1) and 2(1) and (2), and 122A of the Road Traffic Regulation Act 1984(a), hereby makes the following Order on the A5036 Trunk Road in the District of Sefton in Merseyside:

1. This Order may be cited as The A5036 Trunk Road (Princess Way/Church Road Roundabout) (Prohibition of Left and Right Turns and One Way Traffic) Order 2015 and shall come into force on 31st March 2015.

2. In this Order:

"the circulatory carriageway" means the circulatory carriageway of the A5036 Princess Way/Church Road roundabout;

"the through carriageway" means the westbound carriageway of the A5036 Trunk Road which passes through the centre of the circulatory carriageway.

- 3. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a right turn from the circulatory carriageway at its eastern side to the through carriageway.
- 4. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a right turn from the westbound carriageway of the A5036 Church Road at the eastern side of the circulatory carriageway to the circulatory carriageway.
- 5. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a right turn from the through carriageway at its western side to the circulatory carriageway.
- 6. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a right turn from the circulatory carriageway at its western side to the through carriageway.

- 7. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a left turn from the westbound carriageway of the A5036 Church Road at the eastern side of the circulatory carriageway to the circulatory carriageway.
- 8. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a left turn from the through carriageway to the circulatory carriageway at its western side.
- 9. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a left turn from the circulatory carriageway at its western side to the westbound carriageway of the A5036 Princess Way.
- 10. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to make a left turn from the circulatory carriageway at its eastern side to the westbound carriageway of the A5036 Church Road.
- 11. Subject as mentioned in article 12 of this Order, no person shall cause or permit any motor vehicle to enter or proceed in the through carriageway in any direction other than westbound.
- Nothing in articles 3, 4, 5, 6, 7, 8, 9, 10 and 11 of this Order shall apply to any vehicle being used for emergency purposes by the police, fire and rescue or ambulance services or anything done at the direction of, or with the permission of a constable, or a traffic officer in uniform
