# The Air Navigation (Restriction of Flying) (Ministry of Defence Restricted Airspace) Regulations 2024

Made - - - - 20th December 2024

Coming into force - - 23rd December 2024

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the areas specified in the Schedule for reasons of national security associated with the location of Ministry of Defence sites.

The Secretary of State makes these Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Ministry of Defence Restricted Airspace) Regulations 2024 and they come into force on 23rd December 2024.

### Restricted airspace

- 2.—(1) Subject to paragraph (2), no unmanned aircraft is to fly below the corresponding altitude specified in column 4 of the Schedule over the locations listed in column 1 of the Schedule, each of which for the purpose of these Regulations comprises an area bounded by a circle having a radius specified in column 3 of the Schedule centred on the coordinates specified in column 2 of the Schedule.
  - (2) Paragraph 2 does not apply to any unmanned aircraft—
    - (a) operated by or on behalf of—
      - (i) the Ministry of Defence Police,
      - (ii) a Police Air Support Unit, or
      - (iii) a Fire and Rescue Service in response to an emergency incident, or
    - (b) flying in accordance with a permission issued by the Ministry of Defence Police.

#### **Revocation of Regulations**

**3.** The Air Navigation (Restriction of Flying) (Royal Air Force Feltwell) (Emergency) Regulations 2024(a) and the Air Navigation (Restriction of Flying) (Royal Air Force Menwith Hill and Royal Air Force Fylingdales) (Emergency) Regulations 2024(b) are revoked.

## **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations restrict the flying of unmanned aircraft in the vicinity of the Ministry of Defence sites specified in the Schedule.

At the request of the Ministry of Defence, it has been agreed by the Civil Aviation Authority and the Department for Transport that the flying of unmanned aircraft should be restricted in the areas specified in the Schedule for reasons of national security.

These Regulations revoke the Air Navigation (Restriction of Flying) (Royal Air Force Feltwell) (Emergency) Regulations 2024 (S.I. 2024/1203) and the Air Navigation (Restriction of Flying) (Royal Air Force Menwith Hill and Royal Air Force Fylingdales) (Emergency) Regulations 2024 (S.I. 2024/1254).
