# The Air Navigation (Restriction of Flying) (Wishaw) Regulations 2025

*Made - - - - 23rd January 2025* 

Coming into force - - 18th August 2025

The Secretary of State has decided that it is necessary in the public interest to restrict the flying of unmanned aircraft in the area specified in regulation 3(1) by reason of the intended gathering there of a large number of persons at the 2025 British Masters Golf Championships.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a).

#### Citation and commencement

**1.** These Regulations may be cited as the Air Navigation (Restriction of Flying) (Wishaw) Regulations 2025 and they come into force on 18th August 2025.

### Interpretation

**2.** In regulation 3(1) the times referred to are Co-ordinated Universal Time(**b**).

## Restricted airspace

- **3.**—(1) Subject to paragraph (2), beginning at 0400 hours on 18th August 2025 and ending at 2100 hours on 24th August 2025 no unmanned aircraft is to fly below 1,200 feet above mean sea level within the area bounded by a circle having a radius of 1 nautical mile centred at 523314N 0014409W.
- (2) Paragraph (1) does not apply to any unmanned aircraft flying in accordance with a permission issued by the 2025 British Masters Golf Championships event Safety Officer.

## **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations impose restrictions on the flying of unmanned aircraft in the vicinity of the 2025 British Masters Golf Championships, Wishaw, Sutton Coldfield, Warwickshire by reason of the gathering of a large number of persons expected to attend the event which is due to take place there between 18th August 2025 and 24th August 2025 (inclusive).

The Civil Aviation Authority and the Department for Transport agree that the flying of unmanned aircraft should be restricted in the vicinity of the event location for reasons of public safety.

The times mentioned in regulation 3(1) are Co-ordinated Universal Time (UTC) which is one hour behind British Summer Time (BST).

In relation to the permission mentioned in regulation 3(2), the 2025 British Masters Golf Championships event Safety Officer may be contacted as notified.

Full details of this Statutory Instrument will be promulgated by Aeronautical Information Circular (AIC) and Notice to Aviation (NOTAM).
