Her Majesty's Ambassador at Vienna to the Austrian Minister for Foreign Affairs

British Embassy, Vienna, 27th November, 1953.

Herr Bundesminister,

I have the honour, upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, to propose that the Sterling Payments Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Austrian Federal Government of the 31st of January, 1951,(¹) which was reviewed last year in accordance with Article 9, shall continue in force so long as bilateral balances between the United Kingdom and Austria are settled through the European Payments Union, unless the Agreement is terminated at some earlier date by notice in accordance with Article 9 thereof.

If the Austrian Federal Government agree to this proposal, I have the honour to suggest that the present Note and your reply in that sense shall be regarded as constituting an Agreement between the two Governments.
