Her Majesty's Ambassador at Stockholm to the Swedish Minister for Foreign Affairs

British Embassy,

Stockholm, August 25, 1955. Your Excellency.

I have the honour, upon instructions from Her Majesty's Principal Secretary of State for Foreign Affairs, and with reference to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Sweden relating to Air Services, signed at London on the 27th of November, 1946,(1) as amended by the Notes exchanged at London on the 23rd of June, 1952,(2) and the 13th of March, 1953,(3) to propose that Route 2 of Schedule I to the Annex to the Notes exchanged on the 23rd of June. 1952, should be amended to read as follows:---

In the English text:—

四年(1017年)

Kingdom-Stavanger-Bergen-Oslo-"2. Points in the United Stockholm."

In the Swedish text:—

"2. Platser i Det Förenade Konungariket-Stavanger-Bergen-Oslo-Stockholm."

If this proposal is acceptable to the Government of Sweden, I have the honour to suggest that the present Note and your Excellency's reply in similar terms should be regarded as constituting an Agreement between our two Governments, which should take effect immediately.
