EXCHANGE OF NOTES BETWEEN THE GOVERNMENT OF GREAT BRITAIN AND THE UNITED KINGDOM OF NORTHERN IRELAND AND THE GOVERNMENT OF THAILAND CONCERNING THE EXCHANGE OF OFFICIAL PUBLICATIONS

Her Majesty's Ambassador at Bangkok to the Thai Minister for Foreign Affairs

> British Embassy, Bangkok, January 3, 1963.

Your Excellency,

With reference to the negotiations which have taken place between representatives of the Government of the United Kingdom of Great Britain and Northern Ireland and of the Government of Thailand concerning the exchange of official publications, I have the honour to propose, on behalf of Her Majesty's Government in the United Kingdom, that there shall be an exchange of official publications between the two Governments in accordance with the following provisions:

- (1) Each Government shall supply regularly, carriage paid to destination, one copy of each of the serial publications specified on a selected list prepared by the other Government and transmitted through the diplomatic channel. Alterations to these lists may be made from time to time by agreement between the responsible authorities referred to in sub-paragraph 4.
- (2) Each Government shall, at the request of the other Government, supply non-serial publications according to arrangements to be agreed upon by the responsible authorities referred to in sub-paragraph 4.
- (3) Each Government shall aim at ensuring that the total cost of the publications supplied shall be approximately equal to that of the publications received.
- (4) The responsible authority for the transmission of publications of the Government of the United Kingdom shall be Her Majesty's Stationery Office. The responsible authority for the transmission of publications of the Government of Thailand shall be the National Library of Thailand.
- (5) The publications shall be received on behalf of the United Kingdom by the British Museum and on behalf of Thailand by the National Library of Thailand.
- (6) Neither of the two Governments shall be required under the present provisions to furnish blank forms, or documents which are not of a
- public character. The Government of the United Kingdom shall not
 be required under these provisions to furnish publications not published
 by Her Majesty's Stationery Office.

(7) The present provisions shall not be considered as a modification of any existing exchange agreement between a department or agency of one of the Governments and a department or agency of the other Government.

If the foregoing provisions are acceptable to the Government of Thailand I have the honour to suggest that the present Note, together with Your Excellency's reply in that sense, should be regarded as constituting an Agreement between the two Governments in this matter, which shall enter into force on the date of your Note in reply and which shall remain in force until the expiry of twelve months after written notice of termination shall have been given by either Government to the other through the diplomatic channel.
