Sir

I have the honour to refer to the British Expatriates Supplementation (Lesotho) Agreement 1976(1) as amended by the British Expatriates Supplementation (Lesotho) Agreement 1976 Amendment 1978(2) (hereinafter referred to as "the Agreement") and to propose that the Agreement be amended:

- (a) by deleting in sub-paragraph 3 of paragraph 1 the words and figures "31 March 1981" and substituting therefor the words and figures "31 March 1986" and;
- (b) by adding to the list of employing authorities in the Second Annex to the Agreement:

The Lesotho Telecommunications Corporation.

If this proposal is acceptable to the Government of Lesotho, I have the honour to suggest that this Note and your reply shall constitute an agreement between our two Governments, which shall be cited, together with the Agreement, as the British Expatriates Supplementation (Lesotho) Agreement 1976/81.
