British Embassy Amman 2 November 1989

Your Excellency,

I have the honour to refer to the United Kingdom/Jordan Loan No. 2, 1987¹ (hereinafter referred to as "the loan") and to the wish of the Government of the Hashemite Kingdom of Jordan that the loan be cancelled and that Technical Co-operation be provided in its place.

Accordingly, I have the honour to propose that the loan should be regarded as cancelled and that discussions should continue between our two Governments over Technical Co-operation projects to be financed from an allocation not exceeding £5,000,000 (five million pounds sterling).

If the proposals set out above are acceptable to your Government, I have the honour to propose that the recent Note together with Your Excellency's reply in that sense shall constitute an Agreement between our two Governments and that the cancellation of the loan shall enter into force on the date of Your Excellency's reply.

I avail myself of this opportunity to renew to Your Excellency the assurance of my highest consideration.
