## No. 1

Her Majesty's Ambassador at Tegucigalpa to the Minister of Finance and Public Credit of Honduras

> British Embassy Tegucigalpa 4 February 1993

I have the honour to refer to the United Kingdom/Honduras Loan 1980 as amended (hereinafter referred to as 'The Loan') and to inform you that my Government proposes that the final date for payment into the account opened in accordance with paragraph B.1.1 (of the 'Procedures and Practices applicable to the Expenditure of United Kingdom Aid Resources' accompanying the loan) be deferred to 31 March 1994.

- 2. Accordingly, I have the honour to propose that the date in paragraph 5 of the loan be amended to read 31 March 1994.
- 3. If the proposal set out above is acceptable to the Government of Honduras, I have the honour to propose that the present note, together with your Excellency's reply in that sense, shall constitute an agreement between our two Governments further amending the United Kingdom/Honduras Loan 1980 which shall enter into force on the date of your Excellency's reply and which shall be known as "United Kingdom/Honduras Loans 1980 (Amendment No. 4)".
- 4. I avail myself of this opportunity to renew to your Excellency the assurance of my highest consideration.
