**The M4 Motorway (Slip Roads at
Junction 48, Hendy, Carmarthenshire)
(Temporary Prohibition of Vehicles)
Order 2011**

Made 8 September 2011

Coming into force 19 September 2011

The Welsh Ministers, being the traffic authority for the relevant lengths of the London to South Wales Motorway (M4) (hereinafter referred to as “the motorway”), are satisfied that traffic in specified lengths of the motorway should be prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers (2) make this Order.

1. This Order comes into force on 19 September 2011 and its title is The M4 Motorway (Slip Roads at Junction 48, Hendy, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2011 .

2. (1) In this Order :

“exempted vehicle” (*“cerbyd esempt”*) means any vehicle being used for the emergency services or in connection with the works giving rise to this Order;

“the lengths of the motorway” (*“y darnau o’r draffordd”*) means the lengths of the motorway described in the Schedule to this Order;

“works period” (*“cyfnod y gwaith”*) means the period commencing at 20.00 hours on 19 September 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

3. Subject to the provisions of article 4, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to be driven in the lengths of the motorway.

4. The provisions of article 3 shall apply only during such times and to such extent as the application of the prohibition referred to therein is indicated by traffic signs.

5. The maximum duration for this Order shall be 18 months
