# **ROAD TRAFFIC, WALES**

# The A458 Trunk Road (Pont Nantyr-ehedydd, East of Mallwyd, Gwynedd) (Temporary Traffic Prohibitions & Restrictions) Order 2015

Made	5 January 2015
Coming into force	12 January 2015

The Welsh Ministers, being the traffic authority for the relevant length of the Shrewsbury – Dolgellau Trunk Road (A458) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

#### **Title, Interpretation and Commencement**

**1.** This Order comes into force on 12 January 2015 and its title is The A458 Trunk Road (Pont Nant-yr-ehedydd, East of Mallwyd, Gwynedd) (Temporary Traffic Prohibitions & Restrictions) Order 2015.

### **2.**—(1) In this Order:

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road in the County of Gwynedd that extends from the centre-point of its junction with the road opposite the entrance to the dwelling known as Nant-yr-ehedydd to a point 108 metres east of the centre-point of Pont Nant-yr-ehedydd;

"works period" ("*cyfnod y gwaith*") means intermittent periods commencing at 07:30 hours on 12

January 2015 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibitions and Restrictions**

**3.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.

**4.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.

**5.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.

**6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

#### Application

**7.** The provisions of articles 3, 4, 5 and 6 apply only during such times and to such extent as the application of the prohibitions and restrictions referred to therein is indicated by traffic signs.

#### **Duration of this Order**

**8.** The maximum duration of this Order shall be 12 months.
