The A470 Trunk Road (Tal-y-Cafn, Conwy County Borough) (Temporary Speed Restrictions & No Overtaking) Order 2016

Made 13 June 2016

Coming into force 20 June 2016

The Welsh Ministers, being the traffic authority for the relevant length of the Maentwrog – East of Conwy Trunk Road (A470) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be restricted and prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1), (4), (7) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 20 June 2016 and its title is The A470 Trunk Road (Tal-y-Cafn, Conwy County Borough) (Temporary Speed Restrictions & No Overtaking) Order 2016.

2.—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means:

- (a) any vehicle being used by the emergency services; and
- (b) any vehicle being used for naval, military or air force purposes and are being driven by a person for the time being subject to the orders of the member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security

- emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

"special forces" ("lluoedd arbennig") means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

"the length of the trunk road" ("y darn o'r gefnffordd") means the length of the trunk road at Taly-Cafn in the County Borough of Conwy that extends from its junction with the unclassified gated access leading to Bod Hyfryd Hall, south of Tal-y-cafn to its junction with the unclassified road known as Bodnant Road (leading to Bodnant Garden Centre), north of Tal-y-cafn;

"works period" ("cyfnod y gwaith") means that period commencing at 06:00 hours on 20 June 2016 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Restrictions and Prohibition

- **3.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **4.** No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **5.** No person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 4 is in operation.

Suspension

6. Any statutory provisions restricting the speed of vehicles on the relevant length of the trunk road specified in article 2 are suspended during such times as the restrictions specified in articles 3 and 4 are in operation.

Revocation

7. The A470 Trunk Road (Tal-y-Cafn, Conwy County Borough) (Temporary Speed Restrictions & No Overtaking) Order 2015(2) is revoked.

Application

- **8.** (1) The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as the application of the restrictions and prohibition referred to therein is indicated by traffic signs.
- (2) No speed limit imposed by this Order applies to an exempted vehicle.

Duration of this Order

9. The maximum duration for this Order shall be 12 months.
