The A55 Trunk Road (Eastbound Carriageway from Junction 18 (Llandudno Junction) to Junction 20 (Brompton Avenue), Conwy County Borough) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2020

Made	29 December 2020
Coming into force	4 January 2021

The Welsh Ministers, as traffic authority for the relevant length of the A55 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. The title of this Order is the A55 Trunk Road (Eastbound Carriageway from Junction 18 (Llandudno Junction) to Junction 20 (Brompton Avenue), Conwy County Borough) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2020 and it comes into force on 4 January 2021.

2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in

connection with the works giving rise to this Order;

"the trunk road" (*"y gefnffordd"*) means the length of the eastbound carriageway of the A55 Chester to Bangor trunk road that extends from Junction 18 (Llandudno Junction) to Junction 20 (Brompton Avenue), Conwy County Borough;

"works period" (*"cyfnod y gwaith"*) means intermittent periods commencing at 19:00 hours on 4 January 2021 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibitions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road.

5. No pedestrian may, during the works period, proceed on the length of the trunk road.

Application

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

7. The maximum duration for this Order is 18 months.
