# **ROAD TRAFFIC, WALES**

The A40 Trunk Road (Llandeilo to Llandovery, Carmarthenshire) (Temporary Speed Restrictions & No Overtaking) Order 2020

Made 12 May 2020

Coming into force 18 May 2020

The Welsh Ministers, as traffic authority for the relevant length of the A40 trunk road, are satisfied that traffic on specified lengths of the trunk road should be restricted and/or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

## **Title, Commencement and Interpretation**

**1.** The title of this Order is the A40 Trunk Road (Llandeilo to Llandovery, Carmarthenshire) (Temporary Speed Restrictions & No Overtaking) Order 2020 and it comes into force on 18 May 2020.

#### 2. In this Order—

"exempted vehicle" ("cerbyd esempt") means:

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

"special forces" ("lluoedd arbennig") means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director:

"the trunk road" ("y gefnffordd") means the A40 Swansea to Manchester Trunk Road;

"works period" ("cyfnod y gwaith") means the period commencing at 00:01 hours on 18 May 2020 and ending when the temporary traffic signs are permanently removed.

#### **Restrictions and Prohibition**

- **3.** No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in Schedule 1 to this Order.
- **4.** No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the lengths of the trunk road specified in the Schedules to this Order.
- **5.** No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the lengths of the trunk road specified in the Schedules to this Order during such times as the restriction specified in article 4 is in operation.

# **Application**

- **6.**—(1) The restrictions and prohibition in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.
- (2) No speed limit imposed by this Order applies to an exempted vehicle.

## **Suspensions**

**7.** Any statutory provisions restricting the speed of motor vehicles on the lengths of the trunk road specified in the Schedules to this Order are suspended during such times as the restrictions specified in articles 3 and 4 apply.

### **Duration of this Order**

**8.** The maximum duration of this Order is 18 months.

# SCHEDULE 1 Temporary 40 mph or 10 mph Speed Limit & No Overtaking

The length of the trunk road that extends from a point approximately 1.1 kilometres north-east of the centrepoint of its junction with the B4302, north of Llandeilo to a point 460 metres south-west of the centre-point of its junction with the A4069 at Ashfield.

The length of the trunk road that extends from a point 260 metres north of the centre-point of its junction with the A4069 at Ashfield to a point 133 metres south-east of the centre-point of its junction with the C2157, north-west of Llandovery.

# SCHEDULE 2 Temporary 10 mph Speed Limit & No Overtaking

The length of the trunk road that extends from Llandeilo Roundabout (including its circulatory carriageway) to a point approximately 1.1 kilometres

north-east of the centre-point of its junction with the B4302.

The length of the trunk road that extends from a point 460 metres south-west of the centre-point of its junction with the A4069 at Ashfield to a point 260 metres north of the centre-point of that junction.

The length of the trunk road that extends from a point 133 metres south-east of the centre-point of its junction with the C2157 to its junction with the A483 at Llandovery.
