ROAD TRAFFIC, WALES

The A5 Trunk Road (Berwyn Street and Regent Street, Llangollen, Denbighshire) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2021

Made 2 September 2021

Coming into force 6 September 2021

The Welsh Ministers, as traffic authority for the A5 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A5 Trunk Road (Berwyn Street and Regent Street, Llangollen, Denbighshire) (Temporary Prohibition of Vehicles, Cyclists and Pedestrians) Order 2021 and this Order comes into force on 6 September 2021.

Interpretation

2. In this Order—

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in

connection with the works giving rise to this Order;

"the trunk road" ("y gefnffordd") means the A5 London to Holyhead trunk road known as Berwyn Street and Regent Street that extends from a point 5 metres west of the centre-point of its junction with Castle Street to a point 50 metres east of the centre-point of that junction;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 20:00 hours on the 6 September 2021 and ending when the temporary traffic signs are permanently removed.

Prohibitions

- **3.** No person may, during the works period, drive any vehicle, other than an exempted vehicle on the length of the trunk road.
- **4.** No person may, during the works period, ride any pedal cycle on the length of the trunk road.
- **5.** No pedestrian may, during the works period, proceed on the length of the trunk road.

Application

6. The prohibitions in article 3, 4 and 5 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order is 12 months.
