The A487 Trunk Road  
(Pembrokeshire/Ceredigion County  
Boundary near Cardigan,  
Ceredigion to Dyfi Bridge, Powys)  
(Temporary Speed Restrictions &  
No Overtaking) Order 2025

*Made* 21 February 2025

*Coming into force* 27 February 2025

The Welsh Ministers, as traffic authority for the A487 trunk road, are satisfied that traffic on a specified length of the trunk road should be restricted and/or prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. The title of this Order is the A487 Trunk Road (Pembrokeshire/Ceredigion County Boundary near Cardigan, Ceredigion to Dyfi Bridge, Powys) (Temporary Speed Restrictions & No Overtaking) Order 2025 and this Order comes into force on 27 February 2025.

**Interpretation**

2. In this Order—

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

“exempted vehicle” (“*cerbyd esempt*”) means—

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984<sup>(1)</sup>;
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
  - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
  - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A487 Fishguard to Bangor trunk road that extends from the Pembrokeshire/Ceredigion county boundary, adjacent to the dwelling known as Gamallt, south of Cardigan to the Powys/Gwynedd county boundary at Dyfi Bridge, north of Machynlleth, Powys;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 08:00 hours on 27 February 2025 and ending when the temporary traffic signs for each period of works are permanently removed.

### **Restrictions and prohibition**

**3.** No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the length of the trunk road.

**4.** No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the length of the trunk road.

**5.** No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the length of the trunk road.

6. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road during such times as the restriction referred to in article 3 is in operation.

#### **Application**

7.—(1) The restrictions and prohibition in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

#### **Suspension**

8. Any statutory provisions restricting the speed of vehicles on the relevant length of the trunk road are suspended during such times as the restrictions specified in articles 3, 4 and 5 are in operation.

#### **Duration of this Order**

9. The maximum duration of this Order is 18 months.
